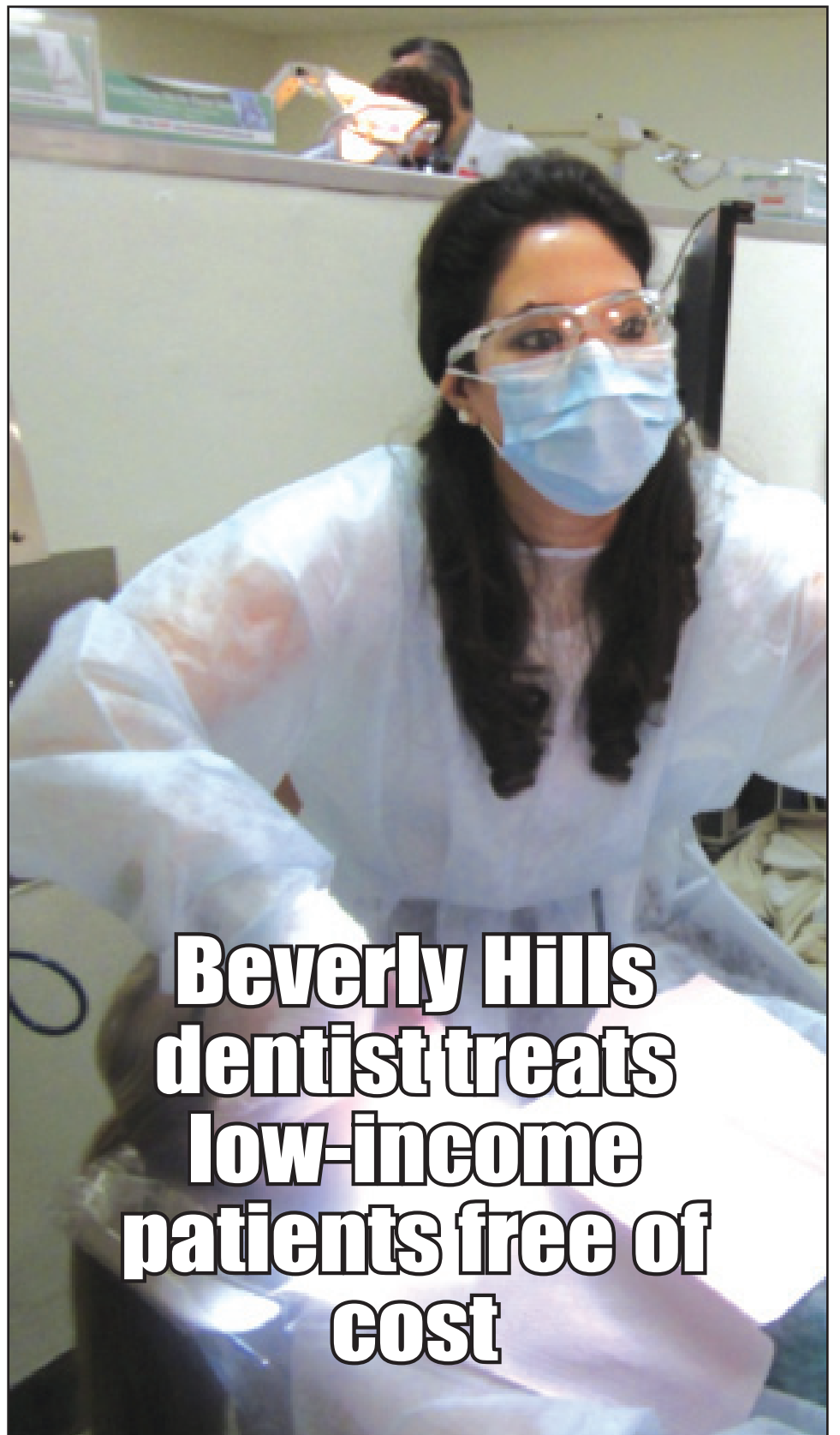

I thought nothing of it until I heard loud bangs and shouts from an officer.

It looked like the officer was pounding on one of the benches with a club and shouting four letter words at what seemed like a very scared homeless man.

The officer kept yelling and even honked the car horn until the man left running.

I could not believe what I was seeing.

That officer's actions might be acceptable in places like New York or Chicago, but I found it disturbing here in Beverly Hills.

One of the neighbors awoke from the shouting.

In the Weekly, we often read of burglaries in Beverly Hills involving large sums of money.

To focus on an apparently sleeping homeless man while more important matters around the city need attention, I felt the need to write this letter.

I believe and know that the Beverly Hills Police Department is the finest police force in the nation.

However, it seems that at least one officer is not with the program.

I suddenly don't feel as safe in my home anymore.

Board of Education unanimously approves campus security program

The Board of Education unanimously approved working with Evidence-Based, Inc., which provides campus safety solutions, in creating a new campus security program across the school district to provide additional protection to students, in light of nationwide patterns of violence.

An officer will be installed at each elementary school, with two at the high school, along with a new lead security chief overseeing personnel and safety plans. The chief will report to the superintendent and the board of education, and will work alongside parent teacher associations, school staff and administration, city officials, and the Beverly Hills chief of police – according to Board of Education President Jake Manaster.

The security chief will perform threat assessment, managing and monitoring situations where they believe there is a potential threat, and helping prevent individuals from getting to the point of a harmful outburst.

Such a program will take effect beginning January 1, 2014.

“I hope the community will now rest assured that we have the ability to be immediately responsive,” Manaster said. “Our police department does a good job of

immediately rising to the scene, but as we saw at Sandy Hook, in order to preserve life and limb, it does require somebody on the campus able to respond in 60 seconds as opposed to a couple minutes. It really does make a big difference.”

The program is a response to the community’s concerns about student and teacher safety in light of recent events, Manaster says.

It reinstalls armed Beverly Hills Police Department trained officers at schools,

whereas they were once eliminated at the beginning of the recession as the city necessarily cut back on expenditures.

The school district will contract with Evidence-Based, Inc., an organization that has recruited numerous recently retired Beverly Hills officers who have served as campus security officers, for this cause.

Manaster says the board unanimously considered this an advantageous route, since these officers are familiar with the community’s children, families, homes, and

businesses.

“This is a very tight knit community that deserves a tight knit security force for our school campuses,” Manaster said.

Manaster, who opted not to seek re-election, will attend his last meeting on Dec. 10.

Medical Overlay Zone: A request to apply the City’s Medical Overlay Zone to the subject property to allow medical office uses. If approved, up to 33,802 square feet of medical office space could be established within the existing building. This would be equal to approximately 45% of the building’s floor area;

Development Plan Review: A request to amend the previously approved Development Plan Review for the subject property. The proposed amendments would modify the project’s existing conditions of approval, and would eliminate prohibitions on medical office space, automobile sales uses, and pharmacies. The amendments would also allow for increased restaurant space within the building, and would establish a fee structure for providing public parking on weekdays and weekends at the subject property; and

Conditional Use Permit: A request for a Conditional Use Permit to allow the establishment of a luxury automobile showroom within the building’s ground floor. The proposal includes a showroom only, and no service operations would occur on-site.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. A Mitigated Negative Declaration (MND) was previously adopted by the City Council on January 30, 2007 for the existing commercial building on the subject site. Therefore, it is expected that an addendum to the original MND will be prepared to evaluate the project changes outlined above, and will be presented to the Planning Commission for consideration.

Development Agreement: As a component of the entitlements listed above, the applicant proposes a development agreement. The development agreement would set forth the City’s rights, the applicant’s rights, and would contain provisions for public benefits to be provided to the City by the applicant.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. An Environmental Impact Report (EIR) was previously certified by the City Council on December 3, 2002 for the existing development on the subject site. Therefore, an addendum to the original EIR has been prepared in order to evaluate the project changes outlined above, and will be presented to the Planning Commission for consideration.

Understanding cultural nuances is becoming increasingly important in the real estate business, he says.

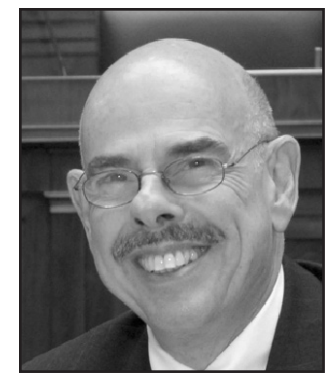
“You have a large population of different cultures and they’re becoming more educated and more successful,” Nourmand said. “They’re going to buy more houses.

The following summary of the above-entitled Ordinance of the City of Beverly Hills has been prepared and published pursuant to Government Code Section 36933.

Summary of Ordinance

This ordinance amends the City’s Administrative Code and adopts by reference the 2013 edition of the California Building, Mechanical, Plumbing, Electrical, Energy, Residential, Green Building Standards, Historical Building, Existing Building, Reference Standards, and Fire Codes (collectively known as the California Building Standards Code, 24 C.C.R., Parts 2 through 12), as well as the latest editions of the International Property Maintenance Code, Uniform Swimming Pool, Spa and Hot Tub Code, Uniform Solar Energy Code, and Beverly Hills Photovoltaic Installation Guidelines, together with certain amendments, deletions and additions.

The California Building Standards Code, as amended, establishes requirements for the structural, plumbing, electrical and mechanical systems of buildings and structures, including historic buildings and buildings not meeting current seismic standards, and for fire and life safety, energy conservation and sustainability. The new City amendments include; changes to wood, structural steel, and seismic design provisions. The other Codes and Guidelines adopted establish standards for property maintenance, construction and maintenance of swimming pools, spas and hot tubs, and installation of various solar energy devices. The ordinance also provides penalties for non-compliance, and for fees.

The City has determined that the ordinance is exempt from the environmental review requirements of the California Environmental Quality Act pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

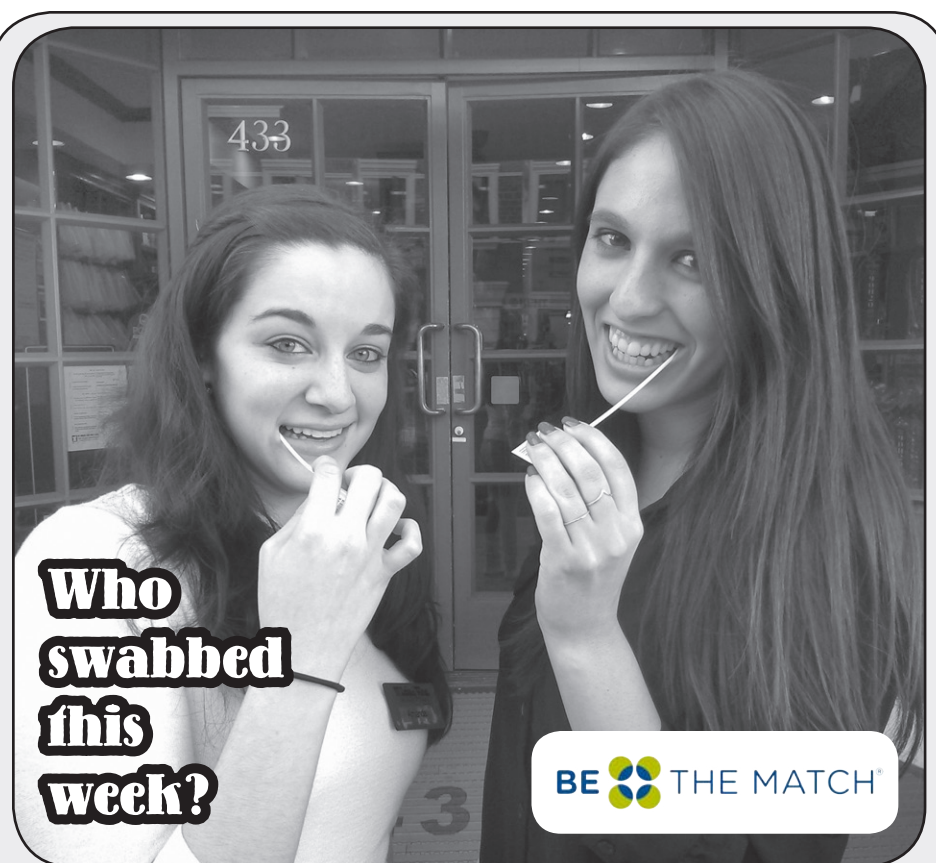

Results from the Tuesday November 5 Board of Education race show that both winning candidates performed strongest on their home turf.

- Korbato performed best in precincts north of Wilshire, Goldstein south of Wilshire.
- 72.2% of voters cast their ballot by mail. The turnout in the polls was one of the lowest in recent memory.

Beverly Hills dentist treats low-income patients free of cost

Last week, Dr. Chanel Yousefzadeh participated in a four-day-long marathon of drillings, root canals, and extractions for Care Harbor, a program that provides free health care to the uninsured.

Care Harbor is a clinic that opens once a year, and relies on volunteers such as Yousefzadeh to examine, treat, and educate the sick on a massive scale. Thousands of people lined outside the Los Angeles Sports Arena on Oct. 31 for the opportunity to be treated by a medical professional.

Yousefzadeh left her Beverly Hills dental practice to volunteer for the four full days at Care Harbor. She treated approximately eight to ten people a day.

"The atmosphere was busy, but laid back. It was well organized with enough volunteers to organize people and show them where to go and what to do. They really thought of everything."

"I was raised in a house where it was always a big deal to do mitzvahs and that's the reason why I got into the health care profession. I wanted to do something to help other people."

Approximately 3,000 patients were treated by the 2,950 medical and general volunteers of Care Harbor.

The arena was sectioned off to include medical areas for dentistry, optometry, and women's health, among others.

"It's different from how it is with [my] dental practice. You just go in there and do the work that you enjoy. There aren't questions about what treatment you need, or the price. You just go in and diagnose the patient," said Yousefzadeh.

A 2002 Beverly High graduate, one of Yousefzadeh's first jobs was working as an advertising representative at Beverly Hills Weekly. She credits her interest in volunteering to being raised in

Fine Arts Commission approves bringing international art fair to Beverly Hills

The Beverly Hills Fine Arts Commission expressed unanimous approval of a major contemporary art fair based in Paris – La Foire Internationale d'Art Contemporain or FIAC – showcasing in Beverly Hills in April 2015.

Such an event would mark FIAC's first time showcasing outside of Paris, as it strives to establish a more worldwide brand. It is currently considering Beverly Hills, amongst other locations, as a location in which to debut outside of Paris.

The expo held annually in October in Paris, traditionally boasts about 200 exhibi-

tors.

With the Fine Arts Commission's recommendation, The Beverly Hills City Council will then vote on whether or not to host the art fair, on November 19.

Fiona Chalom, chair of the Fine Arts Commission, finds the nature of the fair and the city perfectly compatible with each other.

"Beverly Hills is upscale," Chalom said. "It's internationally known for its culture, its dining, its hotels, its shopping, and it's a beautiful city. The stature of the galleries and exhibitors is commensurate with any of the stores on Rodeo Drive. This is not craft. This is not somebody who is painting in their garage. This is internationally established art and artists and galleries."

Remote Area Medical seeks volunteers and doctors for aid mission to Philippines

Remote Area Medical, a non-profit, volunteer, medical relief corps seeks volunteers, especially doctors, to embark upon an aid mission to the Philippines, to assist in the aftermath of Typhoon Haiyan.

Surgeons, ob-gyns, ER doctors, and public health doctors are in high demand, according to volunteer team leader, Rene Steinhauer.

"The longer it takes us to get there, people will die," Steinhauer said. "Right now, people are dying not because they have to die, but because we don't have the resources on the ground to save those lives. This is a battle between life and death in the first few days of the disaster."

The current plan is to meet in Manila, travel together to Tecloban – the center of the disaster zone – and work for about two weeks.

Interested volunteers can call the main office in Tennessee at (865) 579-1530 or contact Steinhauer at (415) 497-6116 or medicrene@yahoo.com.

Volunteers finance their trip themselves. Steinhauer says he expects to spend about \$2,000.

Furthermore, living conditions may be austere, and he recommends bringing a small tent, sleeping bag, water purification system, and food as well, in case food on location is limited. The following immunizations are recommended: Hepatitis B, Japanese encephalitis, and Malaria prophylaxis.

It is unknown how long the trip will last. There is no regular commercial flight to the disaster zone.

The security situation is unknown, though there are no reports indicating a significant security threat.



"You will be dirty, tired, and emotionally drained," Steinhauer said. "On the other hand, you may find that you have never done anything in your life as challenging and worthwhile as this mission. Most of us who went to Haiti spent some time crying. It was a hard place to be. When it was time to go, we were ready, but most of us would return again. This is a place where you can make a huge difference in the lives of many."

BHHS Football Team Loses Season Finale

Beverly Hills lost to Culver City, 49-14, in an Ocean League football game Friday night at Nickoll Field, completing its first winless season in memory.

The Normans (0-10, 0-5 in league play) trailed the league-champion Centaurs 14-0 at the end of the first quarter, 28-0 at halftime and 42-14 entering the fourth quarter.

Both Beverly Hills touchdowns came in the third quarter. Rashad Ysaquirre ran four yards for its first score and Zack Bialobos threw a

40-yard pass to Chris Johnson for the second.

"I thought we played inspired," Norman coach Charlie Stansbury said. "It could have gone in a totally different direction if our kids didn't show up and play with any effort."

The Centaurs (6-4, 5-0) "came out a little bit flat and I think we came out a little bit more excited than they expected," Stansbury said.

"There were some moments in that first half when Culver City was a little uneasy," Stansbury said. "They were surprised we were able to run the ball as effectively as we did."

Beverly Hills is 0-9-2 against the Centaurs since 2002 including 43-0 and 41-0 losses in 2011 and 2012. The high school football website Calpreps.com projected a 62-0 Culver City victory.

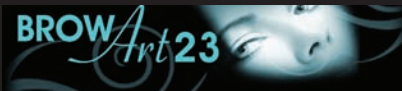

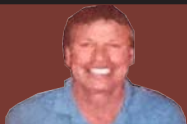
