“Bike lanes”

Earlier this month a Council-appointed ‘blue-ribbon’ committee met for the first of three meetings to discuss the rehabilitation of Santa Monica Boulevard. The project, scheduled for completion in 2015, is a much-needed ground-up reconstruction that presents an opportunity to rethink this key corridor for twenty-first century mobility needs.

As an appointed member I invite all stakeholders to share your vision. This is

our chance to remake this boulevard not only into a scenic corridor but also one that is safe to use. Road safety should always have been the priority, of course, but this former state highway has long been unfriendly to those who would walk, ride a bicycle, and even take mass transit. But we can redesign it for the benefit of all road users.

The priority will remain on maintaining vehicular flow. Two-lane vehicular traffic will remain unaffected. Yet we can consider a palette of design options including a landscaped median and even bicycle lanes to connect our city to Los Angeles and West Hollywood. The latter would facilitate ‘multimodal mobility,’ which is a planner’s term for moving people rather simply moving the sheet metal. Our Sustainable City Plan (2009) recommends we drive less and as a bicycle rider (and frustrated driver) I agree.

Our committee invites your concerns and feedback at our next meeting on December 10th or before in comments to the city. Bring your ideas for making tomorrow’s boulevard the safe, efficient and attractive corridor that our city deserves.

SUMMARY OF ORDINANCE NO. 13-O-2650

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE UNIFORM ADMINISTRATIVE CODE, 1997 EDITION AND ADOPTING BY REFERENCE THE 2013 CALIFORNIA BUILDING CODE; THE 2013 CALIFORNIA RESIDENTIAL CODE; THE 2013 CALIFORNIA ELECTRICAL CODE; THE 2013 CALIFORNIA MECHANICAL CODE; THE 2013 CALIFORNIA PLUMBING CODE; THE UNIFORM SWIMMING POOL, SPA AND HOT TUB CODE, 2012 EDITION; THE UNIFORM SOLAR ENERGY CODE, 2012 EDITION; THE CALIFORNIA ENERGY CODE, 2013 EDITION; THE 2013 CALIFORNIA FIRE CODE; THE 2013 CALIFORNIA GREEN BUILDING STANDARDS CODE; THE 2013 CALIFORNIA HISTORICAL BUILDING CODE; THE 2013 CALIFORNIA EXISTING BUILDING CODE; THE 2013 CALIFORNIA REFERENCE STANDARDS CODE; THE INTERNATIONAL PROPERTY MAINTENANCE CODE, 2012 EDITION; THE BEVERLY HILLS PHOTOVOLTAIC INSTALLATION GUIDELINES, 2012 EDITION; INCLUDING CERTAIN AMENDMENTS, ADDITIONS, AND DELETIONS; AND AMENDING PORTIONS OF TITLE 9 OF THE BEVERLY HILLS MUNICIPAL CODE

This is a summary of the above entitled ordinance of the City of Beverly Hills. This summary has been prepared and published in accordance with the requirements of Government Code Section 36933.

This ordinance amends the City's Administrative Code and adopts by reference the 2013 edition of the California Building, Mechanical, Plumbing, Electrical, Energy, Residential, Green Building Standards, Historical Building, Existing Building, Reference Standards, and Fire Codes (collectively known as the California Building Standards Code, 24 C.C.R., Parts 2 through 12), as well as the latest editions of the International Property Maintenance Code, Uniform Swimming Pool, Spa and Hot Tub Code, Uniform Solar Energy Code, and Beverly Hills Photovoltaic Installation Guidelines, together with certain amendments, deletions and additions.

The California Building Standards Code, as amended, establishes requirements for the structural, plumbing, electrical and mechanical systems of buildings and structures, including historic buildings and buildings not meeting current seismic standards, and for fire and life safety, energy conservation and sustainability. The new City amendments include; changes to wood, structural steel, and seismic design provisions. The other Codes and Guidelines adopted establish standards for property maintenance, construction and maintenance of swimming pools, spas and hot tubs, and installation of various solar energy devices. The ordinance also provides penalties for non-compliance, and for fees.

The City has determined that the ordinance is exempt from the environmental review requirements of the California Environmental Quality Act pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

Notice is hereby given that the City Council of the City of Beverly Hills adopted Ordinance No. 13-O-2650 after a public hearing during the regular City Council meeting on November 19, 2013.

NOTICE IS HEREBY GIVEN that the Council of the City of Beverly Hills, at its meeting to be held on **Tuesday, December 17, 2013, at 7:00p.m.**, in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

A RESOLUTION OF THE COUNCIL OF THE CITY OF BEVERLY HILLS ADOPTING THE GENERAL PLAN 2014-2021 HOUSING ELEMENT UPDATE AND ADOPTING AN ADDENDUM TO A NEGATIVE DECLARATION PURSUANT TO THE CALIFORNIA ENVIRONMENTAL QUALITY ACT.

The Draft 2014-2021 Housing Element would update the City's housing programs, and would replace the existing Housing Element in the City's General Plan. Programs proposed in the new Element focus on:

- Maintaining and enhancing the quality and character of existing housing and neighborhoods;
- Providing for a variety of housing types and adequate affordable housing to meet the diverse needs of the community; and,
- Promoting equal housing opportunities for all residents.

The Draft 2014-2021 Housing Element has been reviewed by the State Department of Housing and Community Development (HCD). The HCD determined that the draft element meets the State requirements for housing elements in California.

The Draft 2014-2021 Housing Element has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. Section 15164 of Title 14 of the California Code of Regulations allows a lead agency to prepare an addendum to a previously adopted negative declaration if only minor technical changes or additions are necessary and no substantial changes to the project are proposed, no substantial changes occurred with respect to the circumstances under which the project is undertaken, and no new information of substantial importance is available. As the lead agency, the City has prepared an addendum to the negative declaration adopted by the City in 2011 for the City's 2008-2013 Housing Element, and found that the adoption of the 2014-2021 Housing Element will not result in any significant environmental impacts. The addendum will be considered at the public hearing.

At the public hearing, the City Council will hear and consider all comments on the Draft Housing Element. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted, and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. Comments must be received prior to the meeting date to be considered.

Please note that if you challenge the Council's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

GIVING THANKS

The *Shahs of Sunset*'s Jessica Parido reflects on her battle with leukemia and her newfound appreciation for life.

At 15 years old, you were diagnosed with leukemia. Tell us how you were diagnosed.

It was the week into my freshman year of high school and I started to get flu-like symptoms. I went to the doctor and they drew up some blood because I had been sick for a while. I was taken out of school that day and brought into the hospital. They did some tests to try to figure out what was going on, including a bone marrow biopsy and from that, I was diagnosed with leukemia. A week later, they told me I did not have leukemia and they sent me home on Thanksgiving weekend. Two weeks later, the symptoms returned and I was, again, diagnosed with leukemia.

What was it like to be diagnosed with cancer at such a young age?

I remember that I was more concerned about my family than I was about myself. I wasn't scared by my diagnosis. I told myself I would be ok. It was my family that I was worried about. I was seeing all the people around me hysterically crying, but I knew from the very beginning that I was going to see myself survive this. They gave me a twenty percent chance to live and through my positivity and my desire to live, I was able to get through it.

Tell us about the treatment and recovery period after your diagnosis.

They started my chemotherapy the day I was diagnosed. I went into the hospital and started a very aggressive round of chemotherapy. On my 15th birthday, a week after my diagnosis, I found out my sister was a

10/10 bone marrow match, which is the best match you could be. At that point, it was up to my parents to decide if they wanted me to have the bone marrow transplant, which was very risky at the time because only 20 bone marrow transplant procedures had been done at that hospital. The procedure itself is dangerous because your immune system is basically shut down in order to transplant the bone marrow. On March 25th, about four months after my initial diagnosis, I had a bone marrow transplant. I was in the hospital for 8 consecutive months in isolation. The only people that could enter my room were doctors, nurses, and a few of my family members. My siblings couldn't visit me because they were too young at the time.

How did your bout with cancer influence your choice to become a nurse?

Before I was diagnosed with leukemia, I would have never pictured myself as a nurse. That was never even an option. But going through leukemia and being in isolation in the hospital after my bone marrow transplant, the nurses became my friends. I saw them everyday, they took care of me, and they became family to me. 8 months of no interaction with anyone other than these nurses influenced

me and changed the dynamic of my life and what I wanted to become. I knew that after I left the hospital and survived this, I wanted to do something influential and pay it forward. I wanted to give back and touch someone's life like the nurses had done for me during my time in the hospital.

Tell us how you have grown as a result of surviving cancer.

To be honest, this was the one event in my life that has molded me into the person I am today. It completely changed my mindset. I literally wake up every single day and I am thankful for my life. I am a firm believer in the power of positive thinking. My dad

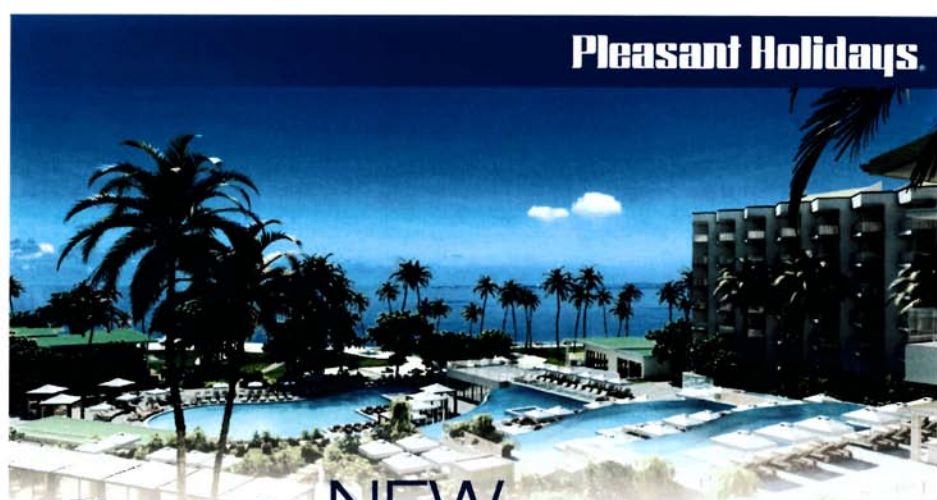
has a white board with the phrase "Think Positive" hanging in his office, which I wrote when I was sick. That was been my motto since and has gotten me through many tough situations in my life.

As many of our readers know, you are dating [longtime Beverly Hills resident] Mike Shouhed, one of the stars of Bravo's "Shahs of Sunset." How did you two meet?

We met at a restaurant called Lexington Social House. I was there for my then-roommate's birthday and Mike spotted me from

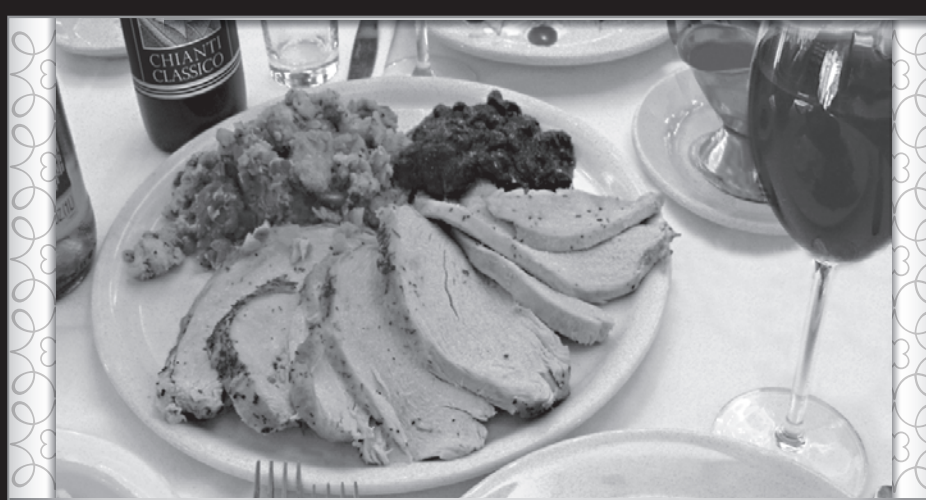

across the restaurant. He approached me and we talked the whole night.

Tell us what it feels like to be in the public eye and how your life has changed as a result.

Being in the public eye is definitely a vulnerable position to be in because people are constantly judging you. But mostly, I find it to be positive because I can share my story with others and inspire people, whether it's through my being a cancer survivor or the fact that I am converting to Judaism. Either way, with this platform, I feel I can help other people who are going through similar circumstances.

On Season 3 of "Shahs of Sunset," viewers see you going through the process of converting to Judaism. Why did you decide to convert and how have people, including your family, reacted to your decision to convert to Judaism?



Converting to Judaism was a personal decision I made on my own. I had been with Mike for a year and a half before I decided that I wanted to convert. I had been around his family and seen the unity that Judaism brings to a family. I wanted to share the same thing with my future family. People may think that

the reason I converted was to marry Mike, but that is not true. I came to this decision on my own. Although I have received some negative feedback about my decision to convert because people assume that I am doing it for the wrong reasons, I have always had the support of my family.

The show has received some backlash from the Persian community and at times, you have been a target of this backlash. How do you deal with the criticism that is constantly directed at you?

It isn't always easy. How I deal with the negative comments? I brush it off. I can't let every negative comment and criticism get to me. My life experiences, mainly surviving cancer, have shown me that there is so much more to life. I try to just ignore the negativity. I know who I am and at the end of the day, that is all that matters.

Beverly Hills Weekly has been promoting "Be the Match," which is a registry aimed at finding bone marrow donors for patients with leukemia and other blood diseases. When you were battling leukemia, how did you find your bone marrow donor?

Planning Commission unanimously rejects plans for Kobor Project Building

The Planning Commission unanimously denied applying a medical overlay zone to the Kobor Project Building located at 8767 Wilshire Boulevard at their meeting last Thursday.

The medical overlay zone would allow the building, initially designated for general office and commercial use, to be partially devoted to medical purposes – 45% of which would go to medical offices and a pharmacy. The Planning Commission also evaluated the proposal for a vehicle showroom on the ground floor of the building.

This meeting follows on the heels of a unanimous authorization by the City on October 22 of an agreement with the building's developers to allow 45% medical usage of the building, after the developers initiated litigation against

UPDATE ON PAST "GIVING THANKS" PARTICIPANTS

JAMES BRUBAKER, first profiled in "Giving Thanks" issue #373, looks forward to enjoying his favorite holiday, Thanksgiving, with his 20-year-old grandson, Brian Brubaker, whom he and his late wife Joy gained custody of when he was 6-years-old.

"We know we have a lot to be thankful for – me for being alive and him for me being alive and having someone shepherd him from being a kid to being a man," Brubaker said.

Brubaker, who now lives in Maryland, received a kidney and liver transplant in 2006 at Cedars-Sinai, after suffering from liver failure, the last symptom of which is kidney failure. It was a perfect match.

"To this day, and it's been seven years, I have not had a single problem with the liver or the kidney," Brubaker said. "It's made such a terrible difference."

He tracks down his surgeon and doctor on every anniversary of his transplant to give thanks for saving his life. At the same time, he ponders his milestone achievements since that critical period, citing his published cookbook as one of his proudest. The cookbook, *Classic World Cuisines*, published a year ago, is a compilation of 125 recipes he accumulated during his travels abroad. He has made every single one of them.

Brubaker began work on another cookbook as of last month, this one of recipes from various sections of the United States.

JANET LAMBERT, first profiled in "Giving Thanks" issue #269, lost her battle to cancer in May.

Lambert battled non-Hodgkins Lymphoma for 14 years. She was in remission in May 2004 after a successful bone marrow transplant. However, the cancer returned in the spring of 2007.

Lambert was treated by oncologist Dr. Philomena McAndrew at Tower Hematology and Oncology while working a full year at Hawthorne in 2007-2008, both as a teacher and as interim assistant principal in the spring.

JACQUES MOUW, first profiled in "Giving Thanks" issue #530, plans to spend a festive holiday at the Brentwood Country Club with relatives flying in from Florida and Europe.

He has had zero complications since his recovery from stage four metastatic renal cancer, which started in his kidney and slowly seeped into his brain. He was given 18 months to live.

"My son is a neurosurgeon," Mouw said. "He put a team of doctors together – all his friends, worked on this for a couple of years, used a new protocol on me, and it worked!"

Mouw maintains an active lifestyle – running his jewelry store, playing golf at the country club, and taking his grandchildren for golf, tennis, and swimming.

"If you look backwards, you can't go forwards," he said. "Never look in your rearview mirror. Always in front of you."

I was lucky enough to have a match in my immediate family. My sister was my bone marrow donor. There was only a twenty percent chance that my sister would be a match. I was very fortunate to have her as a perfect, 10/10 match. I know that there are a lot of leukemia patients out there and a lot of kids out there that don't have matches within their family. It is so important for people to be giving of themselves and to help somebody else. It only takes one person, one match, to save a life and I think it would be so rewarding to be able to do so and help someone else out so that they can keep their mom around, their sister around, their best friend around.

What are you thankful for on this Thanksgiving holiday?

This Thanksgiving, I am thankful for my life in general. I am so blessed in so many ways. I have so much to be thankful for. I am thankful for the opportunity to share my story and help others. I am thankful for my career as a nurse. I am thankful for my family, and I am very, very thankful for the love of my life, Michael Shouhed, and his amazing family, who have been so open and so supportive from the very beginning.

just as a visionary educational leader, but as the larger-than-life face of the BHUSD in the 1960s and 1970s.

In 1981, upon his retirement, the Board of Education renamed the high school's auditorium in his honor.

Former Mayor Vicki Reynolds, who served on the Board of Education from 1975 to 1983, remembered Peters as an icon in the education community.

"The Beverly Hills Unified School District became synonymous with quality education because of Ken Peters", Reynolds said. "His leadership and innovation set the standard for education policy and practice statewide and nationally".

Peters was principal when Reynolds was a student at Beverly High, and later superintendent when she served on the Board of

the City relating to the prohibition of medical offices within the subject commercial building.

The building was originally approved by the Planning Commission on September 14, 2006 for general office, retail, and restaurant uses, specifically prohibiting medical uses among others.

Construction of the general office building commenced in 2009. Shortly thereafter, developers requested an amendment to allow medical offices to occupy 54,900 square feet or 73% of the building, a request denied by the Planning Commission and the City Council in 2010.

The Planning Commission unanimously agreed that the public benefits provided by medical usage of the building would not offset its potentially damaging impacts – lending to increased traffic and parking in the surrounding residential areas and potentially turning other businesses away from the building.

"Generally people don't want to be in an elevator with sick people," Planning Commission Chair Brian Rosenstein said. "Medical is a very intense use. There are a lot of cars coming in and out, a lot of traffic coming in and out. It's not what business headquarters or what entertainment businesses want when they go to an office somewhere."

Commissioner Alan Block expressed concern that approving the settlement set a bad precedent in terms of allowing a party to sue the city to get what it wants.

Nevertheless, the implementation of a high end vehicle showroom on the ground floor garnered unanimous approval by the commission, with the potential to generate a good deal of revenue for the City.

In a phone interview, City Councilmember Nancy Krasne expressed her frustration over the handling of the process from the get go -- when city manager at the time, Rod Wood, advised Kobor not to apply for a medical building, stating that the City was not accepting medical applications. According to Krasne, Wood told Kobor he could apply for medical usage later.

"This is a lawsuit not about medical usage, but about lack of due process," Krasne said.

The City currently faces a \$42 million lawsuit.

"The city could lose \$42 million dollars," Krasne said. "I'm not willing to gamble with taxpayer money. One building is not going to make or break this city. People have been denied due process. They've been screwed over. Mr. Kobor died. I'm sure this put him in the grave a little sooner."

Former mayor Tom Levyn, the attorney representing Kobor, declined to comment.

A decision as to whether to move forward with the settlement will go before the City Council in January.
