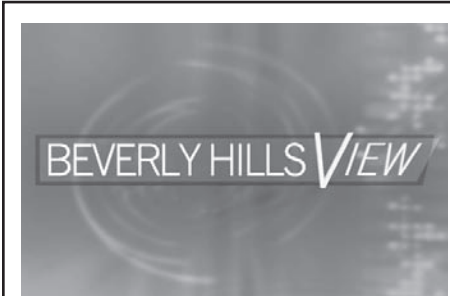

City Council splits cost for EB1 with school district for one year

Though the City Council unanimously agreed to split the BHUSD's campus security program Evidence Based, Inc. (EBI) cost for one year, several councilmembers

questioned the price and effectiveness of having armed campus safety officers on campus.

The annual cost for the BHUSD's campus security program provided by EBI is \$881,423. The city will pay \$440,712 for the 2014/2015 fiscal year. Total costs to the city for three years would be \$1,322,135. At the end of the current contract in May 2015, it will go out for a competitive bid.

"We believe that the security of our residences are a shared responsibility with

the city," Board of Education President Noah Margo said at Tuesday's study session. "That's why I came in the first place. That's why I was hoping to get the assistance."

Councilmember Willie Brien raised concerns on the district's financial plan.

"You keep coming back for more, but you're not dealing with the structural deficits that you're running," Brien said.

In the staff report, the BHUSD said that legal fees in the 2012/2013 fiscal year amounted to \$612,000, and in the 2013/2014 school year amounted to \$2,096,614.

The BHUSD receives \$10 million from the Joint Powers Agreement with the city, and has a \$10 million endowment fund and additional funding from BHEF. Funds from the JPA goes towards supporting infrastructure, facilities maintenance, and other programs, according to the staff report. Approximately \$600,000 from the BHEF is allocated towards academic and athletic programs. The BHUSD has not allocated funds from the BHEF towards EBI. According to Margo, part of the endowment funds will be used to fund OPEB, a post employment benefits.

EBI is headed by Campus Safety Program Vice President Joe Chirillo, a retired BHPD Lieutenant.

The staff report provided a breakdown of EBI costs. EBI Campus Security Officers hourly wages are between \$25 - \$35 with the majority of the officers earning \$30 - \$35 an hour. The Campus Security Officer Supervisor earns between \$35 - \$40 an hour. Each EBI CSO is issued \$3,500 - \$4,500 in equipment, which includes uniforms and computer and radios compatible with BHPD frequencies.

Each school site has a safety officer vehicle, which are leased from EBI at \$10,000 per vehicle per year, which includes insurance, fuel, maintenance and care.

"I understand that [the safety officer vehicles are] a visibility type of thing, but I don't understand why the city is paying for the visibility of these marked vehicles on the campus," Brien said.

Currently, Beverly Vista, Horace Mann, and Hawthorne have single points of entry, Beverly High's plans for a single point of entry will come before the Board of Education in about two weeks, and El

Rodeo has a single point of entry in its master plan, but specific plans are delayed until the Measure E bond is accelerated.

According to Margo, there is not enough money in the Measure E to fund El Rodeo's single point of entry plans.

"I'm struggling in understanding where the priorities are with this in terms of real security in not having single point of entry sooner," Brien said.

Councilmember Nancy Krasne raised concerns on having armed security officers on campus.

"I'm really disturbed about a loaded gun being on the campus at any time by anybody," Krasne said. "I would rather spend that money on police officers for the department and a psychiatrist to work with the teachers to pick out problem students or counselors to help with college planning."

The City Council asked the school district to provide an evaluation tool that will assess whether EBI is an effective safety program.

"It is difficult to assess a program as successful because as a police officer on the street we don't know how much crime we deter just by our presence," BHPD Lieutenant Mark Rosen said. "We can spend the money it costs to have EBI in the school system, and [if] nothing happens over the course of the year and the program was a success, we'll never really be able to evaluate whether that was a result of us being there or whether nothing would have happened anyway."

BHUSD portion of property tax decreases slightly

Beverly Hills property owners received their property tax bills this week for the fiscal year 2014/2015, which showed a slight decrease in the unified schools portion of property tax from the 2013/2014 fiscal year.

For the last 2013/2014 fiscal year, the BHUSD property tax was \$100.24 per \$100,000 assessed property value. For the current 2014/2015 fiscal year, the BHUSD property tax was \$45.84 per \$100,000 assessed property value.

"The [BHUSD] only raised the tax for one year to issue last year's [Measure E bond series], and then let it dip back down," Kegent Managing Director and Public Finance Manager Tony Hsieh said. "If the district is to [raise the tax again],

it's going to come from the affirmation vote of the voters in the district."

If the board votes to place acceleration on the March 2015 ballot and the voters approve it, then the earliest the acceleration could affect property taxes would be in the 2015/2016 fiscal year, roughly this time next year. But the district doesn't necessarily have to activate the acceleration for the 2015/2016 fiscal year, according to Hsieh.

"As long as the District requests the county to levy the tax, assuming a successful vote, they can get the tax rate levied," Hsieh said.

Academy Award party to be held in Beverly Hills for next three years

The City Council unanimously voted to have Vanity Fair's annual Academy Award party held in Beverly Hills in February 2015, and potentially for the next three years.

The Academy Award party will require the closure of the 400 block of North Crescent Drive from roughly February 12 to February 26. Vanity Fair representatives have already contacted the surrounding community, including residents, local businesses and churches, and have informed them on the Oct. 7 City Council meeting. The Wallis Annenberg Center of Performing Arts has given their support for the event.

The backdrop of the event will be Beverly Hills' City Hall on Crescent Drive, with potential use of the Municipal Gallery and the City Hall gardens. An

Oscar awards viewing dinner will have approximately 150 people during the awards, and a party for approximately 850 guests, who will arrive at a scheduled, staggered time throughout the evening.

Any city fees and personnel costs will be covered by Vanity Fair.

The international, high profile event first took place 20 years ago and was originally held in Morton's in West Hollywood. Recently, the location for the event moved to different sites throughout the city.

Nominations for March municipal elections open on November 10

Nominations for the March municipal election are open on November 10. Two city council seats currently occupied by Mayor Lili Bosse and Vice Mayor Julian Gold will be up for election for a four-year term from March 2015 to March 2019. Bosse and Gold have already announced their campaigns for re-election.

Nominations will begin on November 10 and close on December 5. If none of the incumbents do not file by December 5, the nomination period for only non-incumbents will be extended for an additional three days to December 10, according to City Clerk Byron Pope.

Qualifications to run for election include being 18 years old, a citizen of the U.S., and a registered voter within the city limits at the times nomination papers are issued.



Our election endorsements

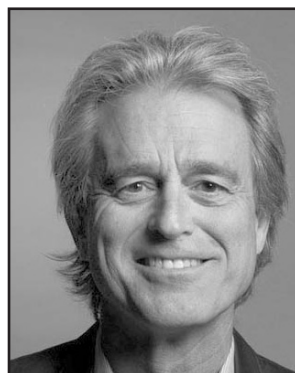
The November 4th election features many races where there is a close choice between two good candidates. But it's the slight differences between them that determine the better pick.



BEN ALLEN FOR STATE SENATE

Ben Allen is an attorney and a twice-elected Santa Monica-Malibu Board of Education member. He has much stronger local connections than challenger Sandra Fluke, having been raised and having attended public school in the district. While Fluke is a nationally known figure on women's rights issues, it is Ben who has paid his dues locally (his mother Elena Allen was also a long-time Spanish teacher at Beverly High). Idealistic and confident, Ben is endorsed by Henry Waxman, Zev Yaroslavsky, Beverly Hills Mayor Lili Bosse and many others we know and respect. Ben Allen is the better candidate for State Senate.

BOBBY SHRIVER FOR COUNTY SUPERVISOR

Sheila Kuehl is well-known to many of us, having represented our area in the state senate in the 2000s. But we have been less-than-impressed with how Sheila has run her campaign this time around.

In an attempt to kiss up to the *Courier*, Sheila voiced some vague support for a "third route" for the subway's Purple Line extension. Bobby Shriver has been steadfast in his support for the Constellation station. While we disagree with Shriver's position, we appreciate his honesty; everyone knows neither Kuehl nor anyone else is going to change the route of the subway absent a legal settlement. So anyone

who is voting for her for that sole reason is going to be sorely disappointed.

Additionally, Shriver has been very accessible, appearing on our Beverly Hills View program, as well as at many community events. Sheila has been nearly invisible, apparently concluding that she already has the election in the bag. We question whether Sheila will be independent from the very public employee unions that she is going to have to negotiate with as a member of the Board of Supervisors. A labor backed group ("Local Experience We Trust") has raised over \$900,000 to elect Kuehl. Along with left-leaning Supervisor Mark Ridley-Thomas, and incoming supervisor Hilda Solis (who was Obama's Secretary of Labor), if Sheila is elected, does anyone really question whether county employees are going to get a generous raise in pay and benefits? We believe Shriver to be the more moderate candidate, and one who is more likely to hold the line on public employee salaries. In a contest of two good candidates, we're going with Bobby Shriver, whom we believe to be more genuine and more accessible to the needs of Beverly Hills voters.

Yet another example of a race between two competent candidates, John Morris is a longtime county prosecutor. He is honest and seems committed to cleaning up well-publicized corruption in the Assessor's office. However, West Hollywood City Councilmember Jeff Prang is better known to us, having been on the West Hollywood City Council for 18 years and a frequent visitor to our community events.

We hosted the only televised debate between Morris and Prang (*watch here: http://vimeo.com/107288714*), where we found both candidates to be well-intentioned and qualified. But we have to give the edge to Prang, our neighbor, whom we've known for many years.



AUTUMN BURKE FOR STATE ASSEMBLY

Autumn Burke is running for the 62nd Assembly District (Marina del Rey/LAX area), a district that does not include Beverly Hills. But we want our readers to be familiar with who she is, because she is someone who is definitely going places.

The daughter of legendary Congressman and LA County Supervisor Yvonne Brathwaite Burke, Autumn comes from a long tradition of public service. But just like Steven Fenton vs. Frank Fenton, Autumn has brought her own style to the Burke name with her own unique approach. Having extensive private sector experience and moderate positions on the issues, Burke will be a breath of fresh air in Sacramento and to a Democratic party that is increasingly moving further to the left. 1.47 million ballots to be mailed out for November 4 general election

L.A. County registered voters can request a vote by mail ballot by October 28 for the November 4 general election. The deadline to register for the November election is October 15.

If voters are unable to go to their designated voting station on November 4, they can vote by mail. The Los Angeles County Registrar-Recorder/County Clerk office started mailing out 1.47 million ballots to voters on Monday.

Go to www.lavote.net to request a vote by mail ballot and to register to vote.

Pollworkers are needed for the election in Beverly Hills. To be eligible, pollworkers must be 18 years or older, a California resident, and a United States citizen registered to vote or a legal permanent resident. Volunteers earn between \$105 to \$175 for serving. Call (800) 815-2666 to become a pollworker.

France's Consul General speaks at Temple Emanuel's "Contemporary Issues Forum"

Temple Emanuel held a panel discussion on Saturday featuring Claremont Graduate University Associate Professor of History and Cultural Studies Joshua Goode, Anti-Defamation League Pacific Southwest Region Regional Director Amanda Susskind and Consul General of France in Los Angeles Axel Cruau, and moderator American Jewish Committee Board member Cathy Unger.

The "Contemporary Issues Forum" focused on the challenge of European anti-Semitism.

Cruau discussed his government's disapproval of anti-Semitic actions, and emphasized the action taken against further attacks, such as fighting hate speech on the internet, focusing on education, and preventing Middle East extremism from pervading France. Susskind mentioned that a recent ADL global survey on anti-Semitism found that 24 percent of Europeans, including 37 percent of France's population, had anti-Jewish feelings.

"We are honored that Consul General Cruau joined our Congregation for the holiest days on the Jewish calendar to engage in dialogue about the rise of European anti-Semitism," Geller said.

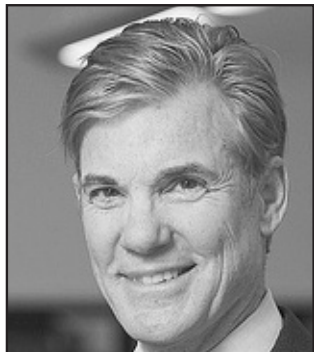

Who is the best candidate for State Superintendent?

TOM TORLAKSON



As the only California teacher and experienced superintendent seeking this office, I know bold action is needed to strengthen our schools. My plan calls for parents, teachers and schools themselves to make education decisions rather than turning our schools over to Washington politicians or Wall Street speculators. It starts with increasing parental involvement, expanding career and technical training, making college more affordable and investing in schools to provide smaller classes and strong academics, including art, music, drama and the technology students need to graduate ready for college. Every student deserves great teachers, which is why we must improve teacher training and support, and remove – fairly – those not up to the job. I helped pass a law making it easier to dismiss teachers for misconduct or poor performance, and I made helping struggling teachers a priority. Beverly High's 42-9 loss to South Pasadena in a nonleague football game last Thursday night at Nickoll Field was the result of turnovers and penalties, according to Normans coach Charlie Stansbury.

Beverly Hills (1-4) allowed touchdowns on interception and fumble returns and a muff on a kickoff return led to another Tiger touchdown, Stansbury said.

A roughing the passer penalty on a third-and-23 play prolonged another drive by South Pasadena (4-1) that resulted in a touchdown, Stansbury said.

A late hit on what would have been a third-and-12 play gave the Tigers a first-and-goal on another touchdown drive.

"The roughing the passer (was) a judgment call by the referee," Stansbury said. "Our guy looked like he was trying not to hit the guy, but he hit him."

On the late hit, "We just didn't make a smart play," Stansbury said.

Stansbury described the interception as

"one of those" plays where you say "Whoa how did that happen?"

The ball bounced off two players "and ended up in the wrong hands and ended up in the end zone," Stansbury said.

David Dolgin kicked a 23-yard field goal on the Normans' first drive. Rashad Ysaquirre ran more than 60 yards for a touchdown in the second quarter for Beverly Hills' other points.

The Norman offense was "productive at times" but "we need to be more efficient," Stansbury said.

Joe Kolko, Beverly Hills' leading rusher entering the game, was unable to play because of an injury. Harry Green, second on the team in receptions, also missed the game because of an injury.

The injury-depleted receiver corps prompted Stansbury to start Mike Massie, who had been the No. 1 quarterback entering the season, at receiver, and give junior Jake Wolken his third start of the season at

quarterback.

"We knew going into the game they were going to try to come up and force us to throw the ball so we needed that extra athleticism to get the ball down the field," Stansbury said.

Stansbury termed the game "a learning experience" for Wolken because South Pasadena was a more physical team than San Marino, the Normans' previous opponent.

The Norman defense played "at times very admirably but we struggled at times," against the Tigers' run-oriented wing T formation offense, Stansbury said.

Linebackers Dylan Rutigliano and Jon Hakimi drew praise for their play from Stansbury.

The loss was Beverly Hills 19th in its last 22 nonleague games dating back to 2010.

The victory was the fourth straight for South Pasadena since a season-opening 22-7 loss to Eagle Rock. The Tigers have outscored its opponents, 124-16, during the winning streak.

Beverly Hills lost to South Pasadena, 41-7, last season.

The Tigers were "much improved over last year in a lot of ways," Stansbury said.

The Normans are also improved over last season, Stansbury said.

"Depth wise is what hurts us right now, but skill-wise and understanding we are much further ahead than we were last year," Stansbury said.

"When you talk to coaches after the game there are a few this year that have

been surprised at how well we played after playing us last year. There's also some things that we do that other coaches have said they weren't sure if they could stop us from doing."

When asked about his team's improvement from the start of this season, Stansbury replied, "Week to week we're getting better and our kids are understanding the game of football a little more every time we go out there."

What's Next?

The Normans are scheduled to open Ocean League play Friday at El Segundo. The opening kickoff is scheduled for 7 p.m.

Stansbury said his goals for his team are to "step up in our level of execution on both sides of the ball." "We want to move the ball and be efficient in our passing and hopefully build on the consistency we've had in the run game," Stansbury said.

The decision on the starting quarterback will be based on the receivers' availability, but Massie will play quarterback in "certain situations," Stansbury said.

The Eagles (5-0) have outscored their opponents 212-26. El Segundo has scored at least 37 points each game and allowed no more than seven.

Stansbury attributed the Eagles' success to "the leadership of their senior class."

"They have nine seniors on defense," Stansbury said. "That helps. They understand the scheme and they understand what

FOUNDING A CHARTER SCHOOL

Jeanette Grattan Parker discusses launching Today's Fresh Start

Jeanette Parker is a longtime Beverly Hills resident who, along with her husband Clark Parker, founded Today's Fresh Start Charter School.

Tell us about Today's Fresh Start Charter School.

Today's Fresh Start Charter School has two charters. The first charter is a State Board charter and was started in 2003. The second charter is in Inglewood Unified School District charter, and the Inglewood school in 2008.

We have a \$20 million dollar grant for our Inglewood Charter. We just finished the first phase where the students are now in the school's new building. It has a gym, an auditorium, and a stage for theatre.

The TFSCS charter school is what you would call a small district. We are highly intensive on differentiated instruction, and learning and teaching every child individually and personally. We have more than 1200 students for our entire population.

We have about 45 percent Latino students and about 54 percent African American students. We have about one percent Filipino and Caucasian.

The schools are transitional kindergarten through eighth grade.

Why did you want to start TFSCS?

My husband [Clark Parker] and I are partners. We've always worked well together and we've been married for more than 50 years.

I wanted to start the charter school personally because I saw the need to educate the inner city youth. We just needed to have another perspective in education. Not that I'm saying that other people's perspective [aren't good], but for our particular school, we're unique because of our high test scores and our population that we have; striving for each child to achieve at his/her best.

I wanted to see other children receive the best education that I thought we could offer them. TFSCS is located in the urban

Los Angeles and Inglewood areas. Our students come from many different areas. Similar to myself, when I was very young in Birmingham, Alabama, we were economically challenged. It's an outgrowth having lived my own life and I wanted to help other children to grow to their very personal best.

Charter schools are independently run public schools which creates flexibility in the in its operations, which gives greater accountability for performance. How do you keep the school on track with its performance goals?

One major differentiation is that we have an intensive internal accountability system for children. We also fight for the children to be personally accountable for their own achievements.

We assess weekly, based on what they've been taught during the week. We have a wonderful, multi-cultural staff, somewhere around nine to ten different backgrounds and cultures.

We have a number of programs that we work with students and we hold them accountable for doing their work. The teachers also hold the students accountable for being responsible individuals.

Our theme this year is, "We are very excited to learn. We're going to finish college." This is for our transitional kindergarteners through eighth graders. We have the Young Scholars College Bound Program with the theme throughout the schools, "I'm going to finish college." We have on each door of our classrooms the name of a University and then post "the class of", meaning, year of their graduation from college. That's one way we promote TFSCS' Young Scholar's College Bound Program. Inside the classrooms teachers have banners of universities so that there's a constant reminder to the students that their purpose is to finish college.

They wear uniforms. Within the classrooms they have an, "I have a dream corner" where they have written their personal life's vision: what are their dreams, and they have photographs of themselves, giving them a sense of ownership and in themselves, their school; and it gives them their own place where they can belong and achieve.

We do a variety of things to keep the children's minds focused on why they're here and why its important to attain a really good education.

Charter schools have a contract that describes the school's mission, program, students served, performance goals, and methods of assessment. Tell us about

TFSCS charter.

The basis for the charter is to lay out what you're going to do or what you hope to do. It's planned so that the school's authorizer understands the school's vision. It's an accountability tool, and a way to hold the school accountable to the mission that they said they were going to plan to accomplish.

Our mission is to teach each child to become a lifelong learner and to teach each and every child individually, personally, and emotionally to their very personal best. That's our mission. We know that children are individuals and each one different. Some can achieve higher than others, but our mission is that each child achieves to their personal best. We hold them to high standards and great expectations.

It doesn't give them wiggle room to say, "I can't do this, I can't do that." Some students

are challenged but we believe that every child and every student has some special gifts and talents where he or she can excel. We keep striving to learn where is that, what is it, and how can we teach every one.

It's what every parent wants for their child, and that's what we do here. Our parents have their children here because they want their children to have the best education.

What makes TFSCS unique?

We have [about] ten different cultural backgrounds of staff. That's unique.

The teacher child ratios [are] very, very important. We have very low teacher child ratios. We have one teacher to every 20 [students] in the transitional through third grade. For 4th and up we have more than one [teacher] per 25 [students] which is really unusual in this day and time. But we've maintained that standard regardless of the economic challenges that we've been having in California. We still maintain that standard and that's one of our keys to maintaining and raising our API test scores; Our API score average is 835. We can give each child individual attention, we can know what each child needs to know. We focus on that. We keep our eye on what they learned during the week, on what they were taught during the week and we look and we say, "Okay, what did you not achieve?" Then we go back and we reteach that standard until he or she understands that it's a mastery of the standard.

We have special education. We are adapting a language facilitation program so that students who have special needs in each language that we're having a push in program to work with those students. Then those students can take advantage [of the programs].

We always consider the individual when

planning our program, using the California Common Core Standards.

We've had a five-year collaboration with UC San Diego. We train the teachers through their preliminary multi-subject credential and we train them into our system. TFSCS funds this program to help clear their credentials.

What are some programs offered at TFSCS that aren't offered at other charter schools?

The teacher child ratio, I don't know what other people have, but I know we've maintained that. I can't really say, because I'm not sure what other people are doing. I'm so focused on our mission and program.

You were a former President of the Beverly Hills Republican Club. Tell us about that.

Yes, I was President of the Beverly Hills Republican Club, but I'm not now.

We held meetings and booked very important Republican elected officials from across the United States.

You're a longtime Beverly Hills resident, originally from Alabama. What brought you to Beverly Hills?

Both my husband and I have always worked well together. We've been blessed by God as we have moved along in life and we just kind of found ourselves here.

That's where we've raised our children. Our children graduated from the Beverly Hills [school] systems there. Even our grandchildren attended as well. It's like a legacy we've managed to maintain.

Tell us about your family.

My husband's name is Clark Parker, my son's name is Clark Parker and my daughter is Alysia. My son has a son, [Kyce], at Beverly High. He plays basketball. Alysia and her husband have three children, Soleil, Greyson and Luna.

Tell us about the curriculum and admissions process.

The admissions process is really a simple process. We give them an admissions packet and they fill out the components of the package and they're enrolled.

Our curriculum is California Core status based. Every student has some piece of personal technology, either an Ipad or with our grades two through eight, each one has a laptop for school use. That's really important. We've already become aligned with the common core practices and standards. We participated in the modern balance assessment. Our students who took the science tests, they've achieved very high scores. We

HONORING HAMLET HEROES

Adam Lewis Discusses The Maple Center's Masquerade Gala

The Weekly interviewed Hamburger Hamlet and Kate Mantilini founders Harry and Marilyn Lewis' son Adam Lewis on receiving the honor.

Your parents, Harry and Marilyn Lewis, founded Hamburger Hamlet. Tell us about that.

They started in 1950. It was originally intended to be a place for struggling actors to go to. My dad was an actor with Warner Bros. through the 1940s. His was in Key Largo, a film well known today [starring] Humphrey Bogart, Edward G. Robinson and Lauren Bacall. Claire Trevor won [an Academy Award for] best supporting actress.

Things happened to the studio system and the contract players that were there broke apart. Dad found himself unemployed and he met my mother, who was the driving force to make his dreams come true.

When he was faced with, "What am I going to do?" What kept going on in his head was, "I want to have a little hamburger place where they can come." And they came and plenty of people came.

Why do you think the Hamburger Hamlet chain was so successful?

Attention to detail, attention to recipes. They were innovative in all of what they did. The various new ideas that my mother came up with were not being done in any restaurant. She was copied by everybody. It's been said that she invented the gourmet hamburger.

Hamburger Hamlet in the beginning was sort of assumed to be a hamburger place. Then prices got higher, more items [were] on the menu, [Marilyn] was doing a healthy platter in the early 1960s [and] people were flocking to that. All the entrees they did, anything new, people would come.

[In] the development [and] the expansion of the Hamlets, one was nicer than the next. None of them were cookie cutters, but all of them had the famous red carpeting. It was iconic for families. Even today, people come to me and say, "My folks used to take me

there every week. That was our treat to go to the Hamlet."

You mentioned that there would be upgrades to the Woodland Hills Kate Mantilini branch. What has been done so far?

We are very conscious of the recession and the affect it has on people's budgets. Along with our menu, which is a bit more expensive than this menu that I'm going to tell you about, we instituted a "light fare" weekday, lunch menu. We have about 12 [full] dishes, which are \$12 and under. I'm going to expand that out by four more dishes very soon. We're working on the salads now that we're going to put on it. That's sort of a big deal to draw more people in.

In Woodland Hills, we're seeing an increase in weekday customers, and we're seeing an increase in our happy hour as well which bleeds into dinner. Those are a couple of things that we've done recently.

You grew up in Beverly Hills. Tell us more about that.

I went to John Thomas Dye as a little guy. Then I went to El Rodeo and Beverly High, and graduated in 1972.

Then I left. I moved to Minnesota. I met a girl, she lived in Minnesota and I moved

there with her. I had four kids with her, we built a big house on the hill, and the marriage wasn't so good and so I came back. That was 15 years after [when I came back].

You were telling us that your father started off as an actor. Tell us more about that.

The story goes is that my father was always an actor.

[Irving "Swift" Lazar], who was a big literary agent in Beverly Hills for decades, died maybe about 10 years ago or so. He was the top literary agent in LA, Beverly Hills, the world, who knew? As an old man he was a guest of ours at Kate Mantilini he came in.

["Swift"] saw Dad, and he liked what Dad was doing. He talked to command and they re posted dad to the entertainment moral division. ["Swift"] saved my dad's life essentially. [My dad] never went overseas and he performed all over in America during the war years. Then they made a film out of it. [My dad] was in that also playing the same roll. He went on contract with Warner Bros. and he did a variety of films. Always "B" parts, never starring roles, but he was in the movies.

Why did you close Kate Mantilini?

The rent went up and we didn't see any

reason to continue it. It was just too high for us.

Were you surprised at all the tears when you announced the Beverly Hills branch was closing?

I was surprised. I was so deep in the forest

in operating that place that when I looked up and I saw unbelievable comments and social media. It equaled one other event, and that was when my father died on June 9, 2013. There were articles written all over the world we pulled them from Australia about his death.

The coverage on [Kate Mantilini closing] blew me away.

We [received a proclamation from Beverly Hills]. That sits on my mother's living room. I gave it right to her. She's very proud of it.

What's it like to receive an honor for you mom and dad, Marilyn and Harry Lewis from The Maple Counseling

Center?

This is really an old hat for my mom. She was honored here and there and we used to go [to] black tie [events] with her. There was always attention on Marilyn Lewis. This is really different. This is about the family.

They were our next-door neighbors for 25 years. We became friendly with them. It was more than just being neighbors it was lovely, it was sweet, and then learning about the work that they do for mental illness, depression, the fact that they treat so many people who can't otherwise afford it. They do such good work. And I'm honored to be honored. My mother will be there, my brother [David] is going to be there, and hopefully invited guests and it's a lovely thing.

met all our targets for our English language learners. Our API scores are high. We have an average between the two charters of about 835.

We are striving to improve those with our method of individualized instruction and close contacts with the students, observing their progress day by day, that's an integral part that we are so very focused.

Each of our charters are accredited by the Western Association of Schools and Colleges (WASC). That's the association that accredits its large universities or other recently accredited institutions.

We are what we believe to be the school for now, and the school for the future. We believe that our students will be successful in society with lot of the academic standards that we are teaching, but we are also teaching

them about character. We believe that they are all going to be very successful and the parents are very closely connected with the school. With that collaboration with the parents and the school community, we believe that we'll be successful not just now but for the future.

Coming from Alabama, it was important and it was so engraved into to us to learn and to be well educated. That was what we were

taught. We were taught that education is the key and that's the only way. That's what we teach TFSCS students and our grandchildren. We want to motivate them, watch them do well, and watch them better.

The Centennial Rose Bush Dedication was held on October 5 at Will Rogers Memorial Park.

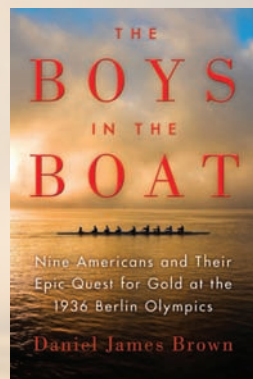
More than 100 rose enthusiasts attended the ceremony hosted by the city of Beverly Hills and the Beverly Hills Centennial Tree and Roses Committee.

 they're asked to do and they can adjust to things on their own."

The El Segundo players have "grown up together, played Pop Warner football" and started as sophomores, coach Steve Shevlin said.

The Eagles reached the second round of the Southern Section playoffs in 2012 and the Northwest Division final in 2013 where they lost to Nordhoff 49-21.

"They see that they're a pretty good bunch of guys that can really play well together as a unit," said Shevlin, El Segundo's coach since 1994. "They've supported each other and worked in the weight room."

The Eagles use a multiple-set offense with three or four receivers, Shevlin said.

Quarterback Lars Nootbaar made a non-binding verbal commitment following his sophomore year to accept a scholarship to play baseball at USC, Shevlin said.

"USC likes him a lot in football," but have not offered Nootbaar a scholarship to play that sport, Shevlin said.

Nootbaar has received scholarship offers to play football from UC Davis and Nevada, "but I think he wants to see how the season ends up and how he's feeling."

Shevlin said he thought Nootbaar would "love" to play both baseball and football in college.

El Segundo was moved into the Ocean League from the Pioneer League

with Lawndale, while Inglewood and Morningside moved from the Ocean League to the Bay League.

Shevlin, also his school's athletic director, said he was against the move "because I don't think the CIF guidelines were followed. We're a very small school. I had an issue about being told to play against Santa Monica for safety reasons."

El Segundo's enrollment was 1,277 students and Santa Monica's was 2,957 in the 2013-14 school year, the most recent year available, according to figures from the California Department of Education.

The high school football website Calpreps projects a 62-0 victory by the Eagles. It had projected a 28-7 South Pasadena victory over Beverly Hills.
