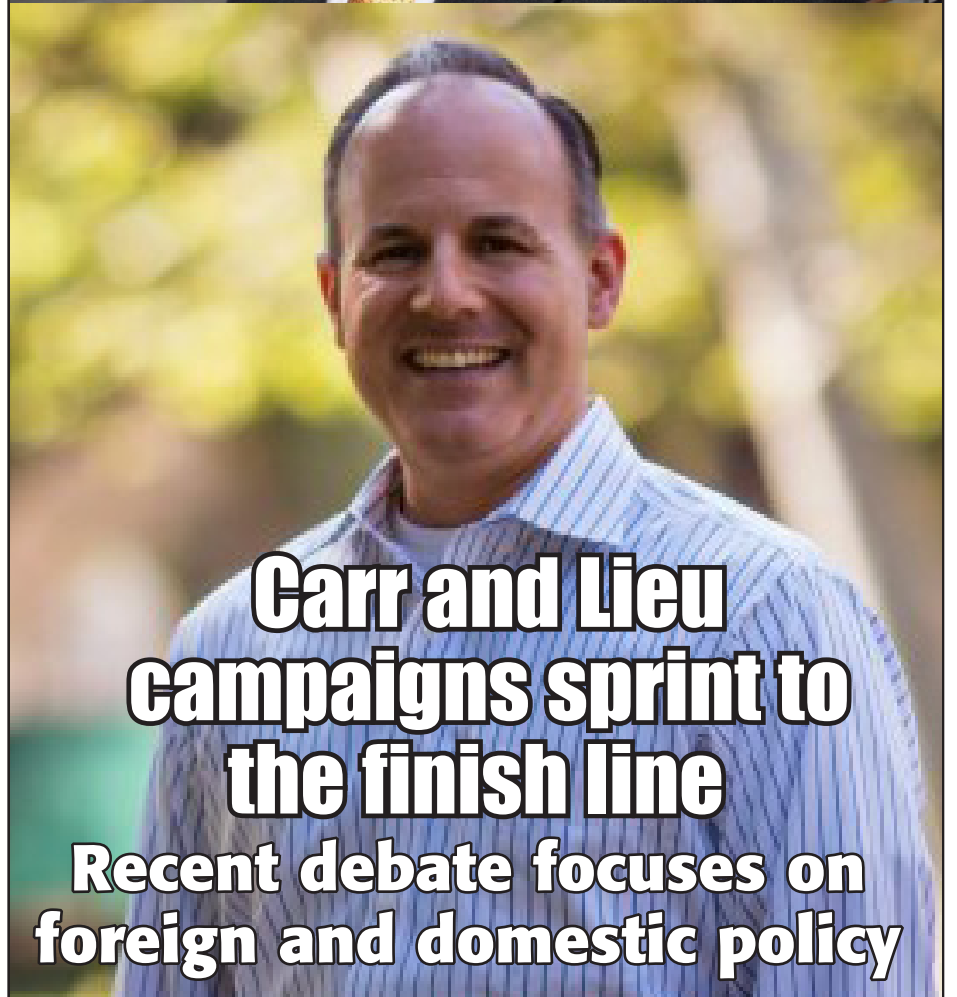

"BHUSD legal fees for first quarter fiscal year exceed \$750,000" [Issue #786]

To quote Ben Franklin, "The only two certain things in life are death and taxes," and to quote one a little less famous, Kenny Rogers in the *Gambler*, "You've got to know when to hold 'em and when to fold 'em."

While as a practicing lawyer I do not profess to have expertise in CEQA or other technical areas of the law, I have done my share of appeals. Just because you don't like the result, the court of appeal does not give you a do over. If, in the trial court, the judge decided factually he/she believed Expert A vs. Expert B, the court of appeal will not second guess the trial court in matters of fact. The court of appeal presumes the trial court was correct as a starting point. A party has to show either the trial court did not follow the law or abused its discretion before it will reverse.

Enough about the BHUSD appealing the trial court in one of its many lawsuits. While the school district may get attorneys fees back, how much will they get back?

In the last fiscal year, the BHUSD spent \$4,376,864.48 in attorney's fees with 4,200 students. That works out to over \$1,000

Despite protest, Rotary Club returns to Beverly Hills Hotel

Despite initial protest, the Beverly Hills Rotary Club will be returning to the Beverly Hills Hotel for their regular meetings starting on December 6.

Ninety-five percent of Rotary Club members participated in a recent survey where 75 percent of the members said that they wanted to return to the hotel if possible. Eighty-five percent said that they would remain a member if the meetings returned to the Beverly Hills Hotel.

The Beverly Hills Rotary Club changed their regular meeting location from Beverly Hills Hotel to a new location in May when Brunei's Sultan Hassanal Bolkiah enacted harsh penalty laws, which the City Council also condemned. The laws include that offenses such as adultery and consensual homosexual acts are punishable by death by stoning, while theft and other offenses are penalized by flogging and severing limbs.

Rotary Club member Gaby Reims Alexander wrote a letter to club members in May requesting that Rotary Club members change their regular meeting location until it changed ownership or until Brunei's controversial laws were repealed, which has yet to happen.

"This is simply a moral issue and Rotary needs to walk its talk in upholding the moral standards we claim to espouse," Alexander wrote. "I personally can no longer patronize the Beverly Hills Hotel in good conscience. And though I will be very sad to do so, I will be forced to take a leave of absence from our club if we do not move our meetings."

Rotary Club President Sean O'Donnell declined comment. Planning Commissioner Brian Rosenstein and Alexander did not return phone calls from the Weekly.

SLAPP motion may prevail if statements made in public proceedings, Richards says

Board of Education member Lewis Hall filed an anti-SLAPP motion after his motion to dismiss was denied in a lawsuit filed by Beverly High Principal Carter Paysinger against the BHUSD

for discrimination and retaliation. The anti-SLAPP law protects statements and comments made during a board meeting.

"No matter what you say during a board meeting, whether you're a board member or you're a member of the public testifying before a legislative body, you can't

be subject to a lawsuit," defense attorney Ronald Richards, who is not affiliated with the case, said. "Otherwise, no one would ever freely testify before a legislative body or in a court."

Richards said that individuals cannot

PLEASE TAKE NOTICE that at its regular meeting on **Tuesday, November 4, 2014, at 7:00 p.m.**, or as soon thereafter as the matter may be heard, in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, the Council of the City of Beverly Hills will consider adopting an ordinance entitled "Ordinance of the City of Beverly Hills amending the Beverly Hills Municipal Code development standards for single family properties in the Central Area of the city to address issues related to building scale and mass and parking." A summary of the ordinance, which has been prepared and published in accordance with the requirements of Government Code section 36933, follows:

Summary of Ordinance

An Ordinance of the City of Beverly Hills amending the Beverly Hills Municipal Code development standards for single family properties in the Central Area of the city to address issues related to building scale and mass and parking.

The Ordinance would amend various sections of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding development standards for single family properties in the Central Area of the City. The amendments as proposed address the following development standards:

- 1) Definitions of roof types for single family houses, including the addition of a new roof type, "Roof, Sloped with Ridgeline."
- 2) Maximum roof plate height and maximum building height for houses in the Central Area north of Santa Monica Boulevard including introduction of a maximum roof plate height, with additional roof plate height permitted if an additional front setback is provided. Additional building height may be permitted for buildings with sloped roofs with ridgelines and additional height may be permitted for buildings with other types of roofs through issuance of a Central R-1 Permit.
- 3) Maximum roof plate height and maximum building height for houses in the Central Area south of Santa Monica Boulevard, reducing the maximum building height for buildings with sloped roofs in certain areas, and increasing the building height for buildings with sloped roofs with ridgelines.
- 4) Minimum required side setbacks for houses south of Santa Monica Boulevard, extending the required nine-foot (9') wide side setback the length of the property.
- 5) Permissible encroachments in front yards to prohibit lightwells in front yards.
- 6) Permissible encroachments in side yards or street side yards to allow decks located at grade, covering portions of driveway ramps that lead directly to subterranean parking for residences; to permit mechanical equipment in side yards if certain criteria are met; to require porte cocheres to be set back from the front setback line; to prohibit lightwells in side yards; and, to permit lightwells in street side yards if screened.
- 7) Parking standards for new houses or for bedrooms added to existing houses requiring additional parking spaces to be provided onsite.
- 8) Setback and landscaping standards for walls and fences located in front yards;
- 9) Required landscaping in side yards.
- 10) An additional limitation on paving in front yards of properties south of Santa Monica Boulevard.

be sued for what they comment on during a board meeting, and the anti-SLAPP motion prevails as long as the statement is made in a public proceeding.

“You don’t have a privilege associated with your statements made outside of the public setting,” Richards said. “You can’t file a lawsuit and then have a press conference and think everything you say is going to be privileged because it’s not. It’s only what’s said in connection with the proceeding.”

Judge Philip Gutierrez denied Hall’s motion to dismiss on five acts, including persuading the district to investigate Paysinger and making racially discriminatory statements to Paysinger. According to the court’s ruling, Hall decisions were made as an individual with “no resemblance to a legislative act...outside the scope of his authority.”

The only act not dismissed was Hall’s vote for a district-wide, anti-nepotism rule, which would prevent relatives and friends from being hired within the district. Paysinger alleged that the rule would only affect his brother and sister-in-law. The court ruled that since the decision was a public policy decision that was made by a formal vote and would affect all potential employees in the district, Hall is immune.

“The question is, can [Hall] overcome the defenses to the statements?” Richards said.

Richards represented Beverly Hills Weekly in its successful SLAPP motion against the Beverly Hills Courier. He also represented Navabeh Borman in a successful case against attorney Hillel

Chodos, who formerly represented Karen Christiansen in a lawsuit against the BHUSD, for high, unpaid attorney fees.

A scheduling conference is scheduled for November 24. Hall’s anti-SLAPP hearing is scheduled for December 15.

Planning Commission prepares changes for historical preservation ordinance

The Planning Commission discussed historical preservation ordinance changes that further defined criteria for exceptional properties to be nominated for landmark status at their October 23 meeting.

“I have nothing against historical preservation but property rights are important too,” Commissioner Joe Shooshani said. “We have to only select things that are extraordinarily historic, not everything.”

According to Commissioner Craig Corman, who was the only commissioner present during the drafting of the original historic preservation ordinance, landmark designation was intended to go towards properties that were “exceptional.”

“How do we protect exceptional properties but not [tie] up a lot of other properties that no one really ever thought would be subject to the ordinance?” Commissioner Craig Corman said. “Looking over the [landmark designation] criteria, they were vague, subjective and overlapping.”

Exceptional properties would include iconic structures in Beverly Hills, such as the Beverly Hills Hotel and the Witch’s House.

“The property has been visited and photograph so often by residents and businesses that it has been inextricably associated with Beverly Hills and forms part of the city’s identity to the world of large,” Corman said.

The list of master architects and master developers would also be shortened. According to Shooshani, there are approximately 180 master architects on the current list.

The draft changes to the ordinance

defines a master architect as someone who has won a major international or national award, and has had their career discussed in a published monograph, such as a non self published book, and would no longer include developers.

“Architects that are on the list none of

us have ever heard of because they really weren’t master architects as originally conceived to be,” Corman said.

Another criteria that was discussed was if the property was owned and occupied by a significant person. Corman said that the criteria was too broad, and could

potentially include a former mayor who signed an important ordinance in the living room.

"Being in the entertainment business is not going to be good enough," Corman said. "We want to protect important architectural works for themselves. Not just because they were done [in] a certain period of time and shows how people lived at the time, but they're works of art and over time they've been recognized as works of art."

Los Angeles Conservancy Preservation Associate Marcello Vavala expressed concern that the changes would set Beverly Hills back in preserving properties.

"We have serious concerns that these revisions represent a major step backwards for Beverly Hills' Historic Preservation Program, greatly limiting the city's ability to protect its historic architectural heritage for the future," Vavala said.

The revised historical preservation ordinance will be presented to the Cultural Heritage Commission prior to going before the City Council.

Early voting available in Norwalk

BHHS football team loses to Lawndale. Normans to face Santa Monica Friday. By Steven Herbert

Beverly High outgained Lawndale, 56 yards to three in the scoreless first quarter of their Ocean League football game Friday night at Nickoll Field.

However, the second quarter was different. Quarterback Chris Murray ran 73 yards for a touchdown on the second play and the Cardinals scored three more touchdowns in the quarter, part of a streak of seven possessions with touchdowns, in a 47-7 victory.

Beverly Hills was outgained 204 yards to minus two in the second quarter and 317 to 120 for the game, with 67 yards coming on its fourth-quarter touchdown drive.

After getting four first downs in the first quarter, the Normans were held without a first down in the second and third quarters.

A first-quarter injury to pulling guard Jon Revah prompted a slight change in Beverly Hills' play-calling, Norman coach Charlie Stansbury said.

"Some of the things we do inside we were not able to do," Stansbury said.

Beverly Hills (1-7, 0-3 in league play) had as many completed passes (two) as interceptions. Jake Wolken completed two of 10 passes for 54 yards and had one pass intercepted. Mike Massie's lone pass was intercepted.

Christian Coleman, Kiyaam Cooksey and Murray ran for touchdowns later in the second quarter as Lawndale (5-3, 3-0) increased its lead to 27-0 at halftime.

Murray threw 61- and four-yard touchdown passes to Bryant Perkinson and Jalen Walker in the third quarter.

Darius Flowers returned an interception 35 yards for a touchdown with one minute to play in the third quarter for the Cardinals' final score.

Joe Kolko ran five yards for lone touchdown for the Normans with less than eight minutes to play.

"We just kind of got off to slow start,"

said Lawndale coach Rick Mathiesen, whose team was ranked 10th in the Southern Section Western Division poll released Oct. 20.

"We were a little undisciplined with our tackling, arm tackling, not making contact. Just a little sloppy. I think the boys needed to get hit and kind of wake up a little bit."

Mathiesen said the game's turning point was a botched handoff by Wolken on a fourth-and-one play from the Cardinals' 29-yard line late in the first quarter, three plays before the game's first touchdown.

Beverly Hills has lost nine consecutive Ocean League games dating back to the 2012 season. The Normans have allowed at least 40 points in 16 of Stansbury's 18 games as their coach, with the lone exception being the games against San Gabriel in both the 2013 and 2014 seasons.

What's Next?

The Normans are scheduled to play Santa Monica Friday at Santa Monica College in an Ocean League game. The opening kickoff is set for 7 p.m.

The Vikings (4-4, 2-1) utilize what coach Travis Clark describes as a balanced multiple offense quarterbacked by freshman Isaiah Johnson.

Storm DeBarge, who Clark said was the first girl to score a point in Santa Monica football history, has made 11 of her 13 extra point attempts this season, according to statistics posted on the high school sports website MaxPreps.com.

Stansbury said he wants his team to "throw with efficiency ... to try to take some of the pressure off our run game," be physical on defense.

"We think there are some things we can do defensively to kind of dictate what is going to happen," Stansbury said.

The Vikings defeated Beverly Hills, 75-0,

last season.

"Being ready for the kicking game is one the big keys to improving over last year," Stansbury said. The kicking game "contributed a lot of points last year, on both their returns and us trying to return and not taking control of the ball."

The two teams have two common opponents Hawthorne and Lawndale. Santa Monica defeated Hawthorne 41-0 on Oct. 10 and lost to Lawndale 20-19 Oct. 17. The Normans lost to Hawthorne 40-30 Oct. 17.

The high school football website Calpreps projects a 42-0 victory by the Vikings. It had projected a 48-6 Lawndale victory over Beverly Hills.

BOARD OF EDUCATION CALLS FOR PLAN TO ADDRESS "PROGRAM IMPROVEMENT"

But what does it mean for Beverly High?

By Nancy Yeang

In the wake of Beverly High being designated under "Program Improvement" by the California Department of Education, at the October 28 meeting, the Board of Education asked for detailed plans with regular updates as steps to avoid another year of program improvement.

"I would need to see a very specific plan with measurable goals and a plan attached to those measurable goals with regular updates," Board of Education Vice President Brian Goldberg said. "Whether it's the states standards or it's our own test that we developed, we didn't meet our goals for two years in a row."

An annual accountability report was presented at the October 14 Board of Education meeting. Chief Academic Officer Jennifer Tedford explained that schools receiving Title 1 funding must meet "adequate yearly progress" (ayp) each year that are based on proficiency percentages.

For the 2012-2013 school year, the proficiency target was 88 percent. Each year the proficiency target raises by 10 points, giving a 100 percent proficiency target for the 2013-2014 school year.

In order for any school to fall under Program Improvement status, proficiency goals would need to have been missed for two consecutive years, which is what happened at Beverly High.

"With the 100 percent proficiency level, we anticipate that all schools will be in Program Improvement next year if they're receiving Title 1 funds," Tedford said.

Of the 1,133 high schools that receive Title 1 funding, 787 are currently labeled as Program Improvement.

Board of Education President Noah Margo said that Los Angeles Center for Enriched Studies (LACES) and Mira Costa High school are also both in Program Improvement. Other high schools that do not accept Title 1 funds, such as Santa Monica, Malibu, Calabasas, and Agoura Hills, did not reach 100 percent passing nor 100 percent proficiency.

If Beverly High does not meet proficiency targets for the 2014-2015 school year, they will be placed under Program Improvement year two, meaning the state constraints will

increase, but funding remains.

The California High School Exit Exam (CAHSEE) was used by the federal government to measure proficiency at Beverly High in the 2013-2014 school year.

CAHSEE tests tenth graders in mathematics and language arts as a pass/no pass exam to graduate. Students have another

opportunity to take the test in eleventh and twelfth grade if they did not satisfy the criteria for both subjects to pass. The graduation rate at Beverly High is 96.46 percent.

"The CAHSEE was seen as a pass/no pass test, and urging to be proficient was not a goal," Tedford said. "The teachers and administration was not aware that the CAHSEE was being used as the proficiency guide until after the students had taken the

test, and did not prepare the students to take the test seriously."

According to Tedford, the district was not notified that the CAHSEE was being used as a proficiency measurement tool until recently April, after the students had already taken the test.

"The state had told districts that there would be no accountability measures, that the districts would not be held accountable

Alternate Performance Assessment scores, and the CAHSEE scores. The California Department of Education produced a three-year API score average for schools in the spring of 2014.

Board of Education member Lewis Hall objected, saying that every test should be taken seriously to prepare taking other exams seriously, such as the PSATs, SATs, and final exams.

"I think that the culture needs to be communicated with students that every test is important," Hall said.

Tedford said that previously, the test was not used for accountability, but since the district now understands that the CAHSEE is being used for proficiency and will count towards the high school's accountability measures, then the "culture must change."

The federal and state government offered a "safe harbor" status that allow Title 1 schools to be removed from Program Improvement by having a ten percent improvement for two consecutive years.

"They'll cut you a break and they'll call that achievement enough in terms of meeting your goals," Tedford said. "We need to see at least ten percent improvement which is much more reasonable expectation, but certainly we need to aim 100 % proficiency."

For Program Improvement year one, certain constraints are placed on funding allocation, such as budgeting a percentage of Title 1 funds towards professional development.

"Essentially what happens is that the state says you have less freedom to do what you want to do as a school," Tedford said at the October 14 Board of Education meeting. "You must do a much more explicit structured program based on the state's requirements."

Parents were supposed to be notified of "a school of choice" of a surrounding school that is not in Program Improvement and the BHUSD would have to allow those students to go to the other school upon request. According to Tedford, currently, there are no schools that the BHUSD is required to send students to since all of the BHUSD schools are high performing.

A plan will be brought back to the Board of Education at the November 25 meeting.

CARR AND LIEU CAMPAIGNS SPRINT TO THE FINISH LINE

Recent debate focuses on foreign and domestic policy

As the campaigns lead to the finish line, the Jewish Federation of Greater Los Angeles hosted a debate between 33rd Congressional District candidates Elan Carr (R-Beverly Hills) and Ted Lieu (D-Torrance) on October 23.

Each candidate discussed their position on a variety of domestic and foreign policy issues, including minimum wage increases, immigration issues, sending ground troops to the Middle East, and how they would handle the increasing situation of ISIS.

Lieu said that he supports comprehensive immigration reform, and will support a package that the United States Senate passed which would include border security, a pathway to citizenship, and access for companies to hire and train workers, especially in the technological industry, from abroad to work in the United States. He said that the package has not been put to a floor vote because of House of Representatives Speaker John Boehner.

Carr has ran a campaign assailing the hyper bipartisanship of Congress, and how he would try to have Congress work together to move issues forward. Though Carr agrees that a comprehensive package must be adopted, he insists that the

hyper bipartisanship hinders any action.

"I can't really speak for the Republican caucus in Congress but I would bet that if they would support a comprehensive immigration reform you might actually have some immigrants that would vote for the republicans in that caucus," Lieu said.

Lieu had voted for minimum wage increases in California, which increased to \$9.00 this year, and will increase to \$10.00 next year. He will continue to support minimum wage increases now.

"We haven't increased minimum wage for so long that it has not kept pace with inflation, so I believe that we need to increase the minimum wage now," Lieu said. "It may cause some job loss, but also cause job creation because money is pumping money right back into the economy, so you might get shifts in what kind of business benefit from that."

Though Carr agreed that an increased wage will help people move ahead, he said that increasing minimum wage will not help the private sector and small businesses.

"The problem is that the unemployment numbers are very high," Carr said. "The only way to solve these problems is

to grow our economy and create opportunity for all of us. Then jobs will increase, unemployment will go down, and wages will increase"

On the issue of sending ground troops to the Middle East, Lieu and Carr agreed to not send ground troops, but differed in the execution of how to subdue ISIS.

Lieu said that he does support the air strikes, but would not send ground troops to stop ISIS, even if the radical group grows stronger in the region. Carr said that he would also not send ground troops, but the way to contain ISIS would be to create relationships with Sunnis tribal chiefs for them to fight Sunnis terrorism and contain Iran. He said that while he was leading an anti-terrorism team in Iraq, this was the effective way to fight Sunnis terrorism.

While discussing funding for women's health care, which would include abortions, Lieu said that he supports full federal funding and embryonic stem cell research.

"I would do everything I can to stop the assault on women's health care," Lieu said.

Carr said that he does agree that women have the right to an abortion as well as

supporting embryonic stem cell research, he does not agree that federal funding should go towards abortions.

"When you have a substantial portion of the country that is deeply pained for religious reason about the practice of abortions, I think United States tax money should not be funding something that is so controversial for so many Americans," Carr said. "Protecting the right is one thing, but funding it is quite something else."

Carr is a Republican running in a highly Democratic election. Moderator Dan Schnur asked why Carr was a Republican.

"I think what needs to happen is that we need to put aside partisanship and come together, because if we don't do that we're not going to solve these problems and at the end of the day we're all worse for it," Carr said. "My wife is a lifelong Democrat. I'm a lifelong Republican. We agree on 95 percent of the issues because we all want better schools, we all want a growing economy and we all want American leadership overseas, so let's put aside the nonsense, work together and get it done."

The election is on Tuesday.

Bocchi, Stefanovic and Gorbacheva all won both of their singles sets for Beverly Hills (6-3, 4-0) before being replaced by substitutes.

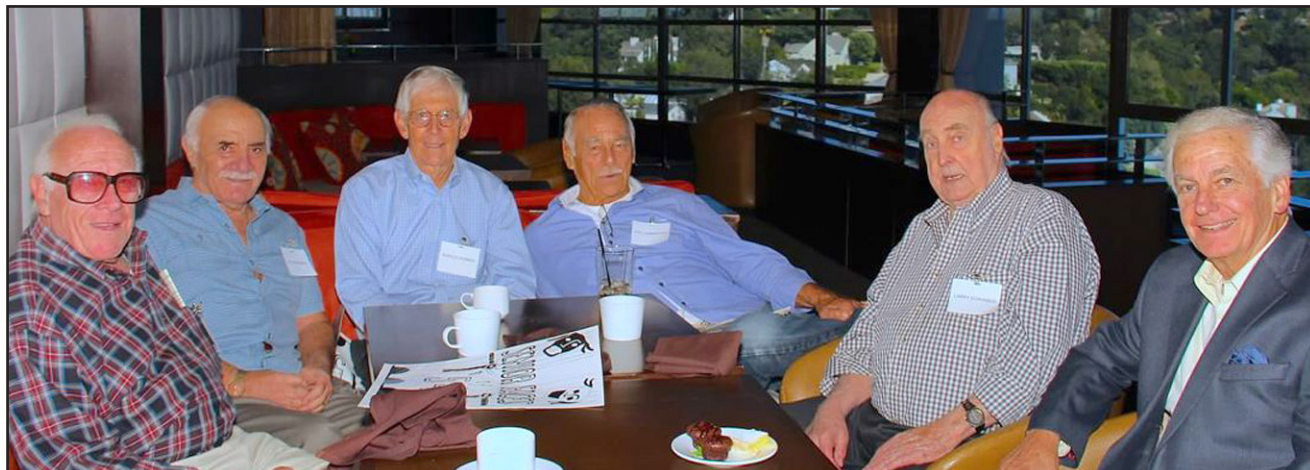

ORDINANCE NO. 14-O-2666

AN ORDINANCE OF THE CITY OF BEVERLY HILLS PROHIBITING TRANSACTIONS IN WHICH COMPENSATION IS PAID FOR THE PURPOSE OF FACILITATING A CHANGE IN THE OCCUPANCY OF A PUBLICLY OWNED PARKING SPACE

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HERBY ORDAINS AS FOLLOWS:

Section 1. A new section 7-3-416 is hereby added to Article 4 (Parking Meter Zones and Fees) of Chapter 3 (Standing, Stopping, Parking) of Title 7 (Traffic, Parking, and Public Transportation) of the Beverly Hills Municipal Code to read as follows:
"Section 7-3-416. Sale of Parking Opportunities Prohibited.

A. It shall be unlawful for any person to facilitate or participate in a transaction by any means (including, but not limited to, via a mobile application), in which any form of compensation is paid for the purpose of facilitating a change in the occupancy of a publicly

owned parking space or in which compensation is contingent on the occupancy of a publicly owned parking space by a specified individual or vehicle.

B. This section shall not apply to any transaction that occurs in connection with an automobile parking and shuttle service operating pursuant to a valid valet parking permit issued pursuant to title 4, chapter 2, article 15 of this code during any time when such service is authorized to operate valet parking operations."

Section 2. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remainder of this ordinance. The City Council hereby declares that it would have adopted this ordinance, and each and every section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

Section 3. CEQA Findings. The City Council hereby finds that it can be seen with certainty that there is no possibility that the adoption and implementation of this Ordinance may have a significant effect on the environment. This Ordinance preserves the status quo and will not result in any changes to the physical environment. This Ordinance is therefore exempt from the environmental review requirements of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

ORDINANCE NO. 14-O-2667

AN ORDINANCE OF THE CITY OF BEVERLY HILLS ADDING SECTION 5-6-604 TO THE BEVERLY HILLS MUNICIPAL CODE TO PROHIBIT THE USE OF UNMANNED AIRCRAFT TO RECORD OR TRANSMIT VISUAL IMAGES OR AUDIO RECORDINGS OF PERSONS OR PRIVATE PROPERTY LOCATED IN THE CITY OF BEVERLY HILLS

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HERBY ORDAINS AS FOLLOWS:

Section 1. Section 5-6-604 is hereby added to Article 6 of Chapter 6 of Title 5 of the Beverly Hills Municipal Code to read as follows:

"5-6-604: PROHIBITION AGAINST USING AN UNMANNED AIRCRAFT TO RECORD OR TRANSMIT VISUAL OR AUDIO RECORDINGS:

A. No person shall use an unmanned aircraft to record or transmit any visual image or audio recording of any person or private real property located in the City under circumstances in which the subject person or owner of the subject real property has a reasonable expectation of privacy (including, but not limited to, inside a private residence or office, and inside an enclosed yard).

B. This section shall not prohibit the use of any model aircraft, which is flown in compliance with Section 336 of the FAA Modernization and Reform Act of 2012 and which does not transmit or record visual images or audio recordings of any person or real property located in the City.

C. This section shall not prohibit the use of any unmanned aircraft by law enforcement or public safety agencies:

1. If a warrant is issued authorizing the use of an unmanned aircraft; or
2. For the purpose of providing emergency management, fire, or police protection services in response to a life-threatening emergency, or for surveying the condition of persons or property during a duly declared state of emergency; or
3. Under circumstances where a warrant would not otherwise be required by law.

D. For the purpose of this section, an "unmanned aircraft" is a device that flies and is operated without the possibility of direct human intervention from within or on the aircraft."

Section 2. This Ordinance was assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines (the Guidelines), and the environmental regulations of the City. The City Council hereby finds that under Section 15061(b)(3) of the State CEQA Guidelines, this Ordinance is exempt from the requirements of CEQA because it can be seen with certainty that the prohibition would not have the potential for causing a significant effect on the environment.

Section 3. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 4. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 5. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
