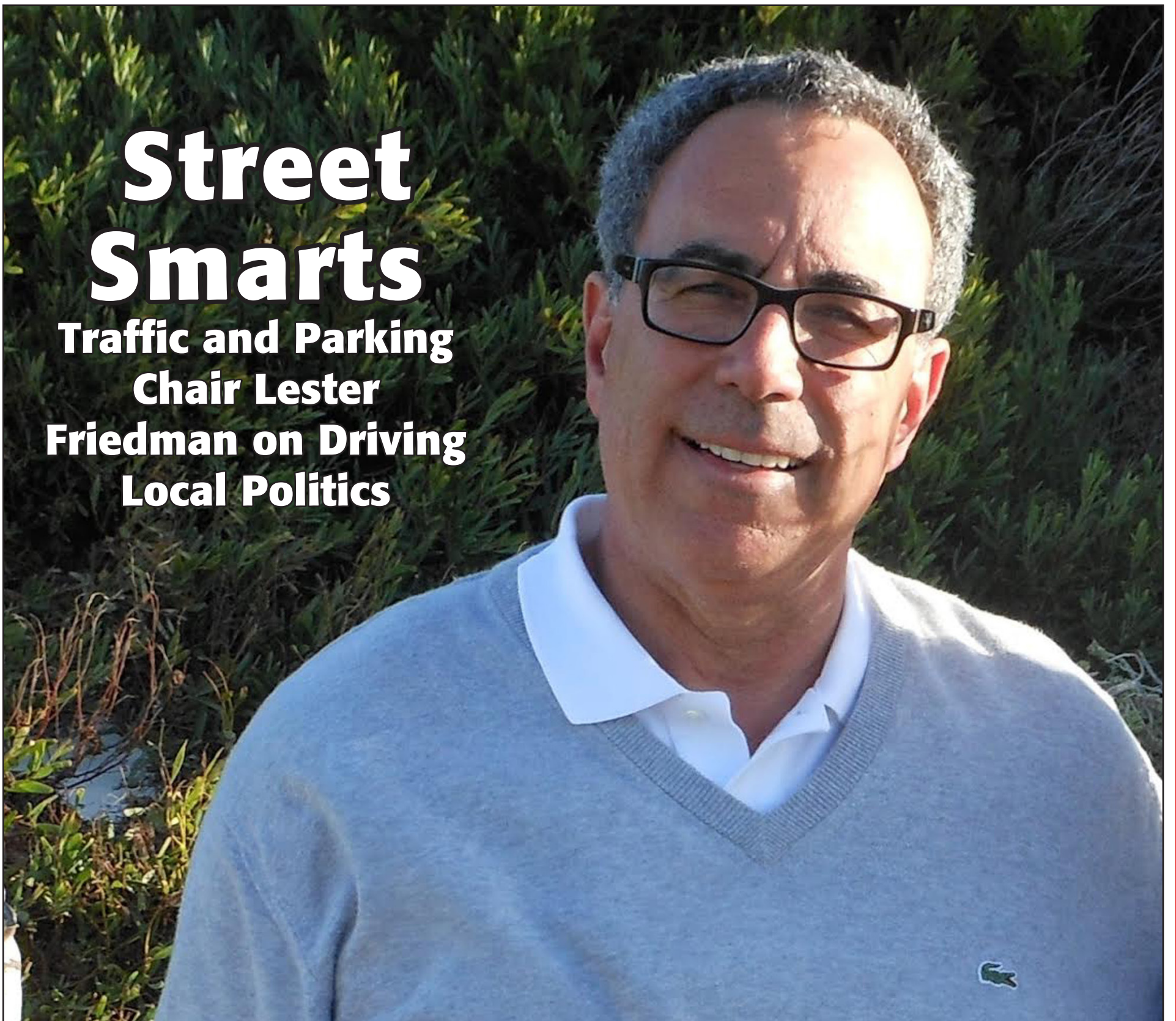

## City Council reviews Santa Monica Boulevard reconstruction project

The Beverly Hills City Council continued its review of the Santa Monica Boulevard Reconstruction project during a study session on December 2.

Susan Healy Keene, Director of the Community Development Department, presented a summary of the project's traffic impacts and construction scenarios, and the City Council Ad-Hoc Committee's recommendations.

"It will take approximately 14 months from the time that you initiate project design to the start of construction—including the bidding process," said Keene. "By preceding with project design now you can start construction by Spring 2016."

In June 2013, the City established an agreement with engineering firm Psomas to perform design services for the Santa Monica Boulevard Reconstruction project between Doheny Drive and Wilshire Boulevard. The agreement consists of two phases: pre-design/public outreach and project design. A decision needs to be made about the possible modification of the existing roadway width prior to proceeding with project design.

Deputy Director of Transportation Aaron Kunz outlined the four different lane closure alternatives associated with the project. Ad-Hoc Committee members Mayor Lili Bosse and Councilmember Willie Brien recommended Alternative 4, estimated to cost \$27.2 million. Alternative 4 provides the lowest cost alternative and the shortest duration, estimated at 21-23 months. Comparatively, Alternative 1 is estimated to cost \$29 million and will require 23-25 months of construction.

According to Kunz, the impact of traffic congestion levels appears manageable if three or four lanes are maintained. Eliminating two or more lanes will significantly impact traffic congestion levels. Kunz stated that the 60-foot section from Canon to Wilshire cannot accommodate bicycle lanes on both sides without reducing lanes and impacting traffic.

Eric Bruins, Planning and Policy Director of the Los Angeles County Biking Coalition, asked that the addition of bike lanes be carried into design. Bruins spoke briefly about biker Paul Livingston, who was hit by a car in Beverly Hills in 2011. Livingston suffered eight fractured vertebrae and a sheared pelvis. According to Bruins, bike lanes would result in a "healthier, safer, more sustainable community."

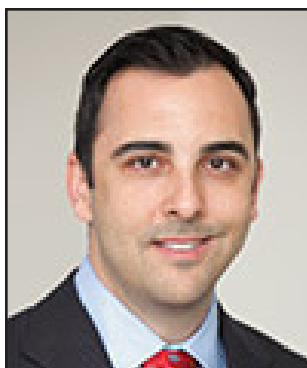
Councilmember Nancy Krasne also expressed concern for the safety of bicyclists.

"Cars are replaceable, bikes are replaceable, bodies are not," said Krasne.

Review of the project will be continued to the January 6 meeting.

Mayor Eric Garcetti announced that people will be able to exchange firearms for up to \$200 in Ralphs grocery cards at two Los Angeles locations on December 13 from 7:00 am to 2:00 pm.

“The goal is to take these guns off the street and make sure they don’t fall into the hands of criminals or children,” Garcetti said. “The Gun Buyback gives Angelenos the opportunity to help make our city safer by turning in unwanted firearms.”

The Gun Buyback program has taken nearly 13,000 guns off the streets since its inception in 2009. The program is an initiative of the Mayor’s Gang Reduction and Youth Development Office.

After the war, Goldschlag converted to Christianity and was sentenced by a war crimes court to ten years in a labor camp due to her collaboration with the Nazis.

## BHHS boys' basketball team wins tournament opener

Trevor Bergher scored 14 points, making three 3-point baskets, Navid Rafalian 13 and Chance Comanche 12 as the Beverly High boys' basketball team defeated Hamilton, 49-43, in a first-round game of the 74th Sax Elliot Invitational Monday.

Beverly Hills led 20-6 at the end of the first quarter, 29-14 at halftime and 41-28 entering the fourth quarter.

Ryan Manoocheri added five points, including a 3-point basket, Fidel Quiralte three and Eman Rafalian two for the Normans (3-2).

Chance Comanche, Beverly Hills' 6-foot-11 inch center who has signed with Arizona, also had 18 rebounds.

The Normans played El Camino Real Wednesday in a championship quarterfinal game that ended after the *Beverly Hills Weekly's* deadline.

If Beverly Hills won, it would face the winner of the Compton-Loyola championship quarterfinal Friday at 8 p.m. in a cham-

pionship semifinal game.

In the Normans lost, they would face the Compton-Loyola loser in a fifth-place semifinal today at 7:30 p.m.

Beverly Hills will conclude play in the tournament Saturday, with the time and opponent determined by the result of its third game.

All the Normans' tournament games will be played at the Swim-Gym.

The tournament is named for Sax Elliot, a Beverly Hills coach and physical education teacher from 1935-50, with a four-year interruption to serve in the U.S. Navy during World War II, who was responsible for the tournament's creation and the construction of the Swim-Gym.

### Trevor Ariza Tip-Off Classic Beverly Hills 53, Peninsula 50

A late deflection by Max Walder leading to a lay-up by Eman Rafalian preserved the victory for the Normans in their season-opening first-round game Dec. 2, Beverly Hills coach Jarvis Turner said.

"We basically tried to give the game away" because of missed free throws and fouls, Turner said.

The Normans outscored the Panthers 18-12 in the third quarter to take a 39-35 lead entering the fourth quarter. Beverly Hills trailed 12-11 at the end of the first quarter and 23-21 at halftime.

Comanche scored 15 points in his Norman debut. Eman Rafalian and Bergher added 11 each, Denzel Holt 10 and Manoocheri six.

Bergher, Holt and Manoocheri all made two 3-point baskets and Eman Rafalian one.

### Beverly Hills 72, North Torrance 54

Comanche had 20 points and 16 rebounds in a championship quarterfinal victory last Thursday.

Bergher added 13 points, making three 3-point baskets, Holt and Eman Rafalian 10

each and Amir Hijirasooli, Manoocheri and Quiralte five each.

Manoocheri and Quiralte both made 3-point baskets.

The Normans led 20-15 at the end of the first quarter, 43-25 at halftime and 56-34 entering the fourth quarter.

### St. John Bosco 61, Beverly Hills 42

The Normans trailed 12-6 at the end of the first quarter, 26-17 at halftime and 44-26 entering the fourth quarter of a championship semifinal game Friday night.

Comanche had 20 points and 20 rebounds. Holt added 12 points, Manoocheri six, Bergher two and Quiralte and Navid Rafalian one each.

### Westchester 57, Beverly Hills 42

The Normans "came out intimidated" in the third-place game Saturday, Turner said.

Over the first four games of its season, Beverly Hills has showed it "doesn't handle the pressure well" against teams that play press defense against it, Turner said.

Another Norman problem against the Comets, a perennial City Section power, was a lack of balanced scoring.

Comanche scored 27, with his teammates combining for 15.

"Coach (Ed) Azzam, the Westchester coach, just mentioned last year, the same guys that we had were more offensive-minded," Turner said.

"Now that we have Chance, they're looking to pass first as oppose to shoot their shots first. They're not playing with confidence and that freedom and looseness that we need them to play with in order to make shots."

The Normans trailed 14-3 at the end of the first quarter and 29-16 at halftime.

Beverly Hills cut the Comets' lead to 34-26 with three minutes, 49 seconds left in the third quarter, thanks to five unanswered points, four by Comanche.

Following a basket by Westchester's 6-foot-6 center Calvin Fletcher, the Normans went on a 7-1 run, with Comanche scoring five points, cutting the Comets' lead to 37-33 with 1:27 remaining in the quarter.


However, Beverly Hills would get no closer. Westchester (5-3) went on a 9-0 in a 1:44 span at the end of the third quarter and start of the fourth to take a 46-33 lead with 7:18 remaining and led by at least 12 the rest of the game.

Manoocheri added five, including a second-quarter 3-point basket, Holt four, Bergher three on a third-quarter 3-point basket, Quiralte two and Navid Rafalian one for Beverly Hills.

All the Normans' games were played at Westchester High School. The tournament is named for Trevor Ariza, a former Westchester standout who later played for UCLA and with six NBA teams, including the Lakers.

## STREET SMARTS

### Traffic and Parking Chair Lester Friedman on Driving Local Politics

#### Why did you decide to join the Traffic and Parking Commission?

I live on a street that had been impacted by the opening of a restaurant and a nightclub in West Hollywood. And as a result of that impact, I, as a [Beverly Hills] resident, got involved in the petition process to have restricted parking placed on our block. Having gone through that process and seeing how government works—and in my case it really did work—I decided I would like to become a part of that process to see what I could do to help the community.

In our interview with former Chair Andy Licht in issue #742, he talked extensively about the Santa Monica Blvd. reconstruction project. “The goal of the committee was to determine the look and the purpose and the ultimate visual outcome of the Boulevard, and Traffic and Parking was commissioned to determine the mitigation.” What are your concerns about the project as Chair?

As everyone knows, the reconstruction project has been slow in getting approval and it was just last week that the City Council said that the city could go forward with the design phase of Santa Monica Blvd reconstruction. And the City Council has assigned to the Traffic and Parking commission the goal of reducing the impact on the residents and businesses by mitigation. Throughout this year there will be hearings on what the residents feel is necessary and what the consultants feel is necessary and then we will come up with a recommendation to City Council regarding the mitigation.

What we’d like to do is really make sure that we can get through the Santa Monica reconstruction project prior to the city being impacted by the La Cienega station of the subway. It’s really our goal to see if we can finish Santa Monica reconstruction in time so that the city traffic will not be totally askew.

#### During the recent City Council meeting, several residents advocated for the addition of bike lanes on Santa Monica Blvd. What are your thoughts on this?

Well, you know the City Council has made their decision as to what is best for the city—they are the elected officials—and

it appears as if Santa Monica Blvd. is not going to be widened so whatever the City Council believes is appropriate for the city is what we will work with in terms of mitigation.

I think the city should be more bike friendly—the question is whether or not having a bike lane on Santa Monica Blvd is what is best for the city. I think there does need to be transportation modes available other than vehicular but whether or not it should be on Santa Monica Blvd is another question.

**Last week the City Council approved five taxicab companies instead of the four that were recommended by the Citizen’s Commission, with an additional 14 taxis to be operated by the fifth company. How do you think the council’s decision will affect taxi operations in Beverly Hills?**

I was a member of the taxi review committee, in fact I was its chair, and we spent many hours and days going over the proposals, listening to consultants, both from the city of Los Angeles and from the private

consulting company, and it was the taxi review’s panel’s view that 171 taxi cabs was really the most that Beverly Hills could sustain. Presently, there are 131 cabs of the 150 cabs that are authorized. And the review panel believed that the addition of 40 extra cabs was really the maximum that the city could accommodate.

The concern of the taxi review panel was that there would be too many cabs in the city which could create additional traffic and parking problems. However, the City Council felt that more competition was necessary in the city and that’s why they awarded the fifth franchise.

#### What sparked your initial interest in local politics?

I’ve been a resident of Beverly Hills since around 1983 and I got involved in the campaigns of some of the City Council members and felt that I could provide some service to the city with my background as both a business person and a resident of the city of Beverly Hills. And I felt that my contribution could aid others in having a more livable experience in the city of Beverly Hills.

You have been the Official Scorer for the UCLA Men’s Basketball Team since 1996. Tell us about your involvement and passion for college athletics.

As a student I was selected to be a basketball student manager in 1968 for the UCLA Freshman Basketball Team and thereafter I became a varsity student manager and the

head manager for the years 1971 thru 1973, which were the [Bill] Walton years. Upon graduating from UCLA I wanted to maintain my involvement in the program and I became the scoreboard operator at Pauley Pavilion from 1973 until 1996. In 1996 the official scorer for UCLA Basketball retired after 50 years and I was asked to become the official scorer and I’ve continued to do that as well as having been the scorer for the

Pac 12 Tournament at Staples Center and the NCAA West Regional held two years ago at Staples and coming up this March.

#### You’re quite involved in your community then?

That’s correct. As well as professionally—professionally I am the management chair of the California Applicants’ Attorney Association (CAAA) and have done that for the past 16 years.

#### Tell us about your family.

I have four children and five grandchildren. My oldest son Joshua is in law practice with me and has been for the past 10 years, we have a small, two-person firm in Beverly Hills. My daughter Allana is an administrator at the Westwood Charter School—part of the LAUSD. My son Adam is a programming manager at the Tennis Channel in Santa Monica. And my youngest son Jeremy just started medical school at Sackler University in Tel Aviv, Israel.

#### It’s unique to have a husband and wife who are both commissioners. (Wife Simone Friedman is Vice Chair of the Recreation and Parks Commission.)

#### Do you discuss the issues in your commissions?

Both my wife and I are interested in city politics and the events that occur in the city and how they impact the city and we do have discussions about it. Her commission is operated differently than our commission and different issues arrive but it does make for spirited conversation.

#### Do you and your wife disagree on any topics?

No, my wife is always right. After 39 years of marriage I’ve learned that my wife is always right.

#### What one goal would you most like to accomplish on the Commission this year?

Having been intimately involved in the taxi franchise process there is going to be a lot of work on implementation of the taxi franchise in the city. The Traffic and Parking Commission is going to be taking a more significant role in the regulation of the taxi franchise. Additionally, we are going to be looking at the valet ordinance which we have put on hold pending the taxi franchise being approved—so we will be working on that. And of course the Santa Monica Blvd reconstruction is going to be a major issue this year. There is always the issue of disabled parking permit abuse in the city and those are probably the four major issues we will be dealing with this year. Each one of the issues is important in its own right.

Beverly Hills is a community that I have grown to love; people are very concerned in this community about making it a livable city and an enjoyable city to be in. It’s a pleasure to be of service to the community and to be a part of the community.

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO ESTABLISH AN HISTORIC INCENTIVE PERMIT

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

**Section 1.** On October 23, 2014, the Planning Commission held a duly noticed public hearing after which it adopted Resolution No. 1730, recommending that the City Council amend portions of Title 10 (Planning and Zoning) of the Beverly Hills Municipal Code to establish the Historic Incentive Permit (collectively, the "Amendments"). On November 18, 2014, the City Council held a duly noticed public hearing, received public testimony, and thereafter introduced this Ordinance.

**Section 2.** This Ordinance and the Amendments were assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City Council finds that adoption of the Amendments will not have a significant environmental impact and is exempt from CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations. The City Council further finds that it can be seen with certainty that there is no possibility that the adoption and implementation of the Amendments may have a significant effect on the environment, because no specific development is authorized by the Amendments, which are strictly procedural in nature. Further, adopting this incentive for historic preservation in the City is an action to protect and preserve historic resources, and thus is exempt from CEQA pursuant to CEQA Guidelines Sections 15308 and 15331.

**Section 3.** The Amendments are consistent with the objectives, principles, and standards of the General Plan. General Plan Policy "HP 1.4 – Develop Incentives to Protect Significant Historic Resources" calls for the development and funding of financial and regulatory incentives to encourage the protection of historic buildings, districts, and public landmarks/monuments from demolition or significant alteration, which may include flexible development standards and other incentive-based mechanisms to make preservation feasible for owners and developers.

**Section 4.** The City Council hereby adds a new Article 32.5 to Chapter 3 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"ARTICLE 32.5. HISTORIC INCENTIVE PERMIT

10-3-3250. Purpose. This Article is intended to incentivize the protection of significant historic resources by providing a process by which owners of locally designated historic landmarks may request waivers or deviations from certain development standards set forth in the Beverly Hills Municipal Code.

10-3-3251. Applicability. The Historic Incentive Permit shall be available only to those properties that are designated as a local historic landmark in the City of Beverly Hills pursuant to the provisions set forth in Article 32 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code.

10-3-3252. Historic Incentive Permit. In addition to any other provision of this code or ordinance of the City of Beverly Hills, waivers or deviations from any development standards set forth in the municipal code may be permitted through the issuance of a Historic Incentive Permit approved pursuant to the provisions of this article.

10-3-3253. Historic Incentive Permit Authority. Upon application by a property owner, in a form satisfactory to the director of community development, the reviewing authority may, if it makes the necessary findings, issue a Historic Incentive Permit to waive or deviate from any development standard set forth in Chapter 3 of Title 10 of the Beverly Hills Municipal Code. No Certificate of Appropriateness shall be required for any project for which a Historic Incentive Permit is granted pursuant to the provisions of this article. Nothing in this section, however, shall be construed to permit any waiver or deviation from land use requirements or restrictions set forth in this Chapter.

10-3-3254. Reviewing Authority. The Planning Commission shall be the reviewing authority for all Historic Incentive Permit applications.

10-3-3255. Public Hearing and Notice. The reviewing authority shall hold a public hearing concerning each application for a Historic Incentive Permit. Notice of any hearing held pursuant to this section shall be completed in accordance with article 2.5 of this chapter and the city's public notice guidelines.

10-3-3256. Findings required to issue a Historic Incentive Permit. The reviewing authority shall not issue a Historic Incentive Permit unless the reviewing authority makes the following findings:

- A. The proposed project either:
  1. Complies with the "Secretary Of The Interior's Standards For The Treatment Of Historic Properties With Guidelines For Preserving, Rehabilitating, Restoring, And Reconstructing Historic Buildings"; or
  2. Does not demonstrate strict compliance with the "Secretary Of The Interior's Standards For The Treatment Of Historic Properties With Guidelines For Preserving, Rehabilitating, Restoring, And Reconstructing Historic Buildings", but nonetheless protects and preserves the historic and architectural qualities and the character defining features that make the property a landmark or contributing property; and
- B. The proposed development will not have a substantial adverse impact on:
  1. The scale, massing, or character of the streetscape,
  2. The scale and massing of the property as viewed by neighboring properties,
  3. Neighbors' access to light and air,
  4. Neighbors' privacy,
  5. The garden quality of the city, and
  6. The public health, safety, or welfare

10-3-3257. Restrictions and Conditions. In granting a Historic Incentive Permit, the reviewing authority may impose such restrictions or conditions as it deems necessary or proper to satisfy the required findings.

10-3-3258. Appeals from Decisions. The applicant or any person aggrieved by any decision of the Planning Commission regarding a Historic Incentive Permit, may appeal that decision to the City Council. The City Council shall have the authority to call such decisions for review pursuant to the provisions of Article 2 of Chapter 4 of Title 1 of this code.

10-3-3259. Time for Exercise of Rights. Unless otherwise provided in the resolution granting a Historic Incentive Permit, the exercise of rights granted in such approval shall be commenced in accordance with the time limits imposed by section 10-3-207 of this chapter."

**Section 5.** The City Council hereby amends the table in subsection A of Section 10-3-253 of Article 2.5 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code to read as follows:

**Section 6. Severability.** If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

**Section 7. Publication.** The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the

adoption of this Ordinance, and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

**Section 8. Effective Date.** This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
