## Board ballot statements yield clues on candidate platforms

In his candidate statement for the November 3rd Board of Education election, Mel Spitz writes that his “overriding objective is to deliver a superior education to all students across the academic spectrum.”

Spitz strives to accomplish this by reducing class sizes, restoring honors and advanced classes, offering “enriching” electives and reestablishing high standards of achievement.

The former Board member recalls that “[BHUSD] schools were among the best in the nation” during his nine-year term, from 1971 to 1979.

Board candidate Carter Paysinger believes the “[Board of Education] has lost it way and squandered the public’s trust and money.”

Paysinger graduated from Beverly High in 1974 and returned to the school after college, building a 36-year career that spanned several different roles: teacher, coach, department chair, athletic director, assistant principal and most recently,

In his candidate statement, Paysinger promises to “work tirelessly to restore an education-first atmosphere where teachers teach and students learn.” He mentions that the current Board’s “petty squabbles...rob students and teachers of motivation, pride and focus.”

A former Citizens’ Oversight Committee member whose work in the public educa-

tion sector exceeds

a decade, Board candidate Isabel Hacker is running on a four-part platform that includes rebuilding public trust and resolving the Measure E bond shortfall.

Hacker pledges to “serve as an independent and informed voice on behalf of students, and to bring the facts on all the issues to the community.”

Hacker, who earned her B.A. in Business from UC Riverside, stresses the importance of restoring fiscal responsibility through “[assessing] district liabilities and [implementing] business-like solutions.”

Board member Noah Margo’s candidate statement focuses on putting “education first,” a goal he aims to accomplish by improving the quality of teaching in the district, tightening fiscal controls, instituting sound resolutions and fostering civility and respect.

Before serving on the Board, Margo previously taught elementary school at Hancock Park School in the LAUSD. In his statement, the USC graduate writes that he has “often found [himself] in the Board minority.”

Board member Lewis Hall received his B.F.A. from UCLA and teaches two classes at Otis College of Art & Design. He strives to “continue to make the BHUSD fiscally sound with modern, safe, 21<sup>st</sup> Century learning environments.”

Running for a second term, Hall submitted a ballot statement that is almost identical to his 2011 statement. In both, Hall proclaims that, “Together, we can make it better and build to excellence” (see side-by-side comparison above).

## Council discusses minimum wage requirements

Last October, Legislative Committee members Vice Mayor John Mirisch and Councilmember Willie Brien met to review proposals regarding the city’s minimum wage requirements.

After the committee failed to reach an agreement, Brien requested that the Council discuss the matter further.

“I think that we have to look at this from all perspectives,” Brien said. “Not just raising the rate, not just the impacts it may

have on businesses, but the impacts—long term—that it has on this community and the businesses.”

Brien said that philosophically, he supports raising the minimum wage.

Recent US Census Bureau estimations revealed that California has the highest poverty rate in the nation. In 2013, Governor Jerry Brown signed Assembly Bill 10, increasing the state’s minimum wage to \$9 per hour after January 1, 2014 and to no less than \$10 per hour on and after January 1, 2016.

Since then, several cities, including Los Angeles, San Francisco and Berkeley, have approved phased-in increases to eventually bring the minimum wage to \$15 per hour.

At the Study Session on Tuesday, Chamber of Commerce Economic Development and Government Affairs Director Andy Sywak presented findings from a “minimum wage impact survey” conducted by the organization last fall.

According to the Study Session staff report, approximately 189 employees working within the City organization are currently paid less than \$15/hour, meaning a boost in minimum wage requirements will add \$308,000 to the City’s budget in 2020.

Sent out to the Chamber’s entire membership, the eight-question survey was completed by exactly 70 businesses.

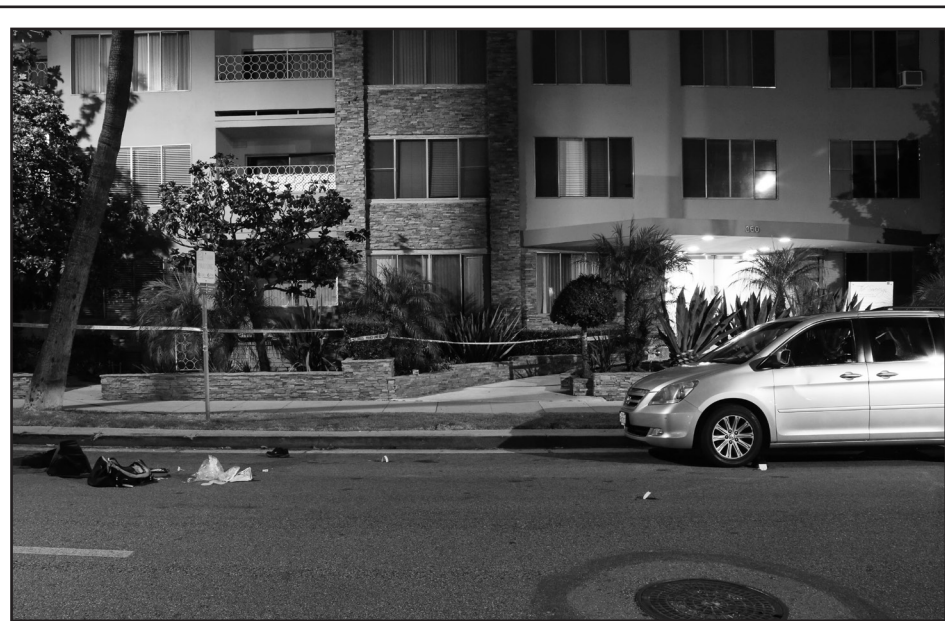

## Fatal hit-and-run leaves one dead; BHPD investigation ongoing

On August 25 at approximately 10:56 pm, Beverly Hills Police Department units responded to a call reporting a traffic collision on the 300 block of North Crescent Drive, where they discovered an unconscious male adult lying in the roadway.

Officers immediately began C.P.R. and were subsequently relieved by Beverly Hills Fire Department paramedics who transported the unconscious victim to a local hospital where he was later pronounced deceased.

The BHPD’s Major Collision Response Team (M.C.R.T.) is investigating the hit-and-run collision.

Based on video evidence and witness statements, investigators believe that two different vehicles struck the 58-year-old victim soon after he exited his car. The individual’s identity is being withheld pending the notification of next of kin.

Both vehicles fled from the scene. The first suspect vehicle, described as a dark or black, four-door sedan, was last seen traveling northbound on the 400 block of North Crescent Drive.

The second suspect vehicle was last seen traveling southbound on Rexford Drive; witnesses described the vehicle as a dark-colored mini-van or S.U.V.

The BHPD is seeking the public’s assistance in identifying the parties responsible for this hit-and-run collision. Anyone with information should contact BHPD Traffic Investigators at (310) 285-2195.

"I think [70 businesses] is not a large enough universe to make an educated decision," said Councilmember Lili Bosse.

Forty-three percent of respondents said they would be negatively impacted if the minimum wage increased to \$10.25 per hour; the number climbed to 52 percent at \$11.75/hr and almost 60 percent at \$13.25/hr.

Sywak defined "negative impact" as anything that might imperil a business, such as cutting back hours and raising prices.

"Are you willing to pay more to go out and eat? Because that's what's going to happen," said Chamber of Commerce President Todd Johnson.

The Council expressed general support for the minimum wage increase and directed staff to reach out to the City's business community, as well as neighboring municipalities, and provide options for consideration.

"You've got to give people a chance sometimes to move up," Brien said.

### BHEA endorses Margo, Paysinger

The Beverly Hills Education Association voted August 27 to endorse Board of Education candidates Noah Margo and Carter Paysinger.

"Our representative council voted to firmly endorse Noah Margo and Carter Paysinger," said BHEA President Telly Tse. "We believe that the two of them

have done great things for our schools, our teachers and our students, and will continue to do so."

Though invited to participate in the BHEA endorsement interview, Board candidate Isabel Hacker disclosed her decision to not solicit or accept the endorsement of any union with which she might be called upon to negotiate with if elected to the Board.

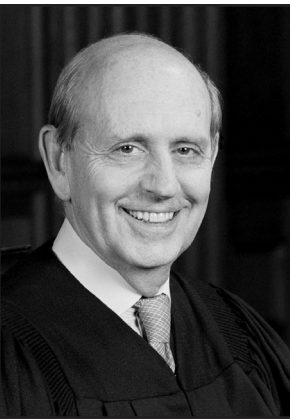

## Council to revisit ordinance prohibiting adults from city playgrounds

At the City Council meeting Tuesday, Vice Mayor John Mirisch and Councilmember Nancy Krasne pulled an item from the consent calendar which would have barred adults eighteen years and older from city playgrounds, unless accompanied by children.

“Sometimes, when I’m upset or depressed or unhappy about something, I like to go to the park and watch children play,” Krasne said. “There is something so innocent, so free [and] so exuberant in watching them.”

If authorized by the Council, the ordinance would have added a paragraph to the Beverly Hills Municipal Code that defines “playground” as an “improved area that is designed and set aside for children’s play, which may include equipment such as swings and slides.”

The additional section mentions that a playground cannot be used as an athletic playing field, athletic court or skateboarding park.

Submitted by Human Services Administrator James Latta and approved by Community Services Director Steve Zoet, the agenda report cites encouraging “appropriate use of City park playground equipment” as the purpose of the proposed amendment.

Councilmembers agreed that the Recreation & Parks Commission should deliberate the proposal before it returns to the Council.

If backed by the Council, the ordinance will go into effect at 12:01 a.m. on the 31st day after its passage and playground signage will be updated to reflect the amendment.

The American Civil Liberties Union (ACLU) did not respond to an email from the Weekly by press time.

## BHHS football team loses its season opener Team to play at Templeton Saturday By Steven Herbert

Beverly High opened its 2015 football season by losing to Oak Park, 40-6, Friday night in a nonleague game at Nickoll Field, allowing touchdowns on both of the Eagles' first two possessions, losing three fumbles and having a punt blocked.

Senior running back Rashad Ysaguirre's eight-yard second-quarter touchdown run cut the deficit to 14-6, but the Normans were held scoreless for the rest of the game.

"Offensively, we just weren't able to get a rhythm going," Beverly Hills coach Charlie Stansbury. "There were probably five plays that were 10 yards or more that were called back because of a penalty, so it disrupted the rhythm quite a bit in the first half.

"In the first game, you want to be able to get a drive going and we weren't able to sustain a drive until the second half."

Because it was the first game of the season, the Normans were "a little bit nervous," leading to "a couple" of dropped passes and "some missed assignments" by offensive linemen, Stansbury said.

"Right when the play is over, we knew exactly what happened," Stansbury said. "When you get in the moment and you got new guys running at you, sometimes it's a little harder than it looks."

The Norman defense "stepped up quite a bit," Stansbury said.

"After the first quarter-and-a-half the game was played on our side of the field and we came up with more than a few stops when we needed it," Stansbury said. "We're getting better with adjusting with our kids. We were able to slow some things down."

Defensive back Skylar Derrick and linebacker Dylan Rutigliano, who both made interceptions, drew praise from Stansbury for their play for Beverly Hills, as did tight end-linebacker Solomon Nwankwo, for both his play on offense and defense.

Norman quarterback Jake Wolken completed 13 of 26 passes for 127 yards.

"In the second half, Jake Wolken did a much better job throwing the ball than in the first," Stansbury said.

The loss was Beverly Hills' eighth straight dating back to last season, 20th in Stansbury's 21 games as coach and 38th in 43 games dating back to 2010.

The Normans have lost five consecutive season openers and eight of their last nine

The victory ended Oak Park's 11-game losing streak dating back to 2013. Eagles coach Tim Kenney credited the victory to "doing a really job of tackling," not giving up "too many big plays due to missed tackles" and "getting off to a good start" offensively.

Oak Park quarterback David Schmucker threw three touchdown passes and ran for two more scores. Tyler Stump ran one yard in the fourth quarter for the Eagles' other touchdown.

"We're capable of playing much better, which is encouraging," Kenney said.

The Normans will travel slightly more than 200 miles north on the California coast to play at Templeton in a nonleague game Saturday. The opening kickoff is set for 5:30 p.m.

Stansbury said his goals for his team are for it "not to be distracted by the travel" and successfully cope with what will likely be the largest crowd it will play before this season.

The Eagles are a run-oriented team that uses the spread offense, according to coach Dan Loney.

Templeton rushed for 360 yards on 46 carries in its season-opening 18-16 intersection victory at Bakersfield Christian Friday night, while senior quarterback Jordan Bernal completed five of 13 passes for 66 yards and one touchdown and had one pass intercepted.

The Eagles were ranked second in the Southern Section Northwest Division poll released Monday. They were 10-3 in the 2014 season, reaching the Northwest Division semifinals.

Beverly Hills was 0-9 in 2014 against its remaining nine 2015 regular season opponents, including a 41-7 loss to Templeton.

Stansbury expressed confidence that his team will avoid a winless season.

"From seeing some of the other teams in the summer and speaking with some of the other coaches, it's going to be more or less who's available for what games (is) what really is going to determine the game," Stansbury said.

## Shanel Melamed

### Executive Director of 30 Years After

**You started your new job as Executive Director of 30 Years After in July. What was your first week like?**

I would sum it by saying eye-opening, inspiring and meaningful. Unfortunately or fortunately, it [wasn't] too eventful—it [was] a series of meetings and really getting acquainted with the Board of Advisors, the Board of Trustees, better understanding the organizational structure and getting acquainted with the ins and the outs. I'm very excited for this position; it's a huge honor for me to be the Executive Director of 30 Years After. I hope to do a lot of great things for our community and I'm counting on our community to pitch in.

**Tell us about the organization.**

The mission of the organization, essentially, is to engage Iranian-American Jews in political, civic and Jewish life. For the most part, our mandate is to engage and impact our community and help them find a role through which to be involved—hopefully, a leadership position through which to be involved. First and foremost, we have the Maher Fellowship, which just finished its second cycle. It's a fellowship that was born of one Board member's idea and we found a donor, Oron Maher—also a young Iranian-American Jew—who was interested in funding such an initiative, so now we're going to be starting our third cycle in the winter, and that's a project that essentially trains for

leadership. It is a few-weeks-long series of lectures, a retreat [and] engagement with different influencers. A lot of the Maher fellows that have gone through the program go on to continue whatever was inspiring them to come to the leadership fellowship. Whether that was a political interest or a civic interest or a religious interest, they move forward and they're prepared and they're better inspired. You might find it interesting that I was a Maher fellow myself in the first cycle, so it kind of inspired me to apply to this position when I heard that [former Executive Director] Tabby Davoodi was leaving. So I think, first and foremost, our Maher fellowship really allows people to get involved—it allows us to engage people on how to better get involved. We also do have events. We have a Power Brunch series, and as you know, every two years we've had the [Civic Action] conference.

**You formerly worked for the Israeli Consulate. How will that experience shape your approach as Executive Director?**

At the Israeli Consulate, I really had the privilege of working with some of Israel's brightest diplomats. I learned management from them [and] I learned leadership from them. I learned critical thinking through them and I really found some great mentors there. So I feel like I come to this position quite equipped to steer a ship and play my part in leading a

community because I had great training through the wonderful people I worked with at the Israeli Consulate and the Israeli Foreign Ministry in general.

**What do you hope to accomplish as Executive Director?**

My personal number one priority is to ensure that Iranian American Jews are on the map—not just in Los Angeles, but in

the U.S. in general. I think we're a strong community, we're a gifted community, we're an educated community, we're a successful community, and it's important for me that we're seen and that we're recognized and we have a say in issues that affect us and that we also play our part in giving back to this country that's given us so much.

## Ivy Kagan Bierman on being named the Beverly Hills Bar Association's Entertainment Lawyer of the Year

**Why do you think you were chosen to be honored?**

When Marc Staenberg, the [Chief Executive Officer] of the Beverly Hills Bar Association, called to inform me that the [BHBA] had decided to honor me as the Entertainment Lawyer of the Year, he said, "You're very well-respected and widely well-liked in the entertainment industry." Then we proceeded to have a conversation where he said to me that in addition to being so well-respected for the legal work that I do, the [BHBA] felt that I also did a lot of important community outreach, which was very admirable. So I think they selected me for my reputation in the industry—for being good at the kind of work I do and for being someone that has good relationships within the industry—but also, again, because I give a substantial amount of my time to the community.

**How did you get involved with the BHBA?**

The work that I do in the community has not been through the [BHBA]; I serve on three Boards: the Board of Women in Film (WIF), the Board of the Hollywood Radio and Television Society (HRTS) and also on the Anti-Defamation League (ADL) Board. What's really good about how the BHBA selects the recipient for this award is that it's not based on the ties you have with the BHBA, it's really based on whether you're perceived to be an exceptional lawyer within the industry, and again, what kind of relationships you have within the industry and what you give back to the community.

I've been involved with WIF for many, many years and served on the Board for many years as well. The primary focus of

my involvement has been with respect to mentoring. I serve on the mentoring committee and I conduct mentoring circles, which are groups of about 8-10 women who do many things within the entertainment industry and are seeking some career guidance. Mentoring women is a very big passion for me. I also mentor female associates as well as mentor other women who are not even in the entertainment business.

In terms of the HRTS, I've been on the Board for several years. HRTS does an amazing number of programs that benefit the industry, both in terms of educational programs and networking. As a Board member, I'm part of the governance of that organization.

The ADL is also a very big passion for me. As you may be aware, the ADL's mission is to not only fight anti-Semitism, but to also fight bigotry and hatred of all kinds. I devote a significant amount of time to the work of the ADL as well. I recently accepted the ADL's request that I become Chair of the Board when the current Chair's term is up, in approximately a year.

**What do you enjoy most about practicing law?**

I really enjoy resolving disputes in as mutually beneficial a way as possible. Many of the matters I work on involve

disputes that threaten feature film and television production and I have a very short amount of time to resolve those disputes. the relationships that I have with my clients but also the relationships I have with the other parties that I need to work with to resolve disputes with.

**Tell us about your family.**

I have two sons. My older son Sean is the Vice Consul for the British Consulate in Boston. It's a really terrific position for someone who's so young—he's turning 26. Sean graduated from Oakwood and went on to graduate from USC. Beverly Hills has a very special meaning for my family: Sean and his husband Arata were married at the Beverly Hills court house in May 2014 and we had the wedding reception at L'Ermitage. My younger son Sam, [who is 18], is a music major at the Frost School of Music at Miami University. He's a media writing

So it really is my proudest moment to date in my career. I'm actually dedicating the award on September 16 to

Joan Rivers and to my mother, Lorraine Berg, who passed away three years ago. My mom was my best friend as well as my personal and professional advisor and biggest cheerleader.

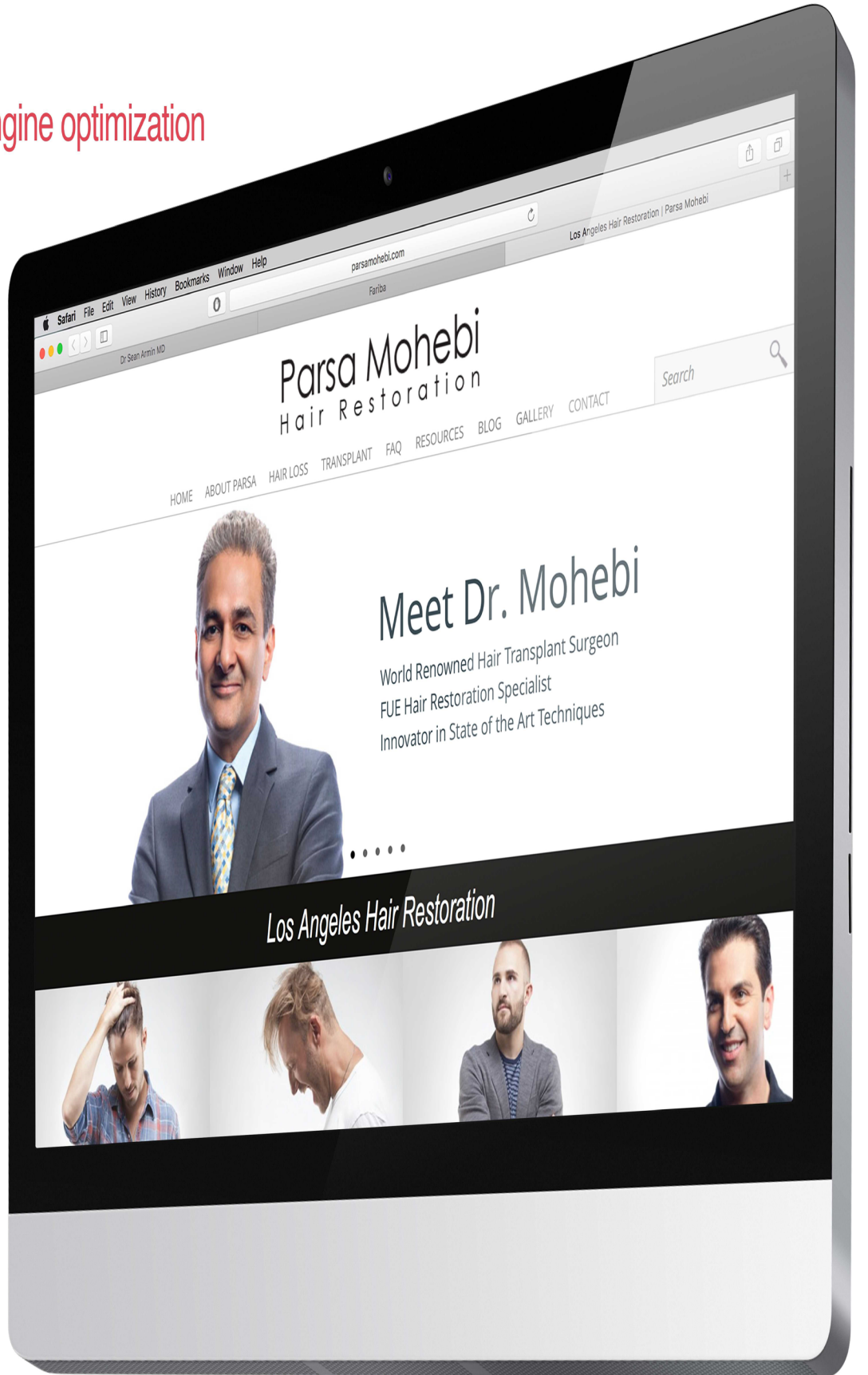
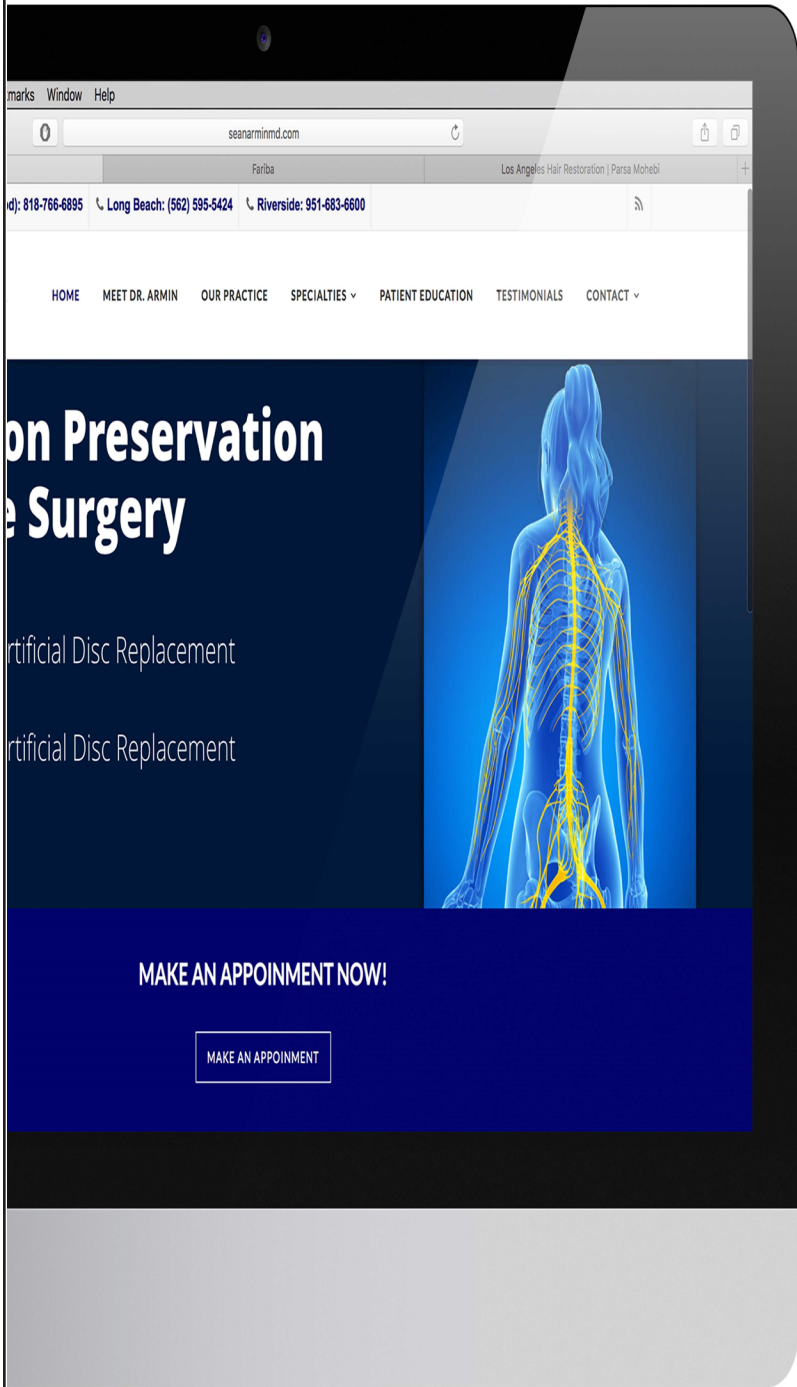
