Yaroslavsky blasts Board on Metro lawsuit

In a *Beverly Hills View* interview taped last week, retired L.A. County Supervisor Zev Yaroslavsky questioned the Board of Education's motives during negotiations on the Metro subway station planned for Constellation Avenue.

"Several years ago, I tried to negotiate, and came close to negotiating, a meeting of the minds with [former Board President] Jake Manaster," Yaroslavsky said. "The only thing I couldn't resolve and we agreed not to resolve was, at that point, the payment for the easement that would have to go under the school."

Yaroslavsky, who mentioned that the BHUSD and City Council have spent nearly \$10 million in legal fees related to the Metro case, stated there is "nothing wrong" with routing the tunnel 80 feet below the Beverly High campus.

"There are subway tunnels under schools all over the world," Yaroslavsky said.

Yaroslavsky's statements challenge assertions made by former and current Board members, namely Lewis Hall and Lisa Korbatov, about the supposed dangers of tunneling below the high school.

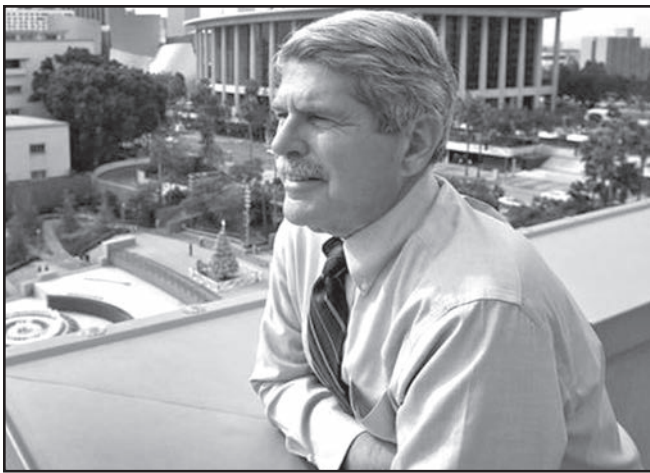

"This has been a ridiculous argument that's been made," Yaroslavsky said. "Frankly, some of your school board members got out on a political limb and can't extricate themselves from it."

In late 2014, Hall starred in "Why We Fight," a purportedly student-produced YouTube series that paints the Metro project as a perilous undertaking.

"The state court, the trial judge, as well as the appellate court, unanimously sided with Metro; this judge sided with Metro on a number of issues, and a few issues it did not," Yaroslavsky said. "At the end of the day, the result will be the same. It's just about how long do you want to wait and how much money do you want to spend?"

Yaroslavsky later blasted the four-story, underground parking garage being planned for the Beverly High campus.

"It's a colossal waste of money," he said.

Yaroslavsky urged voters to consider whether they should support another bond.

Board considering perimeter fence for Beverly High

The topic of school security has resurfaced at recent Board of Education and City Council meetings.

Late last month, the Board gave Totum Consulting direction to solidify fencing

plans for Beverly High.

Principal Dave Jackson was given unanimous approval at a Beverly High site council meeting to address the Board about the matter.

Jackson said the site council backed a wrought-iron fence for the front of the campus and a chain-link enclosure for the back.

"[The site council] wants to make sure, aesthetically, the front of the school is not

chain link," Jackson said.

The Board had previously sought bids for the project, but they ran high, with numbers approaching \$500,000.

Totum's Rick Panos said the firm can have a plan prepared in a few months.

Fencing the iconic front lawn has been a controversial issue. Previous boards opted to keep the front lawn open, as it has been since 1927.

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING ARTICLES 32 (HISTORIC PRESERVATION) AND 32.5 (HISTORIC INCENTIVE PERMIT) OF THE BEVERLY HILLS ZONING CODE TO CLARIFY THAT CERTAIN ARCHIVED PHOTOGRAPHS AND FILMS MAY BE CONSIDERED IN DETERMINING WHETHER A PROPERTY IS AN «EXCEPTIONAL WORK,» TO REFINE THE CRITERIA FOR ISSUANCE OF HISTORIC INCENTIVE PERMITS IN THE TROUSDALE ESTATES AREA OF THE CITY, TO CLARIFY APPLICABILITY OF THE ORDINANCE TO INTERIOR SPACES, AND TO CLARIFY TIMEFRAMES FOR APPLICABILITY OF THE REVISED HISTORIC PRESERVATION ORDINANCE VERSUS APPLICABILITY OF THE PRIOR ORDINANCE.

This ordinance clarifies and refines several aspects of the recently adopted historic preservation ordinance. In particular, the ordinance:

- 1) Amends the definition of «exceptional work» to be clear that certain archived photographs and films may be considered in classifying a property as an exceptional work;
- 2) Refines the types of Historic Incentive Permits that may be granted in Trousdale Estates to prohibit waivers on building height and construction over slopes;
- 3) Clarifies when the ordinance may apply to interior spaces, and
- 4) Clarifies when a property would be subject to the revised historic preservation ordinance versus being subject to the prior historic preservation ordinance.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. This Ordinance is exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations (Minor Alterations in Land Use Limitations).

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. The comments should be received prior to the hearing date.

Please note that if you challenge the City's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing or in written correspondence delivered to the City, either at or prior to the end of the public hearing.

Israel's Ministry of Science and the California Institute for Regenerative Medicine signed a historic agreement on stem cell research Monday, facilitated by the Israeli-American Council.

Board members offer solutions to BHUSD's gloomy budget forecast

The BHUSD ending fund balance will barely total \$12,000 by 2017-18, according to budget projections shared by district staff at last week's Board of Education study session.

"I want to compliment staff for the clarity of this budget forecast," said Board Vice President Mel Spitz. "It shows undeniably that we are on a pathway to insolvency."

At a Board meeting last December, Spitz advised that the district cut down per-student expenditures, which currently total \$15,023.

"Which is 50 percent more than higher-performing neighboring districts, some smaller and some larger," Spitz said February 4.

Part of the problem is a financially unsustainable salary formula developed by former Board member Brian Goldberg.

Budget assumptions for 2016-17 include pay hikes of three percent for certificated and classified employees, as well as increases in STRS and PERS rates.

"Our annual per-student expenditure for certificated salaries and benefits is 63 percent higher than the average of four [comparable] districts," Spitz said. "If we reduce that expense by 20 percent, it will still be 25 percent higher than the average of comparable districts, and we will save \$7.7 million annually."

At Beverly High, several classes are severely under-enrolled, falling well below the 29-student maximum (see chart below). Some performing arts sections have been hard hit by the KL Peters auditorium closure.

Board member Isabel Hacker proposed scrapping the "hard cap," which puts a limit on enrollment and has led to additional hiring, especially in the lower grades.

A veteran faculty member costs the district roughly \$100,000 annually including benefits for a 5/5 assignment. Therefore, each under-enrolled section costs the district approximately \$20,000 per year.

Traffic & Parking supports modifying El Camino Dr. parking regulation

At their meeting last Thursday, the Traffic & Parking Commission heard from several residents who called for a change to the preferential parking permit regulation on the 200 block of El Camino Drive.

Established in 1979, the regulation reads, "No Parking Anytime, Monday through Saturday, Permit 'D' Exempt." Last March, the city received a petition signed by 21 of the 28 homeowners on the block requesting Sunday be added to the rule.

"Sundays are horrendous," said resident Arnon Gurman. "On Sundays I become a sanitation engineer: I clean up the garbage and the mess from the people that come off of Beverly Drive and throw their trash, their food and their litter on the street."

El Camino is adjacent to South Beverly Drive.

A parking occupancy survey conducted by city staff members on January 10 revealed that 91 percent of the residential parking spaces were occupied across a six-hour period. During the peak hour of occupancy, 2 p.m., 96 percent of the spaces were taken.

Twenty-eight single-family homes and six multi-family buildings populate the block.

"There was absolutely no opposition [to this change], which seems to be significant, not only from residents who live in the area, but also from commercial interests," said Bruce Horowitz, who also lives on the street.

Commissioner Lester Friedman said the "good news" is that business is thriving on Beverly Drive, but remarked that residents on El Camino are being negatively impacted by the surge in visitors to the area.

The Commission unanimously approved the change.

Beverly High, Hawthorne auditoriums expected to remain closed until 2018

The Beverly High and Hawthorne auditoriums have remained closed since last April, when the previous Board of Education voted 3-2 to shutter the buildings.

Citing the structures' alleged seismic deficiencies, former Board members Brian Goldberg and Lewis Hall and Board member Lisa Korbatov backed the closures.

Newly appointed Chief Facilities Officer Eitan Aharoni, who inspected the auditoriums with a structural engineer earlier this year, reported on the status of the two buildings at Tuesday's Board meeting.

Aharoni said the walls and roof system

of the Hawthorne auditorium are in "fairly good shape."

"The main problem is the plastered ceiling," Aharoni said.

According to Aharoni, Beverly High's KL Peters auditorium suffers from structural deficiencies and requires "seismic reinforcement."

No student has been injured in the 80-year history of the Peters auditorium.

Aharoni indicated that construction will break ground in February or March of next year.

When asked by Board member Noah Margo whether students can use the facilities in the interim, Superintendent Steve Kessler mentioned the Board would be susceptible to liability unless "all the professionals" supported the move.

"You're saying that even though it never existed that any official body except for the Board majority decided to close those auditoriums, that it's now in the hands of licensed professionals to all sign off on it being okay to reopen them in order to avoid liability?" Margo said.

Margo mentioned that an engineer had never signed off on the closures.

Beverly High's KL Peters auditorium once housed a bevy of performances, including theatrical productions, graduation ceremonies, dance show recitals, assemblies and concerts.

Construction is expected to finish in May 2018.

The Normans led 13-6 at the end of the first quarter, 35-19 at halftime and 54-29 entering the fourth quarter.

The Cougars didn't have a full team because they "had some kids kicked out of school for various reasons so we got the opportunity for our guys who really don't get a lot of playing time to play a lot and that was fun to see," Beverly Hills coach Jarvis Turner said.

Senior guard David Koshki, sophomore guard Daniel Zahabian and senior forward Max Walder all "played extremely well" for the Normans, Turner said.

Zahabian added nine, Sam Cohen seven, Koshki six, Ron Artest III and Grant Gaon five each, Denzel Holt and Eric Ross four each, Kevin Cho two, and Amir Hajirsooli and Sean Mehrara one each for Beverly Hills.

Mason Daniels and Gaon each made one 3-point basket. The Normans made nine of 18 3-point shots.

Beverly Hills 60, Lawndale 42

Maddox Daniels scored 17 points, making five 3-point baskets, and Artest 15, making five of seven two-point shots and five of six free throws, in an Ocean League game Friday night at the Swim-Gym.

The Normans led 11-6 at the end of the first quarter, 30-21 at halftime and 46-35 entering the fourth quarter.

Holt added eight, Cohen and Fidel Quiralte six each, Mason Daniels five and Reskin three.

Mason Daniels and Reskin each made one 3-point basket.

"We played well as a team," Turner said. "We played outstanding defense and we made some shots."

Turner said his team's size "bothered" the Cardinals "a little bit."

Santa Monica 66, Beverly Hills 55

Turner attributed the Normans' second loss in two games to the Vikings to too many turnovers and insufficient "aggressiveness and togetherness" to defeat "a good team."

Turner said Beverly Hills committed 22 turnovers, while a statistics sheet compiled by the team said it committed 16.

"Against a team like that who is a very good basketball team and turns your mistakes into points, we can't allow them 22 turnovers that leads to easy opportunities for them," Turner said.

The Normans trailed 19-16 at the end of the first quarter, 34-27 at halftime and 50-39 entering the fourth quarter in the Ocean League game at Santa Monica Tuesday night.

Artest had a team-high 16 points, making six of eight 2-point shots, and pulled down eight rebounds, despite first-half foul trouble and Hajirsooli "played pretty well" with eight points and a team-high nine rebounds, but "we just really didn't get a lot of perimeter play from our guards," Turner said.

"We usually depend on them to make a couple of shots and it just didn't happen (Tuesday) night," Turner said.

Beverly Hills (17-8, 7-2 in league play) made three of 14 3-point shots, 21.4 percent, with Maddox Daniels making two of seven and Reskin missing all five.

Holt added 10, Maddox Daniels six, Mason Daniels three, Quiralte eight, and Koshki and Walder two each.

Both of the Normans losses in their last 13 games have come against Santa Monica, ranked first in the Southern Section Division 1A poll released Monday.

Beverly Hills is ranked fifth in Division 3A.

What's Next?

The Normans are scheduled to conclude the regular season tonight by playing host to Culver City at the Swim-Gym in an Ocean League game beginning at 7:30 p.m.

Beverly Hills defeated the Centaurs, 58-49, on Jan. 27.

CHIEF MUNDELL CELEBRATES 30 YEARS WITH BH FIRE

But how has the department changed over the years?

You celebrated your 30th anniversary with the BHFD yesterday. What has changed most about being a firefighter over the past three decades?

First of all, we have fewer fires today than we did when I got here in 1986, which is a great thing. One of the reasons that the fires are not as big as they once were—even though we do have fires occasionally—is that all of our properties, new construction, both residential and commercial use, have been required to install fire sprinklers since 1989, so the fires don't get very big even when we have fires. Then there are other areas in the safety world that we're involved in now—[like] urban search and rescue—which weren't really even thought of back in 1986. Our paramedic program has expanded tremendously and we have 27 paramedics total, or nine a day. When I got here, we had 12 paramedics, or four a day. Things like that have changed. And now we're in a world that's confronted with terrorism, both nationally and internationally. So when we say it's a fire department—yes, we still respond to fires and we still extinguish fires—but we have so many other things that we're responsible for and have to be proficient at compared to 30 years ago. Wildfires are much more detrimental, or so it seems, today than they were 30 years ago. The wildland urban interface is a significant problem that we deal with. It used to be that we had a fire season, now it seems like brushfire season is all year long.

How has the department changed over the years?

When I first arrived, we were just transitioning from a department where the firefighters came here and really all they did was that firefighting aspect. One thing that hasn't changed is the support of the community, the City Council and the business community. Today, what we're confronted with is we have a very aging population, not only in our country, but in the fire department. We're transitioning from a relatively old or tenured fire department to a newer one—we've hired 30 new people in the last five years and we anticipate hiring another 15 or so in the next four-to-five years. So we're going from people who have a significant amount of time on the job to a much younger department, and

it will take time to get them up to that same level.

What characteristics define a successful firefighter?

Successful firefighters are committed to a cause; they have a dedication not only to the community that they serve, but to their fellow firefighters; they have a true desire to help people. It's like a calling: you either like being around people and helping people, or you don't. So if you fall into the category of really liking people and wanting to make a difference in people's lives, you can become an outstanding firefighter. We have many, many of those types of people in the Beverly Hills Fire Department. They are tremendously talented, compassionate and empathetic people.

Who hired you into the department?

I was hired by Fire Chief Bill Daley on February 10, 1986. I refer to him as Bill because we're very much friends now; he was an individual that I really looked up to. He was the fire chief when I obviously was hired and he was also the fire chief when I was the Firefighters' Association President. He taught me a lot about customer service and a tremendous amount about making sure that you promote the fire department and not yourself.

What sets apart the BHFD from other fire departments?

I think the significant difference between the philosophy of the Beverly Hills Fire Department and many other fire departments is that sense of outstanding and exceptional customer service. We will offer anyone that we

provide service to a ride to the hospital; even though they may not need to go, but they want to go, because they're going to feel better by going to the hospital. We will stand by and wait for family members to get there so that the person that we're serving feels better because their family is going to be there. We will pick people up that we see walking on the

street—whether it be an elderly person or somebody that might look like they're out of place and we'll stop and ask them, “Hey, is there something that we can do to help you?” Not only do we provide that service, but we want to go the extra mile for the people that we service.

What's a recent example of BHFD personnel going the extra mile?

There was a gentleman who was at a restaurant having dinner with one of his friends when the friend noticed that the gentleman didn't look quite right. The friend called us and we responded and thoroughly evaluated the patient for any health issues. The patient said he didn't want us to do anything, but it would be nice if we could give him a ride home. Once we determined that they didn't have any medical issues that required us to transport the person to the hospital, we took the person home and made sure that they got in and were comfortable. The best example of a situation [where BHFD personnel went the extra mile] occurred about 10 years ago. Our crews responded to a home

north of Santa Monica Boulevard and found an elderly couple. The gentleman was very ill and was transported to the hospital and when they were asking the lady what was going on, [they noticed] that it was an older home, and although cleanly maintained, it had older fixtures. Our personnel wanted to make sure that she was going to be alright and have sufficient food to sustain her for the next couple of days because her husband was going to be in the hospital. The next morning, our paramedics were off duty and going home and they went to the grocery store and bought a bag of groceries, bought some breakfast items and made her breakfast and left her there with wholesome foods so she could have it for the next couple of days. I learned about it three or four days later because the paramedics that did that never told anybody. Those are the types of people that we have in the Beverly Hills Fire Department.

Tell us about your family.

My wife Donna and I will have been married for 30 years in March. Our older son, Ralph, who we refer to as RJ, is 24 years old and a firefighter in the Burbank fire department. Our younger son, Brian, is 21 years old and a baseball player in the Colorado Rockies organization.

What advice do you have for BHFD candidates?

What I recommend to them is to go to college, and if they're in college, to remain in college and get their bachelor's degree. In conjunction with that, we require them to be of good character. We realize that people make mistakes along the way—we all have and we all continue to make mistakes. But if you make a mistake, recognize your mistake, don't do it again and when somebody asks you about it, admit to your mistake. Also, continue to be dedicated to this place and this profession once you are hired, because it's the greatest career there ever was.

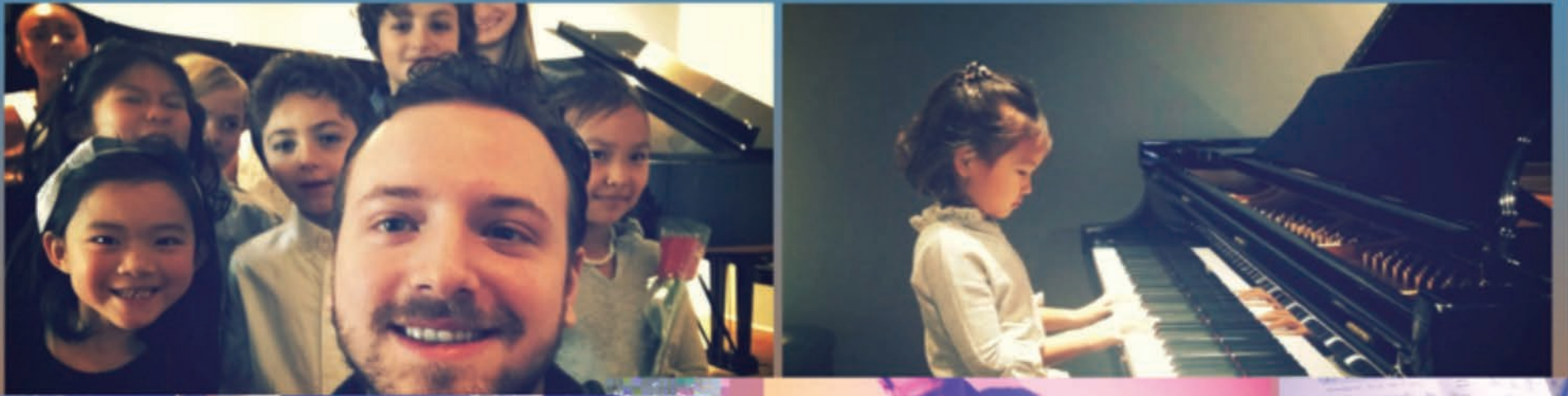
