## “An Open Letter to the Community” [Issue 863]

The developer does not want a six-story building on Wilshire Blvd. Instead, he would like a 26 story building on Santa Monica Blvd. which would be taller than the Statue of Liberty. This will not happen.

The money saved by scrapping the 6 story building should be used to build a pedestrian overpass at the Santa Monica and Wilshire intersection to accommodate all pedestrian crossing possibilities. Automobile and foot traffic at this location is already heavy and will only get worse when the Waldorf Astoria hotel opens next year.

Why are many Beverly Hills residents so staunchly opposed to the Hilton’s offer of an idyllic garden in place of a condo building? First and foremost, Mayor Mirisch has detailed extensively the many deceptions that make up the Hilton ini-

tiative. However, I think the opposition also grows from our history with Hilton expansion. Here’s a quick recap to put it in context.

In 2008, the developers’ plan to squeeze the Waldorf Astoria and two condo buildings onto the Hilton grounds was rejected by the entire Planning Commission, and by many residents who formed a grass-roots organization, Citizens’ Right to Decide (CRD). They gathered enough signatures themselves, with no paid canvassers, to bring a referendum to the ballot, Measure H, which would reverse the City Council’s 3 to 2 vote in favor of the Hilton expansion. The CRD spent a total of about \$80,000, while the Hilton flooded the city with \$3.3 million in mailings, brochures, flyers, newspaper and TV ads, and paid canvassers (that’s happening again), gifts of tote bags to the students of El Rodeo, free cocktail events at the hotel, and more. The Hilton actually lost at the ballot box on election day, but then won when provisional and absentee ballots were counted, amidst documented incidents of voter fraud. The three giant buildings gained approval with only 129 votes out of over 15,000 ballots cast.

Check out the YouTube video, “The Battle for Beverly Hills,” (search using the quotation marks) for the story of the 2008 Hilton project (where the tallest tower was then “only” 18 stories), to see how the current “Garden and Open Space Initiative” echoes the original conflict,

bringing back strong feelings. And now the Hilton is asking for a skyscraper that's even 45% taller, with 26 stories! Depressing!

After all the effort that was made in 2008, after coming so close to stopping the expansion, after absorbing the disappointment of the election loss and the reality of the over-development, it is particularly discouraging now to see this project come back with an even worse plan. The Hilton received an undeserved windfall in 2008, but they're still not satisfied. If they succeed again, not only will we be eternally reminded by the looming skyscraper, but surely Beverly Hills will face an onslaught of real estate developers proposing similar outsize structures.

The Hilton owners present the project as their gracious gift of a garden, even though it could be closed to the public or reconfigured at any time after the election. Those who understand know that combining two buildings into one delivers a massive financial gain. Developers do what they do for profit and camouflage it with an image of generosity. That's why Mayor Mirisch and so many informed residents are urging voters to reject this renewed Hilton expansion.

### “Community program on homeless issues next week” [Issue 863]

Two local papers distributed free every week at our doorsteps. They also arrive to our mailboxes.

Then came the invite. Beverly Hills Weekly sent an invitation, urging its readers “to attend an important panel discussion on the Homeless Issue in our Neighborhoods.” And it was not at the Beverly Hills City Hall, rather at the West Hollywood Auditorium on San Vicente Blvd., across from the Pacific Design Center.

I went not because the word “important” was underlined, rather because it is an issue very close to my heart.

As I walk in the early morning hours, I see the homeless sleeping on the cold pavements, using entrances to closed businesses as their shelters, sitting idly, sometimes smoking, other times talking to some invisible being. If I say “good morning,” this usually elicits a reply, a nod, an acknowledgement. And I keep walking.

West Hollywood Mayor Lauren Meister welcomed those who came to her city, to hear about a regional issue. City boundaries do matter, when one city drives away its homeless, another known to be safer and/or more caring. But otherwise, it is a regional problem, a shame that in America in 2016, in an affluent city-cluster like Los Angeles, there are so many.

L.A. Mayor Eric Garcetti “called for a record \$138 million in the City’s budget to support homeless services, build affordable housing, and work with our County partners to confront our mental

health crisis.” To augment this proposed investment, the California Community Foundation, Conrad N. Hilton Foundation, and Weingart Foundation announced on May 10th they will provide \$16 million in loans and grants to accelerate the production of permanent supporting housing for the homeless in the City of Los Angeles.

So I was particularly interested to learn what Jim Latta, the Beverly Hills Human Services Administrator, his counterpart in West Hollywood, David Giugni, and Captain Holly Perez of the West Hollywood Sheriff’s Department will have to say.

It turned out to be an evening full of surprises.

First, and of lasting impression, was the homeless lady who was having supper at the entrance to the auditorium. This was clearly unplanned, but I was duly impressed. Especially for those gathered, she sat there having a “meal.”

Second, was the greeting, asking me to sign in. The Weekly apparently removed the heading - this was a meeting of the Beverly Hills and West Hollywood Democratic Clubs! A small, seemingly “unimportant” point. Alas, I am glad I was there, a Republican among several dozen “die-hard” Democrats, showing that we care too!

Third, AJ [Willmer] was there, so there were two of us from Beverly Hills. He is an iconic figure, who always cares about our schools and the City and any troublemaking spot possible, and I, Chief Troublemaker as it pertains to Israel and the Jewish people.

The evening was immensely different than all evenings in the City of Beverly Hills. How? WeHo Councilmember Lindsey Horvath came in with a flare. She just arrived from a Lesbian event and was reporting about it to people she knew. That was a reminder that there exists a different world, where “lesbians” (and LGBTQ) are up front and center, a matter of discussion in public events and of interest to major parts of the population. I am not quite sure how or why this should matter to others, but the topics of discussion were definitely different than the ones I am used to hear.

Councilmember Horvath, the moderator for the evening, is a force of nature. Issues that are within the realm of her interest include transpiration and mobility (she is responsible inter alia for West Hollywood being named “The Most Walkable” city in CA) and women’s issues, with a focus on ending violence against women and girls.

Fourth, I was reminded how far we have come in the USA. Not quite 100 years since the 19th Amendment to the US Constitution. In Beverly Hills, the new Police Chief is a very accomplished woman. During the Panel Discussion I was most impressed with Captain Perez of the West Hollywood Sheriff’s Department.

The Captain’s motto is simple: “We are going to get the person help no matter what.” She requires eight hours of mental health mandatory training for anyone interfacing with the homeless population, and she is aiming at increasing it to 40

hours.

She constantly reminds her deputies: “If you lost your compassion, you are in the wrong job.”

And she thinks like a Republican: “I do not think any veteran should be homeless, period!”

Here, Latta pitches in, adding that “homeless vets are great, because they have resources.”

Fifth, if there are dedicated people in Beverly Hills, there are definitely “crazy” people in West Hollywood. One activist told those present of a week he spent sleeping on the streets. I am not sure if it were an experiment or a learning experience, but for me this crosses the line of getting to know a problem.

Sixth, I was extremely impressed with City Staff, both from Beverly Hills and from West Hollywood. With seemingly limited resources (i.e. not endless), they seem to maximize available partnerships (with the private - both commercial and non-profit - sector, and working together with neighboring cities, the county and the federal government) to tackle the issue.

Our own Jim Latta prefaced the evening by saying that “I do [my job] because I am passionate,” and that is exactly the City Staff that I have grown to know and respect over the decades. Properly (and proudly) representing the City of Beverly Hills!

Indeed, my mind wandered, as the evening was overwhelming. Democrats! And I stayed only for the Homeless Panel

- they still had a full evening ahead.

The invitation (extended and/or publicized) by the Weekly must be reciprocated. A similar evening in Beverly Hills. For instance, at City Hall, City Gallery or the Library.

This multi-city panel discussion and gathering serves as a reminder that we face problems and issues that are regional in nature, like water, disasters, homelessness, traffic, etc. And that we need to work together. The COG (Council of Governments) is indeed one way. Cooperation at Staff level is another. And yet another is bringing people together, at opportunities such as this.

Some homeless people are mentally ill or suffer from substance abuse. Most of the time, individuals do not want help, and when a short window of opportunity opens and they do, and are willing to get off the street, “we are not there.” It is important to engage, to know the individuals, to map the ground, and to utilize available resources to the maximum, in a most creative and collaborative way.

I left the evening overwhelmed, likely because of all the smells and sounds to which I am not accustomed. But in the back of my mind a lasting image, the clear realization that a lot of work is being invested into the homeless issue, for the homeless are first and foremost people, too.

accepted a bid from Master Ironworks for a \$40,000 stainless steel fence. An additional \$7,500 was tacked on for footings.

At the April 27th Recreation & Parks Commission meeting, Recreation Services Manager Brad Meyerowitz announced that the restoration is slated for completion this week. The fence will be installed by the end of May.

"Right before the summer crunch," Meyerowitz said.

Kusama's trio of polka-dotted, fiberglass tulips began showing cracks and scratches a few years after their September

2007 installation.

The new enclosure, characterized by curved metal arms and stainless steel cabling, will replace the bright green fence that currently surrounds the sculpture.

## Beverly High abatement, demolition increases to \$2.1 million

The abatement and demolition of Beverly High buildings B1, B2 and B3 will cost more than \$2.1 million, which far exceeds

the original \$1.5-million estimation.

At Tuesday's meeting, the Board of Education approved a \$2.16-million agreement with full-service environmental contractor American Integrated. The BHUSD received a second bid totaling \$3.2 million.

The extra \$600,000 was tacked on to cover the cost of school administrative safety requirements, according to the staff report.

"One of the bigger costs is how the logistics and the movement of the contractor onsite was going to occur," said Totum Consulting's Rick Panos. "There are areas where kids are crossing where there could be construction traffic, and the way we solve that is by putting in flagmen specifically at that site, full-time, so as traffic happens they're there to be able to stop traffic as kids are crossing."

The Board approved Phase 1 of the Measure E modernization program in February.

Included in the plans is the modernization of buildings B1, B2 and B3 at Beverly High, which entails the demolition and abatement of all three structures.

Beverly

High's Building B is divided into four areas: B1, domestic sciences; B2, old classrooms; B3, the KL Peters Auditorium; and B4, the Salter wing (Performing Arts).

Construction is scheduled to break ground June 1 and end in late November.

## Kusama fencing, restoration to be completed end of May

The process of fencing Yayoi Kusama's *Hymn of Life: Tulips* sculpture at Beverly Gardens Park has been a lengthy and intricate one often bemoaned by Fine Art and Recreation & Parks Commissioners.

"For a year we have not had the designer show up one time to have a conversation with anybody," Fine Art Commission Vice Chair Alan Kaye said last May.

Last December, more than a year into the discussion, the Fine Art Commission

## Intermittent Lane Closures to Take Place on S.M. Blvd. for Three Weeks

In preparation for the North Santa Monica Boulevard Reconstruction project, exploratory work will take place to verify and locate existing utilities under the roadway.

Beginning Sat. May 14 and continuing for approx. three weeks, one traffic lane will be closed intermittently:

- ▶ From Wilshire Boulevard to Rexford Drive:  
Sat. and Sun., 8 a.m. to 6 p.m.
- ▶ From Rexford Drive to Doheny Drive:  
Mon. – Fri., 9 a.m. to 4 p.m.  
Sat. and Sun., 8 a.m. to 6 p.m.

Construction is scheduled to begin in late summer and will rebuild the roadway between Doheny Drive and Wilshire Boulevard. The design includes "green street" drainage, decorative street lights, drought tolerant landscaping and widening on the south side between Canon Drive and Wilshire Boulevard.

### Mending Hawthorne "dome issues" to cost \$500K

At Tuesday's meeting, the Board of Education gave direction to design firm DLR Group to undertake the seismic and historic rehabilitation of the Hawthorne clock tower, a \$500,000 project.

The Hawthorne cupola was taken down last October amid news that a five-year-old beehive packed with around 40,000 bees

had been discovered inside the small dome.

Then-Board member Lewis Hall claimed there was "nothing" attaching the 4,500-pound cupola to its base.

But several Hawthorne parents, including former PTA President Lorraine Eastman, challenged Hall's statements.

"However they affixed it back in the day was quite strong," Eastman said. "That thing was not going to be falling off anytime soon."

In a 69-page report, DLR Group summarized its recommendations for the project, which include removing the loose tiles, performing a final survey to assess any hidden areas of damage or deterioration and repairing or replacing deteriorated elements with a lightweight material.

The project involves replacing the decorative "cut" stone with lightweight duplicate fiberglass reinforced panels.

The Hawthorne cupola dates back to the 1920s, when the school was first built.

### Traffic & Parking rejects North Canon petition

Eleven of the 16 family homes on the 500 block of North Canon Drive endorsed a petition in February to prohibit non-permit parking on the block daily from 8 p.m. to 2:30 a.m.

The current parking regulation permits two hours of parking from 8 a.m. to 8 p.m. Mondays through Saturdays.

"I'm really concerned that we are set-

ting a precedent for north of Santa Monica [Blvd], and I think that we've got to do this slowly in steps," said Commissioner Lester Friedman.

According to a parking occupancy survey conducted by staff in March, on average, 30 of the 66 spaces on the block were occupied during the 14-hour survey period.

Friedman, Vice Chair David Seidel and

Commissioner Andy Licht rejected the resident-initiated request, prevailing over Commissioners Jake Manaster and Nooshin Meshkaty.

With a 3-2 vote, the Commission instead supported a test program proposed by city staff members that allows two hours of parking 8 a.m. to 8 p.m. Mondays through

Saturdays and prohibits non-permit parking from 8 p.m. to 2:30 a.m. daily.

"I do believe it solves the problem, or certainly addresses it," Licht said.

The Commission expects to come before the City Council in early June to discuss the initiative.

### Intermittent lane closures to take place on Santa Monica Blvd. for three weeks

In preparation for the North Santa Monica Boulevard Reconstruction project, a City contractor will be performing exploratory work along the street to verify and locate existing utilities under the roadway. Beginning Sat. May 14 and continuing for three weeks, one traffic lane will be closed intermittently to allow for this exploratory work.

Lane closures will be limited to one lane in one direction (eastbound or westbound)

at a time. Lane closures between Wilshire Boulevard and Rexford Drive will occur Saturdays and Sundays, from 8 a.m. to 6 p.m. Lane closures between Rexford and Doheny drives will occur Monday to Friday, between 9 a.m. and 4 p.m. and/or weekends from 8 a.m. to 6 p.m.

The North Santa Monica Boulevard Reconstruction project is scheduled to break ground late this summer. The project will completely rebuild the roadway between Doheny Drive and Wilshire Boulevard. The project design includes "green street" drainage, new decorative street lights, drought tolerant landscaping and widening a portion of the roadway on the south side between Canon Drive and Wilshire Boulevard.

## Darrell Miller Beverly Hills Bar Association's Entertainment Lawyer of the Year

**Why do you think you were chosen to be honored?**

I think, from what I picked up, is that I have demonstrated a consistency over a number of years of working at the cutting edge of my industry. [I have been] thinking beyond the box and finding ways for clients to maximize their careers and their opportunities, even in the face of the monumental change that has occurred over the past 25 years that I've been in the business. way that we did 25, 26 years ago. I read an extraordinary statistic that was presented by a number of music experts that said for the

first half of 2015, 70 percent of all revenues in the record business was generated by streaming. It's unbelievable for a technology that didn't even exist 25 years ago. The idea of what we knew as music, what we knew as broadcast television and what we knew as the motion-picture experience has all been flipped upside down.

**How did you get involved with the BHBA?**

I've been a member of the BHBA for as long as I've been in the profession. It's the bar association that is closest to the entertainment world. I've always looked at the [BHBA] as a good source of networking, continuing education courses and a good opportunity to be among those who are serious about this business.

## BHHS Swimmer Wins Two Individual League Titles Norman boys' tennis team begins playoffs

Amy Okada won the 200-yard freestyle and 100 butterfly, setting meet records both times, and swam the opening leg on Beverly High's victorious 400 freestyle relay team in the Ocean League girls' swimming finals Friday at the Swim-Gym.

Okada won the 200 freestyle in one minute, 50.59 seconds, 4.48 seconds ahead of runner-up Bridgette Allison of El Segundo. The previous record was 1:52.71, set in 2007 by Mattea Perrota of El Segundo.

Okada, who has signed a letter of intent to accept an athletic scholarship from UCLA, won the 100 butterfly in 55.85, 8.6 seconds ahead of the second-place finisher, Culver City freshman Natalie Smith. Okada had set the previous record, 56.96 in 2014.

The team of Okada, freshman Eugene Chi, sophomore Jamie Kim and senior Skylar Smith won the 400 freestyle relay in 3:48.08, 0.9 of a second ahead of second-place Santa Monica.

Okada swam her leg in 52.08, giving the Normans a 3.18-second lead over El Segundo, which finished second, and a 4.06-second lead over Santa Monica.

Okada also swam a leg on Beverly Hills

200 medley relay team that finished second in 1:55.62, 1.33 seconds behind Santa Monica.

The Normans were last in the four-team race, 9.47 seconds behind Santa Monica, when Okada began her leg. Her 24.42 split put Beverly Hills in second, 2.5 seconds behind Santa Monica.

Junior Fritzi De La Pena, Chi and junior Jacqueline Dumouchel swam the other legs.

The Normans were third in the team scoring with 297 points. Santa Monica won with 453, El Segundo was second with 315 and Culver City fourth with 255.

### What's Next?

The Norman boys' and girls' teams are scheduled to compete in the Southern Section Division 3 finals today at the Riverside Aquatics Complex at Riverside City College beginning at 5 p.m.

## BOARD OF EDUCATION, TEACHER'S UNION CLASH

**Class size dispute between faculty and Board dominates Tuesday's meeting**

Tuesday night's Board of Education meeting underscored an ongoing dispute between the BHUSD and teachers about class size and salaries.

Speaking to a packed room, BHEA President Telly Tse kicked off the public comment period, which spanned 70 minutes.

"There's a part of us that feels that the Board and the district agreeing on permits and class size this year—and now backing away from those agreements—is part of an attempt to regain leverage for next year," Tse said.

In an email last week, the BHEA slammed the Board and the district for backing out of agreements pertaining to class size and employee permits during an April 29th certificated bargaining session.

The BHEA suggested the move was a calculated attempt to wipe out a salary formula developed by former Board member Brian Goldberg.

Recently, certain Board members have indicated that the salary formula is financially unstable and might drive the district deeper into deficit spending.

Several hours before Tuesday's meeting, Superintendent Steve Kessler addressed the class size debate in an email to district families.

"On March 29, the Board of Education revised Board Policy to limit K-3 class size to no more than 23 students," Kessler said in the email. "To be clear, this is not a grade or district average, but rather, 23 students are the maximum number of students

that may be placed in any given K-3 class."

But the BHEA maintains that the Board's interpretation of the contract means K-3 class sizes can reach an average of 29:1.

"Which means that those classrooms can potentially have more than 29 students each," Tse said. "Currently, in the contract, one classroom can have 29 and another can have 20."

In addition to their BHEA tees, teachers sported badges emblazoned with "20:1" at Tuesday's meeting.

"20:1 refers to what is currently in the contract," Tse said. "In the agreement that we have, classrooms would be at 20:1, unless every single classroom for K-3 is at 20. Once they're all at 20, then we can look at going to 21 or more. So it's a matter of keeping class sizes small, but also keeping them equitable."

In his email, Kessler pointed out that the majority of K-3 classes in the district have less than 20 students, and only one K-3 class has 21 students.

But Kessler's words did not appear to placate Tse.

"If the district is really interested in keeping class sizes small, they should honor this agreement, because it puts it in writing and it guarantees the small class sizes that parents and teachers and the community want," Tse said.

The current collective bargaining agreement ends in 2017. The salary formula continues indefinitely until BHUSD teachers are the highest paid teachers in Los Angeles County.

## THE SKY-HIGH COST OF THE HILTON TOWER

**Campaign expenses reach \$1.6 million in three months**

From January 1 to March 31, the Beverly Hills Garden & Open Space Initiative spent \$1.6 million on campaign expenses, documents show.

The initiative would result in the city's first-ever skyscraper, a 375-foot residential tower planned for Santa Monica Boulevard and Merv

Griffin Way.

A 35-page campaign disclosure form for the project reveals over \$135,000 was paid to public relations firms (see chart below) in the three-month period.

The project paid \$75,000 to various media outlets, including the *Beverly Hills Courier*. The largest sum, \$51,850, was paid to Iranian broadcast radio station KIRN.

American International Business, a company founded by former Beverly Hills Mayor Jimmy Delshad, received \$8,000. Other Beverly Hills residents who received payments include Susan Berk, through her company Community Resource Partners, and Soraya Nazarian.

The project paid Winner & Mandabach, a political consulting firm that specializes in ballot measure campaigns, roughly \$164,000. Canvassing firm Field Works received around \$65,000.

Helmed by developer Beny Alagem, the project recently filed over 7,000 petition signatures; 3,600 valid signatures are needed to place the initiative on the November 8th ballot.

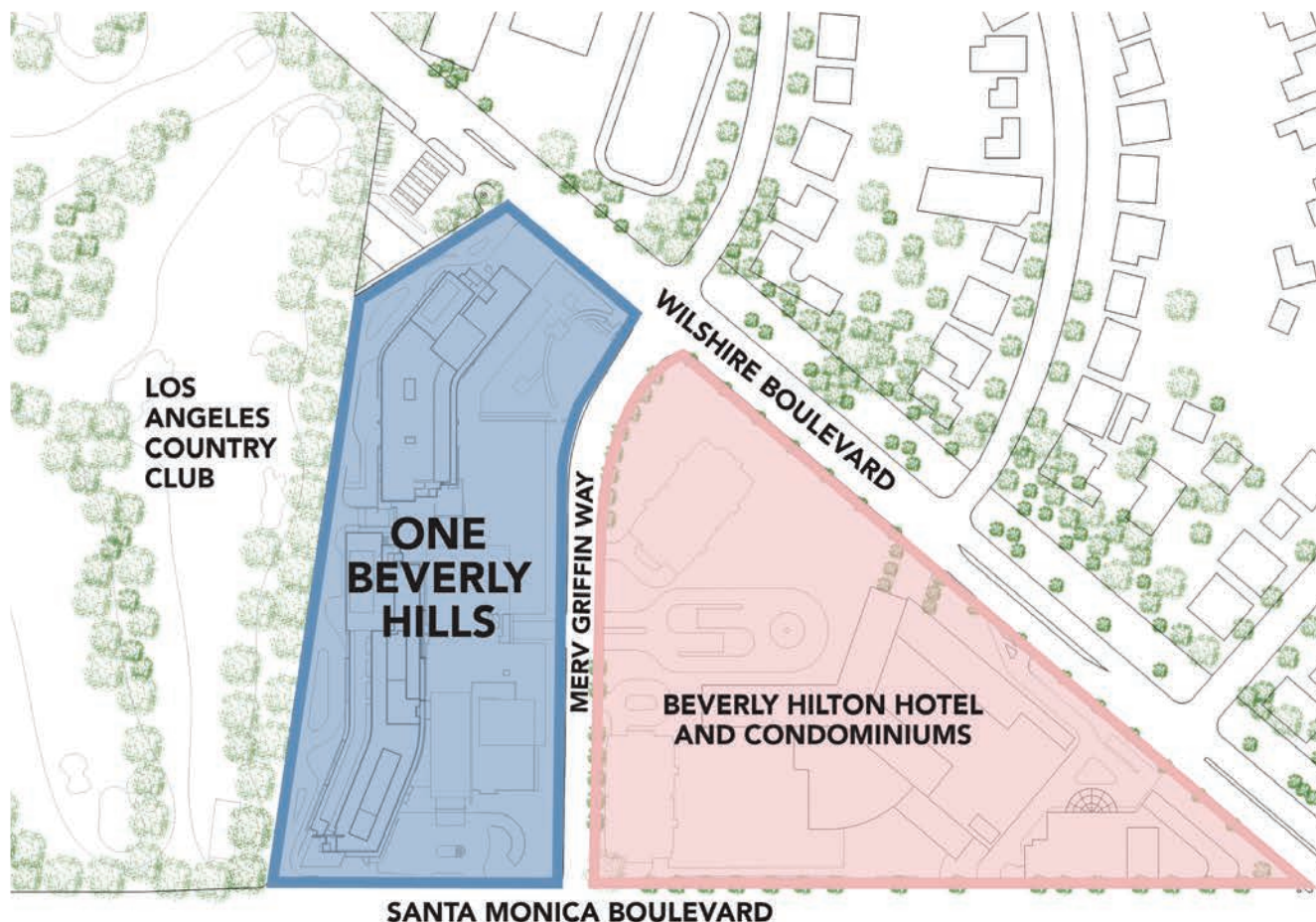
