were just dramatically there,” Gordon said.

The Harry Joe Brown Estate, the residence formerly on the site, was demolished in late 2014 after a 2-2 vote by the Cultural Heritage Commission failed to qualify it for landmark designation. Cultural Heritage Commissioner Noah Fuhrie, whose sister-in-law owned the property, had to recuse himself from the discussion, resulting in a four-person decision.

If pushed forward by the Council, the new building would be constructed on a parcel of land totaling 53,360 square feet, or 1.225 acres.

A tennis court, which is included in the plans, is a common fixture in the Mountain Drive neighborhood.

“The architectural style is beautiful and I wish you the best of luck,” said Chair Alan Robert Block.

Vice Chair Farshid Joe Shooshani also praised the design, the work of Ruard Vietnam Architecture Incorporated.

## Community remembers Akhlaghi

The Beverly Hills flag was flown at half-staff Sunday in honor of Tanaz Akhlaghi, who passed away from pancreatic cancer that morning.

Diagnosed last year, Akhlaghi embarked on a perilous journey to heal her body of stage 4 pancreatic cancer, which she detailed in her blog: [www.teamtanaz.com](http://www.teamtanaz.com). She underwent numerous cancer treatments surrounded by her brothers, parents and fiancée.

A realtor with Partners Trust, Akhlaghi grew up in Los Angeles but called Beverly Hills home for the past 19 years. She graduated from California State University,

Northridge in 1995 with degrees in communications and journalism.

Akhlaghi is survived by her parents; brothers John and Saman; and fiancée Brian Ayala.

Over the past several months, the community donated more than \$235,000 to help cover the cost of Akhlaghi’s medical treatments and medications. Akhlaghi requested no flowers and instead asked that donations be made to her Team Tanaz fund.

The memorial will be held Thursday at 6:30 p.m. at Temple Emanuel.

## Beverly Hills Auto Collection owes CA more than \$680K

According to a list published by the Board of Equalization (BOE) June 2, Beverly Hills Auto Collection ranked among the top 500 largest delinquent sales and use tax accounts in California.

The business, located at 207 South Robertson Boulevard, owes \$684,360. Together, the businesses and individuals listed owe \$449 million.

Since the inception of the program in 2007, roughly \$16 million has been collected from 217 taxpayers. The list is updated every quarter.

## Traffic & Parking OKs three new locations for bike-share pilot program

The Traffic & Parking Commission supported expanding the Beverly Hills bike-share pilot program to three additional locations at their meeting last Thursday.

Launched May 10, the program currently has 30 bicycles in circulation and seven founding, eight monthly and 107 pay-as-you-go users. Founding members pay \$99 annually, monthly users pay \$25 and pay-as-you-go users are charged \$6 per hour.



The Commission supported the addition of 12 racks at the northeast corner of Wilshire Boulevard and South Santa Monica Boulevard; nine racks at the La Cienega tennis center; and five racks at Will Rogers Park.

Six bicycle racks were proposed for placement in front of a bench at Roxbury Park, which the Commission opposed, despite supporting the location.

“I think it’s important to have bikes available at Roxbury Park—it is a destination,” said Vice Chair David Seidel.

Bicycle riding is prohibited at the park.

“I don’t have a particular problem with that site but for the fact that it encourages bike riding in the park, which is not allowed,” said Commissioner Lester Friedman.

The Commission is expected to refine plans for the Roxbury Park bicycle racks at a later date.

The addition of a docking station at the northeast corner of Wilshire Boulevard and Robertson Boulevard did not receive backing from the Commission.

Existing station locations include City Hall and the courthouse on Burton Way.

## Dakota to rock Concerts on Canon next week

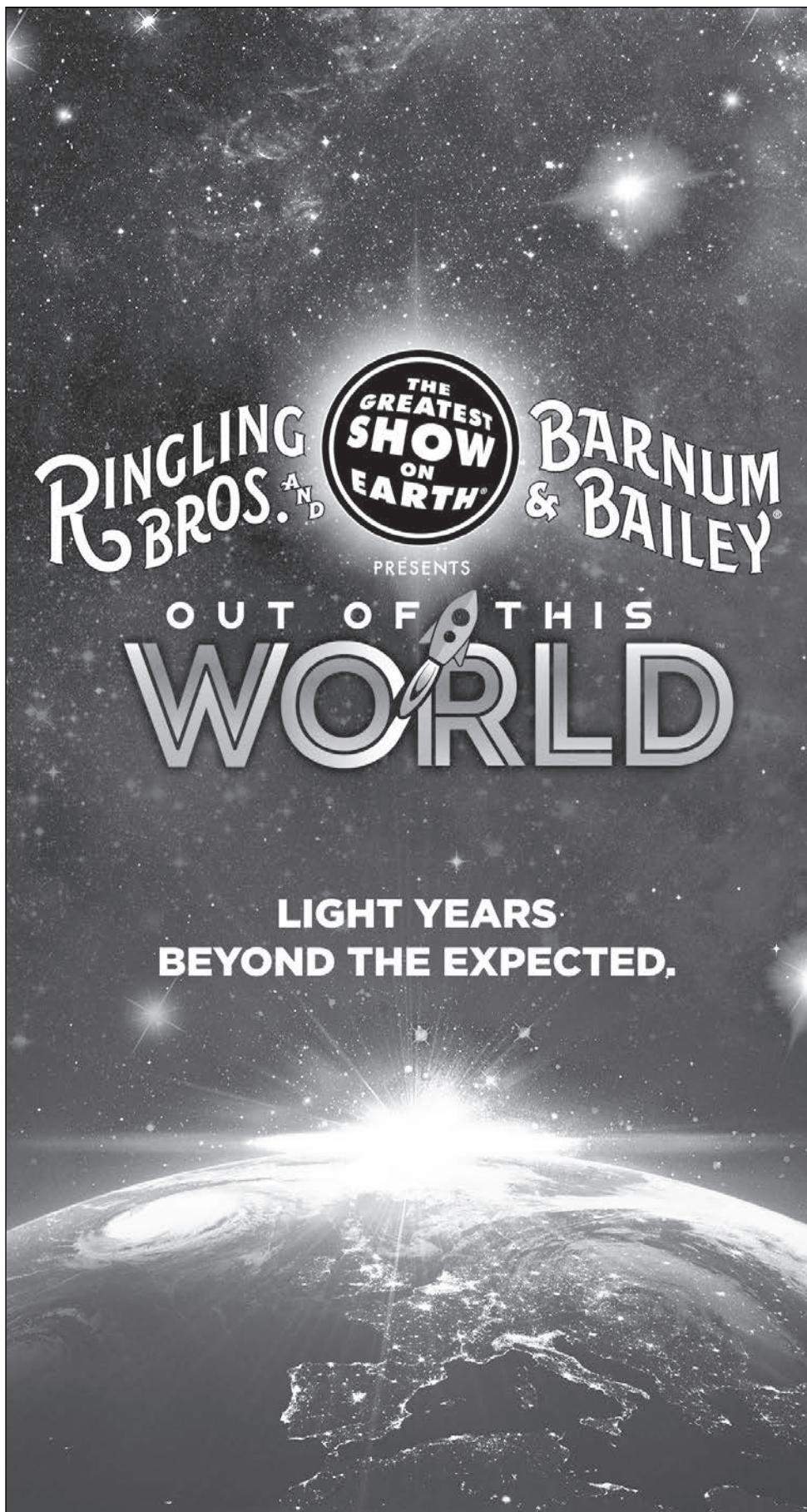
Acoustic rock band Dakota will bring classic rock from the 1960s and 70s to Concerts on Canon June 16.

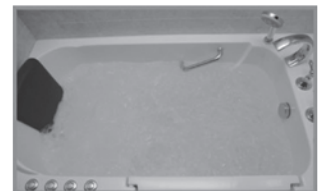

## Hypocrisy, Thy Name is “Hilton” By John A. Mirisch

As described in an earlier article, the Beverly Hilton, in what they are calling a “reconfiguration” of a project which won a referendum by 129 votes in an election with 569 documented cases of voter fraud, is using a California initiative loophole to try to build a 375-foot skyscraper in a city with a 45-foot height limit.

While some of the false claims made by the signature gatherers of the skyscraper initiative very clearly attempted to give new horizons to the meaning of the word *chutzpah*, a recent development (no pun intended) also adds *hypocrisy* with a capital “H” to the mix.

As noted before, the use of the initiative process means that the Hilton, in their efforts to build the 375-foot skyscraper, doesn’t need to go through any of the reviews or public processes which would normally be required for any construction project, let alone a project of this magnitude.

While the Hilton is exploiting the initiative process to scrupulously avoid all municipal scrutiny, including environmental reviews, their neighbor to the west, on the site of the old Robinsons May, is also requesting a modification to its original entitlement. The project, owned by the Wanda Group, and known as One Beverly Hills, is seeking to convert some of the condos of the already entitled Richard Meier designed project to hotel rooms, not to add bulk, mass and height to the project like the Hilton. Playing the

role of the good twin, One Beverly Hills is going through the City’s standard process, which includes various reviews, a supplemental environmental impact report and the ability of the public to raise concerns.

Despite disingenuous protestations to the contrary, the Hilton is trying to use the public planning process

and the California Environmental Quality Act (CEQA) to stop the hotel project — and the competition — next door. In a 21-page letter to the City’s planning department, the Hilton raises a number of concerns and objections related to the One Beverly Hills hotel modification.

I can’t comment on the specifics of the Hilton’s objections at this stage.

There is a process

and those objections will be considered and addressed. But I sure will point out the utter irony in the Hilton’s use of the public process which they themselves are denying everyone else in connection with their own project.

With apologies to Gore Vidal, they have given hypocrisy a bad name.

Or maybe it’s not hypocrisy? Perhaps they are subtly trying to convince the One Beverly Hills folks to come over to the Dark Side. Their utzing message would seem to be: “Hey, why bother go through the pesky review process when you could completely circumvent it with an initiative? Drop the application, buy signatures like we did, and come join us with ‘the Hilton Way’ in the fabulous world of ‘Anything Goes’ development.

“Heck, you can even use our argu-

ment that we already went through numerous public meetings. You did, too! In fact, the changes you’re looking for might even be seen as less drastic than our own. We’re looking to build a 375-foot skyscraper in place of two buildings, adding bulk and mass to our project, reducing the amount of water we recycle and adding outdoor meeting spaces while you’re just looking to convert a few condos to hotel rooms.”

Now we can’t know for sure if the Hilton really is trying to win recruits for the Hilton school of development or just wants to make a little mischief. And in fairness to the Hilton, it should be noted

that there are a few other parties who are trying to jump on the Hypocrisy bandwagon.

For example, in addition to a mystery objector, who had 87 pages worth of objections sent in anonymously, we have a couple of homeowner associations in Westwood who are expressing concerns about the project. These are the same moral authorities who expressed zero concern with the potential issues Metro’s tunneling under our High School could create. They’re clearly not concerned at all about our kids and they went to great lengths in the past to prove it, ignoring both logic and decency, not to mention the facts. They’ve been bought off by developers before, so maybe they’re just looking for another payday now. Whatever their motivation, you gotta give such bad neighbors credit for such a healthy sense of ego. One sometimes can just shake one’s head...

We also received a letter from LA Councilmember Paul Koretz. It’s difficult to say whether he raised objections to placate those homeowner groups — hey, it’s a lot easier to object to development in another city than in one’s own district, isn’t it? Who knows, he may have even been put up to it by lobbyists doing the Hilton’s bidding. The Hilton tried that ploy in WeHo, with their lobbyist having in fact drafted a letter ready for the signature of the WeHo mayor,

who wasn’t about to be tricked.

Whatever the origin of Councilmember Koretz’s letter, we should remember that this is the same guy who ignored our own concerns when the Century City North Specific Plan was violated to create

significant traffic on behalf of a favored developer. This is the same guy who allowed a 40+ story skyscraper to be built directly next to the High School and whose concern for our kids is only matched in its absence by former county supervisor Zev Yaroslavsky. While it’s true the pay-to-play nature of urban planning and

development in LA might be considered to be extenuating circumstances, this is Beverly Hills, not LA, and certainly not Chinatown.

There are enough heapin’ helpings of hypocrisy to go around, but the Hilton itself definitely does take the first prize. Perhaps we should call that prize “the Con-rad.” They are availing themselves of a public planning process to object to a neighboring development, while they are denying everyone else the same opportunity in connection with their own scheme to build a skyscraper which is 70 feet higher than the Statue of Liberty (including the base) and over double the height of the highest building in Beverly Hills (or Niagara Falls for that matter).

Just another reason for the voters of Beverly Hills to reject a project which has already been described by some as “the Skyscraper of Greed” when it comes to the ballot later this year.

To paraphrase the incomparable Vin Scully: so when people write the name Hilton in capital letters in the history books of overdevelopment, that “H” stands out even more than the I-L-T-O-N. The H in “Hilton” stands for “Hypocrisy.”

## BHHS pole vaulter narrowly misses school record in state meet

Amanda Block, who graduated from Beverly High May 27, finished 16th in Friday's girls' pole vault preliminaries at the 98th annual CIF State Track and Field championships at Buchanan High School in Clovis.

Block was among 10 vaulters who cleared 12 feet, but were eliminated by missing three times at the next height, 12-6. Block was placed 16th because she had the most misses among the 10 vaulters.

Block said she was a "millimeter away" from clearing 12-6 on her final vault.

Block cleared the opening height, 11-6, on her second attempt, and the next height, 12-0, on her third.

The prelims reduced the initial field of 25 vaulters to nine for Saturday's finals. Anaheim Canyon junior Rachel Baxter cleared 14-2 to win.

Block said "it was very fun" to compete in the state meet.

"I got to see a lot of really great athletes running," said Block, who plans to continue competing at Brown University, which like all Ivy League schools does not offer athletic scholarships.

"It was great to jump with really great athletes."

Clearing 12 feet was 1 inch off the school record Block had set a week earlier in finishing sixth in the Southern Section Masters meet that qualified her for the state meet.

## BOARD SUPPORTS HIRING EIGHT NEW SPECIALISTS

Commits to \$1.1 million package

At Tuesday's budget study session, the Board of Education supported the implementation of a K-12 intervention program, a \$1.1 million undertaking that entails hiring four K-5 reading specialists and four K-5 math specialists.

Both Board Vice President Mel Spitz and Board member Lisa Korbatov strongly advocated for the addition of math specialists.

"It increases the cost but it's essential," Spitz said.

One full-time specialist costs \$100,000, meaning the cost of hiring eight totals \$800,000.

According to the staff report, the intervention program is intended to "support all learners in accessing grade-level curriculum."

Approximately 25 to 30 percent of district students did not demonstrate proficiency on the 2014-2015 CAASPP (California Assessment of Student Performance and Progress). The intervention program aims to provide "effective interventions for all of these students, grades K-8."

Seated in the audience, all five district principals seemed to back the roughly \$1.1-million package.

"There's a lot that we can't do

because we are going to do this," Board member Noah Margo said. "What my

question is: Do you feel that this is the most effective place to put our money?"

Though supportive of the addition, Margo expressed concern that the specialists might act as "crutches" for the district's general education teachers.

Each K-8 school will

receive a full-time instructional aide that will assist in implementing the program. The specialists will oversee a data-driven Response to Intervention (RtI) program that includes initial assessment data and progress monitoring throughout the year.

"What we have to look at, more than anything else, is what's going on in those classrooms as far as math instruction and how do we improve it?" Margo said.

Later, the Board supported reinstating two technology teachers, a \$240,000 addition.

Chief Administrative Officer La Tanya Kirk-Carter estimates that the general fund currently contains \$976,000 in unassigned funds.

"We still have a lot of heavy lifting to do in the next few years," Kirk-Carter said.

## NEW COUNCIL, NEW PRIORITIES

El Rodeo Scout House, RDC budget among discussion topics

Newly appointed City Councilmember Kathy Reims was officially sworn in at the start of Tuesday's study session.

Deliberation of storage options for the El Rodeo Scout House exceeded an hour and ended with the decision to discuss the matter with the Board of Education at the next Joint Powers Agreement (JPA) meeting.

"I think [the Horace Mann campus] would be a good solution—there's going to be parking, it's on the site of where there used to be a historic scout house, it's a site with kids, it just seems to fit in," said Mayor John Mirisch.

Approximately \$49,000 has been raised so far to assist with the move.

The Council later approved the Rodeo Drive Committee's \$1 million funding request for Fiscal Year 2016/17.

The budget, equivalent to the amount assigned last year, includes \$60,000 for a new marketing platform called *LIVE! From Rodeo Drive*, a series of entertainment segments that will be filmed during awards season (see chart below).

"Hundreds of members from the media flock to L.A. each year during awards seasons and many need a well-located, visu-

ally rich location where they can shoot segments focusing on celebrities and red carpet fashion leading up to the ceremonies and we plan to feature Rodeo Drive as that backdrop," said Rodeo Drive Committee President Mark Tronstein.

Other changes include adding \$75,000 to the Holiday Décor & Lighting Ceremony budget and carrying over \$122,498 in leftover funds to the Walk of Style budget.

Due to the unexpected passing of Donahue Group CEO Craig Donahue in March 2015, the Rodeo Drive Committee suspended some of its Fiscal Year 2014-15 programs, including Walk of Style.

Founded in 1972, the Rodeo Drive Committee is a volunteer-based organization that promotes Rodeo Drive through

a variety of programs that enhance the street's image as a world-wide destination.

The Council's next study session and formal meeting are scheduled for June 21.

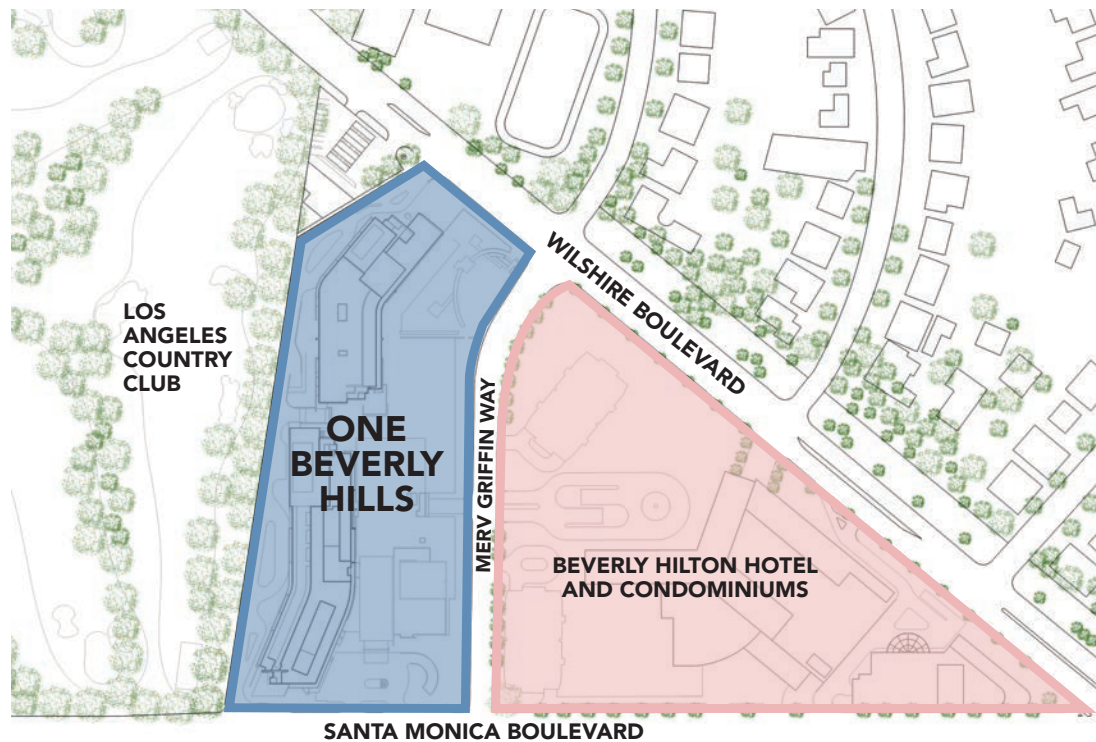

# Clearing up the Confusion

## How **One Beverly Hills** and *The Beverly Hilton Initiative* are different



In June 2015, One Beverly Hills filed an application with the City of Beverly Hills to modify its already-approved entitlements. The proposed plan removes 5 floors of condominiums and replaces them with a 134-room boutique luxury hotel. There will be no change in the project's height or density. One Beverly Hills is going through the City's required environmental review, public hearings and public comment process including full compliance with the California Environmental Quality Act.

*In May 2016, the owners of The Beverly Hilton submitted signatures for The Beverly Hilton Initiative, which would also modify its already-approved entitlements. The Beverly Hilton's plan is to move their already-entitled 8-story condominium building on Wilshire Boulevard and place it on top of their already-entitled 18-story condominium building on Santa Monica Boulevard, creating a new 26-story, 375-foot condominium tower. This initiative seeks to avoid the City's environmental review process and approvals and have the matter be decided by the voters of Beverly Hills without an Environmental Impact Report (including any traffic analysis) and without any review and approval by City staff, the Planning Commission and the City Council.*
