BHUSD deficit spending continues as parents petition to save 23 teachers

An online petition, started by BHUSD parents, is asking Superintendent Michael Bregy and the Board of Education to “cancel the 23 proposed [Beverly Hills] teachers’ terminations.”

“Due to budget cuts, last week the [Board and Bregy] sent ‘pink slips,’ a notice of dismissal from employment, to 23 among of the highest performing teachers in the [BHUSD],” the online petition states. “These lay-offs were determined by seniority with individuals being affected by the cut of important programs. We aren’t just losing the great teachers - we are losing the programs that they teach!”

The creation of the petition follows a highly contentious Board meeting on March 14 where a number of confrontational parents, teachers and students spoke out against the Board’s decision to issue 23 pink slips.

At the meeting, Board member Noah Margo suggested this is an issue that concerned residents should take up with the state.

“Neither the Board nor our administra-

tion can get around state law,” Margo said. “The administration can’t handpick the staff that gets noticed. The seniority list dictates this. What dictates the seniority list? Tenure. We don’t dictate tenure laws. The state does.”

The following day, the Beverly Hills Education Association posted a statement to its public Facebook page denouncing Margo’s comments:

“BHEA rejects this position. First of all, teachers do not have tenure. We have due process. If due process and other protections did not exist for teachers, then perhaps layoffs won’t always affect our youngest and newest educators. [Attacking] due process as the problem and making the layoff of 23 teachers about being able to change who should be laid off avoids the real issue, which is there should be no layoffs at all.”

Layoffs are generally done in inverse seniority, by credential area, with some exceptions.

The online petition was also posted to BHEA’s Facebook page the next week.

BHEA President Telly Tse explained to *the Weekly* that although student enrollment has consistently decreased since 2009, staffing levels have essentially remained the same. He also indicated staffing at each of the K-8 schools is higher today than it was in 2009-10.

“The problem for us is that what they are saying and the actions they are taking

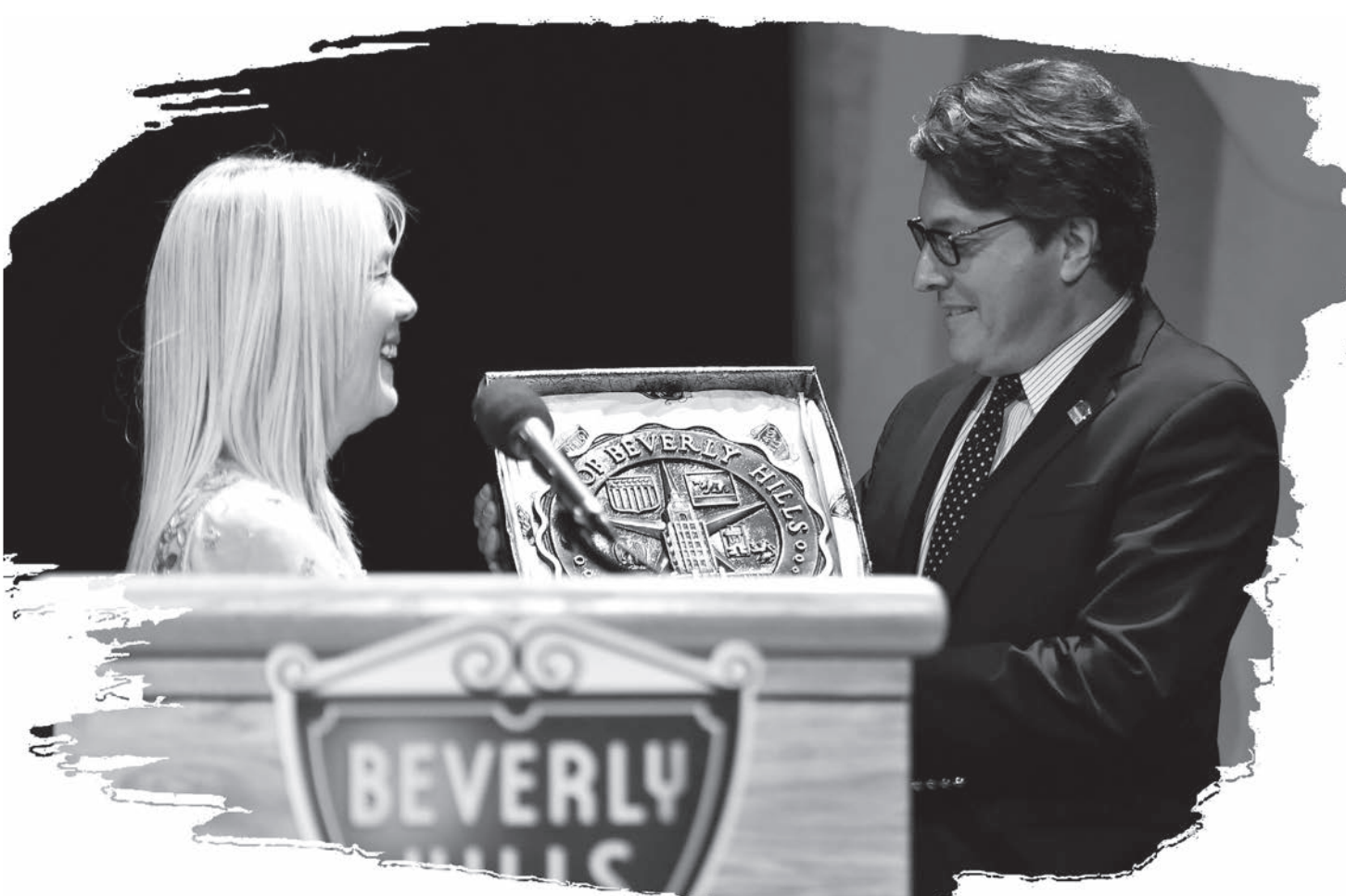

are not consistent,” Tse said. “In the last couple years, [the Board] has been hiring new teachers to replace teachers [who are] retiring. That is a sign of not having a strategic long-term plan.”

Tse also criticized Bregy’s proposal to create a Director of Communication position within the administration and suggested that staffing can be decreased through attrition of retiring teachers.

“[Bregy] wants to expand administration while reducing staffing. Instead of issuing layoffs, [the Board and the administration] can start next year by offering something more to get the staffing down in a way that’s voluntary.”

The BHUSD continues deficit spending by over \$4 million annually. It is the only basic aid district with a salary formula. Basic aid districts keep the money from local property taxes and receive constitutionally guaranteed state funding. The district is not paid per pupil.

Board President Mel Spitz noted that the district is experiencing a “structural deficit” because it is locked into expenses that exceed revenue. The salary formula determines the percentage of increases in property tax revenue that goes into salaries.

An unusual clause in the contract, signed by the previous Board, only allows the formula to expire once every teacher is the highest paid teacher in the county.

“[The salary formula] is one of the major contributors to our financial problem,” Spitz said. “It’s very unfair to the

district.”

Spitz also explained where some of the overall problems lie. The benefits teachers receive and the portion of retirement funds that the district pays for were not figured into the formula. In addition, when property taxes decrease there is not a decrease in the salaries.

“The district is in a position to not have the funds for previous salary increases,” Spitz said.

Disputed Beverly Vista PTA election to be held again

An invalidated PTA election on Tuesday at Beverly Vista has generated controversy.

The dispute originally began when the executive board slate was voided as a result of concerns brought forward by PTA members to the 33rd District, which is the governing body of local PTAs and councils in the designated district.

According to 2016-17 Executive Board member Don Rosen, the PTA has always selected its nomination committee by random draw. Names are chosen out of a hat. Rosen said the group was unaware this violated 33rd

District’s bylaws, which state a separate election is needed to select members of the nomination committee, who are responsible for interviewing applicants and creating the slate.

An email sent from Beverly Vista Green Tree News stated the slate was voided due to an “issue with parliamentary order”:

“Due to an issue with parliamentary order at the Jan. 10 PTA meeting, we

regret that the executive board slate presented at the Feb. 21 PTA meeting must be voided. Therefore, at present there is no executive board slate for the 2017-18 school year and all candidates will be nominated from the floor, discussed and voted on by the general membership at the March 28 meeting,” the newsletter read.

The PTA Council and 33rd District sent representatives to Tuesday’s election. Incumbent Vice President April Jergens and Cynthia Park nominated themselves from the floor for president.

Park explained to *the Weekly*, after ballots were tallied, the majority of votes appeared to be in her favor. Twenty

NOTICE OF PUBLIC HEARING

The Council of the City of Beverly Hills, at its regular meeting to be held on **Tuesday, April 4, at 7:00 p.m., or as soon thereafter as the matter may be heard**, in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING TEMPORARY BUSINESS SIGNAGE DURING SUBWAY CONSTRUCTION

The proposed Ordinance would add §10-4-615 to the Beverly Hills Municipal Code in order to allow certain businesses along Wilshire Boulevard to request additional temporary signage during the construction of the Westside Purple Line Extension project. A business that is entitled to business identification signage under the existing code may request additional signage if the construction obstructs the visibility of a substantial portion of the property or building entrance where the business is located. The Ordinance references design guidelines for signage approved pursuant to the new code section. Details of the design guidelines will also be considered by the City Council at this hearing. The guidelines will establish the size and location of signs allowed pursuant to the new zoning code.

This ordinance was assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. This ordinance temporarily allows some additional business signage to mitigate impacts on businesses affected by subway construction. This temporary business signage will not result in a substantial or potentially substantial adverse change in the environment. It can therefore be seen with certainty that there is no possibility that the proposed ordinance may have a significant effect on the environment. Accordingly, the City Council will consider the staff recommendation to find that the ordinance is exempt from CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations because it can be seen with certainty that there is no possibility that the activity in question would have a significant effect on the environment.

All interested persons are invited to attend and speak on this matter. Written comments also may be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. Written comments should be received prior to the public hearing.

Please note that if you challenge the City’s action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing or in written correspondence delivered to the City, either at or prior to the end of the public hearing.

minutes later, a few parents requested a recount of the votes and the original election results were voided.

“I think we need change at our school. I’m all about betterment for our children and for our school. I can make a difference,” Park said.

She also added some of the areas in which she’d like to see the PTA improve.

“Even though it’s a Parent Teacher Association [our] teachers [don’t have a lot of opportunity to be] engaged,” Park said. “All our PTA meetings are held during class time, including [Tuesday’s] election, so the teachers cannot attend and exercise their right to vote. We have other parents who would like to get involved and, for whatever reason, our PTA is more like a clique so it’s really hard to get involved.”

Rosen, who is Jergens partner, told *the Weekly* that there were 84 voters registered and eligible to participate in Tuesday’s election. However, 95 ballots were cast.

“There’s assumed to be a group of people who want to see changes in the PTA, but didn’t feel like working in the system,” Rosen said. “[Representatives] from the 33rd District invalidated the election based on the apparent fraud.”

Some parents have publically spoken out in support of Park.

Beverly Vista parent Caroline Lee Elkin took to Facebook to air some of her concerns: “Cynthia Chang Park is our PTA

president. If we have a reelection because people can’t figure out how to have a sign-in process that doesn’t involve the counting of hands in the room (which is the lamest thing I have ever seen since Kindergarten – you can’t make this shit up), she’ll do it again.”

Jergens did not respond to *the Weekly’s* email requesting comment.

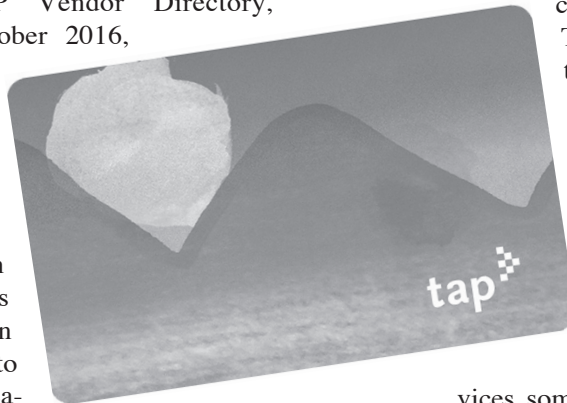
A date for the reelection has not yet been determined. The PTA has 15 days before it is required to announce the new election date.

Only one TAP card vendor in Beverly Hills

It sure is hard to get a TAP card filled in Beverly Hills.

A TAP card is a reusable and refillable card required for boarding most public transit systems in Los Angeles County, including Metro buses and rail.

Metro’s TAP Vendor Directory, updated in October 2016, lists the Vons Supermarket located on Olympic Boulevard and Beverly Drive as the only location in Beverly Hills where users can reload money onto the card. No locations are available north of Wilshire Boulevard.



Garcetti and Hawthorne team up for Oxy’s 3rd LA series

Mayor Eric Garcetti participated in Occidental College’s 3rd LA series, “City on the Verge,” last week in a one-on-one conversation with Christopher Hawthorne. Hawthorne is married to Rachel Fine who is the managing director of the Wallis Annenberg Center for the Performing Arts. The discussion focused on the future of the L.A. River, debates over housing and development, and the 2024 Olympics bid.

There are 26 transit agencies in the county that use TAP, including the Santa Monica Big Blue Bus and Culver CityBus.

The directory also indicates that a wide variety of nearby cities whose city halls offer TAP card services, some of which include Alhambra, Azusa, Claremont, Commerce, Covina, Diamond Bar, El Monte, El Segundo, Hawthorne, Huntington Park, and Hermosa Beach.

City of Beverly Hills Deputy Director of Transportation Aaron Kunz noted that seniors and individuals with disabilities can refill their discounted public transportation passes at City Hall, the Roxbury Park Community Center and the La Cienega Park Community Center.

But Kunz conceded there are no plans to offer the service at City Hall or the Beverly Hills Public Library.

Chamber of Commerce supports Wanda’s decision to allow smoking at One Beverly Hills

Beverly Hills Chamber of Commerce President and CEO Todd Johnson attended the Health and Safety Commission meeting on Tuesday to support the Wanda Group’s new project, One Beverly Hills, during the discussion about regulating smoking in multi-unit housing.

“[We’re more prochoice.] We are here because of Wanda,” Johnson said. “We are here to support a very prominent business coming into our City that is going to [hugely] impact [Beverly Hills] financially. We want to make sure that we find a middle ground and we want to work with you.”

Per the recommendation of City Council, the Health and Safety Commission has been working since last September on drafting a policy that will increase regulations on smoking in multi-unit housing.

The current proposed regulations would prohibit smoking traditional tobacco products, e-cigarettes and marijuana.

In addition, the regulations will only affect complexes with three or more units and exclude single family homes, detached or attached accessory dwelling units, a duplex, a hotel or a motel, and a long term health care facility.

“Wanda has become sort of a unique issue because they are a new developer, so we’d like to see if there is perhaps some accommodation that can be made for them because of the type of units they’re having and because they’re already entitled to build something,” said BHCC Director of Economic Development and Government Affairs Blair Schlechter.

One Beverly Hills was approved for construction by the Council at the end of last November.

It is the revised plan for 9900 Wilshire, the former Robinsons-Ma y Rohan a’Beckett department

store site. The project will consist of a 134-room luxury boutique hotel and 193 luxury residences in two buildings along the western edge of the property.

Wanda Group Deputy General Manager Rohan a’Beckett also attended the meeting to advocate for the right of future One Beverly Hills’ residents to choose whether or not they smoke in their condominiums.

“We feel very strongly that our residents will want to be able to enjoy the use of their property as their lifestyle dictates,” a’Beckett said. “One should have the right to choose how they enjoy their property. We want to protect the rights of residents in One Beverly Hills that are non-smokers, but we still want to be able to allow those owners who do wish to

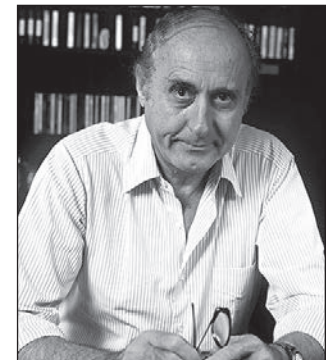

BOSSE SWORN IN AS MAYOR

City Council Installation on Tuesday brings new faces to local government

To liken the words of outgoing Mayor John Mirisch, it was “a very pleasant good evening” on Tuesday night at the City Council and City Treasurer Community Installation Ceremony located in the Samuel Goldwyn Theater of the Academy of Motion Picture Arts and Sciences.

Accolades and ovation flowed freely for the past, present and future elected officials who have committed themselves to working toward the betterment of the City.

Lili Bosse was unanimously sworn in as the new mayor by her fellow councilmembers. Bosse first served as mayor three years ago during the City’s centennial. Her signature initiative “Walk with the Mayor” will be returning this Monday, April 3.

Residents are invited to join Bosse on weekly walks through the City, as they discuss with her their thoughts about issues facing Beverly Hills. Monday’s kickoff walk will also offer a special “sneak peek” of the new Waldorf Astoria site.

Bosse took the opportunity to advocate for an expanded nightlife with longer business hours in the Golden Triangle, the creation of a Rental Registry and transparent discussions regarding the

construction of Metro’s Purple Line Extension project.

Other promises Bosse made during her speech included posting the Council calendar online as well as televising the Mayor’s Cabinet meetings.

Bosse is now the only woman serving on the council. She concluded her speech with a call to arms for more women in government; however, three women were defeated in this month’s council race.

“We need more women at all levels of leadership, from the White House to City Hall. [To] the great women in our community, please step up, lean in and please run for elected office.”

After a close race decided by 18 votes, former Vice Mayor Nancy Krasne gave a heartfelt and emotional farewell to the Council. Krasne did her best to hold back tears as she expressed her gratitude.

“For the last time, I’d like to say ‘thank you to the Academy!’ Thank you for hosting this event,” Krasne said. “This was my first executive decision to bring the installation to this gorgeous venue in 2009 and it has endured. [But most of all,] I want to thank all the citizens of Beverly Hills for giving me this extraordinary opportunity to be your employee and serve you.”

Both Krasne and outgoing

Councilmember Kathy Reims were honored with a key to the City.

Newcomers Les Friedmen and Robert Wunderlich were surrounded by their families as they were sworn in for what Bosse deemed “the experience of a lifetime.”

Howard Fisher was sworn in as City Treasurer after running unopposed during the recent election.

Mirisch, who was reelected for a third term as the top can-

didate, returned to his seat as a councilmember. He was honored with a video montage detailing some of his achievements throughout his year as mayor.

Vice Mayor Julian Gold playfully challenged Mirisch to arrive at his installation for his future term as mayor in an autonomous vehicle, which was one of the key initiatives of Mirisch’s mayoral term.

Several times throughout the ceremony it was noted that councilmembers do not always agree with one another, especially when faced with difficult decisions. However, sentiments from the honored city officials seemed to echo the City’s official motto, “Embrace Civility.”

The first formal meeting of the new Council will take place next Tuesday, April 4 at 7:00 p.m.



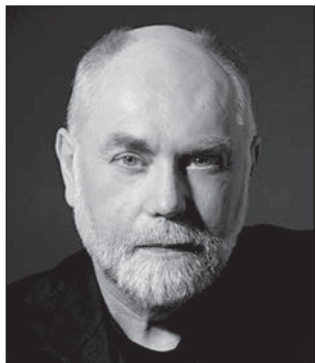
