## Planning Commission: removal of four heritage trees will benefit the City

The Planning Commission unanimously agreed that the removal of four “heritage trees” located on the front yard setback of 1163 Hillcrest Road will be “a benefit to [not only] the property owner, but also the community” at its meeting last Thursday.

Commissioners Alan Block, Andy Licht and Chair Joe Shooshani all voted in favor of the plan after a presentation from city staff and project representatives. Vice Chair Lori Greene Gordon did not attend the meeting.

“To me it would almost be a mistake not to do it,” Licht said. “I think it’s going to be much more beautiful and clearly will support the garden quality of the City.”

A “heritage tree” is defined as any tree species on the City’s official list of native trees with a trunk circumference of 48 inches or more and a height of at least four feet six inches, according to the April 13 staff report. One of the trees proposed for removal is a Canary Island Pine and the other three are Fern Pines. Both types of trees are not on the City’s native trees list; however the size of all four trees keeps them protected under

City ordinance.

Crest Real Estate President Jason Somers attended the meeting as the project’s representative. Somers is also currently representing Woodbridge Investments on behalf of a controversial Hillside R-1 permit at 1260 Lago Vista Dr.

“I’ve spoken with my two clients at 1169 Hillcrest and 1171 Hillcrest just past this, and the both support the tree removal,” Somers said. “We’re proposing the replacement at about a 2-1 of the trees. We’ve already got some of the Olive trees on sight.”

To offset the loss of the protected trees, the project includes planting eight mature Manzanillo Olive trees, each with a circumference of 48 inches or greater, in the front yard area. The staff report indicates Manzanillo Olive trees can grow to a height of 25 to 30 feet. The applicant’s proposal suggests the new trees will be maintained at a height of 15 to 18 feet.

The Commission’s decision to approve the tree removal permit is appealable to the City Council for the next 14 days.

recommend that the City Council establish two new preferential parking permit zones on the 9100-9200 blocks of Whitworth Drive, abutting South Palm and South Oakhurst Drives.

The recommended regulations will establish a two-hour parking limit from 8:00 a.m. to 6:00 p.m., Mondays through Saturdays, permit "AO" exempt.

The Whitworth street blocks currently have no permit system with a two-hour parking regulation from 8:00 a.m. to 6:00 p.m., Mondays through Saturdays.

At the Feb. 2 commission meeting, city staff recommended pursuing the establishment of permit zones on the Whitworth Drive blocks, adjoining South Palm and South Oakhurst Drives, to allow residents to park beyond the posted two-hour time limit.

City staff received little feedback after mailing out surveys to 19 dwelling units in the corner multi-family buildings adjacent to South Palm Drive and 21 dwelling units in the corner multi-family buildings next to South Oakhurst. As of March 29, staff received a total of three surveys in favor of the two proposed permit zones.

However on the morning of the April 6 meeting, staff received five letters from residents opposing the proposal.

"There seems to be a misunderstanding of what the permit does," said Commissioner Jake Manaster. "There's definitely a fee, which people are opposed to and I understand that but it seems that some people are concerned that they are no longer going to have parking. I think that's a misunderstanding because [it] doesn't actually change anything other than allow residents to potentially utilize the space longer and more often."

The commission has also previously discussed options and alternatives on how to proceed with streamlining the preferential parking permit petition process to create districts with uniform parking regulations.

There are currently 73 existing preferential parking permit zones in the City

covering approximately 170 residential street blocks, according to the Nov. 3, 2016 staff report.

The Commissioners previously suggested staff identify areas that may be potential districts, meaning preferential parking permit zones with similar parking characteristics. Staff drafted a map with 20 preliminary zoning suggestions.

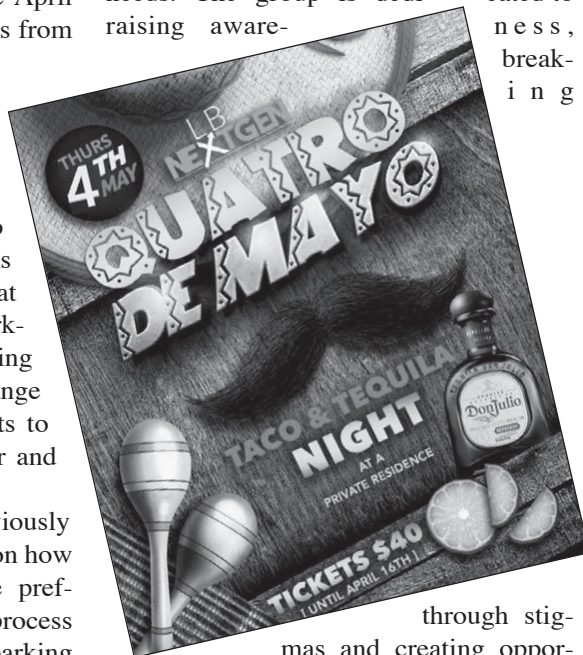
The issue of consolidating preferential permit parking zones to create districts has not appeared on the commission's agenda since last November.

The production is utilizing student directors and choreographers and features performers from the Drama Lab and Theatre Arts Workshop classes.

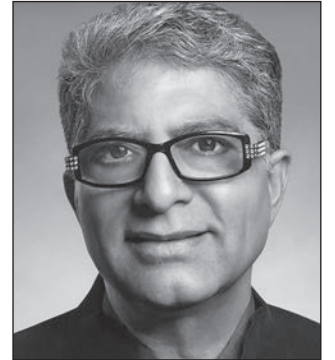

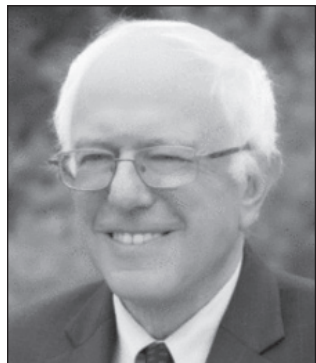

## ALTA DRIVE HOUSE RECEIVES LANDMARK DESIGNATION

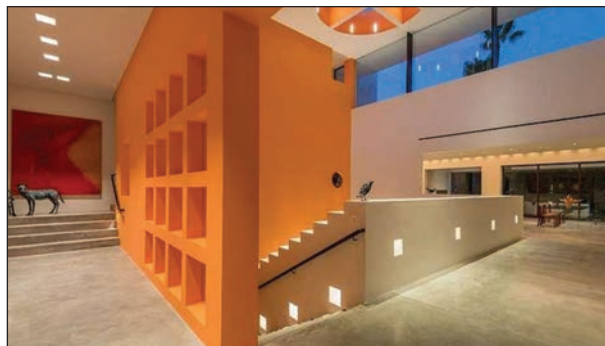
### But are the standards being compromised?

The Cultural Heritage Commission nominated “Casa Coleman” at 702 Alta Dr. for local landmark status at its meeting last Wednesday, April 12.

The resolution, unanimously approved by the Commission, recommends that the City Council designate the “Casa Coleman” a landmark and place it on the Beverly Hills Register of Historic Properties.

“For a city that is relatively small in land

area, we have an extraordinarily high concentration of works by world-renowned architects,” said Commissioner Richard Waldow. “I will enthusiastically support a motion on this property. I think it’s well-deserving of inclusion on our list of landmarks.”

The property was designed by Master Architect and internationally recognized designer Ricardo Legorreta Vilchis.

The Commission is required to make findings in specific criteria areas before it can approve a nomination for landmark status. According to the City of Beverly Hills Landmark Criteria, a landmark must satisfy the following requirements:

It is at least 45 years of age, or is a property of extraordinary significance; it possesses high artistic or aesthetic value, and embodies the distinctive

characteristics of an architectural style, type or period; it retains substantial integrity from its period of significance; and it has continued historic value to the community.

The residence was assessed for eligibility as a local landmark by Jan Ostashay of Ostashay & Associates Consulting.

“We’re looking at a property that is obviously less than 45 years of age,” Ostashay said. “[It] is not unusual for properties such as this to come up and be considered.”

Ostashay noted the National Park Service guidelines for properties less than 50 years old were consulted when determining if the property is of “extraordinary significance.” These specific guidelines are also referenced in the City’s Landmark Criteria.

The design is uniquely contemporary and driven by sensibilities of the Latin American designer. The incorporation of bold geometries and the juxtaposition of color patterns and water elements were signature features of Legorreta.

The project began construction in 2010 and was completed in 2012. Upon completion, the City awarded the property the “Beverly Hills Design Award.”

The Alta Drive property is the only private residence designed by Legorreta in Beverly Hills and was one of his last projects before

died at the age of 80 in 2011.

Mark Elliot, who has also been an active proponent of the recently enacted Rent Stabilization ordinance, is a renter on South Reeves Drive. He wrote a letter to the Commission explaining the Alta Drive property is not historically significant “because it falls 41 years short of our 45-years threshold.”

His letter also raises issue with “the motivation of the property owner to seek landmark designation.”

“So why is the applicant asking for bonuses now, just a few years after construction was completed,” Elliot wrote in his letter obtained by the *Weekly*. “And why use the city’s historic preservation process to get them? I suspect this applicant has come to [the Cultural Heritage Commission] because meeting the ‘extraordinary significance’ criterion for designation is easier than securing variance findings from the Planning Commission.”

Later on in the meeting, Commissioner Lisa Greer addressed Elliot’s concerns by pointing out that the property now has new owners since construction was completed in 2012.

This is a Commission-initiated project application. The property owner’s representatives have indicated the owner’s support of the landmark designation, according to the staff report.

## REZNIK V. RICHARDS: IS THERE A CONFLICT?

### Attorney in Lago Vista development alleges conflict with opposing counsel

Attorney Ronald Richards alleges Benjamin Reznik has a conflict of interest in the ongoing dispute over a proposed development for 1260 Lago Vista Dr.

Reznik was recently retained by Crest Real Estate President Jason Somers, who is the representative of the Lago Vista developers.

Richards, who is also a neighbor of the project, is one of the leaders of the opposition movement against the proposed construction of a 10,228 square foot single-family home on Lago Vista Drive.

In 2014 project neighbors Debbie Weiss and Adrian Lorimer hired Reznik “as a group” to represent them in real estate and land use matters.

Reznik previously represented Weiss and Lorimer against a development on the cul-de-sac of Loma Linda Drive, ultimately helping to get the Hillside ordinance passed.

Last August, the City Council passed an ordinance aiming to regulate developments in the hillside

area, which have become increasingly larger in scale and size. It reduced the by-right limit

of export/import from any single site to 1,500 cubic yards in a five-year period for properties located immediately adjacent to a street that is less than 24 feet wide, such as Lago Vista Drive.

The developers of the new Lago Vista project are requesting a Hillside R-1 permit from the Planning Commission, which allows them to make exceptions to some of the regulations set forth by the ordinance.

“[Reznik] provided [Weiss and Lorimer] detailed information to pass the Hillside ordinance,” Richards told the *Weekly*. “Now, in the first project seeking an R-1, [Reznik] is fighting against [Weiss] who is actively opposing this project.”

Richards noted that he believes this to be “unethical.”

“The issues are the same, the positions are the same, and [Reznik’s] 180 degree flip undermines the value of the positions [Weiss and Lorimer] paid for. [Reznik’s] concurrent representation of this applicant, who employs the same professional staff the Loma Linda applicant employed, violates in my opinion his ethical obligations to his client.”

Reznik says he does not have a conflict of interest because his work on the Loma Linda project has been completed.

“There is no conflict of interest. Period. [Richards] claims are about another one of

my clients on Loma Linda. I completed that work last year successfully. My scope of employment was very narrow. We’re done. We were asked to stop a project at the cul-d-esac of Loma Linda and we did. There is no conflict for me to take this developer or any developer in Beverly Hills who wishes to file for a permit to build a house.”

Reznik also added that the Lago Vista devel-

opers would not have been required to take their project through a public process if the Hillside ordinance was not in place.

“As part of my work to stop the [Loma Linda] project, I wrote a letter to the City encouraging them to adopt [the Hillside ordinance]. Now, you have a developer who is following those new rules. In other words, this project would never have been subject to a public hearing had the Hillside regulations not been adopted last summer,” Reznik said.

The project was scheduled to appear before the Planning Commission on Wednesday at 7:00 p.m., just as the *Weekly* was going to press.
