## Mirisch clarifies his position on the JPA

In response to a statement issued by BHEA, the Beverly Hills teachers union, Councilmember John Mirisch issued the following statement:

“The intransigency of the Beverly Hills teachers’ union, the BHEA, in defending an unsustainable salary formula which links teacher salaries to property values is disheartening on any number of levels. Perhaps most concerning is that the BHEA’s position is intellectually dishonest and intellectual dishonesty is not a useful quality in individuals who are supposed to be teaching our kids.”

“The BHEA points its fingers in any number of directions – all towards the School Board – in an attempt to explain the District’s fiscal challenges. But that deflects attention away from the ridiculous salary formula that links teacher salaries to Beverly Hills property values.”

“Importantly, rising pension costs are correctly identified by a BHEA surrogate as one of the main culprits in the District’s financial mess. As with municipalities, rising pension costs represent a real fiscal threat to the ability of public agencies to do what they are supposed to be doing. But those pension deficits are driven by teacher salaries which,

in turn, are linked to Beverly Hills property values.”

“Beyond much-needed pension reform, it is imperative for the School Board to rescind that irresponsible and ridiculous salary formula that takes decision-making power away from our elected school board”, Mirisch said.

BHEA president Telly Tse referred the Weekly to a prepared statement that read, in part “We view as dangerous Mr. Mirisch’s threat to kill the Joint Powers Agreement (JPA) between the District and City, an agreement that provides nearly \$10M of funding to the District (18% of its budget) in exchange for allowing the City to use District property for community events and affairs. The threat appears to be linked to Mr. Mirisch’s philosophical objections over how the District chooses to compensate its employees. That is not a valid basis to, in the eleventh hour, blow a \$10 million hole in the District’s budget with less than two months left before the current JPA expires. The primary casualty of such an action would be the students of BHUSD who are relying on City leaders to support their education, not frustrate it.”

revealed classified information derived from Israel in his meeting last week with Russian officials at the White House.

“We have heard a number of times from the White House that President Trump’s conversation with Russian Foreign Minister Lavrov was ‘wholly appropriate.’ However, nothing could be further from the truth. In his conversation with Lavrov, Trump apparently divulged to the Russians highly classified information collected by Israel. This is utterly disturbing on many levels.”

“Trump’s reckless actions threaten to damage our relationship with Israel. It is mind-boggling that the President would jeopardize that relationship – and the lives of US and Israeli citizens in the process – to mindlessly boast and misguidedly placate the Russians, while throwing Israel under the bus in the process.”

“Given Russia’s close relationship with Iran, it’s even more concerning this kind of sensitive intelligence could make it into the hands of Iran and its proxy Hezbollah, which seek the destruction of Israel. Other US allies are now dissuaded from sharing sensitive information with the US because they can’t trust the Administration. Trump’s dangerous actions call into question his fitness as President and must be investigated by Congress to the fullest.”

Beverly High pole vaulter Julie Park and its girls' 1,600 relay team qualified for the Southern Section Division 3 track and field finals with their performances in Saturday's prelims at Estancia High School.

Park was among eight vaulters to clear 9 feet 9 inches.

The Norman relay team of Julianne Araullo, Danna Rosman, Leticia Valle and Sarah Smith had the ninth fastest time, four minutes, 5.87 seconds.

Nine competitors or teams from each event qualify for the Southern Section finals.

The qualified Normans will compete

in the Southern Section Division 3 finals Saturday at Cerritos College. The girls' pole vault is scheduled to begin at 12:15 p.m. A series of four 1,600 relay races is set to start at 6:05 p.m.

## INSIDE "HOUSE OF CRAVINGS"

Beverly Hills' hottest new neighborhood restaurant

*Gabriel Frem, owner of House of Cravings, discusses how he came up with the concept of the newly opened restaurant on Olympic & La Peer and what sets House of Cravings apart from other restaurants.*

### Tell us about the concept and style for House of Cravings.

House of Cravings is a modern-day diner. What we tried to accomplish is a few things at the same time. This used to be an IHOP, and many people in the community had said that their parents or grandparents used to bring them here when they were kids so we wanted to keep that nostalgic connection. That's why we called it "House of Cravings"—we kept the "house" [in the name], we kept the A-frame [design of the building], but we made it a lot nicer inside by raising the ceiling, which was about 8-feet high. We raised it all the way to the roof, to the top of the A-frame. The idea is to have a casual restaurant for the community. It has beer and wine, pizza, burgers, wraps, paninis, things that you crave. Ultimately, what it does is it also offers a place where people can hang out casu-

ally. The patios have no service—you can order online, we have an [cell phone] application where you can order and then come here and pick up or you can be sitting on the patio and order. Once your order is ready, we text you to pick it up at the counter and you can have a seat on the patio for as long as you want, like you would at a café or at a Starbucks.

### What drew you to this location?

This location was purchased in 2010. We wanted to do a restaurant all along but we wanted to do it after we opened our restaurant in the golden triangle. We own Sweet Beverly. We opened that location first. Once we opened that, we came back and opened [House of Cravings].

### Did you encounter any opposition/obstacles, specifically from residents since you are in a residential area?

The residents that we have met have been very supportive. When we got our permits, the city [of Beverly Hills] sent mailers to everybody. There were a couple of concerns, literally less than five out of the whole neighborhood. People

have been extremely supportive. The city of Beverly Hills has been very supportive too. They have assisted us in making this happen. It took us a bit longer because we wanted it to come out right, but the city has been very supportive and the neighborhood has been very supportive. We have access [to the restaurant] from the alley, which would be a natural access for us and would facilitate our flow, but I decided to close that so that the cars are not entering [the lot] from the back alley and making noise close to the residents' homes. Look, I always say that we build the restaurant and the guests own it. The guests here are part of the neighborhood and so they will be the owners, they will be the people who make it succeed, and so to that effect, we have to be sensitive to the neighborhood we live in and we have to make it feel like home for them.

### Tell us about your background.

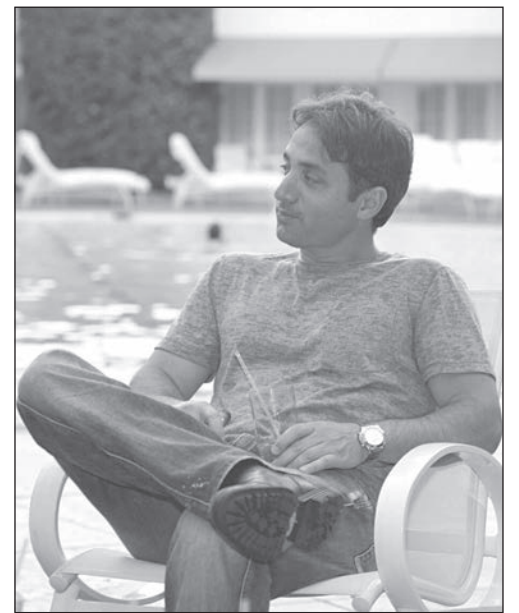
So, I own the restaurant Sweet Beverly. I had another restaurant called Brand 158, but we exited that investment. It was a short investment for us. We may have another one in Beverly Hills. We are looking at possibilities in Beverly Hills.

### Would the new restaurant be the same style as House of Cravings?

It wouldn't be the same style. It would ultimately be defined by the building and location we end up being in. We try to fit in rather than be revolutionary. We try to be evolutionary and evolve the building. Our other restaurant, Sweet Beverly, has a completely different feel because it happens to be in a completely different setting. We try to fit in and match the setting we are in.

### What's one thing you want our readers to know about your restaurant?

We grind our own beef, we bake our own bread. The pizza dough, the burger buns, the Panini bread—it's all made in-house. We buy high quality ingredients and we don't over-engineer the food. We keep the prices very approachable. The ultimate test for a restaurant is taste. We want people who taste our food to crave it, hence why we called it House of Cravings. We want to create food that you come back for. You don't feel bad after you leave because the price was right and the taste was right. I always tell people that you know if you ate a good meal 30 minutes after you leave a restaurant. A lot of restaurants over-salt or use MSGs that make you eat the food when you are there, but when you leave, you feel bad. Here, you will notice that you will feel as good leaving as you did when you were eating, and that is very important to us.

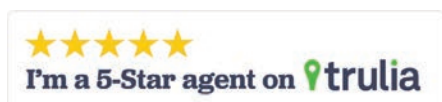
