

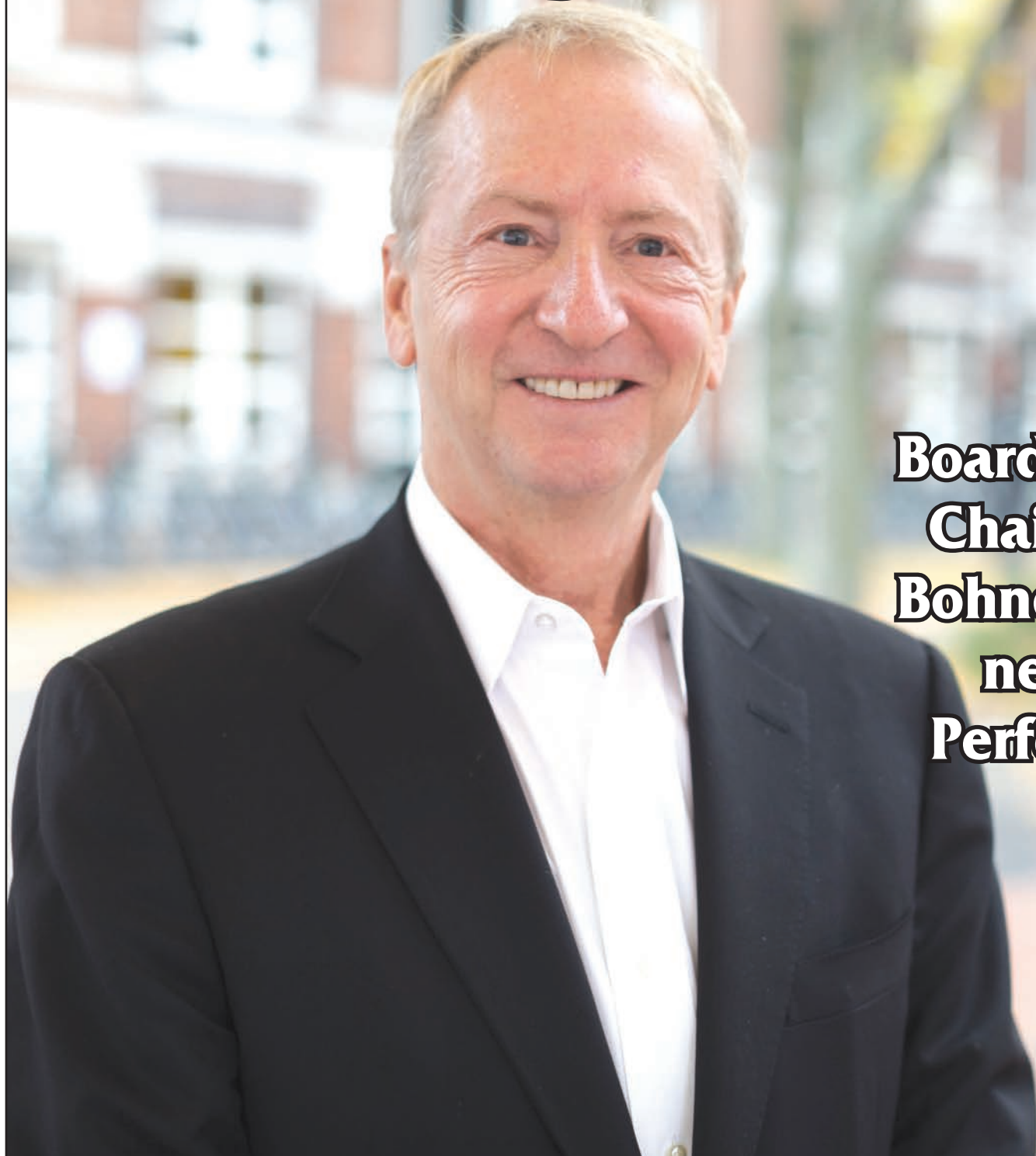

“Rent Stabilization Ordinance”

AN OPEN LETTER TO THE CITY COUNCIL:

For most of us, the homes that we live in are the most valuable asset that we own. As single family homeowners, you probably spend thousands of dollars each year on maintenance, improvements, insurance, utilities and other costs in order to protect your investment and live in the comfort you have grown accustomed to and worked so hard for. The same holds true for my wife and me, and the 4-unit apartment building we own and live in that is now subject to the City’s Rent Stabilization Ordinance.

As with all large investments, not only has each of us worked very hard to afford our properties, we have also taken huge risks with the hope that someday we will see a return on our investment. However, through the imposition of the City’s Rent Stabilization Ordinance, the value of my investment, and the properties owned by other rental housing providers in our City, is being severely diminished.

Think about it – less revenue equals

lower value. Imagine if the same restrictions were placed on the sale of single family homes. In other words, when you sell your home, you would be limited to no more than 3% appreciation per year. That sounds crazy, but then again, surely you agree we have to make our City’s single family homes affordable for the affluent professionals that want to live in the City of Beverly Hills.

So, in simple mathematical terms, if you purchased your home for \$2.0 million just 10 years ago, you would be entitled to sell it for no more than \$2.6 million (that’s 3% appreciation compounded for 10 years). Although at that rate of return, you probably could never recover all of the maintenance and improvement costs you paid for all of these years, but think about how great it feels to help out the next family that needs a house. As you know, since the 2008 recession, housing prices have increased substantially more than 3% per year! In fact, since housing bottomed out in the Great Recession of 2008, according to Zillow, median single family home prices in Beverly Hills have increased about 7.2% per year.

If the goal of the Rent Stabilization Ordinance is truly to provide more affordable housing to those in need, there are other ways to accomplish that goal. For example, zoning laws could require or provide square footage bonuses for rental complexes to include a mixture of regular

and small-sized rental apartments (studios? efficiency units?), so that the small-sized apartments would rent for less. Or those with lower incomes could just receive housing vouchers from the City. These solutions would be far less expensive than the annual cost of implementing the Rent Stabilization Ordinance.

If the goal of the Rent Stabilization Ordinance is to provide a better means to address code violations or poor living conditions, then strengthen the complaint based system by putting details of complaints into a public system that can be easily viewed online and can identify buildings with recurring issues to be addressed by the City.

If the goal of the Rent Stabilization

Ordinance is to truly protect our City's renters, then do not move forward with the rental registry. Community members on both sides have expressed concern with the intrusive nature of the rental registry, including disclosure of rents, terms of tenancy, and age and disability status of the City's tenants. The City can obtain the information it is seeking through other means, including its own gross receipts tax records and the County's property tax records.

If the goal of the Rent Stabilization Ordinance is to protect tenants from being evicted just so rental housing providers can raise rents, then require 60-day eviction notices be filed with the City, track

BHUSD Enrollment Dips Below 4,000

First day of school enrollment numbers at the five BHUSD campuses indicate that for the first time, total student enrollment has dipped below 4,000. The most precipitous drop has been at Beverly High, which 10 years ago had enrollment around 2,000.

In related news, 21 of the 23 certificated layoffs have been rescinded and reassigned positions within the District. The two individuals not assigned were due to their specific content areas—in Dance, the position was filled by former Horace Mann Principal Dana Findley, who returned to her role as Dance instruc-

tor at Beverly High. In Pre-K Special Education, the selection was reduced by one due to “not having a need,” according to the Human Resources Director.

Additionally, several staff members transitioned to Tech TOSA (Teachers on Special Assignment) positions this school year which created temporary vacancies. The district opened up a number of primary classrooms due to the “roll-up” of high numbers of students in one grade advancing to the next grade which created a need for instructors. The roll-up—which means that if one grade has a high number of students, it may be larger than the previous year’s group when it moves up a level—was seen in grades two to three, three to four, and four to five.

Six staff members also took advantage of the Supplemental Employee Retirement Plan (SERP). The district had 15 certificated resignations.

BHUSD Board of Education Approves Additional Extension of JPA With City of Beverly Hills

The Beverly Hills Unified School District approved an amendment to extend the Joint Powers Agreement with the City of Beverly Hills by an additional term of two months, through October 31 at a Special Board of Education Meeting

held yesterday. The current two-month extension of the JPA between BHUSD and the City expires on August 31.

The Board voted unanimously in favor of the extension, in order to provide the City time to analyze data compiled by the District quantifying the hours of use and costs involved as a result of City use of BHUSD facilities.

The next meeting between the City and BHUSD liaisons committee to discuss

terms of the JPA is scheduled for August 23 at 10:00 am at City Hall.

In existence since 1978, the purpose of the JPA is to provide residents, organizations and groups in Beverly Hills access to BHUSD fields and facilities for programs offered through the City’s Community Services Department.

“It’s just an extension until we’re able to openly figure out a longer-term solu-

frequency of evictions, and intercede when rental housing providers have abused the eviction process. If the goal of the Rent Stabilization Ordinance is to protect those who are truly in need, then provide relocation benefits to the City’s seniors and disabled that are truly in need with a means test income threshold. Permit relocation fees to vest over 5 years, so that nuisance tenants can be removed by landlords without incurring excessive legal or eviction costs (most nuisance tenants become evident within the first several years of their tenancy).

If the goal of the Rent Stabilization Ordinance is to protect the City’s tenants from being gouged with excessive annual rent increases, then establish a 7% (a 30% reduction from the original 10% per year) allowable increase each year along with a new habitability standard requiring reasonable maintenance to ensure proper upkeep of the City’s aging stock of rental housing. Institute a mediation board so that disputes can be brought to a resolution and so that repeated 7% increases can be tracked and addressed by the City.

And, finally, exempt owner occupied buildings that are 4 or less units. It is my home. Leave me alone!

The City has not yet funded the Rent Stabilization Ordinance, and it is not too late to turn back from the pending \$2 million annual cost of implementation. I urge the members of the City Council to postpone the funding of this poorly thought out set of regulations, and work on sensible solutions to address the concerns of all parties. The City can achieve results based on data and mechanisms already in

place without copying 30 year old rent control laws from neighboring cities that cost those cities millions of dollars each year. Every dollar spent by the City on the Rent Stabilization Ordinance is a dollar less in funding for our first responders and our schools. Vote NO on funding the new and completely unnecessary rent control program.

tion,” said Councilmember John Mirisch. “We’re still waiting for some information and it gives us more time to work things out.”

Business District to Receive Enhanced Holiday Lighting

At their August 8 study session, the City Council approved a funding budget of approximately \$1,500,000 for the City’s annual holiday lighting décor.

Every year, the City sponsors a signature holiday program designed to celebrate the season and attract visitors from around the region to shop and visit Beverly Hills. They work in conjunction with the Rodeo Drive Committee (RDC), the Conference and Visitors Bureau (CVB), and the Chamber of Commerce.

This year, the RDC and CVB have submitted a proposal for enhanced holi-

day elements with customized interactive lighting displays. The program is a continuation of the Businesses Open Later Days (B.O.L.D) initiative and is “part of an effort to create new and interesting experiences for our residents and visitors,” according to the staff report.

Rodeo Drive Committee President Kathy Gohari said that many large fashion houses are investing in advanced technology and campaigns to encourage clients to come into the store rather than just buying products online. In order to stay competitive and forward-thinking, Gohari asserts, the City would greatly benefit from continuing the B.O.L.D initiative into the holidays.

“We are at a point where we have to start thinking about our future. How are we going to reach the next generation? What are we doing for our businesses?” asked Gohari. “We don’t want to imitate; we want to imitate. We have to create. We

have to be the standard.”

Some of the holiday enhancements will include the implementation of enhanced lighting displays on medians and Baccarat chandeliers from Gearys.

During deliberation, Councilmember John Mirisch introduced the idea of renting instead of purchasing the proposed helix lights, saying that their relevance will change with the times. He suggested purchasing the Baccarat Fine Crystal chandeliers, which he believes will always maintain relevance.

“The helixes [for the] lights—those seem to be great for this year [but] I don’t know that I’d purchase them because those are things that I think are kind of trending,” said Mirisch. Next year it will be something else. The year after it will be something else, whereas Baccarat—that’s a constant. That ain’t changing.”

The \$1.5 million proposal will be broken up into the following areas: North Beverly Drive (\$350,000); South Beverly Drive (\$200,000); North Canon Drive (\$300,000); Beverly Canon Gardens (\$150,000); marketing (\$150,000); and electrical needs (\$100,000).

Hollywood Basin Testing Underway

The City of Beverly Hills has just conducted the first phase of testing of the Hollywood Basin Wells.

The first phase included jar testing, laboratory testing and analyses. The acidification was performed to determine whether lowering raw water pH could eliminate or decrease the amount of iron sulfide in the water.

Based on the testing, it was found that significantly less iron sulfide particles were observed on the filter of the acidified samples. According to the staff report, there was a 50 percent reduction in particles. The particles of the non-acidified samples were more aggregated than the acidified sample.

“It looks very positive at this point, from what we’ve seen,” said Water Resources Manager Vince Damasse.

However, the iron sulfide particles were

Planning Commission OKs New Project on Third Street

The Planning Commission decided at their August 10 meeting to approve a Development Plan Review for construction of a new dwelling unit located at 9171 West Third Street.

The project, which was also granted eight variances, will be a 2,548 square foot one-unit building on a multi-family zoned property. The existing property is 2,580 square feet and is currently vacant.

First brought to the Planning Commission on August 11, 2016, the project proposal has seen three public hearings. At the latest hearing on June 22, the commission provided direction to the applicant regarding project changes.

Some of the changes included providing three parking spaces on the site including one space in a garage; including a porte-cochere structure above the two parking spaces that are not located in a garage; meeting the code required modulation requirement by enlarging the proposed balcony by one square foot; and moving the building two feet toward Third Street to maintain a 12 foot easement at the rear of the property.

During public comment several residents expressed concerns about potential traffic increases.

Michelle Forrest—who lives in the building right behind the property—noted tour buses drive by Third Street seven days a week, and said that they should be rerouted back to Burton Way.

“Do any of you live on Third Street where the buses [go]? Just put yourself in our situation,” said Forest. “[There’s the everyday] traffic of cars, the construction traffic and everything, plus the tour buses—is there any way they can bring those buses back to Burton Way? It’s too much now.”

Commissioner Andy Licht responded by saying that the City Council voted to move the tour buses to Third Street and encouraged Forest to bring her comments to the next Council meeting as the Planning Commission doesn’t have purview over bus routes.

At deliberation, the commission considered the variance requests, some of which included a variance to allow a reduction of the required side and rear yard setback; a variance to provide two parking spaces instead of three parking spaces; and a variance to provide parking spaces in an open form (not shielded from public view) and to provide the spaces in a required rear yard.

Ultimately, they decided that the changes applicant Hamid Gabbay made were satisfactory and unanimously approved the project.

not completely eliminated, likely because of oxygenation prevention and operating conditions.

The next step, the “pilot scale,” is to test this in real time at the wellhead. From August until December, staff will plan, prepare, procure equipment and conduct pilot testing to validate results from the jar testing.

Staff will also be performing operational testing from the Maple Wells. The contributing well flows from the Maple Wells will be blended with the existing Hollywood wells to simulate combined flows from all six wells—four Hollywood and two Maple Yard wells.

There were some comments from Commissioners regarding the specifics of the pilot phase, as the report originally made the implementation of sand separator a sequential step. Unbeknownst to the Commissioners, staff decided to combine that step with the manganese removal.

“It would be helpful if when we have these updates, we provide them in the context of the original proposal because that’s how we digested that information,” said Chair Jeff Wolfe.

BHUSD Spends \$5,000 on Saban Theatre Rental

The BHUSD auditorium closures have been costly.

The BHUSD paid the Saban Theatre \$5,000 for the Beverly High music department’s Band and Orchestra Spring Concerts.

The events, which were held on May 15 and 16, were not held at Beverly High’s KL Peters Auditorium, which was closed by the Board of Education in 2015.

BHUSD paid for this rental with previously budgeted funds in Measure E for the BHHS Modernization Project.

Traffic & Parking Commission OKs Preferential Parking Permit Zone on South Willaman Drive

At their August 3 meeting, the Traffic & Parking Commission voted in favor of a resident-initiated petition to establish a Preferential Parking Permit Zone on the 200 block of South Willaman Drive. The petition requests a no parking daytime regulation on weekdays.

Staff has recommended changing the current non-permit regulation of “2-Hour Parking, 8 a.m. to 6 p.m., Except Sunday” to “1-Hour Parking, 8 a.m. to 6 p.m., Monday through Friday, Permit ‘UU’ Exempt.”

The 200 block, which has 28 single-family homes with approximately 35 on-street parking spaces. 21 of the 28 households signed the petition to address the commuter parking impacts from businesses on Wilshire Boulevard and visitors of multiple-family buildings from neighboring streets.

“The residents here are fed up,” said resident Karen Segel in a letter. “Ours is a residential neighborhood, not a parking lot for non-residents’ convenience.”

Staff conducted a parking occupancy survey last month from 8:00 a.m. to 6:00 p.m., and found that on average 8 of 35 spaces were occupied. The peak occupancy of 40 percent was recorded at 3:00 p.m.

During deliberation, the commissioners discussed the proposal—encouraging staff and lead petitioners to make sure the public notice includes all the necessary the petition requirement information. Vice Chair Nooshin Meshkaty noted it should be clarified so that residents signing the petition are aware they’d have to purchase street parking.

Transportation Planning Analyst affirmed that the petition is as clear as possible. “We provide the municipal code section. We also have a cover page that indicates the instructions and what the requirements are, and the types of parking regulations,” said Vasquez.

Commissioner Jake Manaster noted

that no matter how clear the petition is, it is the residents’ job to read the content.

“These are residents asking residents to sign a petition. There’s a certain flaw in that from day one,” said Commissioner Jake Manaster. “If people aren’t going to read the form before they sign it, there’s not a whole lot we can do about that.”

North Santa Monica Boulevard Reconstruction Brings Detours

Starting in mid-august for approximately three weeks, North Santa Monica Boulevard between Wilshire Boulevard and Alpine Drive will be open to only two lanes of westbound traffic.

Similar to detours in June, eastbound traffic will be detoured to Santa Monica and Wilshire Boulevards. This will give the contractor a wide work space to perform major construction activities and expedite the completion of the second segment between Rodeo Drive and Alpine Drive ahead of the holiday season.

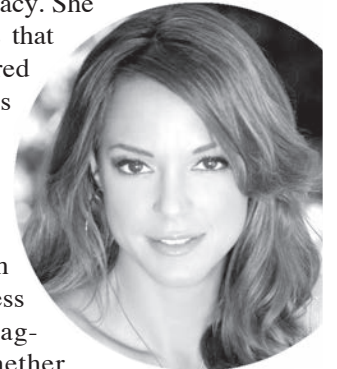
The following modifications are planned for during this time period: re-routing eastbound traffic to South Santa Monica Boulevard starting in Century City, returning to North Santa Monica starting at Doheny Drive; eliminating left turns from Wilshire Boulevard to eastbound North Santa Monica Boulevard; temporary bus stop locations on the south side of South Santa Monica Boulevard will be west of Charleville Boulevard, west of Crescent Drive, and west of Camden Drive; Metro buses will be re-routed back to North Santa Monica Boulevard via Doheny Drive; no left-turn from Wilshire Boulevard to Trenton Drive; signal timing adjustments on South Santa Monica Boulevard and Burton Way Meter Bags; heavy presence of TCOs and Police Officers to manage traffic.

City-wide mailers will be sent to all residents and businesses a week ahead of the detour phase.

Retired El Rodeo Teacher Passes

At age 92, former El Rodeo Teacher Pat Melniker died in her Los Angeles home in October 2016.

Melniker joined the BHUSD in 1959 and taught 6th grade for many years, until becoming a consummate Middle School Math instructor in the El Rodeo 7th and 8th grades. A great storyteller and campus historian, she often recalled a visit from Eleanor Roosevelt to her classroom in 1961.

Melniker was known for initiating the El Rodeo Yosemite Institute trip, an 8th grade rite of passage thousands of students over the decades looked forward to. Sometimes known as “Pathfinder Patty,” she adored the National Parks and in October of 2016 at age 92, spent 11 days visiting and hiking through several of them with her son.

Although Melniker officially retired in 1988, she continued to first substitute and then volunteer weekly in El Rodeo classrooms and the Library for 28 additional years until she passed away. Her artistic talents were evident in the way she designed jackets for books that had no covers, and in the dozens of colorful, thematic, and instructive display cases in the Library. She mentored students in topics from Mental Math to Rules of Divisibility to Patterns of



Design Review Commission Conditionally Approves North Beverly Design Review Permit

The Design Review Commission has decided to conditionally approve a request for an R-1 Design Review Permit on 708 North Beverly Drive.

The proposal involves an addition and remodel of an existing two-story single-family residence located in the Central Area of the City north of Santa Monica Boulevard. It was initially identified by Architect Carla Vaga as French Revival Style.

Vaga originally submitted the application earlier this year, and the commission first reviewed the project at their meeting on July 6. They felt the design still warranted further review and directed the project to be restudied.

Some of their concerns were as follows: the windows need a hierarchy and should have a deeper recess, overall style does not appear to be French; appearance is stern and lacks detail; roof line needs refining; flat roof over the entry door does not appear to go with the design; and the chimney design is too prominent.

The applicant proceeded to modify elements like increasing the depth of the window and door recesses to create deeper shadow lines and increase the depth of the façade; streamlining the design and simplifying the façade by using the same stone for façade as the quoins, mouldings and entry details; simplifying the massing with consistent detailing; reworking the entry design and eliminating the flat roof over the entry; increasing the pitch of the roof; refining the chimney so it will not appear so prominent; and reworking the window design to create more definition and a hierarchy.

But at their most recent meeting on August 3, the Commissioners felt that although the new design was “better,” the modifications hadn’t addressed all of their concerns.

“[The door needs] definitely something over the entry that provides a little more shelter but isn’t overbearing,” said Commissioner Sandy Pressman at the most recent meeting on August 3.

Ultimately, the commission decided to conditionally approve the request after the Ad-Hoc committee ironed out the last few issues.

All dialogues are facilitated by Professor Sukhsimranjit Singh, Assistant Professor of Law and Practice at Pepperdine.

The tenants committee is comprised of seven residents. There is no chairperson. All committee members are tenants. The committee includes Mark Elliot, Richard Gitahi, Chuck Moffitt, Alma Ordaz, Gwen Owens, Michael Schulman and Ramin Zar.

Representation is this committee's highest priority, therefore residents who rent housing on Beverly Hills are encouraged to contact the committee: committee@bhrentersalliance.org.

To date our committee has participated in two roundtable discussions with rental property owners. A third and perhaps final dialogue is scheduled for Sunday, August 20 at 1:00 p.m. at the Roxbury Park Community Center, 471 South Roxbury Drive. On the agenda for Sunday's roundtable discussion are several key aspects of the city's rent stabilization policy:

- 1) Allowed annual rent increase;
- 2) Relocation fees and notice requirements for terminated tenancies; and,
- 3) No-just-cause evictions

Facilitator Singh has also identified two additional issues of concern for discussion:

landlord retaliation and Chapter 5—specific tenant protections. All tenants are encouraged to attend, however active dialogue will be limited to the committee's members. Professor Singh will allow periodic breaks for public comment and committee conferencing.

Juliet Fine Horace Mann Principal

What made you decide to pursue a career in education?

I began my career volunteer teaching literacy in the program called Americorps. I taught reading and writing to English language learners—students new to the country—at an elementary school and I loved it. I was actually telling my mother-in-law who was a principal as well as director of special programs about my enjoyment of teaching literacy and she suggested, “Maybe you should try teaching.” I also have two uncles who are professors—one who recently passed away, his name was Barry and he was an educational historian for about 40 years. [The other] was a professor at USC; his name is Murray. I have many educators in my family and so it seemed like, when she mentioned it, this made sense. I tried substitute teaching and fell in love with having a class and started from there.

You previously served as the Assistant Principal at the William S. Hart Union High School District in Santa Clarita. What did that entail?

I was an assistant principal at West Ranch High School located in Stevenson Ranch, California. It was the fifth highest performing school in all of North LA County [for the] common core assessment called the CAASPP in the English language arts portion. So it was a very high performing high school and I oversaw CAASPP testing as well as academic programs, facilities and maintenance, [and] special education. I also saw the professional development of teachers, as well as English language learners—still working with students new to the country. I really loved working with our teachers on professional development but the school itself had about 2,700 students grade 9-12, and the students went to many different types of schools from ivy leagues to UC’s to the top performing private schools. It was a great school and I really enjoyed it, but as a new teacher when I was teaching about 15 years ago when I first started, my heart and passion was always working with elementary [students]. I also was a junior high school teacher at Arroyo Seco Junior



High School, and that’s also in Santa Clarita Valley. So I always loved working with junior high aged kids, so when this opportunity came about it was definitely something I wanted to pursue. They’re so creative! Their energy is amazing and I would have to say they’re probably the most creative. They’re going through all these emotional changes at that age so they have this great energy about them.

You’ve emphasized a focus on “results-oriented leadership.” Tell us about that.

I would say one of my personal leadership qualities is not only being focused on culture in a city or in a school—Horace Mann has a very unique culture and I talked with the teachers a lot about respecting the culture that exists at Horace Mann and upholding its traditions—but when we talk about results-oriented leadership, it’s about also seeing growth every day in our kids. [It’s about] making sure that every day when they enter our doors, they leave a little bit better. So they’ve grown either academically, physically, emotionally, so that they feel like they can take home whatever we’ve given them from the school and have become a little bit better, changed, or inspired. I really do focus a lot on culture—the culture of the school, the culture and values of the community, because Beverly Hills values certain things and expects certain things from the school and we want to make sure that as a school, we value what the parents and community want. But we also have a culture at Horace Mann that values developing young minds and inspiring the kids here. We want them to become better every day. So when I say “results-oriented” I could talk about data, and as I mentioned at West Ranch we were one of the highest-performing schools. When you look at [how] Horace Mann performs, they

do a great job. The teachers work so hard. Every day, we’re committed to making sure that children come home inspired to be better than they were yesterday.

As the new Horace Mann Principal, what are you currently working on?

As the new principal, my job right now is a lot of listening. [It’s] a lot of listening, observing, and really asking a lot of good questions from the parents to find out what they value, what the teachers have been doing that has been so successful here at Horace Mann—the people love this school and this community, so asking the teachers, “What have you been doing that’s so great? Tell me about your work with kids. Why are the Horace Mann students so devoted to you?” I want to ask a lot of questions and I want to listen. I want to listen to what the community has to say about what they love so much, focusing on the positive and all the strengths of the school and learning about it. And then from there, after doing a lot of listening, then together we come up with a plan to continue seeing students achieve, and also listening to what the parents have to say. If there’s something specific about a strength, we want to continue that strength. We want to continue that practice. The teachers here are amazing; they do so much with the kids. They’re so committed to Horace Mann and its students and this community that really, it’s about holding true to the core belief of Horace Mann.

Tell us about your family.

My husband [Adam] is an art teacher at a public school and our conversations at night are a lot about what students are learning. We talk about lesson plans; we talk about what’s working; we talk about educational policies coming in from the state. We talk a lot about education, and as I said my mother-in-law, Beverly Fine, is a former educator as well. She’s a former principal and director of special programs. So in my family life, she is a huge influence on me because I can talk a lot about

what I am doing here and bounce ideas off of her. She has this great perspective. My father-in-law is a dentist; he’s been practicing dentistry in Santa Clarita Valley for about 40 years, so we’re very well-established in our community. I also have my son [Jacob], he’s 7 years old and going into second grade this year. I’m really excited for him. I’m a cub scout den leader and we spend a lot of time doing cub scout things. My son is very involved in chess and art and robotics and swimming. We have a community swim team he’s very involved in. A lot of our time as a family is spent volunteering for my son’s activities.

A year from now, what do you hope to have accomplished?

It’s not about me so much; it’s about how much growth our kids make. By the end of the year, I want every child at Horace Mann to feel like they’ve made not just a year’s growth, [but] that they’ve made this emotional, physical, academic growth and that they feel confident to come back next year as a changed person; that they walk away feeling inspired; that every teacher feels like they’ve also made growth in the classroom; that I’ve supported them; that everyone feels like this has been a successful year because we’ve changed the life of kids. I’m here to support the community. I really believe in servant

leadership. I’m here to serve the community of Beverly Hills so if the teachers, the students, the parents, my administrator David, who’s amazing, the counselors—if everyone feels like we’ve made growth, this is a place for learning and the students are all moving forward in their lives, then it’s the work that speaks. It’s the growth and the children that make a difference. It’s not about me; it’s about serving this community and I truly do believe that. When our children make academic growth and they feel like they are better because of what we’re doing here, if they are contributing back to the community themselves, then I’ve done my job.

THE WAY OF THE WALLIS

Board of Directors Chairman David Bohnett on what's next for the Performing Arts Center

By Olivia Anderson

You're currently serving as the Chairperson of the Wallis Board of Directors. How has that been going so far?

I was inducted two years ago this fall so I am just completing my second full year as Chairman. It's going very well. I think the most important factors [are] the quality of the programming and the very, very positive audience reaction and the very positive critical reviews. The performances that we put on the stages have been very, very successful and well received.

You founded the very first social networking site on the internet, GeoCities, in 1994. Tell us about that.

I was always interested in giving people a chance to contribute and participate. The internet was new at that point, so I thought it was important to give people a chance

to express [and] talk about what they were interested in and build pages in communities where they could meet people that have similar interests. So it was an early forerunner of what became Myspace and then Friendster and Facebook. But it was really about giving everybody the opportunity to be a part of a new medium.

Your background is in tech entrepreneurship. What drew you to the Wallis?

I've been a big advocate of the importance of the arts in our community and society. I think the arts bind us all together as a community. I think it's important that people have access to the arts in school and education programs. So it's just a part of my overall personal phi-



losophy of community building and social justice.

When we talked to Artistic Director Paul Crewes in Issue #851, he said

"The joy of the Wallis is that we can present the best work, whether it be theatre, music or dance, that we see in LA, the U.S. or from around the world." What goes into deciding which shows the Wallis performs?

I think the most important thing [is] to represent diversity in our community. Even though we're located in Beverly Hills, we strive to serve the broader Westside area and [we have] a very, very diverse community on the Westside. So, we look for programming that attracts the whole variety of age ranges, and ethnicities across genres. There's something for everybody, and that's I think one really exciting thing about the Wallis.

What are your plans to make the Wallis more financially solvent?

We are always looking for additional corporate support, additional foundation support, we have now another government grant that we've been approved for. The financial stability will build over time. We are new. Somebody asked me the other day, "What do we really need to be successful?" and I said, "We need history." The LA Philharmonic is 100 years old. They've built up a database and a base of supporters after all that time. So we're doing that, and we're doing that at a pretty fast [pace]. Time and the quality of our programming.

Tell us about your family.

I grew up in the Midwest. I grew up in Chicago. I was fortunate to go through public school where we had music education programs and we had art

appreciation programs so I played the clarinet in clarinet and high school. Education was always a very important component of my upbringing so I was fortunate that I had a good public school education. Then I came out to USC as an undergraduate so that's what brought me to Southern California. I still have family in Chicago.

What's in store for the next year at the Wallis?

We have expanded our cabaret programming, which people were very excited about. It's called "The Sorting Room" [and] it's in the old sorting room in the post office. We have a very broad array of cabaret performers next year. We're presenting a very robust dance program as a matter of fact. And Hershey Felder [interviewed in Issue #931], who just finished a performance run [in "Our Great Tchaikovsky"], will come back next year with a new performance of his. I encourage everybody just to go to www.TheWallis.org where you'll see the entire season coming up.

ORDINANCE NO. 17-O-2734

AN ORDINANCE OF THE CITY OF BEVERLY HILLS PROHIBITING ALL COMMERCIAL CANNABIS ACTIVITY (BOTH MEDICAL AND NON-MEDICAL) EXCEPT FOR DELIVERIES OF MEDICAL CANNABIS, MAKING RELATED MUNICIPAL CODE AMENDMENTS, AND FINDING THE ORDINANCE EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES ORDAIN AS FOLLOWS:

SECTION 1. Findings and Purpose.

A. The City of Beverly Hills, California (the "City") is a municipal corporation, duly organized under the constitution and laws of the State of California.

B. On November 8, 2016, California voters approved the Control, Regulate and Tax Adult Use of Marijuana Act ("AUMA"). The AUMA added Division 10 to the California Business and Professions Code, sections 26000, et seq., which grants State agencies the authority to create, issue, renew, discipline, suspend, or revoke licenses for cannabis businesses. The AUMA provides that the State shall begin issuing licenses to cannabis businesses under Division 10 of the California Business and Professions Code by January 1, 2018. California Business and Professions Code section 26055(e) provides that a State licensing authority shall not approve an application for a State license for commercial non-medical cannabis activity if approval of the State license will violate the provisions of any local ordinance.

C. On October 9, 2015, Governor Brown signed Assembly Bill No. 243, Assembly Bill No. 266, and Senate Bill 643 into law, which were collectively known as the Medical Cannabis Regulation and Safety Act (hereinafter "MCRSA"). The MCRSA established a State licensing scheme for commercial medical cannabis uses, while protecting local control by requiring that all such businesses have a local license or permit to operate in addition to a State license. The MCRSA allowed the City to completely prohibit commercial medical cannabis activities.

D. On June 22, 2017, the Planning Commission of the City of Beverly Hills held a public hearing on this proposed Ordinance, at which time all persons interested in the pro-

posed Ordinance had the opportunity and did address the Planning Commission on these matters. Following the receipt of public testimony the Planning Commission closed the public hearing.

E. At the conclusion of the Planning Commission hearing and after due consideration of the testimony, the Planning Commission adopted Resolution No. 1813 recommending that the City Council adopt the proposed Ordinance, to prohibit all commercial cannabis activity except for the delivery of medical cannabis.

F. On June 27, 2017, the Governor signed into law Senate Bill 94 which repealed the MCRSA, included certain provisions of the MCRSA in the licensing provisions of the AUMA, and created a single regulatory scheme for both medical and non-medical cannabis known as the Medicinal and Adult-Use Cannabis Regulation and Safety Act ("MAUCRSA"). The MAUCRSA retains the provisions in the MCRSA and the AUMA that granted local jurisdictions control over whether commercial cannabis activity could occur in a particular jurisdiction. Specifically, California Business and Professions Code section 26200 provides that the MAUCRSA shall not be interpreted to supersede or limit the authority of a local jurisdiction to adopt and enforce local ordinances that completely prohibit the establishment or operation of one or more businesses licensed under the State, within that local jurisdiction. Furthermore, the MAUCRSA provides that a State licensing authority shall not approve an application for a State license for a business to engage in commercial cannabis activity if approval of the State license will violate the provisions of any local ordinance or regulation. The MAUCRSA requires that a State licensing authority begin issuing licenses to marijuana businesses beginning January 1, 2018.

G. On July 18, 2017, the City Council of the City of Beverly Hills held a public hearing on the proposed Ordinance, at which time all persons interested in the proposed Ordinance had the opportunity and did address the City Council on these matters. Following the receipt of public testimony the City Council closed the public hearing.

H. All legal prerequisites to the adoption of this Ordinance have occurred.

SECTION 2. The definition of "Person" contained in Section 1-2-1 (Application of Definitions) of Chapter 2 (Definitions) of Title 1 (General Provisions) is hereby amended to read as follows:

"PERSON: A natural person, joint venture, joint stock company, partnership, association, club, company, corporation, business trust, organization, cooperative, and collective, and any manager, lessee, agent, servant, officer or employee thereof."

SECTION 3. The definition of Marijuana Dispensary, Store, Co-Op, or Cultivation Operation from Section 10-3-100 (Words Defined) of Article 1 (Definitions) of Chapter 3 (Zoning) of Title 10 (Planning and Zoning) is hereby deleted, with all other definitions remaining in effect without amendment.

SECTION 4. The City Council of the City of Beverly Hills hereby deletes Section 10-3-2761 (Marijuana Dispensary, Store, Co-Op, or Cultivation Operation Prohibited) from Article 27 (Other Uses and Building Restrictions) of Chapter 3 (Zoning) of Title 10 (Planning and Zoning).

SECTION 5. The City Council of the City of Beverly Hills hereby adds Article 47 (Cannabis Prohibitions and Regulations) to Chapter 3 (Zoning) of Title 10 (Planning and Zoning) to read as follows:

"ARTICLE 47 CANNABIS PROHIBITIONS AND REGULATIONS

Section 10-3-4700: Purpose.

Section 10-3-4701: Definitions.

Section 10-3-4702: Prohibited uses and activities.

Section 10-3-4703: Exceptions.

Section 10-3-4704: Violation, penalty.

10-3-4700 Purpose.

A. The purpose of this article is to expressly prohibit the establishment of commercial cannabis uses in the city.

B. The city council finds that prohibitions on commercial cannabis activity are necessary for the preservation and protection of the public health, safety, and welfare of the city. The prohibition of such uses is within the authority

conferred upon the city council by State law and is an exercise of its police powers to enact and enforce regulations for the public health, safety and welfare of the city.

10-3-4701 Definitions.

For purposes of this chapter, the following definitions shall apply.

A. "Cannabis" means all parts of the plant Cannabis sativa linnaeus, Cannabis indica, or Cannabis ruderalis, whether growing or not; the seeds thereof; the resin, whether crude or purified, extracted from any part of the plant; and every compound, manufacture, salt, derivative, mixture, or preparation of the plant, its seeds, or resin. "Cannabis" also means the separated resin, whether crude or purified, obtained from cannabis. "Cannabis" includes cannabis that is used for medical, non-medical, or other purposes.

"Cannabis" does not include the mature stalks of the plant, fiber produced from the stalks, oil or cake made from the seeds of the plant, any other compound, manufacture, salt, derivative, mixture, or preparation of the mature stalks (except the resin extracted therefrom), fiber, oil, or cake, or the sterilized seed of the plant which is incapable of germination. "Cannabis" also does not include industrial hemp, as defined in California Health and Safety Code section 11018.5.

B. "Cannabis accessories" means any equipment, products or materials of any kind which is intended for use, or designed for use in planting, propagating, cultivating, growing, harvesting, manufacturing, compounding, converting, producing, processing, preparing, testing, analyzing, packaging, repackaging, storing, smoking, vaporizing, or containing cannabis, or for ingesting, inhaling, or otherwise introducing cannabis or cannabis products into the human body.

C. "Cannabis product" means cannabis that has undergone a process whereby the plant material has been transformed into a concentrate, including, but not limited to, concentrated cannabis, or an edible or topical product containing cannabis or concentrated cannabis and other ingredients.

D. "Commercial cannabis activity" means the cultivation, possession, manufacture, distribution, processing, storing, laboratory testing, packaging, labeling, transportation, delivery or sale of cannabis and cannabis product for medical, non-medical, or any other purpose and includes the activities of any business licensed by the State or other government entity under Division 10 of the California Business and Professions Code, or any provision of State law that regulates the licensing of cannabis businesses.

E. "Concentrated cannabis" means manufactured cannabis that has undergone a process to concentrate one or more active cannabinoids, thereby increasing the product's potency. Resin from granular trichomes from a cannabis plant is a concentrate.

F. "Cultivation" means any activity involving the planting, growing, harvesting, drying, curing, grading, or trimming of cannabis.

G. "Delivery" means the commercial transfer of cannabis or cannabis products to a customer. "Delivery" also includes the use by a retailer of any technology platform owned and controlled by the retailer.

H. "Distribution" means the procurement, sale, and transport of cannabis and cannabis products between entities licensed under Division 10 of the California Business and Professions Code, as they may be amended from time to time.

I. "Manufacture" means to compound, blend, extract, infuse, or otherwise make or prepare a cannabis product.

J. "MAUCRSA" means the Medicinal and Adult-Use Cannabis Regulation and Safety Act as codified in Division 10 of the Business and Professions Code, as the same may be amended from time to time.

K. "Private residence" means a house, an apartment unit, condominium, or other similar dwelling that is lawfully used as a residence.

10-3-4702 Prohibited uses and activities.

A. Commercial cannabis activity, whether or not for profit, is prohibited in all zones, specific plan areas, and overlay zones of the city. No person shall establish, operate, maintain, conduct, allow, or engage in commercial

cannabis activity anywhere within the city. To the extent that this prohibition conflicts with any other provision of this Municipal Code, this prohibition will control.

B. A property owner shall not rent, lease or otherwise permit any person or business that engages in commercial cannabis activity to occupy real property in the city. A property owner shall not allow any person or business to establish, operate, maintain, conduct, or engage in commercial cannabis activity on any real property owned or controlled by that property owner that is located in the city.

C. Subsection A above shall prohibit all activities for which a State license is required pursuant to the MAUCRSA, as the same may be amended from time to time. Accordingly, the city shall not issue any permit, license or other entitlement for any activity for which a State license is required under the MAUCRSA, as the same may be amended from time to time. The city shall also not issue any local license to a non-profit entity pursuant to California Business and Professions Code section 26070.5.

D. To the extent not already prohibited by subsection A above, all deliveries of cannabis or cannabis products for non-medical purposes, to or from any location are expressly prohibited. No person shall conduct or perform any delivery of any cannabis or cannabis products for a non-medical purpose, which delivery either originates or terminates within the city. This subsection shall not prohibit any person from transporting cannabis through the jurisdictional limits of the city for delivery or distribution to a person located outside the city, where such transport does not involve delivery or distribution within the jurisdictional limits of the city.

10-3-4703 Exceptions.

A. Notwithstanding Subsection 10-3-4702 above, the delivery of medical cannabis from a business located outside the city and licensed under the MAUCRSA, or any other provision of law that permits State licenses for medical cannabis businesses, shall be permitted into the city.

B. To the extent that the following activities are permitted by State law, nothing in this article shall prohibit a person 21 years of age or older from:

1. Possessing, processing, purchasing, transporting, obtaining or giving away to persons 21 years of age or older, without compensation whatsoever, not more than 28.5 grams of cannabis not in the form of concentrated cannabis;

2. Possessing, processing, purchasing, transporting, obtaining or giving away to persons 21 years of age or older, without compensation whatsoever, up to eight grams of cannabis in the form of concentrated cannabis;

3. Smoking or ingesting cannabis or cannabis products except as prohibited by California Health and Safety Code section 11362.3;

4. Possessing, transporting, purchasing, obtaining, using, manufacturing, or giving away cannabis accessories to persons 21 years of age or older without compensation whatsoever; or

5. Engaging in the cultivation of six or fewer live cannabis plants within a single private residence, inside an accessory structure located upon the grounds of a private residence, or if grown outdoors within a locked space that is not visible by normal, unaided vision from a public place.

C. This article shall also not prohibit any commercial cannabis activity that the city is required by State law to permit within its jurisdiction pursuant to the MAUCRSA.

10-3-4705 Violation, penalty.

In addition to any other enforcement permitted by this Section 10-3-205 of the Beverly Hills Municipal Code, the city attorney or city prosecutor may bring a civil action for injunctive relief and civil penalties against any person or entity that violates this chapter. In any civil action brought pursuant to this article, a court of competent jurisdiction may award reasonable attorneys' fees and costs to the prevailing party. Notwithstanding the penalties set forth in Section 10-3-205 of the Beverly Hills Municipal Code, no provision of Section 10-3-205 or this Article 47 authorizes a criminal prosecution, arrest or penalty inconsistent with or prohibited by Health and Safety Code section 11362.71, et seq. or section 11362.1, et seq., as the same may be amended from time to time. In the event of any conflict be-

tween the penalties enumerated under Section 10-3-205 of the Beverly Hills Municipal Code and any penalties set forth in State law, the maximum penalties allowable under State law shall govern."

SECTION 6. The Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act ("CEQA"), the State CEQA Guidelines, and the environmental regulations of the City. Planning Division staff has determined that the adoption and implementation of the Ordinance is eligible for a class 5 categorical exemption for minor changes in land use limitations and will not have a significant environmental impact. The Ordinance is exempt from the environmental review requirements of CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations. Planning Division Staff has also determined that the Ordinance is exempt from the requirements of CEQA pursuant to CEQA Guidelines Section 15061(b) (3) because it can be seen with certainty that there is no possibility that the adoption and implementation of the Ordinance to prohibit commercial cannabis activity except for the delivery of medical cannabis will have a significant effect on the environment. The adoption and implementation of the Ordinance will not result in a permanent alteration of property nor the construction of any new or expanded structures. The City Council has reviewed Planning Division Staff's determination of exemption, and based on its own independent judgment, concurs with Staff's determination of exemption. The City Council, therefore, directs that a Notice of Exemption be filed with the County Clerk of the County of Los Angeles in accordance with CEQA Guidelines.

SECTION 7. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance for any reason is held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

SECTION 8. Restatement of Existing Law. Neither the adoption of this Ordinance nor the repeal of any other Ordinance of this City shall in any manner affect the prosecution for violations of ordinances, which violations were committed prior to the effective date hereof, nor be construed as a waiver of any penalty or the penal provisions applicable to any violation thereof.

SECTION 9. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the city within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this city.

SECTION 10. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
