

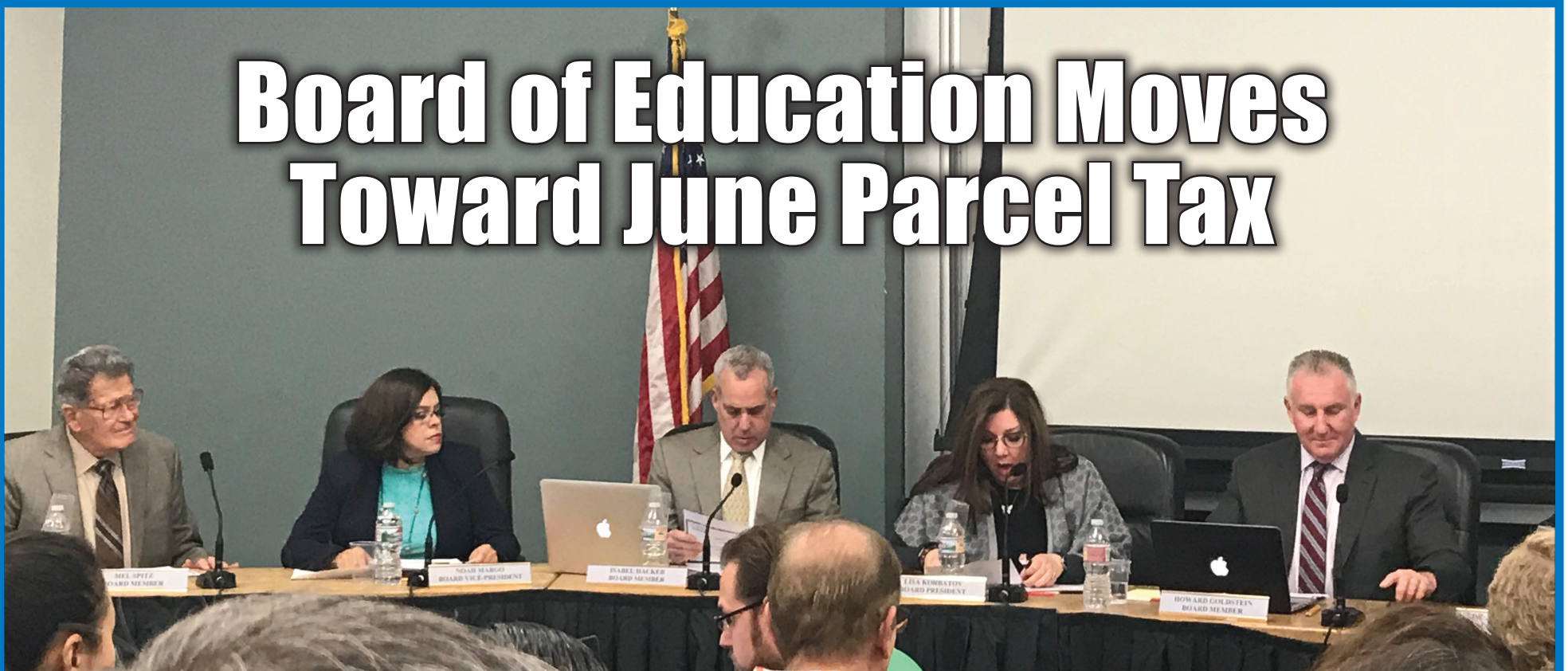

It is clear that we are not close to deciding the best option.

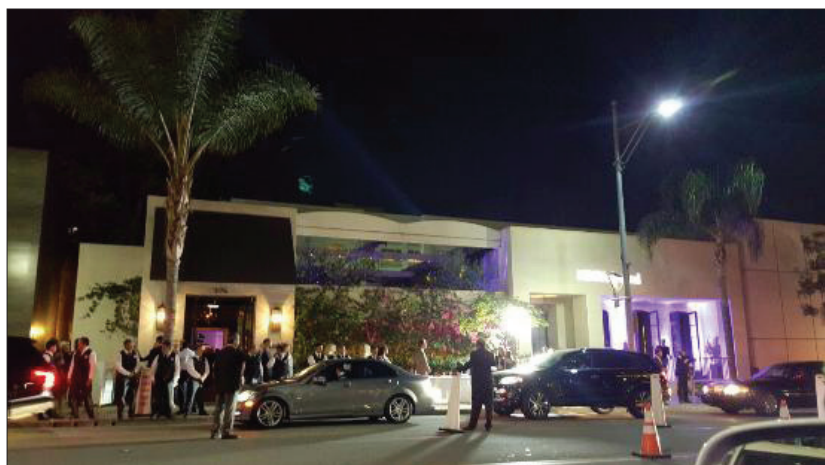
Safety must come first, of course. However, everything must be based on facts and not untruths.

Traffic & Parking Commission Recommends Full North Canon Closure

The Traffic & Parking Commission recommended last Thursday a full closure of North Canon Drive at Wilshire Boulevard during Wilshire/Rodeo Purple Line Extension station construction in order to mitigate traffic.

The recommendation follows City Council’s engagement of Fehr & Peers consulting firm to conduct a transportation impact analysis. The firm evaluated potential operational impacts of construction to nearby intersections during peak morning and afternoon commute hours and midday business hours with a potential closure of North Canon Drive at Wilshire Boulevard.

The analysis concluded that providing advanced vehicle detour signage, updating traffic signal timings, and the signalization of the North Crescent Drive and Clifton Way intersection would best mitigate the impacts.

The study determined that if the City approves the closure at North Canon

Drive, the overall construction schedule will be reduced with a consistent traffic control pattern.

But at public comment, several local storeowners said that these closures could further affect their businesses. Some of these businesses included Spago restaurant, located directly north of Wilshire Boulevard on Canon Drive, and the Saban Theatre located on Wilshire Boulevard.

“We have suffered immensely,” said Spago and Saban attorney Murray Fischer. “If you were to look at the phone calls received not only by the Saban Theatre but also by the residents, I think you would have possibly changed your opinion.”

Fischer went onto say that both businesses would lose their valet parking, because once it’s closed there is no way for people to get to the east side of the street. He said this would pose an especially onerous problem for Spago, as the restaurant hosts many nighttime events and relies heavily on valet parking.

“Spago has many events that take place in the night time. Without the ability to have valet parking, without the ability to have people, some of them being elderly like me, turn around and park on the proper side, [but instead] to park on the opposite side, be let out, and then try to walk across the street—it’s a total disaster.”

Another community meeting about the issue was held February 7 at City Hall in the Municipal Gallery beginning at 6:30 p.m. Murray Fischer did not return a call for comment.

Council OKs Bike Lane Treatments

On February 6 the City Council approved staff’s request for bicycle lane treatments following completion of the North Santa Monica Boulevard Reconstruction Project.

These include high visibility treatments, thermoplastic material applied with retro reflective and anti-skid material, green thermoplastic in areas where potential conflicts may occur, and green paint throughout the lanes.

The decision follows Council’s agree-

ment on June 20, 2017 to proceed with striping North Santa Monica Boulevard (NSMB) between Doheny and Wilshire with five-

foot high visibility wide bike lanes in both directions once the project reaches completion.

Staff then hired Iteris to conduct an analysis of high visibility bike lanes, finding that the FHWA approved interim experiments utilizing green colored pavement in communities like Chicago and New York.

According to the staff report, green was selected over blue or red because in the US, blue roadway markings are reserved to designate accessibility parking while red markers are sometimes used to alert motorists of wrong way driving.

Based on Iteris' technical memorandum, the Council chose to proceed with most of the recommended treatments. One recommendation was to only include green paint for part of the lanes, as it would save money, but several councilmembers said this could prove unsafe for residents.

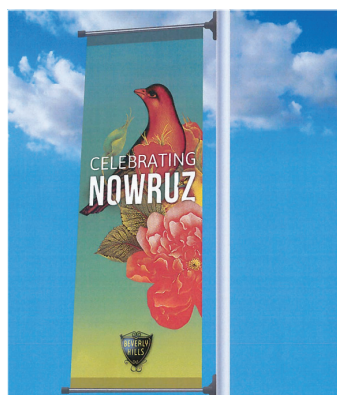
"I do think it can be somewhat confusing," said Mayor Lili Bosse. "For me the intention has always been that it would be the entire lane green. Granted, it will cost more money but this is money well spent."

The estimated installation costs is approximately \$35,000 and will be funded by the Santa Monica Boulevard Capital Improvement Program. Thermoplastic will need to be re-installed every three years for maintenance.

Nowruz Banners to be Installed Around City

On Tuesday, the City Council approved a formal request from local residents to consider the installation of banners commemorating The Persian New Year, Nowruz, this March.

Celebrated for over 3,000 years, Nowruz is a non-religious, secular festival welcoming the start of spring.



Beverly Hills is home to a large Persian resident population.

Many residents expressed support for the request, including former Mayor Barry Brucker.

"The Iranian Community has brought a rich diversity of culture, leadership, compassion, family and community involvement," wrote Brucker to the Council. "Our City's diversity is our strength and the Iranian Community here in Beverly Hills has helped establish the soul of this wonderful town."

Therefore, the City Council Liaison/Rodeo Drive/Special Events/Holiday Program Committee (Mayor Lili Bosse and Councilmember Lester Friedman) met on January 31 to review the request. Several community members spoke in support of fabricating and installing banners, which both Liaisons supported.

Staff initially proposed the fabrication and installation of ten street pole banners near Wilshire and Santa Monica and one horizontal street banner at that intersection, but the Liaisons recommended continuing the street pole banners into the business district on both Wilshire and Santa Monica.

"I actually the horizontal banner is confusing," said Vice Mayor Julian Gold. "You would have to put a line vertically down the middle, so I much prefer option number one."

Including tax, the estimated cost is \$15,967.50. This includes the installation and removal of the horizontal banner and the street poles.

The banners are slated to be installed by the end of this month and removed shortly after the Persian New Year.

Schwartz, Friedman Appointed to Community Charitable Foundation, Charitable Solicitations Commission

At their study session on Tuesday, the City Council appointed Mark Schwartz to the Community Charitable Foundation (CCF) and Ira Friedman to the Charitable Solicitations Commission.

The CCF Interview Panel, composed of Vice Mayor Julian Gold, Councilmember

Lester Friedman and City Treasurer Howard Fisher met on January 19 to interview six candidates for one upcoming vacancy on the CCF Board.

Schwartz will fill the position of Foundation Board member Ronit Stone, whose term is scheduled to end on June 19.

The Charitable Solicitations Commission Interview Panel, composed of Friedman, Councilmember Robert Wunderlich, Chair Pam Kraushaar and Vice Chair Joe Safier met on February 2 to interview four candidates for one upcoming vacancy.

Friedman will fill the position of Commissioner Murray Fischer, whose term is scheduled to end on June 30.

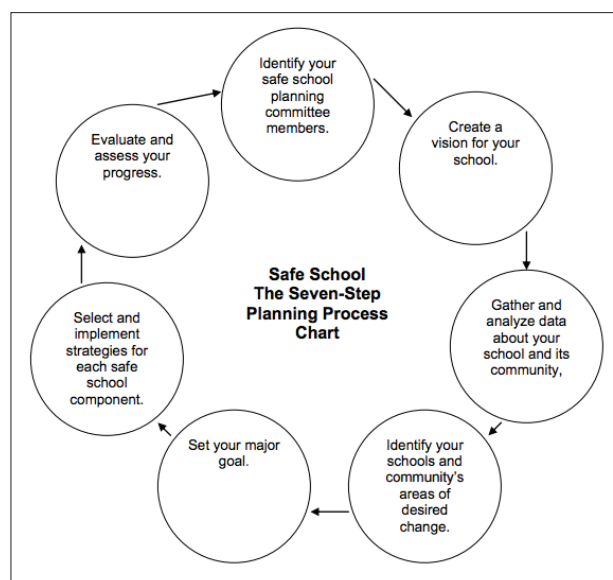
Both Schwartz and Friedman must attend all meetings of their respective commissions leading up to their appointments.

Board Approves Safe School Plans

The Board of Education approved the 2017-2018 Safe School Plans at their January 30 meeting.

The approval comes after the enactment of Senate Bill 187, which makes school districts and county offices of education (COE) responsible for the development of "comprehensive school safety plans" in each of the schools for which the district or COE is responsible.

The State Legislature's intent in enacting SB 187 is to "unite all existing statutes that relate to school safety and ensure

compliance with their provisions by including the requirements of school safety provisions in each school's comprehensive school safety plan."

The plan requires assessing the current status of school crime, identifying safe school strategies and programs, and addressing the school's procedures for complying with existing laws relating to school safety. This includes the development of child abuse reporting procedures, disaster response procedures, suspension and expulsion policies, procedures for notifying teachers of dangerous pupils, sexual harassment policy, school-wide dress code prohibiting gang-related apparel, procedures for safe ingress to, and egress from, procedures to ensure a safe and orderly environment conducive to learning, and rules and procedures on school discipline.

According to the school safety plan, SB 187 has "the great benefit of allowing school administrators to ensure that this vital learning support element is fully in place."

Beverly Hills Cactus Garden Now Open

The Cactus Garden in Beverly Gardens Park on Santa Monica Boulevard between Camden and Bedford Drives in Beverly Hills is complete after a nine-month renovation.

The Cactus Garden, donated to the City of Beverly Hills by John Bullard in 1934, was known during its time as one of the few comprehensive, outdoor cactus and succulent collections featuring indigenous specimens from the deserts, mountain and jungles of every continent.

The restoration project included preserving rare and fine specimens and assimilating them into the new design, led by landscape architecture firm Mia Lehrer + Associates. Over 61 cacti and succulents were preserved and the *Beaucarnea stricta* is the most-aged specimen in the garden.

The restored Cactus Garden allows visitors to walk along a decomposed granite pathway for close-up vantages of the many cacti and succulent varieties from

the arid climates of the Mediterranean Biome, Northern Mexico and South America, the Southwest USA, the Mediterranean Seas and South Africa.

A stone border wall provides further definition and protection for the garden. The new design reduced turf by 45%, providing a water savings of 37% - making this garden a work of sustainability and beauty.

The Cactus Garden is part of the Beverly Gardens Park Restoration Project, a major renovation of the City's century-old park encompassing 1.9 miles of green space over 23 blocks from the eastern

city limits, fronting the north side of Santa Monica Boulevard and Wilshire Boulevard. Beverly Gardens Park Restoration Project was initiated in 2011 by the City of Beverly Hills, working with resident and businessman, Steve Gordon. Gordon

leads a grassroots effort to fundraise and help in the city's restoration of the park.

BOARD OF EDUCATION MOVES TOWARD JUNE PARCEL TAX

Following immense debate about the future of BHUSD school configuration—an ongoing issue that arose from the district's current financial instability—the Board of Education gave direction on Tuesday to discuss the possibility of a parcel tax.

The tax, if implemented, would raise a lump sum that can be used to supplement their budget for educational programming.

In order for a parcel to pass, the Board will need 66.67 percent, or two-thirds of

the vote. A BHUSD parcel tax failed in 1990 by four votes. A 2016 Bond measure failed with approximately 63 percent.

Not all members agreed with a parcel tax, with Board member Mel Spitz contending that if a parcel tax were to pass, it would fund “the wrong things we are doing.” He added that a parcel tax would not substantially improve resources for middle schoolers.

Spitz. “I’m concerned about that.”

The Board did not reach the decision to further discuss a parcel tax, however, without lengthy debate about potential reconfiguration.

Board President Lisa Korbatov expressed concern for both a dedicated middle school and a 3 K-8 model, arguing that the BHUSD cannot transition to a 3 K-8 for five years due to a lack of space.

Superintendent Michael Bregy said this assertion is untrue.

“I want to see four robust K-8’s, and I’m not ready to give up on that model,” said Korbatov.

Board member Mel Spitz also countered that reconfiguring Beverly Vista, for instance, to a dedicated middle school could be done without major construction. Facilities Director Don Blake corroborated this fact.

Spitz said that doing so would leave the other three schools with a slightly number of students than they currently have. The school—which would hold 920 students—could create various drop-off times for different age groups.

“It’s doable. All I’m saying is that one dedicated middle school and three K-5’s is doable and it’s doable a year from now,” said Spitz.

COUNCIL FINALLY REACHES BASEMENT ORDINANCE CONSENSUS

In a meeting that ran until midnight, the City Council reached consensus regarding revising basement regulations and grading/retaining walls in the Hillside area. Staff did not, however, draft an ordinance making these regulations yet (even though the Council asked for it), as City Attorney Larry Wiener said the process would take over an hour.

“Larry and staff worked on this ordinance for hours, and we’re asking them to do this on the fly,” said Councilmember Lester Friedman. “I personally don’t feel comfortable. I think it just needs a lot more thought.”

Key recommendations included extending the expiration date an extra year from May, which Wiener said would be doable.

At public comment, a number of residents expressed support for the base-

ment revisions. One such commenter was Lago Vista resident and attorney Ronald Richards, who argued that the pipeline projects must be regulated in order to protect residents.

“This isn’t just a few disgruntled homeowners; this is an entire community,” said Richards. “Your vote [at the next meeting] will be a vote you won’t forget because you’ll actually stop these ridgelines. We want it applicable to all the projects in the Hillside that are pending. I don’t think it’s a problem for you to simply cause an R-1 Permit to protect us from these remaining projects.”

Their consensus follows several years of community concerns about the intensity and scale of development in single-family areas as well as general development standards in the Hillside area.

These concerns related not only to de-

velopment scale, but also to degradation of the natural hillside contours, increased construction impacts, and slope destabilization. At the Planning Commission meeting on October 26, 2017, the commission adopted a resolution recommending changes to the Council.

On December 5, the Council considered how the changes in the ordinance would impact projects currently under City review (a.k.a “pipeline projects”). The Council ultimately directed the Planning Commission to discuss an additional amendment to the draft ordinance to allow deviation from the revised regulations for wall height/location through a Hillside R-1 Permit.

Regarding the pipeline projects, residents have argued that the pending projects could have negative impacts on the neighborhood and surrounding proper-

ties due to design features that would no longer be allowed under the new code provisions. Staff provided a recommendation of following five category goals for handling pipeline projects, including tenants like exempting pipeline projects in Central and Trousdale areas, and those that have active entitlement applications as of the effective date.

The Planning Commission made the recommendation to the Council on January 11 to revise the regulations.

Staff will bring back the drafted ordinance to the February 20 Council meeting.

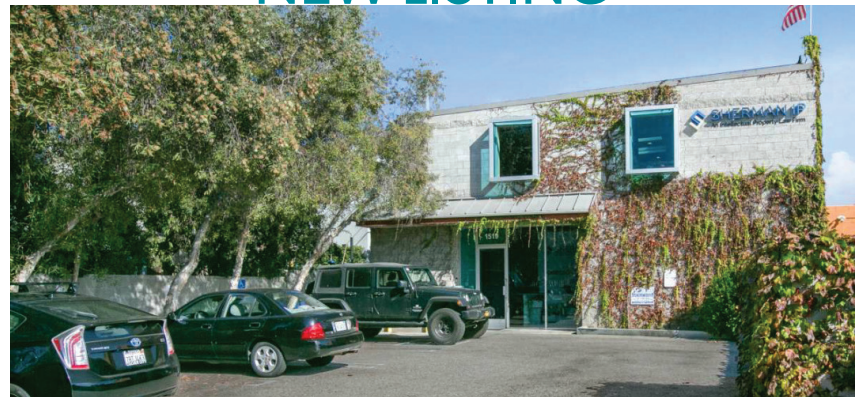

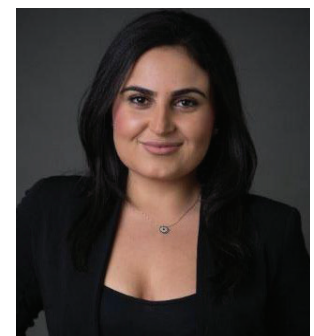
