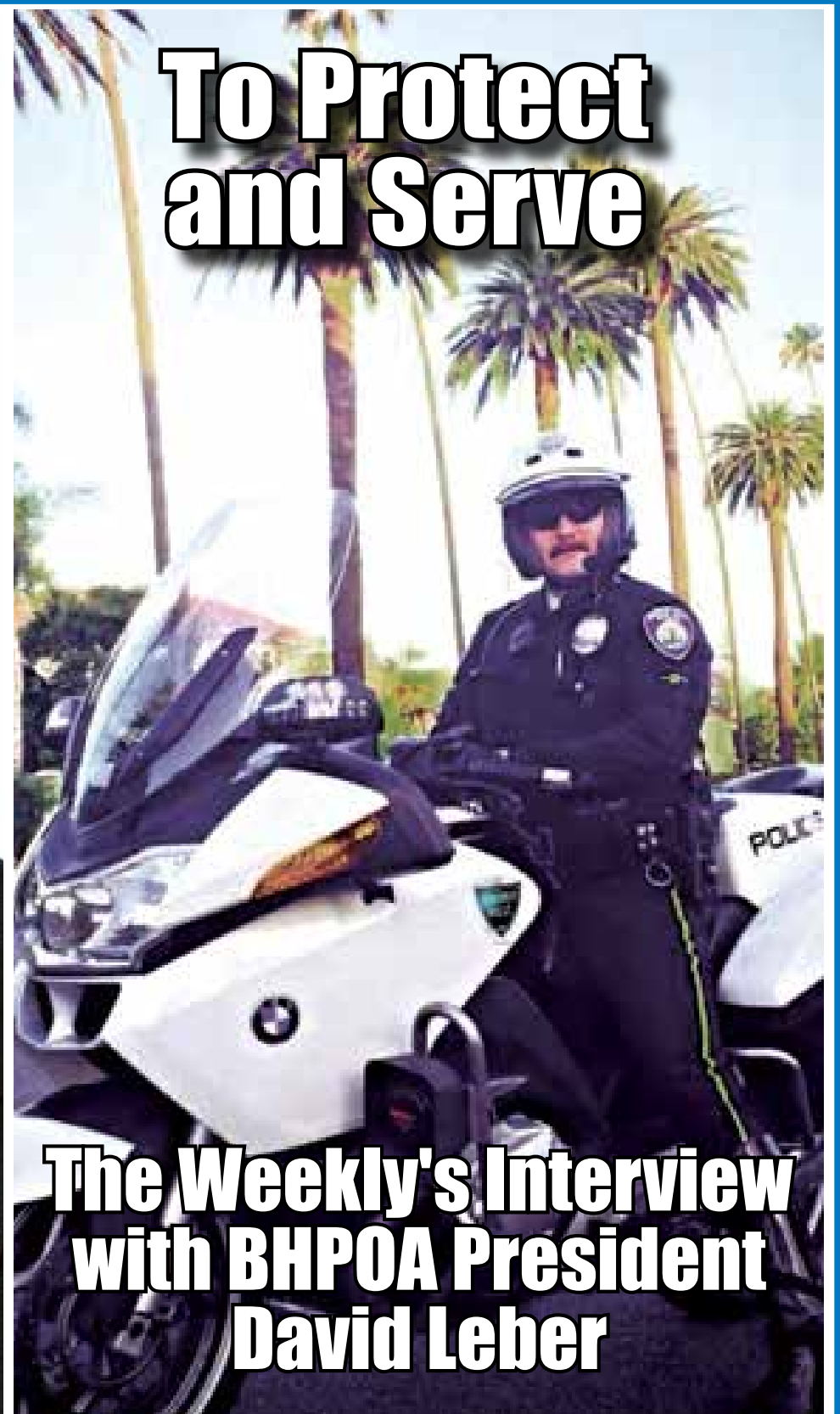

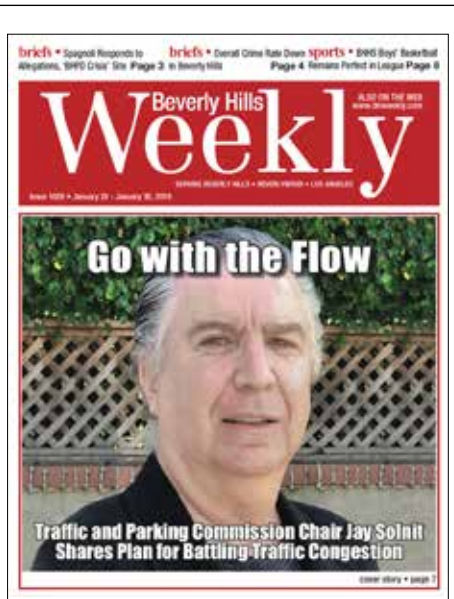

## Planning Commission Approves Calle Vista Project, Again

The end may finally be in sight for media mogul Byron Allen's bid to build a 21,787 square foot home on Calle Vista Drive after several years of debate over whether the project was allowable under the City's municipal code.

Last Thursday, the Beverly Hills Planning Commission voted in favor of the project for a second time, unanimously approving three Hillside R-1 permits and voting 4-1 in favor of a zone text amendment that would allow proposed projects located on sites throughout the Hillside

Area, where the current development of the site does not comply with current code requirements related to maximum allowable floor area and is considered legally nonconforming, to apply for Hillside R-1 permits for cumulative floor area.

Commissioner Lori Greene Gordon cast the lone dissenting vote against the approved zone text amendment, stating that she would rather vote for "option two," which would state that proposed projects on sites throughout the Hillside area, where the current development of the site does not comply with current code requirements related to maximum allowable floor area and is considered legally nonconforming, should not be allowed to apply for a Hillside R-1 Permit for cumulative floor area.

"Option two, to me, provides clarity for future development and a remedy for Mr. Allen and those are the two things I see that will be acceptable to me. Or I can go the variance route," Gordon stated, a nod toward the commission's third option: a variance that would allow the project to retain its nonconforming floor area and be eligible for the subject Hillside R-1 Permit.

Following the vote, Allen's project now moves forward with some conditions:

the current footprint of the project must be maintained or decreased and no more than 3,500 cubic yards of earth material can be exported throughout the construction process. The commission also told Allen and his team that no more than 566 haul trips would be permitted and that no new retaining walls should be proposed for the site. Another condition of the approval stated that revised plans "shall be reviewed and shall be subject to review and approval" by the Director of Community Development and that the basement "shall not expand beyond the footprint shown on the plans presented to the Planning Commission on January 24."

This latest iteration of the Calle Vista project will allow for a cumulative floor area of 21,787 square feet and a 9,402.89 square foot basement. The plans also feature a swimming pool and parking for four cars, provided through an existing on-site garage.

Though the project received an approval, not everyone present at the meeting supported it. Several residents spoke out against the project including Lago Vista resident Debbie Weiss, who has long been in opposition to the proposed plans.

"I have a lot of sympathy for the applicant. Staff should never have let the project get this far," Weiss said. "It is unfair to all other residents for the City to make an exception for one applicant. It is equally unfair to create a new ordinance that enables one project to avoid the codes that

everyone else has to follow.”

Weiss and other residents also expressed concern about the number of haul trips that would be required for the project, estimating that it could take about 1300 trips in total to remove all the soil and debris shifted during construction. This, they said, would be a problem for the “very, very narrow” and “accident prone” street. Allen disputed this claim.

“We have committed to making the investment to have a number of people guide the traffic and control the traffic,” Allen told the commission.

Commissioner Peter Ostroff pressed the issue of haul trips as he believed they would create a “substantial adverse impact on the surrounding neighborhood.” Ostroff questioned Allen and his team at length about how many trips they believed would be necessary to successfully remove the needed amount of earth material and about how the potential effects of those haul trips might be mitigated, as did his fellow commissioners. During this questioning, a member of Allen’s team said they did not feel Ostroff should be allowed to take part in discussions of the project because of a 2018 Fair Political Practices Commission (FPPC) ruling that said he should not participate in decision related to ordinances that affect all properties in the Hillside area.

“Just for the record, based on the findings from the Fair Practices group and how they ruled, we absolutely agree and believe that you should recuse yourself from this process,” Allen told Ostroff.

“I’ve always been clear that because you wrote the document as to what the Hillside Ordinance could be and because it started in your living room, you should recuse yourself and not be part of this.”

Assistant City Attorney Dave Snow said the City did not believe there was a conflict of interest on Ostroff’s part and said the FPPC ruling did not apply in relation to the proposed project.

“The ordinances at issue here that the commission is considering only deal with a small subset of properties within that area and those would be properties that are nonconforming due to structure size, therefore, we do not believe there is a conflict with respect to Commissioner Ostroff,” Snow said.

The approved zone text amendment will go to the City Council as a recommended ordinance and must be approved there before it will be official. If the Council votes down such an ordinance the project will likely return to the commission again for a hearing for a variance that would allow it to move forward.

The actual start date of construction for a City Council-approved project, according to City Planner Ryan Golich, is still several months away and would likely be sometime in late summer.

“If the commission were to forward an ordinance to the City Council today, it would go to them on March 5. That would require at minimum a first hearing and a second reading in April. There’s no second meeting in March because of the Mayor installation,” Golich said. “Then, 30 days after the April reading the ordi-

nance would become effective. So, the earliest would be the beginning of May, but then the project would need to go fully through plan check, review for structural requirements, and the construction management plan.”

### Board of Education Votes Unanimously to Eliminate 26.2 Staff Positions

The Beverly Hills Board of Education voted unanimously on Tuesday to eliminate 26.2 full-time certificated staff positions in preparation for the opening of the Beverly Hills Unified School District’s first middle school next school year. Notification to staff who will be impacted by the reductions began this week and, according to an email from BHUSD Superintendent Michael Bregy, will continue through February. All impacted staff will be noticed by March 15 at the latest in compliance with education code.

Tuesday was the first time that the staff reductions were outlined publicly, revealing that 17 full-time certificated positions for K-5 teaching services would be eliminated as well as 1.6 full-time sixth through eighth grade language arts positions, 0.6 full-time sixth through eighth grade science positions, one full-time sixth through eighth grade math position, two full-time sixth through eighth grade social science positions, and four full-time technology positions.

Beverly Hills Education Association (BHEA) President Ethan Smith was one of several BHUSD staff members who spoke against the decision on Tuesday. He told the Board he felt a better way to execute the reductions would have been to allow students to make elective choices prior to announcing which subjects would lose what number of teachers. This, Smith said, would save staff from “the state of precarious limbo” they will experience throughout the process.

A full list of elective course offerings for the consolidated middle school was provided to students and parents this week. Among the new offerings are robotics courses, STEM/Engineering, 2-D art (sketching), 3-D art (pottery), and many more. “Here’s an example: Some cuts to the social studies teachers may be redirected toward the middle school elective courses

once the district knows what the needs are based on the students’ elective choices,” Smith said, adding that students’ elective choices for next year are due by no later than February 8. “Those teachers may have their RIFs [reduction in force] rescinded or possibly not, but they won’t know until the number of elective sections needed has been determined. The time between when a teacher receives a RIF notice and when the elective choices are processed will mean uncertainty for that teacher and their family.”

Bregy responded by saying that the district elected to carry out the process as it has thus far because they want to let staff know where teaching assignments and locations will be sooner rather than later.

“We could’ve toed a really tough line with the March 15 date but we want to ensure that those teachers that will be laid off have as much time as possible to start looking and so that we can do what we can to assist them in that process. There’s a trade off, however, and that trade off is if you start to look at this work early, there’s still going to be some fluctuation,” Bregy said. “I recommend to the Board that we pass the resolution because we still have a lot of work to do in front of us but I think this is a goodwill attempt to take care of the staffing that we need at this point right now and to start letting staff know where teaching assignments and locations will be. The sooner we do this, the sooner we can share that information.”

Board member Rachelle Marcus, who has been involved in education in Beverly Hills for more than five decades as an educator and who currently serves on the reconfiguration steering committee, also expressed a belief that the reduction process was carried out fairly and in the best way possible. She urged staff to be patient as she suspected the number of those being laid off could lessen as reconfiguration continues.

“I have been watching the administration work on this. They are working as hard as they can and hopefully there will be many teachers who may in fact receive a reduction in force notice and then things can change and it can be taken back,” Marcus said. “I already know that the classes are beginning to get very full and we may have to open up some new classes at some of the schools already.”

## La Cienega Park Could Provide Metro Station Parking

Based on reports from the latest Recreation and Parks Commission meeting, La Cienega Park could provide parking spaces



for commuters using the Wilshire/La Cienega Metro station once it becomes operational in 2023. The additional spaces, if ultimately approved, would be constructed as part of the La Cienega Park redevelopment project.

Assistant Director of Community Services Pam Shinault confirmed that dedicated “park and ride” spaces were being considered as part of the La Cienega park project at the meeting, though she also noted the already existing demand for parking in that area could make accommodating additional needs difficult.

“What is interesting to note is that with the parking garage at La Cienega Park, two thirds of the uses are permitted. So, this is something we want to look at but we also don’t want to force people by getting rid of all of the permits, not saying that we would, out onto the streets along with having the influx of all the Metro riders,” Shinault said. When asked, Shinault clarified that “permitted” parking

was a reference to parking spaces purchased from the City by businesses for their employees to use.

Commissioner Susan Mishler also questioned how parking would be allocated if such a plan were to be put in place and received a mixed response from staff, who said they were aware of the difficulties adding a new type of parking might bring but were still looking into the park as a viable location.

“Let’s say we added 200 parking spaces at La Cienega Park and people work 9 to 5 or whatever, so they need the spots at certain times, and then the Bridge Club needs parking, and the public needs parking.

That gets dicey and needs a lot of foresight into who would be using those new 200 parking spaces because of the time of day when people come out to do x, y, and z,” Mishler said. “There’s very little parking there now. So, it’s great to say we need more parking, but we might have to allot them and designate them to specific people and really exclude commuters. I’m just thinking kind of out of the box, but do you get what I’m saying? How do you put some spots in a box for people who are commuting,

some for the Bridge Club, and some for people who want to take their kids to things across the street?”

“It is very challenging and we do have those issues currently in that area,” City Project Manager Rob Welch responded. “The demand from various users is difficult. All I can say is I understand what you’re saying and it is a concern. It would be something we’d have to vet if we add parking because we would probably fill that parking up the second it was built.”

Other plans for the street-level look and feel of the Metro stations being constructed as part of the Metropolitan Transportation Authority’s Purple Line Extension project were also discussed, including bathrooms and options for first and last mile transit.

“Nowhere do I see, and I know it’s been discussed a hundred times, bathrooms or any kind of facility for people who take the Metro to this point and need to use the bathroom,” Commissioner Judie Fen-

ton said. “Is there no intent to put a restroom in any of these stations?”

Welch told Fenton that Metro does not currently put bathrooms in any of their stations, but said that the inclusion of restroom facilities are being negotiated for Section Two of the project, which includes the future station at Wilshire/Rodeo. Bathrooms at Wilshire/La Cienega are not a part of those negotiations, the results of which are expected to go before the City Council on February 19.

### On Attending the U.S. Conference of Mayors

Mayor Julian Gold attended the United States Conference of Mayors' 87th winter meeting in Washington, D.C. on January 23-25. He spoke with the Weekly about what he learned and what he will bring back to Beverly Hills.

**You have attended the U.S. Conference of Mayors in the past. What was different this year from previous years?**

I think that each time we have a Conference of Mayors there is a different focus that seems to be the major subject of conversation. This time the issues of infrastructure made it to the forefront and although we've talked about that many times in the past, this time it really was front and center. The issue of housing and homelessness has taken

center stage as well, although it too has been discussed before.

Part of the discussion also had to do with the relationship between cities and the branches of government that sit above them, which is different from what we've talked about in the past. There were lots of conversations about a city's ability to self-govern, what we call local control. That is the ability for a city to set rules for its residents that are specific and sensitive to the people that we serve. There has been an increasing trend over time for the state and now federal government to try and overreach and control the work that cities do. The latest big example is related to small cell towers. These are installations that are used to support cell phone coverage. Today in most cities there are rules that govern where those towers can be placed, how big they are, and what exactly they can look like. Now, to be clear, the cell tow-

ers themselves are often big and have multiple parts. The reason they are called small is because they cover limited ranges, so the area they cover is small.

Up until now cities have been able to control all of the elements of design for those, including how big they are and how many can be in an area. Now the FCC [Federal Communications Commission] has implemented rules to allow cell companies to essentially do whatever

they want without city approval. The City of Portland in particular has been at the forefront of pushing back against this federal intrusion into the rights of cities. The City of Beverly Hills certainly agrees with the notion that cities ought to be able to control their own destiny. There was a lot of

energy around conversations about how we as cities can bind together and influence what the federal government wants to do. I think this was the first time that issue has gotten so much attention.

**What was it like hearing former Vice President Joe Biden speak at the U.S. Conference of Mayors?**

Joe Biden was one of three potential presidential candidates in the next election that showed up at this that I recognized, though there may have been more. The others were [Michael] Bloomberg and [Los Angeles Mayor] Eric Garcetti. So, we had at least three potential candidates for the presidency present.

Biden spoke mostly about climate change and the need to improve upon our infrastructure to be able to rely less on fossil fuel. He also spoke about reducing our carbon footprint and using renewable types of energy. His most important mes-

sage, however, was one that was in support of this country. He basically said that because of everything happening in the world Americans are walking around with the sense that the sky is falling, terrible things are happening, and that America is not what it once was. He told us to ignore that, stand tall, and lift our heads. This is the United States of America. There is nothing we cannot do if we put our minds to it. All we need to do is do the work and if we do the work we will be successful in reinvigorating this country. It was a very uplifting speech and I enjoyed it very much. His ability to take the temperature and mood of the country, I think, was spot on.

**Which Mayors did you spend the most time with at this year's conference?**

I probably spent the most time with the Mayor of Reno, Hillary Schieve. I also spent some time with Mayor Joe Covello from Cape Coral, FL, the Mayor of Kansas City, and Mayor Carey Davis from San Bernardino. Lots of Mayors from Oregon were there as well. Mayor Garcetti was there. I spent a good deal of time with the president of the organization, Mayor Stephen Benjamin from Columbia, SC. We had the opportunity to sit and chat for a bit.

**Which panel discussions did you participate in and what did you learn from them?**

There are panels for various subjects

like infrastructure, development, and economic mobility. The agenda is posted online if anyone wants to see specifics. You'll see that there are sessions, which generally are more like speeches, but also workshops and forums. Usually for those what happens is

Mayors sit

around a table and talk. Depending on the room and how many Mayors show up, you get to sit with other folks dealing with the same things that you are but in different places. It leads to interesting conversations. Take water, for instance. We know that for us water is an issue because we live in a drought-prone place. If you live on the east coast, you know water is a big issue there as well because they have to deal with flooding. So, different sides of the same issue come up a lot and it helps to work through that with those perspectives.

**Do you plan to implement any new policies or projects following the conference?**

I do think that we are going to take a more active role in some of this discussion of local control. We have instructed the City Manager and City Attorney to put information together for that. I think it'll take a few meetings for us to get there, but in terms of substantive conversation it'll probably be weeks or even a few months for us to really get into discussions about that.

## TO PROTECT AND SERVE

#### Where did you attend the police academy?

I began my police career in 2005 with the Orange County Sheriff's Department. I went through the Orange County Sheriff's Academy, which was in Garden Grove at that time. It has since relocated to Tustin. I was honored as the top recruit in physical training. I spent two years with the Sheriff's Department where I worked at the Theo Lacy Jail Facility in the City of Orange. I worked a variety of assignments there including court transfers, high-risk inmate housing, barracks, and academy preparation for incoming recruits. I lateraled in 2007 to the La Habra Police Department mainly because I wanted to hit the streets and didn't want to spend another five years in the jails or courts. While there I worked patrol, field training officer, motor officer, SWAT, defensive tactics, explorer advisor, political action committee member and acting traffic sergeant. In 2013, I lateraled to the City of Beverly Hills for financial reasons to support our growing family. But I was very careful when choosing my next, hopefully last, department. Beverly Hills fit what I wanted in a City and where I wanted to go. It was a good fit.

#### Who does the Beverly Hills Police Officers Association represent?

The Beverly Hills Police Officers Association represents sergeants and officers. Although our legal defense fund covers captains and lieutenants as well, we do not participate in their contract negotiations.

#### What is your role as the head of the union?

As head of the union my responsibilities are to look after the welfare of our members concerning disciplinary proceedings. However, these responsibilities can change year to year and from president to president. I feel the president is responsible for continuing communication/relationships with City Councilmembers and the City Manager. We are going into a contract year and knowing the Council expectations and concerns are important to iron out a good contract for both parties. As head of the union it is also important to have a good relationship with the administration. Chief [Sandra] Spagnoli was hired to be a progressive leader and implement a lot of changes from the Management Partners report. It is good to be able to find compromise with the Chief to implement these changes with little change to working conditions while accomplishing her goals.

#### What is the union's relationship with Police Chief Sandra Spagnoli given

#### the recent lawsuits and allegations against her?

The union is aware of the pending lawsuits against the Chief. Those will be settled through the City or court system. Our relationship with the Chief has not changed since the day she took the reigns of the department. In my three departments, I have served under two sheriffs and nine Chiefs of Police. Chief Spagnoli is the first Chief I have worked with who meets with the POA [Police Officers Association] on a scheduled monthly basis and has always been open to compromise with the POA on issues where we disagree.

#### Historically, the department has been understaffed with sworn officers, though recently there was a crop of new hires. Where is the department with regard to hiring goals?

Concerning hiring you would have to talk to the administration to get the numbers on that. However, from an officer perspective, we have hired a lot of officers over the past two years. But the department is also in a state of expansion as we are trying to get ahead of the curb on a lot of changes to the community. This is a trend that is happening to all the surrounding Police Department's mainly due to the impact of the incoming Metro stations and what issues that may bring. However, there are still a lot of tenured



officers retiring every year so the department is always playing catch up. Realistically, no department is ever 'fully staffed' for this reason.

#### What part about being a police officer is not as glamorous as it looks on TV?

There are a few things not as glamorous about being a cop as it appears

on TV. If a TV show or movie were to accurately depict a real cop story, the real 'action' scene would be the first 10 minutes of the episode followed by two hours of paper work. Also repeatedly dealing with the dark side of humanity for years takes its toll on the best of us.

#### What advice do you give to new officers?

One piece of advice I give to new officers is to share their day and experience with their significant others. The details don't need to be present but if you can't share your day with your loved one then it creates a wall and a divide that I have seen cause issues. Sharing your day with another police officer is one thing, but being able to express it with your loved one will make sure they are on this journey with you. I am lucky that when I have been through a traumatic call my wife is always open to listen and it always lifts the weight of witnessing a horrible event off my shoulders.

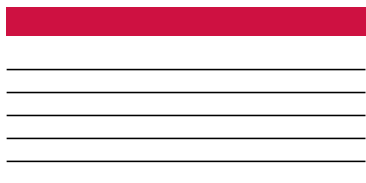
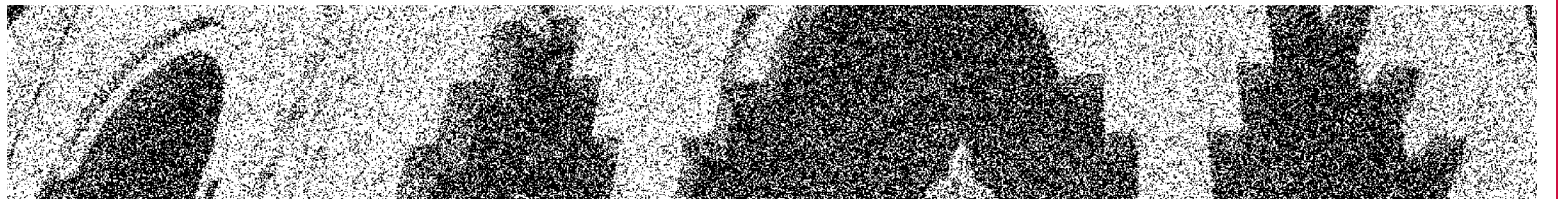

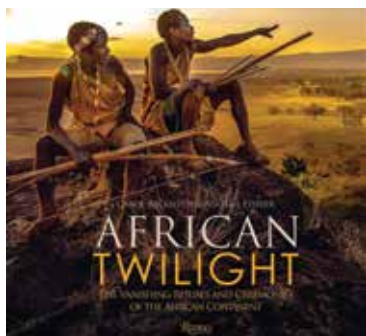
