

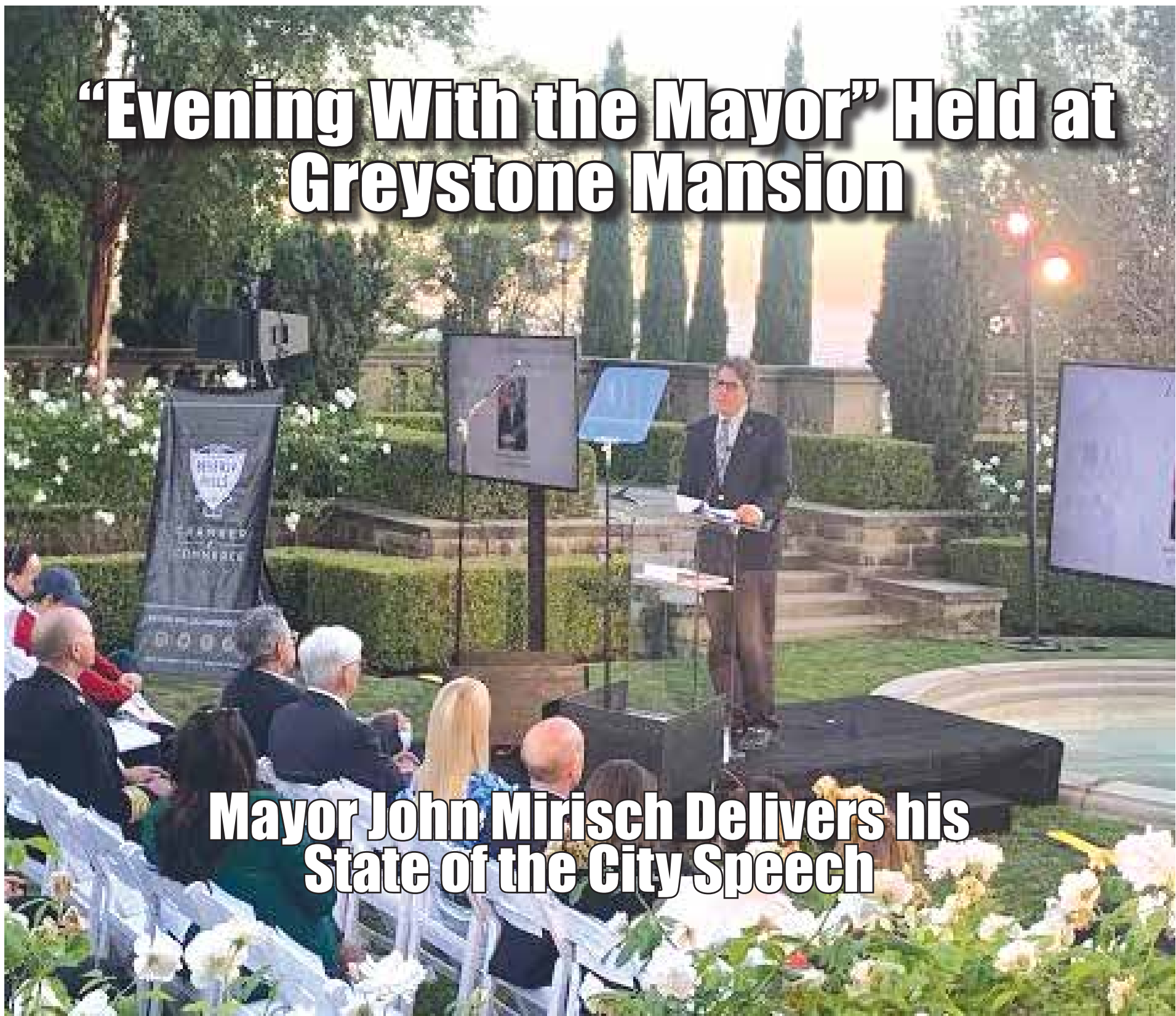

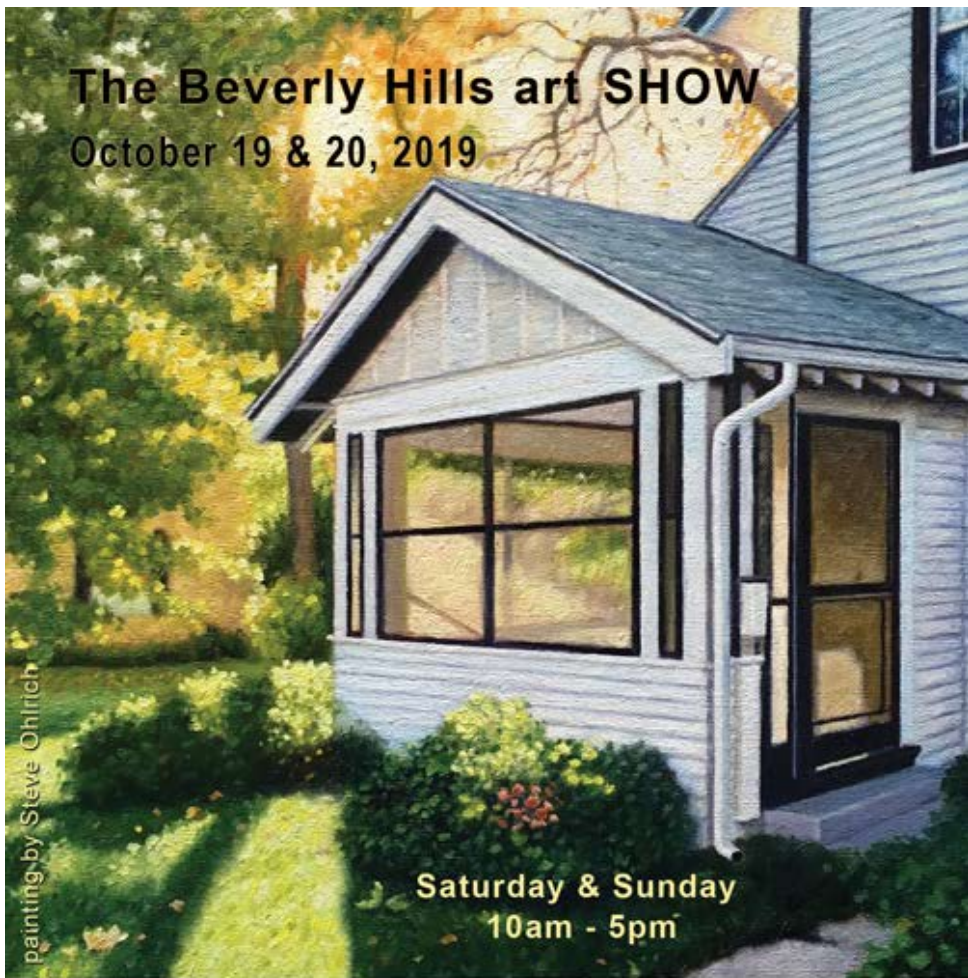

## La Cienega Town Hall Meeting Held on September 25

A town hall meeting was held on September 25 to provide updates and public comment on the La Cienega Park Master Plan.

This is the third town hall meeting concerning the project. The first meeting was held on October 18, 2018, and the most recent prior to last week's meeting was held on February 27 of this year.

The City Council met on April 2 after the February 27 La Cienega Town Hall meeting to discuss refining the master plan, establish priorities, develop an implementation strategy, analyze costs, and identify a phase one proposal.

A Council Liaison Committee reviewed revisions during an August 14 meeting.

Cal State Sacramento Senior Mediator Dave Ceppos introduced the discussion and presented most recent survey information concerning the park.

The public outreach summary presented by Ceppos indicated a stakeholder assessment of 24 interviews and 46 participants, eight focus groups with 62 participants, a comprehensive publicity and media program, and an online survey with

## A Statement from Board of Education Member Tristen Walker-Shuman Regarding the Academic Calendar:



While we hear from a few teachers and community members that starting later in the year or taking a longer Thanksgiving break will negatively impact student's performance on AP testing, that is not accurate. AP scores have remained flat for the last 11 years despite a total upheaval in our calendar moving from a Labor Day start to a mid

August start. The excuses are unfounded and easily proven inaccurate. By making this massive change, we gained between 8 and 10 additional instructional days for these AP students between the start of the school year and AP test, and there was no significant or consistent rise in achievement during the same timeframe.

There were 418 AP students out of approximately 3600 students enrolled last year. That represents 11% of our population. In addition there were over 236 stu-

dent absences and 46 teacher absences in 2018 in the three days before Thanksgiving break. This represents almost \$10,000 in additional expenses paid by the district for substitute teachers on those days alone, with a clear reduction in actual delivery of any curriculum on those days. By comparison to many other local district we have many more days to prepare, and yet we see no result from this change. The question is, why do we do the same thing year after year and expect a different result? The earlier calendar start and short Thanksgiving break is not delivering better AP test results and therefore is not a rational justification for keeping it. There are countless districts with later start dates, longer breaks and fewer instructional days prior to AP testing (which is the same for all students nationwide) who achieve far higher scores than we do - it is on us to explore what will ensure more success, but one thing we can completely discount as a guarantor of success is our calendar.

Claims that it is better for students to start earlier, have shorter breaks, or additional instructional days before the end of the 1st semester are not factual, they are

unsubstantiated opinion.

The teacher's union [BHEA] supported the proposed calendar 92-8 and the reasoning that only 100 teachers voted so somehow it's not representative of true support is just silly. All union members have the right to vote on the calendar, and to be informed as to the content of what they were voting on. If they did not support it, they should have participated in the vote, and/or voted no. If we were truly going to make decisions based on "majority" opinion, then we should have a district-wide survey allowing all parents, students and staff to respond.

The district staff (professionals in education) and calendar committee created this proposed calendar and recommend it. The teacher's union voted in favor of it. It's time to stop making decisions based on feelings and anecdote, shackled to the way we have done things in the past in favor of data-driven, fact-based decisions truly reflective of our stakeholders and education experts. Our students, families, faculty and community deserve no less.

700 responses.

"57 percent [of the 700 responses] say they use the park at least once a week," Cerros said. "Of those people, about 30 or so percent were not residents [of Beverly Hills], but nonetheless make active use of the park."

Almost everyone surveyed expressed interest that current uses of the park should be retained. These programs and recreational activities include organized sports, running paths, tennis, youth play, a duplicate bridge club, and a new community center.

"There is a need for a better, multi-functional community center," Cerros said. "A lot of people said [the current center] is too old, and needs to be repaired."

The survey also indicated that residents would like to see restrooms, snack bar, ballfield configuration, and playground remodeled.

"The playground is very high on the list. [Those surveyed] said the equipment gets too hot, and that it should be replaced with something newer," Cerros said.

The highest priority on the list, according to those surveyed, is the proposed pool.

"By far, the number one thing that users responded to was the need for a public pool, by a very far significance," Cerros said.

Councilmembers Lili Bosse, Julian Gold, and Robert Wunderlich attended the town hall meeting as well.

Jim Favaro, Principal Architect behind the design of the project, presented the master plan implementation update.

Favaro broke down cost components related to the site into four categories: buildings, aquatics, ball fields and park open space, and parking, streetscape and infrastructure.

"In this case, we were fortunate because the City has a cost estimator and consultant [team] who worked independently and we arrived an agreement on a number to present to Council," Favaro said.

The community center is estimated to

cost \$500 a square foot, gymnasium to cost \$445 a square foot, rooftop tennis to cost \$75 a square foot, and demolitions to cost \$15 a square foot. The most expensive costs in terms of square footage pricing would be the preschool at \$600 a square foot and kitchen and concessions at \$750 a square foot.

The community center will cost about \$24.5 million, Favaro said.

A new, one-story parking area will contain approximately 310 parking spaces, and will feature a 16-court tennis center on the roof. The parking structure will be located on the west side of La Cienega Boulevard beginning on the south end of the park. Parking is also proposed on the east side of La Cienega Boulevard with approximately 180 spaces in single-aisle, subterranean garage.

Also proposed is a storm retention basin that will be placed on the east side of the park, a new little league field and adult softball field on the west side of the park, an outdoor fitness circuit, and multi-purpose field on the east side of La Cienega Boulevard. An elevated park extension is planned over the boulevard as well.

"The grassy slope would extend over from the east section of the park and over the boulevard to arrive at the threshold of the community center," Favaro said.

The main purpose of the elevated pathway is to "provide seamless connection between all the [sections] of the park," Favaro said, and that it would not be like crossing a bridge but moreso "strolling from one part of the park to the other."

Favaro cited New York City's Highline public parks project as a "fair comparison" to the elevated bridge.

The updated review will be before the Council during an October 22 session, including public comment at this meeting.

### Simchah Green Announces Bid for City Council

Simchah Green has announced his candidacy for the March 3, 2020 election.

Green graduated from and was ordained as a Rabbi at Yeshiva University, and has served in several modern orthodox syn-

agogues on the East Coast. Green arrived in California to be the Rabbi of the Young Israel of Santa Barbara in 2005, and has permanently resided in the state since then. He has lived with his wife in Beverly Hills for the past four years.



"I am presently involved in *Simchah Green* many aspects of Jewish education, especially teaching men and women who are candidates for Jewish conversion," Green said.

Two years ago, Green offered to "volunteer as liaison to the Beverly Hills large Jewish community," and is "therefore running for a City Council seat in order to properly serve such a liaison role without any strings attached."

Green cites his platform in four "major planks," to change in the present City position on marijuana, he presents "a plan for the acceptance of medical marijuana stores and institutions within the city limits since the vote on Proposition 64 three years ago was in favor of the same."

Additionally, Green cites that "There are 11 synagogues in Beverly Hills, two Reform and 9 Orthodox. I shall show these congregations how they can approach the city council in a variety of ways, all legal, for the mutual benefit of the city and its 60 percent or more proud Jewish population."

Green plans on being an active voice for the large senior population in the City, and said he will run his campaign without any large expenditure of money.

"Perhaps it is time Beverly Hills has a Torah observant member on its City Council," Green said.

### The Wallis Adds Five Business Leaders to Board of Directors

The Wallis Annenberg Center for Performing Arts is adding five business leaders to its growing Board of Directors. Chairman of the Board of Directors Michael Nemeroff announced the election last week.

The additions include Thomas Blumenthal, Donald Kivowitz, Agnes Lew, Peter Lowy, and Richard Ziman.

Blumenthal, a Beverly Hills resident, has served as president and CEO of GEARYS Beverly Hills. Currently, Blumenthal serves as the Chair of the Board of Trustees of Mount St. Mary's University, where he has been involved since 2002. He continues to serve on numerous philanthropic boards and com-

### 360 and 375 North Crescent Drive in Consideration for Landmark Status

At the recommendation of the Land-  
mark Nominations Subcommittee of the  
Cultural Heritage Commission, the com-  
mercial properties at 360 North Crescent  
Drive and 375 North Crescent Drive are  
before the Commission for consideration  
of initiation of landmark proceedings for  
eligibility as a local landmark and to be  
placed on the Beverly Hills Register of  
Historic Properties.

"The properties remain in well-main-

tained condition with no major compro-  
mises to their architectural integrity and  
both appear to be eligible for listing, in-  
dividually or together," the report read.

Architect Paul R. Williams earned the  
Award of Merit from the Southern Cali-  
fornia Chapter of the American Institute  
of Architects in 1939 for the headquarters  
of the Music Corporation of America, lo-  
cated at 360

North Cres-  
cent Drive in  
Beverly Hills.  
The overall  
complex was  
construct-  
ed over time  
(beginning  
in 1937 with  
the northern  
building) and  
includes of-  
fice space,  
gardens with  
fountains and  
statuary, and  
a subterra-  
nean parking  
garage, all of  
which are de-  
signed in re-  
sponse to the

Georgian-revival architectural style.

The classically inspired garden office  
campus consists of a north and south  
building with a courtyard between and  
an aboveground parking structure across  
the street from the office complex at 375  
North Crescent Drive, designed cohesive-  
ly in the Colonial Revival architectural  
style in 1967 by structural engineer Ray-  
mond Itaya for the firm Ty Lin & Asso-  
ciates. The office campus (consisting of

mercial area of Beverly Hills (Georgian  
Revival) and the properties also appear to  
meet the definition of iconic, as stipulated  
in the Municipal Code.

The highly identifiable architectural  
work at 360 North Crescent Drive has  
also proven, over time, to be an excep-  
tional work by the Master Architect Paul  
Williams, a prolific designer for fashion-  
able clientele in Beverly Hills.

The project was pushed to an ad hoc  
meeting set for a future date.

### Traffic and Parking Reviews Modified Right-of-Way Signage

The Traffic and Parking Commission  
reviewed modified signage to bicycle  
lanes and channelized intersections at a  
meeting last week.

Staff submitted a work order to Public  
Works to change out the "No Stopping  
Any Time" signs to "Tow-A-Way/ No  
Stopping Any Time" and install an addi-  
tional sign between the first two street-  
light poles closest to the Waldorf Astoria  
driveway, to further deter vehicle parking.  
The work is scheduled to be completed by  
October 31.

Commission Vice Chair Jake Manaster  
mentioned that there may be potential li-  
ability "for not having a stop sign at the  
cross section [at the intersection near]  
Waldorf Astoria."

Reeves Drive resident Mark Elliot ex-  
pressed a possibility of "a raised table  
crosswalk" for the intersection.

"When I look at the roads from a user  
perspective, I often wonder why the  
[roads] are constructed this way," Elliot  
said, adding that modifications should be  
looked at from a pedestrian and cyclist's  
perspective as well, "not just a driver's  
perspective."

Staff is also working  
with the Public Works  
Commission to identify  
possible enhancements to  
the westbound "Class 2"  
bicycle lane configura-  
tion.

Seven channelized is-  
lands at seven intersec-  
tions were reviewed for  
modification to signage,  
with opportunities to  
change in the future.

The Rexford Drive and  
Clifton Way intersection  
will be reconstructed, so  
pedestrians have a "ref-  
uge island," according  
to the report. Crosswalk  
markings will be added.

Commission Chair Jay  
Solnit argued that the  
pedestrian crosswalk at  
that intersection is too  
long and can benefit from  
modifications.

"Cars coming east go  
right through that stop  
sign" said Solnit, adding the need for re-  
placed signage at the intersection.

Wilshire Boulevard and Beverly Drive bike share station was removed the week of September 16. The Traffic and Planning Commission reviewed a possible relocation of the bike share station at a meeting last week.

Staff had proposed to temporarily move that station to the southeast corner of Wilshire Boulevard and Le Doux Road adjacent to 8530 Wilshire with up to nine racks, and the sidewalk adjacent to Reeves Mini Park at 125 S. Reeves Drive up to six racks.

Only one bike share station was proposed for installation, and the existing 50-bike fleet would remain the same with no expansion. Staff proposed two sites for consideration from the commission, Wilshire and Le Doux and Wilshire and Reeves; neither site was selected.

"Three commissioners expressed waiting for a broader discussion on mobility devices, including exploring possible conversion of the fleet to electric bikes, and coordinating with the forthcoming Complete Streets Plan to identify more useful locations. The existing 50-bike fleet will be distributed among the nine existing bike share stations," City Transportation

Planning and Traffic Engineering staff reviewed the sites and confirmed them to have available space, ADA clearance, and pedestrian access. The sites were also reviewed by the BHPD, BHFD, and Community Services Staff.

Public notices were mailed to residents and businesses adjacent to the two proposed stations, but no correspondence was received as of September 25.

The City officially launched the Bike Share program on May 10, 2016, and currently has 50 smart bicycles in circulation within the system.

We're up to 694 students now [total], and we have 30 TK through 5 classrooms. In TK we have one [section], in kindergarten we have 4, in first grade we have 4, in second grade we have 5, third we have 6, in fourth we have 5, and in fifth we have 5 [sections].

**And I'd imagine Horace Mann hasn't gone through any physical changes like Hawthorne has due to reconfiguration?**

Not due to reconfiguration, no. We did have some final construction; they did just finish the roof, which is beautiful. But other than that, it was just moving of furniture. All of the middle school furniture went to [Beverly Vista] and all of the elementary furniture came here [from there].

As far as the physical layout, Horace

Mann has not changed.

**How do the kids seem to be taking to the changes?**

I think the beginning of the school year is always interesting in terms of getting to know a new community, but it is bringing the two communities together, and in that [the students] are getting to experience new friendships and new teachers.

Everything is a learning curve, but I think we are all having fun in the process.

**Are there any new extracurricular programs or afterschool activities offered this year?**

In terms of what is offered after school, we do have all of the adventure camp programs, and during the school day we have the same "specials" classes that Hawthorne has: instrumental music, choir or vocal music, art, science, MakerSpace, and P.E.

**In her issue 1042 interview we asked Hawthorne Principal Sarah Kaber what she thought was the biggest challenge of reconfiguration. She said, "I would say that the biggest challenge has been merging pre-existing communities into one, new community, without anyone feeling a loss of what they've had." What do you think was**

**the biggest challenge?**

I think along those same lines [as Sarah Kaber said], bringing those two communities together and bringing along specific traditions to those two specific communities, and how to merge those has been the biggest challenge.

I think it's not just about the kids, its about the [all encompassing] communities: the kids, the teachers, and the parents as well.

**What district and grade level did you teach before coming to Beverly Hills?**

I was in Burbank for 14 years. When I was in the classroom, I mostly taught 5th grade, but sometimes 4th. Over there, I was a curriculum specialist, which is a teacher on special assignment, and I did that for nine years.

I loved teaching [4th grade]. They still, for the most part, love coming to school, but they also get your humor! That was the biggest [positive] for me, and what I loved about 5th grade, is when they give it back.

When I was a curriculum specialist, I

taught intervention for TK through grade 5. Intervention was for kids not meeting grade-level standards. I worked with the students on specific academic holes that

they may have had, and filled those holes and got them up to grade-level standards and expectations.

Watching those kids that didn't believe themselves, achieve and then celebrate, was what I enjoyed about that the most. It gets me emotional. The kids that didn't think they could, and they did.

**Do you experience any of that now, as a principal?**

Absolutely, that is what my job is all about. Now, my job is not just with the kids, but with the teachers and the parents and the community, and to bring everyone together and really help everyone reach their full potential, including myself and the school as a whole.

# “EVENING WITH THE MAYOR” HELD AT GREYSTONE MANSION

## Mayor John Mirisch Delivers his State of the City Speech

Mayor John Mirisch delivered his State of the City speech on October 3.

Mirisch spoke on Beverly Hills becoming the first city in America to pass a ban on the sale of all tobacco products.

“We have always been a City that has taken the lead on restricting smoking and promoting public health,” Mirisch said. “Now that we’ve taken action, we call on other cities follow suit and do something about the 480,000 tobacco related deaths in America each year.”

Mirisch's speech also mentioned the City's effort to minimize the impacts of construction as Metro continues to expand the Purple Line.

Another focus of the speech was continuing efforts to plug the oil wells at Beverly High, which “is expected to be complete next summer,” Mirisch said.

Also mentioned was the master plan for La Cienega Park. Mirisch said the Council will be making some important decisions as the City prepares to create “a dynamic experience for the next generation of families in Beverly Hills.”

Mirisch later addressed California's housing affordability

crisis.

“Policies like those embodied by SB50, SB330 and other Wall Street-driven bills, which fly in the face of the personal choice of Californians throughout

the state, have the potential to destroy the diverse unique communities throughout our state, all using the pretext of homelessness and housing,” Mirisch said.

Also mentioned was Environmental Activist Greta Thunberg, whom Mirisch referred to as his “Swedish lantsman,” before agreeing with her own monologue at the United Nations.

“She’s right, of course. Shame on us, who aren’t even willing to question the fairytales of eternal economic growth, which are the basis of the anti-community, trickle-down, Reaganomic housing policy that Sacramento and the Trump Administration are trying to force upon us,” Mirisch said.

Mirisch also took the remarks as an opportunity to “salute those who have called our City home for decades and those who go above and beyond with acts of love, kindness, and loving kindness.”

“If we are to allow ourselves to broaden our horizons and expand our potentials, we need to practice not only kindness, but tolerance. In fact, I would argue that tolerance is a major component of true kindness. Maybe we can remember the

power and importance of simple human decency within our community,” Mirisch said.

Mirisch closed his speech asserting that he “firmly believe[s] that community is an extension of family and home.”

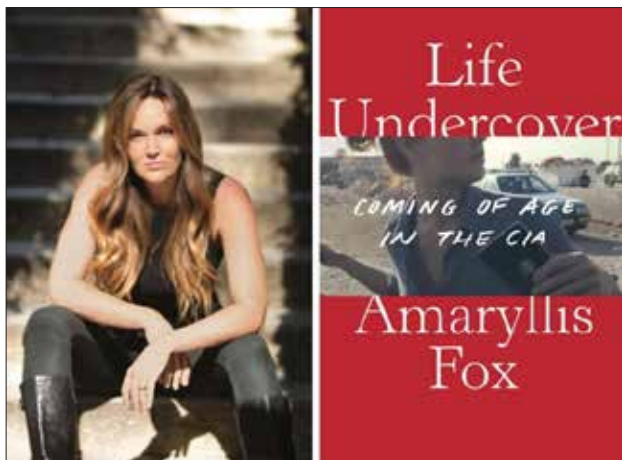
“It is precisely because local government is a reflection of community, that when done right, it is the absolute best form of democracy. It’s nonpartisan. It’s closest to home. Home, that magical, comforting place where we belong, where we don’t have to explain ourselves, where we can be ourselves, where we are safe and where we can build a life together,” Mirisch said.

## BHHS football team again routed by Lawndale

The Beverly High football team “just got hit in the mouth by a juggernaut” in its 63-0 loss at Lawndale Friday night in the Ocean League opener for both teams, coach Jarrod Bunch said.

“They’re big, they’re strong, they’re fast,” Bunch said.

The Normans (3-3) were held under 100 yards, Bunch said.

The Cardinals (4-2) had a substantial size advantage over Beverly Hills, both physically and in the number of players in uniform, Bunch said. The Normans had 23 players in uniform, Lawndale about 55, according to Bunch.

“They can put fresh new people in all the time and we have to roll with the same guys on offense, defense, special teams,” Bunch said. “It takes a toll.”

Bunch said his team benefited from the game because “we saw a championship team.”

“If we want to be a championship team, we have to play to their level,” Bunch said. “We physically felt how they played. We saw how they came on the field. We saw how they established their will and if you want to be a championship team,

that’s what you have to do.”

The Cardinals are the defending CIF State Division 2A champions. They were fifth in the Southern Section Division 3 poll released Monday, the same rank as the previous week.

The Normans are 0-6 against Lawndale since it was moved into the Ocean League for the 2014 season and been shut out five consecutive times.

Beverly Hills has been outscored by the Cardinals 354-7 since 2014, including 61-0 in 2018.

### What’s Next?

The Normans are scheduled to play host to El Segundo Friday at 7 p.m. at Nickoll Field, seeking to end a 17-game losing streak in league play dating back to 2015.

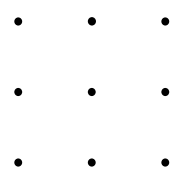
