"Dump Spagnoli"

Throughout America, good police officers are fleeing cities whose residents attack or hate them. In Beverly Hills, we love our police yet dozens of our finest have fled, not from the citizens they protect, but rather from their prejudiced, ill-willed, incompetent police chief, Sandra Spagnoli.

I urge the City Council still again to remove Spagnoli from the position of police chief. Replace her with a competent person of integrity who can restore leadership to our police department.

The citizens of Beverly Hills have become impatient and continue to await decisive action from you. You have had overwhelming evidence of Spagnoli's incompetence and lack of integrity almost from the start of her employment. She has cost our city dozens of our great police officers, and multi-millions of dollars in attorney fees, legal judgments and settlements against her.

Under Spagnoli, the number of detectives has shrunk, and with it, the conviction rate.

Under Spagnoli, crime stats don't add up, and are hidden from the council and the public. Under Spagnoli, young officers remain under-trained, under-educated, or unmotivated to carry out basic law enforcement.

Because Spagnoli does not have enough lieutenants at the moment, she is drafting two underqualified individuals who meet neither the training nor the educational standards that the Beverly Hills Police previously required. There is little or no training for new recruits and Spagnoli is specifically incompetent to train them.

Our patience is gone. It's election season, and make no mistake: Just because only two of the councilmembers face re-election this time around, a change in the mix will impact each of you who remain.

At some point, a responsible city council will remove Spagnoli, and the problems you have ignored or obscured will permanently define your public life.

Ultimately, we need excellence in police leadership that is both sensitive and mature. According to Mayor John Mirisch, these are among the specific traits Spagnoli lacks. I ask you again, Mayor, why have you not removed the current chief who you know to be unfit for the job?

T & P Holds Special Complete Streets Meeting

At a special meeting on December 3 in the Municipal Gallery, the Traffic and Parking Commission discussed the ongoing Complete Streets plan.

The purpose of the meeting was for community members to provide input on the drafts of both the Complete Streets Plan and Technical Appendices, and the Complete Streets Action Plan.

The discussion follows a meeting several *Robert K. Tanenbaum* years ago where the City Council agreed on the implementation of a Bike Mobility Plan as the first step in developing a citywide mobility plan. They supported expanding the scope of the plan to a "complete streets approach," which included a comprehensive analysis of pedestrian, bicycle and street networks, and emerging transportation modes like automated vehicles.

Since then, the Complete Streets Plan has garnered significant community attention through a robust outreach process that consisted of online surveys and local events. Generally, most community members expressed support of a Complete Streets plan but have voiced that the plan “lacked project specifics.”

At last week’s meeting, community members showed up en masse to discuss the future of the Complete Streets Plan, including former Mayor Robert K. Tanenbaum expressed frustration over a recent mailer that he claims implied the plan allows the option to mark off Whittier through Elm Drive for bike lanes, thus preventing residents from parking in front of their homes. He also called the mailer deceptive and misleading in glossing over its real intent.

“Could you imagine the impact which could ultimately happen if we go forward of residents knowing homeowners that are no longer allowed to park in front of their

home?” said Tanenbaum. “It’s a radical deviation from our way of life. We pay dearly for our homes.”

During deliberation the commission talked about the potential revisions to the plan.

“I do think this kind of a plan necessitates an awful lot of intellectual capacity to figure out solutions that allows access to what is needed for everyone’s choice without substantially and unfairly impacting one person’s privileges to do certain things in the City over others,” said Vice Chair Jake Manaster. “I think that’s going to be a very tough balance because people feel very close to their property rights such that they’re going to know that one neighborhood wasn’t favored over another, one street wasn’t favored over another and one home wasn’t favored over another.”

Manaster pointed out that finding a balance would be a “difficult task” since the area is quite large, but that going forward the City will need to thoroughly consider

who will be impacted positively and who will be impacted negatively.

Commissioner Nooshin Meshkaty suggested the idea of starting neighborhood meetings instead of solely holding sporadic meetings at the Municipal Gallery in order to encourage community engagement.

“Whether we want it or not, at the end when it goes in front of the City Council, if it’s something they’re against they will rally up and all the work from months and years will be going down the drain.”

The discussion is currently ongoing, but it’s estimated that the City Council will adopt the Final Draft Plan and Action Plan in January 2020.

Demeter, Hudnut Named Planning Commission Finalists

Myra Demeter and Tom Hudnut have been named as finalists to fill two upcoming vacancies on the Planning Commission.

Demeter is currently a Health and Safety Commissioner. She previously served on the Beverly Hills Board of Education from 2001 to 2009.

Though new to city government, Hudnut has led a significant career in private school

education administration. Before retiring in 2013, Hudnut was the headmaster of Harvard-Westlake, including when Harvard and Westlake merged in 1991. He currently runs Resource Group

175, a search consultant firm that provides services like head of school and senior administrator searches as well as executive mentoring.

The Planning Commission interview panel consisted of Mayor John Mirisch, Councilmember Lili Bosse, Planning Commission Chair Alan Robert Block, and Vice Chair Peter Ostroff. The panel interviewed 17 applicants for the upcoming vacancies, which will replace Block and Commissioner Joe Shooshani.

With the concurrence of the City Council, a formal report for adoption will appear as an item at the December 17 meeting. Demeter and Hudnut’s appointments are set to begin January 1, 2020.

Whitworth and Elm Stop Sign Discussed

NOTICE OF PUBLIC HEARING

The Council of the City of Beverly Hills, at its regular meeting to be held on **Tuesday, December 17, 2019 at 7:00 p.m.**, or as soon thereafter as the matter may be heard, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

AN INTERIM ORDINANCE OF THE CITY OF BEVERLY HILLS TO PROHIBIT RESIDENTIAL DEVELOPMENT PROJECTS THAT FAIL TO COMPLY WITH INCLUSIONARY HOUSING REQUIREMENTS AND CERTAIN PUBLIC NOTICING REQUIREMENTS AND DECLARING THE URGENCY THEREOF.

The Council will consider whether or not to adopt an Interim Ordinance that would establish when a residential development project must provide affordable housing units and/or pay an in-lieu fee, and to establish different public notice requirements for certain planning applications. If adopted by four fifths vote of the City Council, the Ordinance would take immediate effect, and remain valid for 45 days unless further extended by the City Council in accordance with the provisions of Government Code Section 65858.

This Interim Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. The adoption and implementation of the Interim Ordinance represents minor alterations in land use limitations and noticing procedures for certain projects and do not result in any changes in land use or density. It can therefore be seen with certainty that there is no possibility that the proposed amendments may have a significant effect on the environment. In addition, the Interim Ordinance consists of an action taken by a regulatory agency for the protection of the environment due to the fact that it will apply inclusionary housing regulations to all multi-family housing developments. Accordingly, the City Council will consider the staff recommendation to find the Interim Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15061(b)(3), 15305, and 15308 of the California Code of Regulations because it can be seen with certainty that there is no possibility that the activity in question would have a significant effect on the environment.

All interested persons are invited to attend and speak on this matter. Written comments also may be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. Written comments should be received prior to the public hearing date. Any written comments received by close of business on Tuesday, December 10, 2019 will be attached to the agenda report regarding this item. Any comments received after Tuesday, December 10, 2019, but prior to the public hearing, will be distributed to the Council under separate cover. Please note that if you challenge the City’s action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at a public hearing or in written correspondence delivered to the City, either at or prior to the end of the public hearing.

Pursuant to the Americans with Disabilities Act, the City of Beverly Hills will make reasonable efforts to accommodate persons with disabilities. If you require special assistance, please call (310) 285-2400 (voice) or (310) 285-6881 (TTY). Providing at least forty-eight (48) hours advance notice will help to ensure availability of services. City Hall, including the Council Chamber and Room 280A, is wheelchair accessible. The City Hall Council Chamber and Room 280A are also equipped with audio equipment for the hearing impaired.

The intersection, shared between the City to the north and Los Angeles to the south, has garnered significant push since January 2018 to transition from a two-way north-south stop control to an all-way stop control.

Approved by the Traffic and Parking Commission at their December 5 meeting, the installation warranted mailed notices of the commission's impending review to residents within 500 feet of the intersection. This included the 400 South blocks of Whitworth, Beverly, Canon, Crescent, Elm, Rexford, Maple, Palm and Oakhurst.

Staff also advised the City of Los Angeles traffic engineering staff on the meeting.

In March 2018, city staff conducted an engineering study for a multi-way stop application and evaluated existing signage and striping conditions. But based on the evaluation, they determined an all-way stop was not needed and instead painted red an additional ten feet curb on Whitworth to improve sight distance.

But neighborhood frustration persisted when a resident spoke at the May 2 Traffic and Parking Commission meeting, urging a reevaluation of the contentious intersection based on updated data.

According to the staff report, both the City and Los Angeles reviewed the new findings and subsequently determined that the intersection meets the guidelines for an all-way stop installation.

Derrick Ontiveros Incoming Next Beverly Hills President

So you're the new Chair of the City's Next Beverly Hills Committee. Tell us about that.

It feels really great. I was lucky enough to have Kaveh Farshad as my Chair this year, and I was Vice Chair all year. He was Vice Chair last year and prior to that he was involved in the leadership for our Next Night block party. So he really helped me out a lot; he was a great influence and really showed me the ropes. I got a lot of pointers and tips from him. He did a good job of including me in everything—communication with the City, the decision-making process, running the committee. So I feel really good about it and I'm happy to have had that experience with him.

What made you want to first get involved with Next Beverly Hills?

I really believe in the mission of Next Beverly Hills. Beverly Hills is obviously where our population skews older and that is a great thing in a lot of ways but I think bringing younger people into the City and making the City more attractive to younger people—whether that's a place where younger people want to come hang out at night or live—I just want the younger generation to see Beverly Hills as a place they want to live and also a place they want to work. There are a lot of amazing companies in the City of Beverly Hills and I personally would like to see more tech and entrepreneurship in Beverly Hills for younger people. I think our mission is really conducive for that; we really work hard to make Beverly Hills the place for the younger generation, and we have some stiff competition in LA.

Yeah, West Hollywood and Culver City are neighbors to the City.

These cities are doing an excellent job of creating an atmosphere where people want to be, where the younger generation wants to be. We can do that too here

in Beverly Hills.

Tell us about your professional background before joining the committee.

I'm a software developer. I have an HR software business that I'm a partner in, and I do all sorts of software application development. I've had an entrepreneurial background myself. With entrepreneurship you have to have the skill and the knowledge to make your business a success, but also a really vibrant network. Beverly Hills is a place to build that network. There are certainly places that are less expensive to live and have an overall cost of living, but I think the payoff of having a business in Beverly Hills is tremendous. We might have a lot of high-end retail here, but if you want to start a tech business or something in fashion or the entertainment industry, Beverly Hills is a great place to be and that's why we have so many businesses in those industries here.

What priorities does the committee have for 2020?

We do set annual priorities every year. Under my leadership starting in January, one of the first things we're going to do in our January meeting is go through a priority-setting exercise and decide on five or six priorities we want to focus on. However, there are some that I think I can safely say will be carried over. This year one of our new priorities was entrepreneurship and innovation, and we were lucky enough to have some people who started the Beverly Hills incubator last year. We created a program where we help young entrepreneurs and early-stage startups learn about the various aspects of starting a business and the things they have to do to prepare themselves for a round of financing or funding. We do that all within Beverly Hills. So in addition to helping them go through the process of building a business model canvas, we also explain to them why Beverly Hills

is such a great place for them to be and a place where they should aspire for their business to be. Since we have residents that are looking to fund early-stage startups, Beverly Hills could be a place where new, innovative young businesses seek to be. Another area of focus that we have is Next Gen art. One of our members, Corey Clem, was instrumental in putting a mural on the North Canon soundwall, rather than having the Metro graphics. I would really like to expand on that this year and bring more Next Gen art into the City. Things that are more Instagrammable give the City more of a young, vibrant vibe.

In August, you threw a block party as part of the City's BOLD initiative. Do you plan to do that again next summer?

Yes. We plan to do Next Night again next summer. We're hoping to continue to expand that. It was our fourth year last year and it was our second year as part of the BOLD program, and we'll be continuing that with BOLD this year. I think every year it gets bigger and better and we're definitely going to aim for that this year.

When we talked to former chair Kaveh Farshad in Issue #1011, he mentioned wanting to build an "ecosystem for community" for next generation residents. He said, "We want to create a sense of connectivity between people, a network effect that allows for grassroots growth in terms of connecting with one another. Right now I believe there is a vacuum for that demographic." Do you feel you have accomplished that?

We've definitely made a big leap forward in that regard under Kaveh's leadership. I don't think we're ever go-

ing to say, "We've accomplished that." We want more and more to create that community here. But I will say that right now our membership is very strong. We have a very strong core group of people who are dedicated from various walks of life, vastly different backgrounds and all age groups. To be a member of Next Beverly Hills you just have to believe in the mission. We're not looking for a specific age or particular industry. We have some really great members and we've come a long way. We want to make the committee more than a place where we talk about ideas, but also where we learn from each other, open up to each other, and create those bonds.

What is one specific thing you want to have accomplished by this time next year?

We have a very good groundwork in place. I'd like to grow our events series. I'd like to have events once a month. I'd like to see new faces at these events—people who are really considering Beverly Hills as a place to start their lives, grow a young family or move their business to. I'd like to be much more successful with outreach and have greater reach beyond just the people in Beverly Hills or who know about us through someone in the City. I guess what I want to do is grow the committee with people that really share the mission and want to make Beverly Hills work for the younger generation. The founder of Next Beverly Hills was Julian Gold; he's been our biggest advocate and [having him] really believing in Next Beverly Hills and pushing for initiatives that bring in younger people has been tremendously helpful and beneficial for us and our members.



"There are certainly places that are less expensive to live and have an overall cost of living, but I think the payoff of having a business in Beverly Hills is tremendous"

TINA TALKS

The entrepreneur discusses her upcoming book “Napkin Finance”

Beverly High graduate Tina Hay's new book “Napkin Finance: Build Your Wealth in 30 Seconds or Less” will hit shelves on December 30th and is available for preorder now on Amazon. The Weekly spoke to her about her career in finance and upcoming plans for the book.

Your new book “Napkin Finance: Build your wealth in 30 seconds or less” will be released on December 30th. What inspired you to write it?

The inspiration behind the book was my own challenges in business school, coming from a liberal arts background. I went to business school at Harvard Business School and was in a classroom with bankers and former consultants. Coming from a liberal arts background I had never really taken finance classes. I'm a visual learner, as most people are, and visual learning is a classic concept. I started sketching out notes and using illustrations and graphics to answer my own questions. When I started Napkin Finance, the napkins and visuals really resonated with people. Our entire platform became this visual type of learning. So, the book Napkin Finance is basically a visual way to learn about money and simple finance to make it more digestible, engaging with a concept that traditionally has been intimidating for most people.

How did you get involved in finance?

I always wanted to go to business school and was an entrepreneur even before I went to graduate school. I had started another business before that called City Tripping, which was a lifestyle guide channel. I had always wanted to and loved starting companies. And I had always wanted to go to business school. The timing was right, and I got in at a time when I had a break from other projects.

I kind of accidentally got into finance. I went to business school, graduated, and really had never thought I would launch a company that was involved in any kind of financial services or content. But I think being an outsider has really helped me give people a perspective into the world of money and finance so it can be more empowering and transparent. The goal is to really help people make better decisions and understand their choices. Being an outsider has actually helped me. I've never really thought of myself as someone who works in finance so I think that's been one of the assets for myself and for the firm.

Tell us about your company “Napkin Finance,” which you founded.

We're a multi-media company that creates content both for individuals but also for banks and financial institutions around the globe. We're in 80 million households right now through our partners, so we work with everyone from JP

Morgan Chase to US Bank, among others. And we also have a show coming out with NBC News for kids, a money 101 video series. But really, we're most excited about the book coming out at the end of the December. It's an overview of all topics around money and finance.

Why do you think personal finance isn't taught effectively in schools?

[Personal finance] should be required curriculum, but for some reason most people never learn in schools or learn from their parents. It's really a vicious cycle.

It's so critical that people have access to resources early on, and part of what we do is have a philanthropic arm to the business. We give away a lot of content to nonprofits, schools, universities. We previously worked with [former first lady] Michelle Obama through her Better Make Room initiative, and we now work with the U.S. Olympic Committee in helping out athletes who have their own unique financial considerations. I think what we are is a for good, for-profit company. We're a social enterprise that really wants to help people and provide access to resources and tools that should be provided in schools but aren't.

Is the reason they aren't because the topic is not as high of a priority?

I don't know. It should be a priority; it's interesting that it isn't. And this actually isn't just in the United States. This is around the world. I think one of the issues is that it's difficult to teach. There aren't a lot of resources that are easy to guide people, especially earlier on. I think part of the problem is having access to the best resources and tools, and also people who are trained to do so.

Do you think the advent of online stock trading has been a help or a hindrance?

I think it's great. I think technology has really provided a lot of amazing tools for people, whether it's saving, investing, lending money. There are so many interesting ways that technology has disrupted financial services and provided better rates, lower fees, and access to people that traditionally wouldn't have access to those opportunities.

First-time investors are often intimidated by a lot of the terminology involved in finance. What would you tell them?

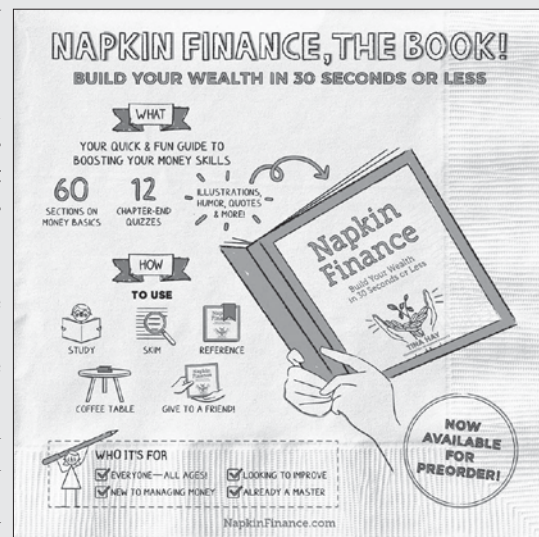
Finance doesn't have to be intimidating; it can actually be very simple. The key really is to be educated—knowledge is power. Even in investing, I think part of it is that everyone has access to the necessary tools, but also that there are a lot of resources out there. I think the most important thing is that people get help when they need to, ask the right questions, and access the resources and tools around them.

What are two or three things everyone can do to build their personal wealth?

Number one is to have an emergency fund. And number two is to start saving for retirement as early as possible.

Tell us about your future plans for the book and what you hope it will accomplish.

We're excited to get the book out to a lot of different age groups, and anyone who really wants to start their financial path to empowerment and use the book as a stepping stone to get there. The book is very accessible and fun. It has a touch of humor but it's very light and easy to digest. We're hoping that we can reach people in different age groups who are looking for a way to take control of their money and finances and make better decisions.

Beverly Hills football coach Jarrod Bunch said he hopes the extensive participation on Beverly Vista Middle School's flag football team will lead players on that team to play when they enter the high school.

Bunch said he is also trying to revive a tackle youth football team based in Beverly Hills.

A lack of players, mainly out of parental fears of concussions, is a key reason the Normans have had nine consecutive seasons of three victories or less.

Their 3-7 record in 2019, their second season under Bunch, was their best since 2010 when they were 6-5, qualifying for

the Southern Section playoffs for the most recent time.

Bunch said Beverly Hills “almost had to forfeit” its final regular season game because of a lack of players.

Injuries sidelined two of the team's five best defensive players, while a third was not allowed by his parents to play against Culver City because of fear of injury, Bunch said.

The Centaurs entered the game with a 9-0 record and ranked first in the Southern Section Division 5 poll.

Bunch said Culver City coach Jahmal Wright agreed to play his starters only in the first quarter to avoid a forfeit by the Normans.

A Beverly Hills team with what Bunch said had about 21 players in uniform was outscored 7-0 in the first quarter en route to a 55-0 loss, its 21st consecutive loss in Ocean League play dating back to 2015. The Normans were 0-5 in Ocean League play in 2019.

Beverly Hills is winless in its last 17 games against Culver City, a streak that includes ties in 2005 and 2006.

Bunch said he is also hoping to have more involvement in the football program from the players' parents.

"It's difficult to build a program when you don't have all the parents of the kids involved," Bunch said. "We had 25 kids on the team. I probably met five or six parents of the players."

"All the parents were invited," but few attended, Bunch said. "We need to get all of the parents to let them see what I'm trying to do with the

program."

Another challenge Bunch said he faces is letting people know the benefits of playing high school football.

"It's not about just football," Bunch said. "It's about a whole lot more -- building character ... and responsibility and changing lives and giving memories they'll live with for years and years to come that they can pass on to their children."
