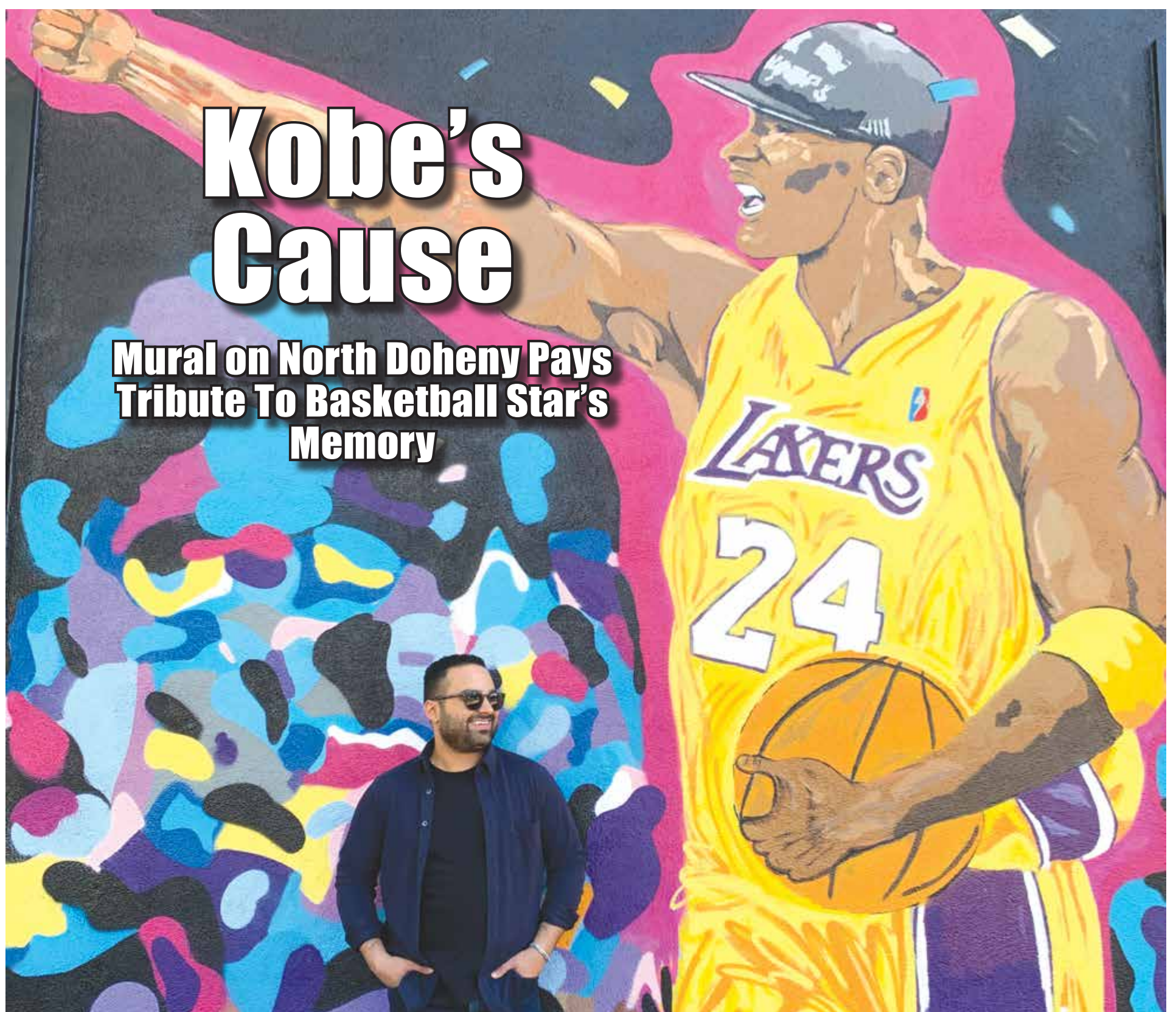

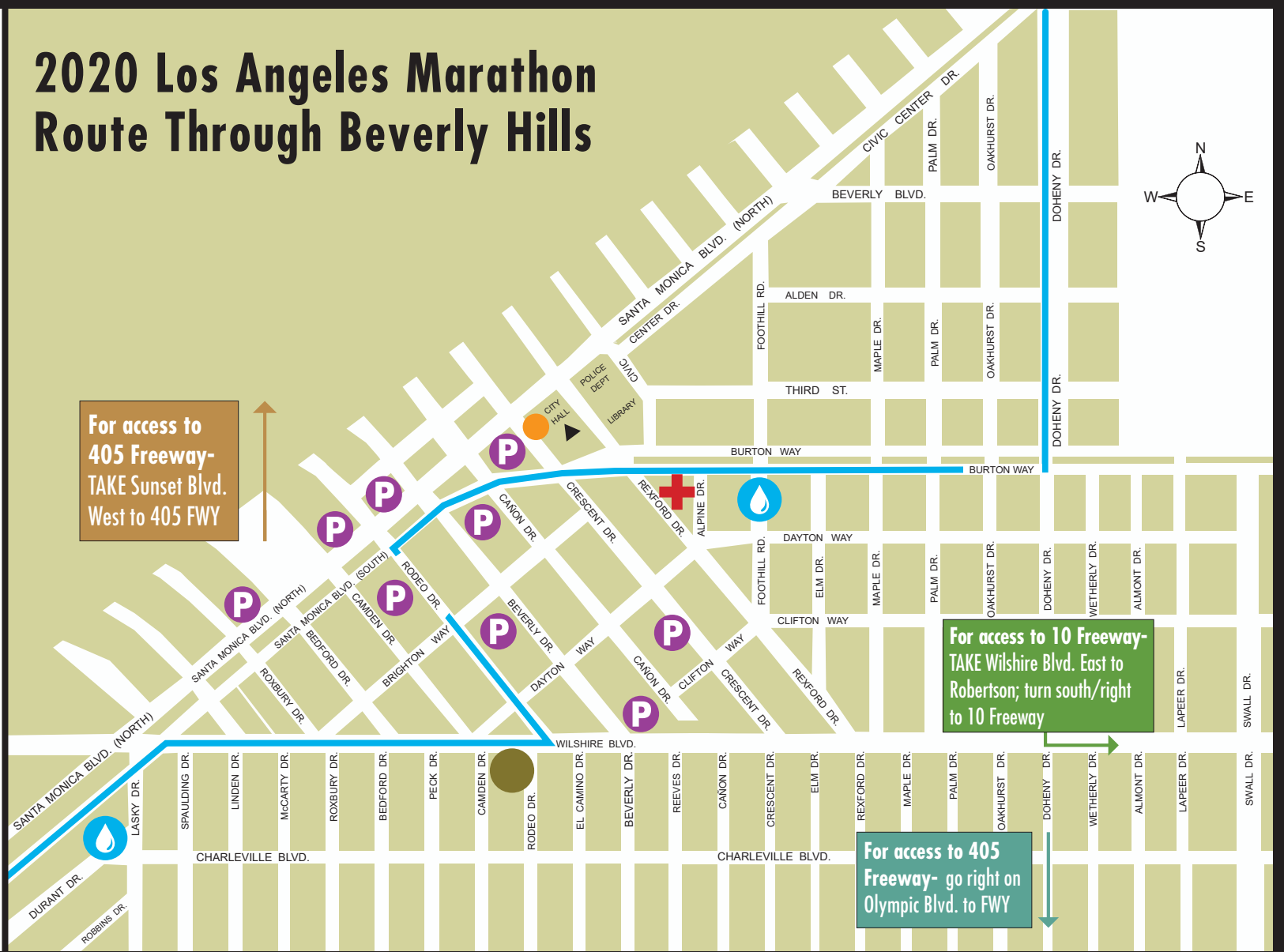

### “Response to ICAN endorsement in Beverly Hills Courier”

The [ICAN] endorsement in the February 21 issue of the Beverly Hills Courier (p. 4) is misleading. The paper has a right to print a paid or in-kind advertisement supporting candidates, but a reputable paper has a responsibility to take a closer look at what it labels as “news.”

Throughout our history, mayor after mayor has publicly supported the Jewish state. The support for Israel over the decades has manifested itself in our residents supporting different endeavors in Israel, from Yad Vashem to hospitals, universities, museums, archeology, the City of Jerusalem and the Israel Defense Forces. Thousands gather at the Hilton for the JNF breakfast each year, the brainchild of a former mayor. It is the support of Israel that sends Christian Pastors to walk in the footsteps of Jesus and become even better ambassadors of the Jewish birthplace of Jesus. The sum total of all the activities and support to Israel is so unique and so universal among us, that it makes the City a shining example; like no other.

Our elected officials have stood time and again when others shied away, when

it was not popular to support Israel. The level and intensity of support have only strengthened with the rise of Anti-Semitism and the spread of the Boycott, Divest and Sanction movement, but it was always here, flowing through our veins.

Israel is not an issue in our local election, and any attempt to create a problem when and where one does not exist is plain wrong. By allowing this “endorsement,” did the organization - or the paper - mean to indicate the other candidates are not as supportive of Israel? Or maybe that they are against Israel?

It is admirable for any organization to show its gratitude to the Beverly Hills City Council and its candidates for their ongoing support of Israel. However, I believe such an endorsement should be in the form of a clearly labeled, paid advertisement in lieu of a newspaper report that may unfairly imply a different position by the other candidates.

### Bosse, Gold Re-Elected

City Council incumbents Lili Bosse and Julian Gold were re-elected Tuesday.

Preliminary results as of press time have Bosse with 2,648 votes and Gold with 2,016 votes. Planning Commissioner Lori Greene Gordon came in third place with 1,615 votes, Simcha Green received 355 votes and Robin Rowe received 338 votes.

While ballots postmarked by Tuesday will be counted until Friday, the results are not expected to change. The lines at the Beverly Hills City Hall Vote Center Tuesday were reported to be two hours or longer. Mayor John Mirisch said that there obviously weren't enough polling places in Beverly Hills and the County Registrar/Recorder, who ran the election, seems to have been completely unprepared.

“For the state-wide primary in 2018, there were 15 polling places in Beverly Hills. This time there were only three,” Mirisch said. “The Registrar’s inability to prepare adequately and run a smooth election likely disenfranchised some voters. It’s completely unacceptable.”

Both Bosse and Gold were first elected to the City Council in 2011. Bosse served as mayor from 2014 to 2015, and then again from 2017 to 2018. Gold served as mayor from 2015 to 2016 and again from 2018 to 2019. Gold had previously said that he would not run for more than two terms.

A lawsuit between Beverly Hills and Los Angeles County ensued when the county’s new touchscreen voting system placed only four of five city council candidates’ names on the first page. Councilmember Julian Gold’s name was listed on the second page, which voters would have to press a “more” button to see. Though the city’s lawsuit continues, the ballot placement apparently did not disadvantage Gold from being re-elected.

Los Angeles County voter turnout as of press time was 20.5%, less than the 25.8% turnout statewide.

The new City Council will be installed ceremony on April 6 at 7 pm. Vice Mayor Lester Friedman is slated to become Mayor at that time.

### BHUSD Board Member Clashes with BHEF President

Beverly Hills Education Foundation president Cindy Trost feuded with BHUSD Board of Education member Tristen Walker-Shuman about BHEF’s Summer Academy last Tuesday.

Trost said that Walker-Shuman had gone around BHEF to ask staff, administrators and district cabinet members for BHEF Summer Academy’s WASC report, which she is not entitled to. She said BHEF is a private corporation and exempt from the Freedom of Information laws that regulate government information.

“Your request was not made directly to BHEF, instead you consumed and utilized district time and resources in an attempt to gain access to the report,” she said.

While public comment usually involves community members sharing an issue to the board without being addressed afterward, board members are allowed to make comments as long as there is no dialogue. Walker-Shuman said she has a right to respond because Trost spoke directly about her actions.

Walker-Shuman said in her comment that she asked for the WASC report be-

cause Trost had said it outlined community support for changing BHEF Summer Academy’s start dates in the past and wanted to read it.

The BHEF Board will determine if it will provide Walker-Shuman with its WASC report at its next meeting on March 23.

Trost also said that Walker-Shuman had unfairly promoted another district’s summer school on her social media and not BHEF’s program.

“You are endorsing a summer school that overwhelmingly does not meet the needs of our community and you are encouraging families who might otherwise stay with BHEF, which employs BHUSD staff and offers BHUSD approved curriculum, to attend another summer school,” Trost said.

Trost added that any funds BHEF makes after the expenses for summer school go into the general fund, which has donated over a million dollars to the district in the last 40 years.

Walker-Shuman said that she supports BHEF but wanted to share alternatives to the Beverly Hills Community because she relates to the struggle of not being able to enroll her child in summer school because its start dates are inconvenient.

“I’m sorry that you feel that my influence is so great that I’m turning families away from BHEF, that’s not the intent,” Walker-Shuman said.

Walker-Shuman added that she’s been clear for several years that the dates for BHEF don’t work for all families and many people have felt the same as her.

“For the last three years, the enrollment at BHEF has declined every single year. I believe that’s tied to the change to the date,” Walker-Shuman said. “From three years ago to two years ago, we lost half of the enrolled students that were in BHEF.”

Trost also said during public comment that Walker-Shuman has repeatedly claimed to receive calls from parents and students saying that BHEF Summer Academy’s start dates don’t work for them. She said that if that were true, Walker-Shuman should be referring them to guidance counselors.

“The reason I didn’t ask a guidance

couldn't make that decision [of conformance of approval], that could cause havoc," he said. "Whether a plan is in conformance with our approval is really an administrative determination because we've already made our decision."

Block added that despite being well meaning, he thinks changing the process could be misused and open a can of worms for the commission.

Commissioner Lori Greene Gordon said that she

would be in favor of this change if it were used on rare causes where it was needed.

Community members spoke in favor of changing the process during the public comment portion of the meeting.

Ronald Richards, an attorney, said that a change would streamline projects for everyone.

"It is a big problem that is growing, where the staff is put in the improper position of making judgment calls on violations and that's not implementation," Richards said. "It also creates a tremendous tension between the residents and the staff that's unnecessary because the resident feels that the staff does not work for them."

Richards added that he disagrees with concerns that people would abuse shifting this process.

"I just think that if there's an abuse where people are just appealing to you to try to delay a project, that's something we can address with a filter or some other mechanism," Richards said. "But I personally don't believe that that's a legitimate harm, there's no evidence in the staff report that the public is going to abuse the process by bringing to your attention a legitimate issue."

Debbie Weiss, a Lago Vista resident, said that staff is often dismissive of the concerns raised to them.

"In the event of a dispute over interpretation, whether it be by a resident or an applicant, I believe that the interpretation is to be clarified by those who made the conditions," she said. "I do not believe that staff should have the final say on whether the conditions that the Planning Commission puts on these projects are being complied with."

## Community Development To Review Beverly Terrace Entitlements

The Community Development Director will review the renewal of Beverly Terrace Hotel's subject entitlements instead of the Planning Commission, after a Planning Commission meeting last Thursday.

Beverly Terrace Hotel applied to renew its conditional use permits, which allow for

it to operate its restaurant and open dining area, in 2019. The Commission decided to change how it processes the renewal of the hotel's subject entitlements moving forward during Thursday's meeting.

The Commission conditionally passed a Conditional Use Permit to Beverly Terrace Hotel in 2016. This allowed for a dining facility to be open to the public, a Development Plan Review to operate an open air dining area and an Extended Hours Permit for the restaurant to operate between 7 a.m. to 11 p.m.

The applicant submitted a request to renew the application on September 12, 2019. They are not asking for any changes from the current conditions in place.

Commissioners expressed support for

having the director handle the renewal process and said that it makes sense in this specific situation.

In order to review the applicant's renewal request, the Planning Division staff acquired a list of Police Department calls for service to the project site between August 2017 and November 2019. They found that there were 40 calls for service in this time frame, which were unrelated to the hotel's restaurant or open air dining area.

Staff also reviewed the Community Preservation and Code Enforcement Log, but found no service calls or violations reported in its time frame.

The Commission unanimously decided the hotel's renewal will be reviewed at the Director level in the future. In its next steps, the request for renewal will be notified to the public.

## Prospective Changes to Fifth Grade Promotions Discussed

The Board of Education debated changes to fifth grade promotion costs last Tuesday night.

Superintendent Michael Bregy said that he began having conversations with PTA and Beverly Hills Education Foundation three years ago to determine consistency between what the district and PTA pays for fifth grade promotions.

"There wasn't a lot of consistency, and so it was a little uncomfortable when it first came to the district. Some PTAs were paying per paper and some of those basic needs and requirements," Bregy said. "So slowly we've been starting to change some of those things because it's something the district should be providing."

He added that the district is establishing new protocols and traditions throughout the district. He plans on continuing to col-

laborate with stakeholders.

The district office's staff has begun to do research into what the basic needs for individual school promotions will be. Hawthorne Elementary School, whose auditorium is closed, would need chairs and a stage to have its promotions outside. The lowest cost for that would be \$4,737.57. Horace Mann Elementary School asked for the district to cover chairs, which would cost \$2,039.98.

Board of Education Vice President Rachel Marcus said that she doesn't think the promotion should be something so epic that following eighth grade promotions will struggle to measure up to. She said it should be kept in perspective as to what fifth grade promotion should be.

"I've always (believed) that if you give kids something so grandiose to start with when they're graduating from fifth grade, and then you get to eighth grade, you have to top what you did in fifth grade," Marcus said. "I think you really get yourself into a bind."

She said that she's in favor of providing whatever basics the schools need in order to have a ceremony.

"I'm all in favor of providing what they need to have in order to have a ceremony, in other words the chairs, the stage and things like that," Marcus said.

The district will continue to research how to work alongside the PTA and schools to determine future costs.

Captain Hill's final assignment has been Administrative Lieutenant in the Office of the Chief handling tasks such the Body Worn Camera Program and the implementation of new Use of Force Policy and the Use of Force Simulator. He is the recipient of the 1999 Rotary Club Officer of the Year. Hill is the father of recently resigned Congressmember Katie Hill (D-Santa Clarita).

### Captain Scott Dowling

Scott Dowling will be appointed to the position of Captain on March 16. Captain Dowling was hired by the Beverly Hills Police Department as a police officer on May 16, 1986. His final assignment as Lieutenant has been to Special Investigations, managing the Crime Impact Team, SWAT, and the Canine Program. He is the recipient of the 2009 Felix Rothschild Award and a 2018 Chief's Core Values Award.

## Planning Commission Considers Changing Disputed Planning Conditions Process

The Planning Commission debated whether it should review disputed planning conditions it created, rather than staff members, last Thursday.

Vice Chair Peter Ostroff asked for a discussion on requiring conditions of approval for entitlements given by the Commission to return for interpretation if there is a disagreement about the condition's meaning during Thursday night's study session.

The commission typically reviews entitlements requested by applicants. During the review process, the staff and the commission recommend conditions to the project to ensure that it doesn't impede the City's interests. Staff later follows up on projects to ensure that conditions are met throughout their implementation.

During staff's plan checking, the meaning or intent of a condition might become unclear while projects are being implemented. In these situations, the Director or staff members are put in charge of interpreting and considering the intent of the condition in question.

The commission debated the feasibility of changing the process so that it re-reviews unclear conditions instead of staff and was split on its stance.

"I looked through the code to see if there was anything in there that said staff shall be the final arbiter of Planning Commission resolutions, and of course, there's nothing that says that," Ostroff said. "There's no ordinance we have to change."

Ostroff added that since it's the commission's resolution, it should be the ones interpreting the meaning of it if there's a dispute.

Chair Alan Robert Block said that all jurisdictions have staff determine if a project is in conformance with an approval.

"If every time we had a project that staff

The Beverly Hills Unified School District opened its 2020-2021 enrollment last week during Public Schools Week celebrations.

Public Schools Week is a celebration of public school achievements, student accomplishments and teachers which the district celebrated from February 24 to 28. BHUSD opened its enrollment amid its celebrations and is available to Beverly Hills residents' children.

According to BHUSD, its test results are 20% higher than the Charter School and California State average.

The newly opened, consolidated Middle School has 44 electives and the district offers technological devices for students in every grade. The district is also community oriented and has around 1,467 PTA members that schools work with on a daily basis.

The district serves around 3,560 students in grades TK-12. It currently has two elementary schools, Hawthorne and Horace Mann, and another under construction. Its two middle schools are El Rodeo and Beverly Vista Middle School. Beverly High serves grades 9-12 and Moreno High is its continuation high school.

## City of Beverly Hills Answers FAQ on Coronavirus

The City of Beverly Hills issued a statement providing answers to frequently asked questions on coronavirus preparations in the city.

Health and Safety Commission Chair Daniel Nazarian said that the the commission has been a leader in proactive measures to promote public health on issues ranging from vaccinations to disaster preparedness.

"Residents are reminded to continue their overall preparedness and practice strong personal hygiene, specifically frequent washing and sanitizing of hands," Nazarian said. "We encourage everyone to make a plan, gather supplies and be informed."

### 1. What is the City doing to prepare for the Novel Coronavirus?

The City's leadership and Pandemic Planning Committee, active since 2006, have been meeting to prepare for any potential impacts from the Novel Coronavirus or any other emerging disease.

### 2. Who is responsible for providing direction to the City regarding an infectious disease protocol?

The City of Beverly Hills works in partnership with local, state and federal health officials (including the CDC and LA County Department of Public Health) to receive guidance and coordinate response.

### 3. Is City staff trained to deal with Novel Coronavirus?

Yes. The City's emergency personnel are trained and capable to respond to any emerging disease, including the Novel Coronavirus, and implement appropriate healthcare protocols.

### 4. Will the City continue to operate normally if the Novel Coronavirus arrives here?

Yes. The City has robust business continuity plans in place for all departments and

services to ensure the continuing operation of the City government.

### 5. What can I do to prevent contracting the Novel Coronavirus or any other viruses?

The best way to stay healthy is eating well and practicing good hygiene such as frequently washing your hands and utilizing hand sanitizer, keeping a distance between anyone who is coughing or sneezing, avoiding touching the face and staying home if you feel unwell.

### 6. How should I prepare for the spreading of the virus and the potential need to stay at home?

Residents should stock up on food, water, medicine and other necessities for at least 7-14 days and continue to monitor City communication channels and local media. Residents should also sign up to receive notifications by visiting [beverlyhills.org/emergencynotification](http://beverlyhills.org/emergencynotification) or texting BEV-HILLS to 888777.

### 7. Do I need to wear a facemask in public?

Face masks should always be an item in your personal emergency kit, however, the Centers for Disease Control and Prevention does not recommend routine use of a face mask or respirator. Most often, spread of respiratory viruses from person-to-person happens among close contact (within 6 feet).

### 8. Can I travel?

At this time, the CDC recommends that people avoid all nonessential travel to mainland China and South Korea. Check the CDC's webpage ([cdc.gov](http://cdc.gov)) for up-to-date recommendations before you travel. Additionally, review any travel advisories by visiting [travel.state.gov](http://travel.state.gov).

### 9. Should I stop attending events with crowds of people?

According to the County of Los Angeles Department of Public Health, currently there is no need to cancel school or social events and there are no restrictions on large public gatherings.

## KOBE'S CAUSE

### Mural on North Doheny Pays Tribute To Basketball Star's Memory

*Matthew Lavi, a Beverly High Class of 2006 graduate, spoke about how his admiration for Kobe Bryant motivated him to display a mural in the late basketball player's memory. The mural is on display on 470 North Doheny Drive and designed by the artist BournRich. Lavi and his brother, Nuriel Lavi, organized putting the mural up together and it was completed last Wednesday.*

#### Describe what motivated you to do this mural on Kobe Bryant.

It was my brother [Nuriel] and I, we had been long-time fans. Being born and raised here, he was really someone that we looked up to, not only [just] in the NBA or in the basketball world. [He] inscribed and pushed us to be good people all around. When we had this chance to remember him, we thought that this would be a great opportunity to keep [his

memory] alive ... to be able to showcase to the community and the area how much we appreciated and loved Kobe.

#### What was the process behind bringing your idea to life?

It definitely wasn't easy, it was a lot of work. Luckily ... I was able to find BournRich through networks, contacts that I have and [see his] work on Instagram. I saw that what he wanted for the mural matched mine and so we were able to collaborate together. With his artistic input, we

were able to create something that really is the abstract form of Kobe in his glory.

#### Did you always plan on having a mural to pay tribute to him or it sort of came together through the process of orchestrating something for Kobe Bryant's memory.

It just kind of came together. We were just fortunate that everything lined up in this unfortunate situation of his death.

#### How did you decide on the design itself and how you depicted Kobe Bryant?

We looked through a lot of images, but we ultimately chose one that we thought spoke to his greatness. You know, singling him out, having him stand out and something that focuses on his words exactly because there's a quote there. So it's almost like two or three murals in one because it's so large.

#### What permits did you have to get from the city to do this?

I don't think a permit was required because of the situation about the art, and given that this is a Kobe mural. With the timing and the subject, we were able to bypass that.

#### Why do you think this mural is something significant for the Beverly Hills community?

I think we're the only one or one of the only murals in the area that is showcasing, highlighting and commemorating Kobe in the community. That basically is something [the community] needed. The community can come around [the mural] and it's a place where we can all come together to remember and tribute someone that we really looked up to as an athlete, entrepreneur and overall hero.

#### What are you hoping viewers get out of seeing this mural?

We hope that people will feel that it gives inspiration. They can be whoever they want, whatever they want to be. We hope that the wall speaks to people and is a form of expression highlighting that being unique and striving to be the best of what you are and what you're doing is achievable if you just dream hard enough and work hard enough.

#### Why do you think Kobe Bryant had such a significant impact on the Los Angeles Community, including the community of Beverly Hills?

I think he brought the city together. Regardless of what people believe, he made basketball lovers [and] he made Angelenos come together

under one cause – that cause being the love for our city through sports. Even afterwards, after the NBA, being an Oscar winner and creating Mamba Academy, he spent a lot of work outside of basketball that people in our community look up to and are grateful for.

#### How long do you expect to keep this mural up? Is this something you're planning to keep indefinitely?

Not indefinitely, but for the foreseeable future. At least for the next two to four months, through spring.

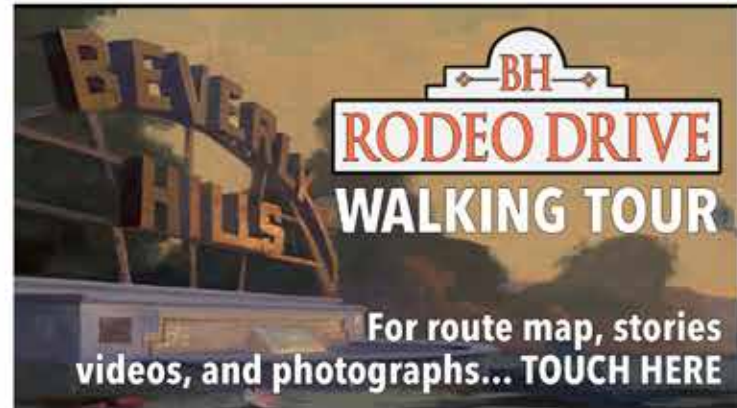
