If LA County or another district was able to have a sales tax increase qualify for ballots and it was approved, the proposed Beverly Hills sales tax increase measure would ensure that the revenue went to the Beverly Hills municipal government rather than the county or district.

# Face Coverings in Beverly Hills



All persons shall wear face coverings when they leave their home or place of residence for essential activities, such as taking a walk through their neighborhood, if there is a potential to come within six feet of someone who is not a member of their household.



The penalty for not wearing a face covering is an administrative citation which carries a fine of \$100 for the first offense, \$200 for the second offense and \$500 for the third and subsequent offenses.

Offices Project in the amount of \$472,626 Tuesday.

The Beverly Hills Land Company, which is the applicant for the proposed Beverly Hills Creative Offices Project, will be responsible for paying the consulting fees. Its proposed project is of 11 creative office buildings to be constructed 9220 North Santa Monica Boulevard, otherwise known as Lot 12.

In addition to this project, the Beverly Hills Land Company has proposed conveying the fee title of Lot 13 to the city.

The California Environmental Quality Act requires the project to prepare an Environmental Impact Report, which assesses the impact a project will have in the surrounding community.

Councilmembers approved an agreement with Dudek to prepare the CEQA environmental documents. LEED AP Principal-in-Charge Eric Wilson and Project Manager Nicole Cobleigh are the Dudek team which will be leading the project, according to a city staff report.

The agreement with Dudek also requires data collection and technical study production, preparation of draft documents, analysis of potential environmental impacts and more.

According to a city staff report, the Beverly Hills Land Company has already deposited the amount of the contract and the city's 15% environmental contract administration fee.

### BHUSD Discusses Distance Learning Plans for Fall

The BHUSD Board of Education approved two learning options for the upcoming fall semester for parents to potentially choose from Tuesday, either the Independent Learning Center or live instruction delivered to students at home.

The Board's decision comes after Gov. Gavin Newsom announced TK-12 grade schools in counties on California's coronavirus monitoring list must remain closed for the upcoming academic year. Los Angeles County is currently on that list.

According to Assistant Superintendent for Student Services Laura Chism, the district will not be able to have students on campus until it meets Newsom's mandate to be off the list for 14 consecutive days and therefore all students will start online or have virtual programs.

The Board approved the distance learning options of either the ILC or "LIVE@BHUSD" with a 4-0 vote, with Board member Tristen Walker-Shuman absent. The district would still need to approve a Memorandum of Understanding with the Beverly Hills Education Association – the union representing BHUSD faculty – before it moves forward with this plan.

The ILC will use the online platform APEX Learning for grades 6-12. Teachers will meet with students every week for an hour under this option, according to Superintendent Michael Bregy's presentation. The deadline to choose the ILC is July 27.

Students under the "LIVE@BHUSD" option will have daily live interaction at home and their schedules will be similar to a bell schedule, according to Bregy's presentation. Platforms like Seesaw and Google Classroom will continue to be used, in an age-appropriate manner.

Once the district meets Newsom's orders, Public Health requirements and other necessary criteria, students can possibly return to school in phases, according to Bregy's presentation.

Before Newsom's order was issued, the BHUSD was discussing its plans last Tuesday for potentially reopening schools with COVID-19 health and safety regulations.

Last week, Superintendent Michael Bregy said the district wanted to ensure that it is offering an effective and consistent way to deliver instruction to students.

"We know more about the virus, we know more about what work and what didn't work in the past, and that's helping us as we explore our options going into the future," Bregy said.

Bregy shared that administrators had been researching several options and plans for the upcoming fall semester. These included workplace controls, infection controls and COVID-19 policies and procedures to keep students and faculty safe.

The workplace controls include the following items, according to Bregy's presentation:

- Teaching methods impacted.
- Staggering access to lockers.
- Alternative ways to store items and preventing students from sharing items.
- Lunch in classrooms as much as possible, to avoid interactions with other classrooms.
- No spectator events.

- Singing activities suspended.
- School-wide event cancellations.

The infection controls included the following items, according to Bregy's presentation:

- Doors and windows remain open as much as possible.
- Cleaning and disinfecting schedule.
- Optimal ventilation in the school.
- Upgraded air filters.
- Shutting water fountains.
- Removing high-touch playground equipments
- Requiring face masks for people above 2 years of age.

- Allowing teachers for younger children to wear a face shield, with a tucked in drape.

Bregy said administrators have become similar to public health officers, because there isn't enough of them. He said the district must put together a COVID-19 Compliance Team to start processing and collecting data on people who test positive for coronavirus.

"We have had students with COVID-19 in our school district. So I understand the research, I spend a lot of time doing this every day," Bregy said. "But we've had students that have had COVID-19 and we will have students that have it again."

Bregy also shared the following policies and practices administrators had been considering for the upcoming academic year:

- Screening people for COVID-19 before they enter the school.
- Assessing symptoms, such as coughing and fever.
- Checking temperature.
- Adults who screen positive would return

home and self isolate.

- Students who screened positive would potentially go to an isolation space on campus, return home and self isolate.
- The COVID-19 Compliance Team is informed of positive COVID-19 test results.
- Adult visitors who were in close proximity with someone infected would return home to self isolate.
- Only essential visitors would be allowed to enter campus.

Bregy had said the district's plan for the fall semester is not meant to be a permanent situation for its schools.

"No matter what option, whichever way we go, we have to immediately start looking at how we're going to transition back full time," Bregy said.

### Former Mayors Tanenbaum, Krasne Call for Council Term Limits

Former Mayors Robert K. Tanenbaum and Nancy Krasne have requested that the City Council place an initiative on the November 3rd ballot, which would allow voters to decide if there should be a three-term limit for Beverly Hills city councilmembers.

In a letter sent to the council last Thursday, the former mayors said that residents have asked for an ordinance that limits council terms for some time.

"On behalf of these requests, we ask that the City Council place this term limitation matter on the November, 3, 2020, ballot, preceded by a robust public debate," they wrote.

A number of local cities have City Council term limits, such as the City of Downey.

### Council Approves Name for Metro's Wilshire/La Cienega Station

The City Council supported naming one of the Metro Purple Line Extension subway stations in Beverly Hills as "Wilshire/La Cienega" last Tuesday.

The Metro Purple Line Extension will have two stops in Beverly Hills, on La Cienega and Wilshire Boulevard and Wilshire Blvd and Rodeo Drive.

The City of Beverly Hills entered a memorandum of understanding with the Metro Transportation Authority in 2017, which included an agreement that Metro would not name a subway station in the city without receiving the council's consent.

Councilmembers were unanimously in support of the subway station's name. It reviewed the suggested name in its July 14 study session and voted 5-0 to approve it in its regular meeting later that night.

The Metro Board will review and make a final decision on the name in a meeting anticipated to take place this September, according to the study session. Existing metro stations have been named Wilshire/Western, Wilshire/Vermont and Wilshire/Normandie.

Councilmember Lili Bosse said she supports the name, but would like the station to indicate in some way that it is in Beverly Hills. She said she acknowledges that the meeting was only to approve the station's name, but would like the matter to be discussed in the future.

"I do want to have something in the station that people know that when they are in Wilshire and La Cienega, they are in Beverly Hills," Bosse said.

Councilmember John Mirisch echoed Bosse's sentiments.

"There are people to this day who don't know that Wilshire and La Cienega is actually Beverly Hills," Mirisch said. "I think it's super important for that station to let people know they're in Beverly Hills."

Metro had gathered potential names for the station by collecting community input and following its board's criteria for naming, according to a city staff report.

The Metro Board's station naming process includes identifying initial station names mostly based on location, soliciting input from communities and having a focus group review the resulting station names.

It had a booth at the "Halfway to La Cienega Community" event on June 2, which initiated the naming process. Metro promoted

the naming process on social media, community meetings, e-blasts and local events.

The board stopped re-

ceiving input on names at the end of September last year, according to a city staff report.

The most popular choices for the station's name included Wilshire/La Cienega, La Cienega, Restaurant Row, Sister Unity and Beverly Hills.

### Council Urges for Enforcement of Face Mask Ordinance

The City Council urged for Beverly Hills police officers to more strictly enforce the city's face mask ordinance last Tuesday.

The ordinance, which went into effect April 10, requires people in Beverly Hills to wear face coverings when in public. Public Information Manager Keith Sterling gave councilmembers an update on how the ordinance has been promoted to residents and enforced since it was issued.

Sterling said the city has conducted a media campaign, Mayor Lester Friedman has spoken about the ordinance on broadcast news channels, larger signs are being printed to advertise the order and so forth.

Sterling said that he is aware of one citation being issued to someone for not wearing a mask, at the time of the meeting.

"We had a citation in the last few days, [it] was issued to a server at a restaurant who was not wearing a face covering," he said.

Sterling added that city staff are meeting this week to discuss developing information booths throughout the city, which would share information about the city's face mask requirement and other city programs with residents.

The council unanimously said they would like to see stricter enforcement of the face mask ordinance in the future after Sterling's presentation.

Councilmember John Mirisch said that it seems police officers are not taking face mask enforcement seriously. He said only one person being ticketed is outrageous.

"[Police officers are] walking by people who are not wearing masks and doing nothing," Mirisch said. "There need to be consequences also for the people who are tasked with enforcement if they're unwilling or if they refuse to do their jobs."

Councilmember Lili Bosse asked City Manager George Chavez to show that the city is giving fines and tickets immediately. She also asked for the council to receive reports on how the city is doing and how many fines it has given.

"I have to say I'm pretty mortified that we haven't given more tickets or more fines," Bosse said. "There isn't a day that doesn't go by that I'm not receiving many emails, calls and texts from people really concerned and afraid that they see people on our streets without masks."

According to Sterling, 37 citations have since been issued through July 17 and July 21. Sterling said 25 were for not wearing a face covering, two were for lack of social distancing and ten were for business non-compliance.

### Council Considers Rent Subsidy Program For Beverly Hills Tenants

The City Council reviewed a proposal for a rent subsidy program for tenants that cannot pay rent due to COVID-19 Tuesday.

The program, which Vice Mayor Robert

Wunderlich requested to be reviewed, would require the council to decide an amount to allocate for the subsidy.

The city staff report said the funds would be available from the following: \$150,000 through the Community Development Block Grant, \$170,000 from the Westside Cities Council of Governments and \$217,000 from the CARES Act.

The subsidy is meant to assist tenants once the eviction moratorium is lifted and they are required to pay forborne rent. Councilmembers considered three possible options for who would qualify for the subsidy.

The first option would be for the subsidy to apply to all tenants who filed the "Beverly Hills Residential Tenants Impact by COVID-19" form with the city and their landlord." If chosen, it would apply to 166 tenant households.

The second option would be for the subsidy to apply to those who filed a COVID-19 form and also reside in an Rent Stabilization Ordinance unit. If approved, it would apply to 148 tenant households.

The final option would be for the subsidy to apply to tenants who filed a COVID-19 form and reside in RSO units with a rent amount not to exceed \$5,000 monthly. If approved, it would apply to 140 tenant households.

### More Candidates Pull Papers for BHUSD Board of Education Election

Three more candidates have pulled papers to run for the November 3rd BHUSD Board of Education election as of press time.

Board member Noah Margo filed papers last Thursday. Frank Chechel and Donna Tryfman pulled papers this week, but have not filed them as of press time. Robin Rowe, a computer scientist who previously ran for the City Council, pulled papers on July 14 but has not filed them as of Tuesday.

The board will have three seats open in the upcoming election, with Board members Isabel Hacker, Mel Spitz and Margo ending their terms in December. Spitz said he will not be running for re-election.

The filing period is from July 13 to August 7. If one or more of the incumbent board members do not file papers to run for election, the filing period will be extended by three days. See [lavote.net](http://lavote.net) for more information.

# HOW ARE YOU STAYING BUSY DURING THE QUARANTINE?

## Beverly High Alumna Launches Chocolate Business, Finds Fulfillment Through Entrepreneurship Amid Pandemic

Beverly High Class of 2011 graduate Brittany Pourmorady founded CHOCBOX during quarantine. She sells DIY all-natural dark chocolate kits, which allow customers to make their own chocolate at home, in six different flavors. Her products can be found on chocboxla.com.

### Can you tell me about your business?

It's a dark chocolate recipe kit. You have all the ingredients you need, supplies – which is a dark chocolate mold that's reusable – and instructions to make your own amazing dark chocolate. It's all-natural,

vegan, gluten free, very simple, very real ingredients. Once you go online, you see all the flavors and you can choose from six flavors.

Your first box is called your starter kit, it would include the mold. When you want to re-order, you reorder as a safer kit [which] means you already have your mold and you just want to take more chocolate. It's a fun activity to do. It's something that was brought out of the quarantine for me, just because I'm a dental hygienist and I was not working at all. It's actually turned into something amazing and it's really exciting.

### How long has your business been running?

I started doing shipments and orders ... June 19 is when I launched. The idea came to mind, I think it was April. I worked on it for a few months, got all my inventory, distributors and all that. It's been almost a month now.

### What inspired you to want to start a chocolate kit business? You mentioned that the quarantine has played a role.

I've always been an entrepreneurial

thinker. But I was never able to find something that I wanted to pursue. Besides being a dental hygienist, I was always thinking of products to create. If you ask any of my friends, I'm that type of person that I see something [and] I'm like, "Oh, it would be so good if we had this."

I was making chocolate for fun and posting it on one of my [social media] accounts. I actually was teaching spin too on the side, so I had an account for spinning and health. I was posting things like what to make and if you look at the account you'll see I have the highlights of "Almond milk, with this and that." I was making chocolate, [but] I wasn't measuring the ingredients I was just going by my gut. People were

messaging me and they're like, "What are your ingredients? How do you make it? This, that." And I was like, "I can't tell you what my measurements are but this is what I'm making."

Right when corona hit, everyone was like, "Can you send us chocolate?" I mean I can ... But the idea of making it yourself is more meaningful and fun. It makes it more special than me delivering chocolate. The idea just came to me. I'm a really visual person, so the first thing I did was make a website. Once I saw the website, I was like "Okay, this is going to be good." Then I made [an] Instagram, which is the number one way for [marketing] my business around the U.S. People from Pennsylvania and random places have ordered. Which is amazing and it came through Instagram.

### Chocolate isn't something the average person knows how to make. How did you learn to make it?

My sister [Chloe] actually taught me. It's an all natural chocolate, so it's a very raw, homemade chocolate you will not find in stores. Those chocolates [in

stores] are tempered, so they go through this process where you heat it up at a specific temperature and then cool it down to break up the crystals. Then you heat it up again, so it [can] stay out without melting.

This chocolate everyone's making, you freeze it to harden it and then you have to keep it in the fridge. It's more simple. You do your research and you find the ingredients you need. But I think the hard part is the measurements. My sister and I worked on the measurements for two weeks to make sure everything was perfect. So this chocolate is really good.

### Expand on what your marketing strategy has been.

[My social media] is a very unique account, where you see it and you're like, "Whoa this is cool, what is it?" Then sponsored ads and reposting the boxes [people ordered]. People want to show their friends what they're making. Everyone wants to show people that they're making chocolate because it's not the ordinary [thing to make]. You're not doing it everyday. It's a word of mouth type of marketing right now.

### How many sales have you made as of now?

Not specifically, but over 200 boxes.

### A lot of companies have begun to sell products where customers receive the ingredients and instructions, and then they have to make the item themselves. Do you feel like quarantine has opened up a market for products such as these?

People are spending more time at home. They're spending more time with themselves. I think quarantine has helped a lot of people expand their creativity. It depends how you choose to work with the situation that we're in. Either you sit on your couch and order postmates everyday, or you get up, adapt and figure out ways [to learn and improve yourself]. It sucks, but there's so many good

things that could come out of it if you take advantage of the situation.

My life before quarantine was non-stop. I didn't have a second to sit. Everyday, 7:30 a.m. [I was] in the office until 5, workout, come home, eat, go see my friends or do something on the side. And I never had time to sit and really pay attention to what I wanted. I think it helps a lot of people, definitely.

### Tell us about your professional background.

[I am] a dental hygienist. I work in Westwood. I was working everyday before the quarantine and once that stopped, I started this business. One of my

bosses wanted me to come back – I was working at three different offices – and I decided that my dream life is to work twice a week and focus on the business too. I took the risk, quit those offices and now I'm just working twice a week. [I'm] spending my time on chocbox.

### What's it been like to transition into being a businessowner?

It's really challenging. Everyday, I'm faced with challenges but I feel like I wanted this. I'm excited about it. I'm spending a lot of time on it, but I love it. I really love working from my computer and my phone. I love seeing people enjoy my product. It is really fulfilling for me.

It's something that I feel like I was set to do. Because I was always looking for more, even as a dental hygienist. After work, I'd be in my car and be like what am I gonna do with my life? I always wanted more.

### Was there anything you wanted to add?

I created my own sweetener blend [included with the boxes]. It's like a secret sweetener – I don't say the ingredients. It's a secret sauce kind of thing.

ornaments, which will be exclusively sold at Geary's, Tuesday.

The ornaments, made by Joy to the World Collectibles, will be for city use but will not be resold by the city, according to a city staff report.

Councilmembers approved the license to Joy to the World Collectibles for its use of the shield, authorize City Manager George Chavez to finalize and execute an agreement between the company and city, and authorize the purchase of up to 100 of the ornaments at wholesale price.

The negotiated wholesale cost is \$25 and the ornaments are expected to retail for \$60.

According to a city staff report, Joy to the World Collectibles will pay \$1,500 to the city for the permission fee, 10% royalty fees

on wholesale purchases and 6% royalties on retail purchases. The agreement is for a two-year term.

## Architecture Commission Approves Mural for Van Cleef & Arpels on Rodeo Drive

The Architectural Commission approved the installation of a temporary mural on the outside Van Cleef & Arpels boutique on Rodeo Drive last Wednesday.

The mural, designed by Alexander Benjamin Navet, would have a green lattice design and six large flowers that project from the piece, according to a city staff report. The building is located on 300 North Rodeo Drive.

The commission voted 3-2 to grant a sign accommodation that allows the mural to be installed. Chair Sheri Hirschfeld and Vice

Chair James Matson were the dissenting votes.

Alexandria Smille, the applicant, said the installation is like window animation and will bring life to the boutique.

"It's just a time that we want to celebrate and even now, it's a nice time to highlight bright colors, joyfulness and happiness on our facade," Smille said.

The mural will only be displayed for two months, according to a city staff report.

Vice Chair James Matson and Commissioner Tim Devlin expressed concern that the installation would cause damage to the building's facade.

Project Architect Victor Fuentes responded to their questions and said they are trying to minimize the attachments to the building, but they also don't want it to be unsafe.

"With our engineer, we came up with a

minimum amount of penetrations to the facade and once it gets taken out, we'll have to work with a general contractor to patch everything and paint it again to as new condition," Fuentes said.

Any damage caused from the temporary

installation will be repaired soon after removal, according to a city staff report.

Matson added that he disagrees with Commissioner Jennifer Schreiber and Devlin, who said they were supporters of the mural's design.

"I think your existing building is a very beautiful building with a lot of iron work that is quite handsome," Matson said. "That this is actually a distraction from your existing facade."

The City Council discussed how Beverly Hills retailers and restaurants are using outdoor space to continue operating amid COVID-19 regulations last Tuesday.

Open BH, a city program, allows for businesses to continue operating in adjacent outdoor areas while complying with COVID-19 health and safety regulations. Several restaurants have participated in the program, such as Spago on North Canon Drive, by placing tables six feet apart on the sidewalks surrounding their buildings.

"This program came about after lots of conversations with our businesses about what makes the most sense to them," said Marketing and Economic Sustainability Manager Laura Biery. Biery is also a mem-

ber of the COVID-19 Business Recovery Task Force.

Outdoor space that can be utilized include sidewalks, parking lots, parklets or a mixture of those options. Businesses must apply for permits to be able to participate, which the city has waived the costs for.

Special Events and Filming Coordinator Magdalena Davis said sidewalks have been the most popular outdoor space businesses have used. There have been 17 sidewalk permits issued and 14 are queued to be issued, according to Davis' presentation.

Davis said the second most popular outdoor space has been parking lots, with three different businesses using their employee or valet parking lots for additional outdoor

dining.

"We have two additional businesses that are looking to use their parking lots and are right now going through the process with different departments, including police, fire and public works to ensure that they are in compliance with all the necessary exit and safety measures," Davis said.

## EYE FOR DESIGN

### Design Review Chair Tony Spann on Good Architecture and Design

#### Why did you join the Design Review Commission?

[I am] a resident of the city, as well as an architect who practices here. I make my living doing this, and I think because I do that, I owe it to the city. It's something that's inherent in my architectural education. All my life, my entire family's latched on to something individually. For me, it was always giving back to the community.

#### You're an architect with Harrison Design. Architects on the Design Review Commission are not required to be Beverly Hills residents, which is different from other city commissions. What made you want to serve?

I moved down here in 2012-2013. [Those years], I was going back and forth so we decided to get a company apartment ... I moved down here and that made it easier because [when I] had to go back up to Santa Barbara it was just the opposite. I've spent more time down here than I do in Santa Barbara over the last five [to] seven years.

In 1993, I joined the City of Santa Barbara's Sign Committee. I was on it for four years, I was chair for four years. From there I went to the Historic Landmarks Commission for eight years. I was its chair. During that time, the Montecito Board of Architectural Review was formed and I was a charter member. I served on that board for 10 years. I was its chair, almost the entire time. I also served on the Santa Barbara Trust for Historic Preservation as a director for 10 years.

I moved down here for work and now where am I giving back? [If] I'm not going to go up and give back to Santa Barbara, what am I going to do with myself? I have all this free time, what am I going to do? Well, give back to the [Beverly Hills] community. [Harrison Design] had received a 2011 City of Beverly Hills Architectural Review Design Award for the Saban Theater. We do quite a bit of work in Beverly Hills, our office was in Beverly Hills, so Beverly Hills it is.

#### Compare and contrast the City of Beverly Hills and the City of Santa Barbara.

There's Santa Barbara City and there's Santa Barbara County. What I'm going to refer to is the comparison between Santa Barbara City and the City of Beverly Hills.

They're very similar in that .... really the person who runs the city is the city manager. Then there are [council members] and mayors. Unlike Beverly Hills, in the City of Santa Barbara you vote for

a mayor – they don't rotate. Whereas in Beverly Hills, you vote for a council and they rotate.

Beverly Hills is about 30,000 people. The City of Santa Barbara is about 80,000. [Santa Barbara] has very strict design review laws that over the last 20 years, I've been instrumental in helping write.

#### How are the two cities similar and/or different in terms of its architecture?

The City of Santa Barbara doesn't allow anything over four stories. It's just now allowing things over five stories. Of course, we all know the reason why – it's because of the housing impact that the City of Santa Barbara is facing, just like the City of Beverly Hills is facing. There's always a housing shortage in the City of Santa Barbara. Just now, under pressure, the city is looking at allowing housing in the downtown corridor. It'd be the first time this happened, since the city was chartered in the 1800s.

In that regard, the City of Beverly Hills and the City of Santa Barbara are very common. They have a similar problem in terms of they're low housing. But, [for] Beverly Hills, it's locked in right? You [have] LA all around you, you can't go anywhere so you have to go up. You have high rises in Beverly Hills, you don't have high rises in Santa Barbara.

#### You have some experience with historical preservation. Tell us about that.

My dad always told me, "You don't have to reinvent the wheel." He really meant, know your history. I was always curious, I still am to this day [about] how things work. My dad was very patient and he would explain to me how they work, what they did [and] why they work that way. When you're in Chicago – you're a kid, you're growing up and you're seeing all this – by the time you're 20 years old, you think you've seen it all. Then you move up to California when you're 23 [or] 24 and it's a whole new world.

You don't build out here, like the way they build back east. I'm like, "Oh my gosh, I went to college. I learned all this stuff all my life and I don't know [anything]." So two things occur. One, they are building differently in California. The second thing that occurs is, when you do find old buildings on the west coast you need to know how to treat them so you can preserve them. Because if you do it wrong, they'll just crumble and fall apart.

Over time, when we would be called to do remodels versus tear downs. In Santa Barbara, it was not always economical to tear the house down like it is in Beverly

Hills today for example. You might buy the property and instead of remodeling the house, you just tear it down. The economics are there. Well, in Santa Barbara 20 years ago it wasn't like that. It was actually better and more economical to remodel the houses.

A lot of those houses were old to begin with. So I had a lot of fun doing house remodels and finding all these old ways that they were built back in the 1920s to 1930s in Santa Barbara. That was very fascinating to me. It would go back to the 1700s, when you got the presidios and the missions.

#### You mentioned that buildings are different on the west coast and the east coast. Can you elaborate on why?

On the east coast, they build what's called balloon framing. That means that you build the ground to the roof and then you waterproof that shell as fast as possible. So if you want a second or third floor, you put it on after the roof is on. Whereas out here – because it doesn't really rain much – they build the first floor ... and they build the next floor like a platform. They don't care if it's going to rain.

#### How does being an architect influence the work you do on the commission?

I can read plans pretty quickly. I can understand in three dimensions, what this proposed project will look like. I could in my mind compare to the existing built environment, the neighborhood around it and make a judgment call whether I think it's compatible or not.

#### What are your goals as chair?

I'm hoping that we can continue to educate the community, make them understand what constitutes good architecture and design [and] what adds value to the community. I also hope more applicants try to go back to the basics. We're seeing a lot of pressure to use false materials – plastic, things that I don't think will last long.

I know certain things the state is mandating, just like the state mandates we have to have housing. The state mandates certain things like the green code, which means that the only way to get a certain type of roof is to use a plastic roof these days. Those are frustrating things for an architect. Especially a purist like me where, why would I want to put plastic where it should be slate?

My job is, I know that the garden City of Beverly Hills is based on authentic real materials. So if we can somehow still get authentic, real materials and not use all the fake [materials] that are out there

on the market, it would be better for the community. That's what I'm trying to do and I think that will be my biggest challenge.

#### What is the commission currently working on?

We only look at certain projects in the flats. We don't look at anything up in the hills, up in Truesdale. We don't look at any commercial projects, only residential, and only the ones that the urban planner Mark Odell deems needs to see the [Design Review Commission]. Our focus is limited to streetscapes, front elevation, neighborhood compatibility in that regard. All [the Commissioners] want is [to not] lose the garden quality of the City of Beverly Hills. I think that's probably

one of our number one goals, to accomplish that.

#### In an cover interview with former Chair Ilene Nathan in Issue #719, she said the commission wanted to keep the integrity of the city and for everything to blend in. Do you agree with that statement?

Absolutely. [That adds] value to our community. The community is held to a standard and the standard is understood throughout the world. Beverly Hills is known throughout the world.

For example, as a gold standard. You

can't then pass it off as being silver or copper, its gold. The idea is if you can keep the standards high, you keep the standards high for everybody, [it] creates a better place. A better quality of life, integrates into what was already here and why we all want to be here in the first place.

#### Tell us about your family.

My oldest son, John, and his wife Liz live in Santa Barbara. He's a IT guy for a company called GoToMeeting. My son, Jim, and his wife Nikki have two beautiful children, Penelope who is three and Paisley who is eight months. Jim works in the packaging business. My daughter, Sophia, is in a third year of medical school student. My son Anthony is a senior at Chapman, he's going into business finance. My wife, Linda, is the general manager at the Santa Barbara club.

#### In a few words, describe the significance of design to a project.

The significance of what we try to do on the DRC, is to provide good architecture. We do that with our comments, we try to work with the applicant to do that. In my mind, good architecture is timeless in style and design, it evokes positive human emotions and it adds value to the community.
