


## “Board Selects Superintendent Finalist”

Earlier this summer, our Beverly Hills Board of Education President Myra Lurie invited both rank-and-file teachers and the leadership of the Beverly Hills Education Association to give input into the qualities we desire in our next superintendent. The teaching staff appreciated this opportunity and on behalf of BHEA, I thank the Board for soliciting our input during this very early stage of the superintendent search process.

Next came the interview stage. Candidates for superintendent were interviewed by the five Board members, and no one else. Next came the deliberation stage. These deliberations occurred among the five Board members, and no one else. Next came the site visitation

stage. The five Board members, and no one else, traveled to the finalist’s place of work to talk with the finalist’s colleagues.

I am critical of the Board’s decision to exclude teachers from every part of the superintendent selection process, save the initial input phase. Some members of the Board told me that the candidate pool would not have been as good if other parties, like BHEA, had played a role in the later stages of the process. The better question is: Why would BHUSD want to hire a candidate for superintendent who demands that teachers not have a voice in his or her hiring decision?

Excluding teachers from this important decision does not mesh with the district’s stated goal of collaboration. When the Board allows shared decision-making to occur, all stakeholders feel valued and gain a sense of ownership with the decision. The superintendent touches everyone’s lives in our district: the staff, the students, the parents, and the community at large. The Board lost the opportunity to be inclusive on this important decision. And as a result, 100% of the accountability for our next superintendent’s tenure lies squarely on the shoulders of our five Board members: Nooshin Meshkaty, John Millan, Myra Lurie, Myra Demeter and Alissa Roston. That is an enormous responsibility, one that our Board members did not have to bear alone.

Let’s build upon the areas where coop-

eration between BHEA and the district are successful, and let’s learn from the knowledge that all of us can contribute to our Beverly Hills Unified School District.

## Board of Education Approves Choices

Program to provide students caught with drugs an alternative to suspension.

The BHUSD Board of Education voted unanimously Monday night to approve two related Board Policies that will allow a new drug and alcohol disciplinary program at Beverly High. The approved policies are a part of Choices, a program which will provide the school district with an alternative to suspending students who are caught as first time offenders of drug or alcohol possession or use.

"In light of the fact that practically all high schools, public and private, face the issue of some drug and alcohol abuse among their students, our Board has

explored various ways to educate our students to prevent such negative behaviors and provide effective options for the rehabilitation of those students who are engaged in alcohol and drug use," said Board of Education President Myra Lurie.

The program is not meant to lighten the consequences, but meant to be a deterrent, Lurie said. She explained that expulsion is not always the best option for a student as they are not offered any treatment or support.

The City Council of Beverly Hills, at its regular meeting to be held on **Tuesday, September 19, 2006, at 7:30 p.m.**, in the Council Chambers of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210; will hold a public hearing to consider:

AN APPEAL OF THE PLANNING COMMISSION'S DECISION DENYING A REQUEST FOR A GENERAL PLAN AMENDMENT, A ZONING CODE AMENDMENT TO CREATE AN OVERLAY ZONE, A VESTING TENTATIVE TRACT MAP, AND A PLANNED DEVELOPMENT PERMIT TO ALLOW CONSTRUCTION OF A MIXED-USE PROJECT WITH 4,774 SQUARE FEET OF RETAIL/COMMERCIAL SPACE AND 25 RESIDENTIAL CONDOMINIUM UNITS FOR PROPERTY LOCATED AT **8600 WILSHIRE BOULEVARD (WILSHIRE COLONIAL PARTNERS, LLC)**.

The Planning Commission at its hearing of July 27, 2006 denied the project, citing mixed-use, largely residential development as an inappropriate land use for the project site which is currently zoned for commercial development along the Wilshire frontage, and for single-family residential development along the Stanley and Charleville frontages. The project applicant has appealed the Planning Commission's decision to the City Council by filing a timely appeal with the City Clerk's office.

A Draft Environmental Impact Report (DEIR) was prepared for the project and the DEIR was released on Friday, March 17, 2006 for public review and comment pursuant to a notice published on March 17, 2006. A public hearing on the DEIR was held April 27, 2006 and the 45-day comment period ended June 1, 2006.

All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210 and should be received prior to the public hearing.

Please remember, if you challenge the Council's action in court, you may be limited to raising only those issues you or someone else raised at the hearing before the City Council or in written correspondence delivered to the City, either at or prior to the hearing.

9876 Wilshire Boulevard (The Beverly Hilton Oasis) The City of Beverly Hills is preparing an Environmental Impact Report (EIR) for the proposal described below. The public is invited to attend a preliminary "scoping" meeting to comment on environmental issues that should be addressed in the EIR.



**Project Location:** The project site, currently occupied by the Beverly Hilton Oasis Hotel, is part of a larger triangular area just west of the intersection of Wilshire and Santa Monica Boulevards and occupied by two other land uses: the Robinsoms-May site and the Unocal gas station (see map). The Beverly Hilton Oasis is located east of Merv Griffin Way. The project site is currently zoned commercial (C-3) which limits development to a 2:1 floor area ratio (FAR), three stories, and a height of 45 feet.

The proposal would necessitate changes to the existing zoning and general plan and would be subject to review by the Planning Commission, Architectural Commission, and City Council.

**Project Description:** The proposed project would redevelop the hotel campus. With the exception of the 8-story main hotel tower, all buildings on-site would be demolished. The campus would be configured to provide more public and private landscaped areas than currently exist and new development would include luxury condominiums, luxury hotel condominium/hotel rooms, and a subterranean parking structure. A summary of existing and proposed uses is provided below. The project is not listed on the State's "Cortese" list of contaminated sites. Additional details, including architectural plans and written documentation, are available for review in Room G-40 of City Hall (see address below).

The project may have potentially significant impacts on the following environmental resources, which will be studied in the EIR: Aesthetics, Air Quality, Cultural Resources, Geology, Hazards and Hazardous Materials, Hydrology and Water Quality, Land Use and Planning, Noise, Population and Housing, Public Services (Police, Fire, Schools, Parks and Recreation, Libraries), Recreation, Transportation, Traffic and Parking, and Utilities (Water, Wastewater, Solid Waste). The Initial Study completed for this project concluded that the project would not have potentially significant impacts on Agricultural Resources, Biological Resources, and Mineral Resources; therefore these topics will not be studied further in the EIR.

**Purpose of the Scoping Meeting:** The purpose of the meeting is to present a project overview to the public and provide an opportunity for a discussion of the environmental issues that are important to the community. The meeting will include a presentation of the project proposal and summary of the environmental issues to be analyzed in the EIR. Following the presentation, interested agencies, organizations, and members of the public will be encouraged to present views concerning what environmental issues should be included in the EIR. The oral and written comments provided during the scoping meeting will assist the City in scoping the potential environmental effects of the project to be addressed in the EIR.

After the Draft Environmental Impact Report has been prepared, the Planning Commission will hold a public hearing on the EIR and on the project. Notices of the availability of the Draft EIR and of the hearings on the project will be released at later dates. an option for student success,” Lurie said.

Choices will not automatically be an option for students who are caught with drugs or alcohol. In order to qualify, they must be recommended by the school’s principal and their parents must agree to the

high school campus.

“Having sought the advice of expert consultants and administrators from other districts with experience in such programs, we have decided to consider using non-aggressive drug-sniffing dogs to make random, unscheduled campus visits,” Lurie said.

sniffing dogs and the results they yield are not always accurate.”

Schroeder cited the example of Attorney General Janet Reno being stopped in an airport because a drug sniffing dog smelled drugs on cash she was carrying.

“It’s also something that undermines trust between students and teachers and students and parents,” she said.

In order to remain in the program and avoid expulsion, there are several requirements of Choices, which the student must agree to and follow through on. Once a student has been recommended and approved for the program, they must then enroll in counseling, which will include sessions with their parents, participation in a 12 step intervention program and agree to volun-

tary random drug testing. Students must also meet attendance requirements and keep their grades above a passing level.

“It’s a very serious contract that students and parents sign,” said Assistant Superintendent Richard Malfatti. “We want to let kids know we are serious.”

According to the policy, Choices will only be an option to prevent students from being expelled. All regular steps will still be taken if they are caught with drugs or alcohol, including a five day suspension from school, notifying the police department and the student’s parents and a 12 week suspension from any co-curricular activities.

conditions of the program, which requires their involvement as well. The students must be first time offenders and will not qualify if they are caught distributing or selling any substances.

Lurie said that Choices is a part of a comprehensive program to counteract drug and alcohol use in local schools. Choices will work with other plans to combat and discourage substances including voluntary urine analysis, student search and seizures, and having drug sniffing guard dogs on the

“These dogs will sniff the classrooms, lockers, parking lots and common areas of the school, but will not sniff the students themselves.”

Drug sniffing dogs could provide another set of problems and costs though. Associate Director of American Civil Liberties Southern California Elizabeth Schroeder said that the ACLU thinks there are better means to check students for drug use than drug sniffing dogs.

“It is very expensive to bring in drug

## League of Women's Voters Terminates Association with Alliance

The League of Women's Voters of Beverly Hills has terminated its association with the Beverly Hills Residential and Business Alliance after the California Supreme Court's decision to deny the Alliance a hearing on the Montage litigation.

"The Municipal League and League of Women Voters originally formed an alliance opposing the Montage building," said Dorothy Kaufman, President of the League of Women Voters. "When the decision of the California Supreme Court denied the hearing, [the issue] was closed."

The League released the statement that they are no longer automatically a part of the Alliance or any other group which may be formed for any future developments in Beverly Hills.

This puts an end to an ad-hoc coalition that successfully placed an initiative on the ballot in an attempt to overturn council approval of the Montage Hotel and Gardens.

However, recent court decisions have dampened the relationships between the League and the Alliance which led the battle against the Montage in early 2005.

The League of Women Voters is a nonpartisan political organization that encourages citizens to actively participate in government. They strive to influence public policy though

education and advocacy with no affiliation to any political party or candidate.

The Montage project is currently under construction north of Wilshire Boulevard between Beverly and Canon Drives. It will include a Montage luxury hotel with up to 25 condominiums; 33,000 square feet of public gardens with adjacent restaurant and office space; and 1,172 parking spaces. The project is expected to be completed in the fall of 2008.



still retain the expulsion option if they felt it would be a more appropriate measure.

“Our purpose is to better use and provide a means of rehabilitation,” Lurie said. “But it could be that the expulsion might be something we would elect to do.”

Students attending Beverly High on an inter-district transfer permit, who are caught with illegal substances and referred to the program will have their permits revoked and will be returned to their resident school.

Student Board Member Samantha Pop said that as a student of Beverly High, she felt that the drug sniffing dogs would be a large visual deterrent for most students. She also inquired as to whether the program would be implemented in the District’s middle schools.

Malfatti said there are no current plans to use the Choices program in the lower grades, but depending on how successful it is in the high school, adapting it to the rest of the schools may be an option.

Because the school district does not have an exact number of how many cases they are likely to encounter once all of the branches of Choices are put into place, they therefore did not have an exact cost estimate for the program. Malfatti said the main costs will be the drug sniffing dogs, a counseling care provider and the urine analysis.

The board plans to further discuss details of the policies and the best way in which to implement them at their September 26 meeting.

## Of Markets, Planning And New Chances

Some mistakes, some opportunities of past and present.

Although Pavilions has a very long term lease, their property at Beverly Drive and Olympic has reportedly been sold. The market, one of the few survivors in a city that used to have as many as six full service food stores, is an example of planning gone awry.

Originally built as a Vons – Pavilions being an upscale sister of the chain, faced considerable opposition from some of the then neighbors. The result was a traffic control plan that was neither protective of the area or in any way sensible.

An alley going west was permanently blocked to traffic because one resident on El Camino feared delivery trucks and patrons would arrive or exit next to her house. The protesting neighbor has moved, but the inherited mess remains. Instead of a direct route to El Camino, shoppers now leave the store on Olympic causing congestion, especially during rush hours, on one of our busiest streets. Where

do they go from there? Of course, right on El Camino.

The most damaging impact of trying to hold down the size of the store was the surface parking lot, one of the ugliest eye sores in our city. Instead of a market large enough to make parking below surface an integral element of the structure and permit a more economically viable, larger store, we have a hybrid that has nowhere near enough space to fully service shopper's needs.

Having said that, it should be noted that the store workers are among the friendliest and most helpful in the area and the "study" elements of the general plan call for considering rules that would permit expansion of the size of a possible new market. Of course, that's up to the lease holder, but has anyone alerted Gelson's?

Whole Foods, one of the fastest growing food store chains in the nation, also has bemoaned the size of their store in Beverly

Hills, one of the smallest they operate in Southern California. The store is on land owned by the city, which also owns the property rented to Beverly Hills Market, Pioneer and Lucerne Hardware, a retail postal office, bakery and barber shop, north of Whole Foods on Crescent.

Above Whole Foods is a marvelous experiment in affordable senior housing, created during the tenure of then Mayor Donna Ellman. The General Plan study has and should consider similar possibilities when providing for smaller mixed use developments.

Getting back to bad planning, take Rite Aid, please. The solid blank wall facing Canon Drive is beyond ugly and inhibits beautification of one our most important streets. **Fred Hayman**, who owns one of the largest buildings on the street and who was a leading visionary in creating what is now Rodeo Drive, needs to be drafted by the city to bring some imagination to future plans for that street. It has some very fine shops and restaurants and the possibilities exist to use imagination and the tools of a new general plan to enhance Canon Drive. Talk to Fred.

Getting back to Rite Aid, at your own peril. The pharmacy should provide in-house entertainment; waiting to pick up a prescription is an opportunity to become

well acquainted with your neighbors in the permanent lines. I recently asked one totally exasperated patron why they would endure the long delays and he answered it was because of the available parking. Our many wonderful pharmacies, such as the venerable Schwab's on Bedford Drive, are close enough to public parking to make them more viable.

As for the servers, and certainly not all, it is usually rude to interrupt their work on the floor to ask where an item, any item, can be found. Their sister store on Bedford is no better, although not quite as busy. The newer drug store at Doheny and Wilshire, built as a Sav-on and now a CVC, is almost a full food market with a freezer section for frozen foods, something not available at Rite Aid. But here too the planners, responding to some resident objections, created an exit and entrance design, plus a frontage and elevated entrance, that is chaotic.

Planners, and our current commission, did not do themselves proud in the handling of a proposal to create a mixed use project by Legacy Partners on Wilshire, Maple and Palm Drives. Incidentally, all the headline writers for our community newspapers also erred. The "project" was NOT approved by the city council, the appeal to overturn the decision not to permit mixed use was, but not the development itself.

What was inexplicable was the year's long uncertainty of what the city would approve. If the Planning Commission, and

the council, could not decide if mixed use was appropriate, the neighbors and the developer should have known months before what an eventual appeal would bring. All five councilmembers favored mixed use, but only one commissioner did.

As for the argument against mixed use made by the Planning Commission majority, it was sophomoric and illogical. A former commission chair, **Jerry Felsenthal**, raised this issue of information processing and chided the commission for the deliberation process.

The land, as most of the immediate neighbors recognized, would not remain vacant and would be developed. Right or wrong, they opposed an abandoned hotel bid for the site, but backed the mixed use as the least intrusive. It simply took too long to communicate city intentions to residents and builders, and that made it all the more costly and divisive.

Is mixed use – housing and retail good

for Wilshire Boulevard? For some properties, it is clearly the best planning possible. 9900 Wilshire meets every test of viability. Aside from a magnificent design, it will be our first ever totally “green” construction and that alone should make any dissidents pause.

However, and this was raised during the Legacy project, will a proliferation of mixed use negatively impact city revenues? The Planning Commission chair thought so, arguing that this venue would be “ideal” for a talent agency. Obviously, it wasn’t. The land has been empty for years and none of the agencies such as William Morris, ICM and CAA each of whom has tried to find new homes, even considered this site. Why? It is much too close to residential and too far from hotels and restaurants. On the other hand, other entertainment groups are moving into what was once our Industrial Area where land costs were more market viable, but not the major talent groups.

Loss of revenue is important, office

buildings do bring the city money through the business license tax. But housing needs are critical and mixed use may be the best possible compromise for some, but not all, of the developable land on Wilshire Boulevard. At the same time, impacts of traffic must be part of the decision making and there are good arguments in support of housing and uses that actually reduce through traffic.

The site of the Legacy project has an interesting history. It was once the home of famed criminal lawyer Jerry Geisler who had a house/office there.

He was the lawyer in the sensational trials of **Errol Flynn** and **Charlie Chaplin**. After he sold the property, it became a used car lot and automobile dealers are, after hotels, a major source of tax dollars. The same area does suffer from the presence of a Lexus dealership which has tried to coexist with its neighbors. The daily arrival of cars for servicing and the more disruptive delivery of new cars have made that street a very difficult place for resi-

dents and motorists alike.

Another car dealer, BMW, further down on Wilshire, is reportedly ready to leave our city because it needs more space. This too would hurt tax collections.

In any case, the mix of housing, retail and office needs along with fiscal impacts, should be part of the exciting road to adoption of a new General Plan. Responsible planning, community involvement and rational decision making could mean a more livable community. But are we too disinterested to make a difference or will the forces that line up on both sides of development issues wait to draw battle lines one project at a time instead of working to plan for the future through an exciting new General Plan.

and Frank Fenton for helping to protect our neighborhood. Their thoughtful decision genuinely balances the need of our neighborhood with the needs of our City.

We applaud City Council for making the needs of residents a priority. They clearly heard and understood that BVNA’s neighborhood needed a project on this site which minimizes, not maximizes, the traffic and parking impact. Our neighborhood is

already at the breaking point. Our neighborhood is stressed out and saturated with traffic and parking problems. BVNA already communicates weekly with City staff and City Council about the egregious traffic and parking problems experienced by S. Maple, Palm and Oakhurst Drives.

We also want to thank Legacy Partners for their willingness to change their design so it is more resident friendly. The design for their mixed use project directs traffic and parking away from the residential sec-

tion adjacent to this site. We hope that future projects are so considerate of residents.

Under the innovative leadership of our City Manager Rod Wood, Beverly Hills is working with Legacy Partners to ensure that the City recaptures the financial differential between designating this site for mixed use vs. office use. We trust that Legacy Partners and City Council will be flexible and work together to find solutions to the other to-be-decided development

issues which work for everyone.

BVNA recognizes that other Beverly Hills residents are concerned about the potential impact allowing mixed use at 9200 Wilshire might have on their neighborhoods. As City Council members said, this decision is regarding the correct usage for this location only—it is not a precedent for any other site in Beverly Hills.



## BHHS Football Team Wins Second Game Of Season; Heads to Massachusetts For East Coast Debut

Norman girls' volleyball team finishes second in tournament; boys' water polo team third.

Beverly Hills High School overcame disappointing starts offensively and defensively to defeat Palos Verdes, 26-7, in a nonleague football game Friday at Palos Verdes.

Meyer Linter threw three touchdown passes, two to Dominique Sandifer and one to Jon Skura, as the Normans scored the final 26 points to start 2-0 for the first time since 2002.

Beverly Hills has not started a season 3-0 since 2000.

A holding penalty and a sack forced the Normans to punt after three plays on their

first offensive series, and the Sea Kings (0-1) scored a touchdown on their first offensive possession.

Beverly Hills cut the deficit to 7-3 on Trevor Charlston's 23-yard field goal. The Normans went ahead 9-7 on a four-yard touchdown pass from Linter (17-for-25 for 236 yards) to Sandifer for the second quarter's only score.

In the third quarter, Beverly Hills got a 34-yard field goal and a 45-yard Linter-to-Sandifer touchdown pass, increasing its lead to 19-7.

Linter threw a four-yard touchdown pass to Skura in the fourth quarter.

"We played as well as we've played on defense in several years," Norman coach Carter Paysinger said. "Offensively, we had a real tough time. It was a real physical game. They created some matchup problems for us on the front line, so we had to overcome those and it affected our running game a little bit."

Beverly Hills met its pregame goal of controlling the tempo, Paysinger said.

"We got control of the game in the second quarter," Paysinger said. "We went to the no huddle and sped the game up a little bit, got the ball to our receivers and ran our running backs wide and made it a perimeter game."

Fullback Gerald McGee, receiver Darrian Richardson, who caught five passes for 77 yards, and Skura, a tight end, drew praise for their play offensively from Paysinger. Defensively, linebackers Nathan Forrest and Sae Bin Park drew praise from Paysinger.

The victory extended the Normans' regular-season undefeated streak to 12 games, their longest streak since a 16-game winning streak from 1995-97. The current streak began at the start of the 2005 season.

### What's Next?

The Normans are scheduled to play at Marshfield, Mass. Saturday at 4 p.m. (Pacific Daylight Time) in their East Coast debut.

The Rams opened the season with 20-14 victory at Falmouth Friday and were 6-4-1 in 2005.

### Girls' Volleyball

#### Centurion Varsity Girls Volleyball Tournament

Beverly Hills lost to Santa Ana, 21-25, 25-21, 17-15, in Saturday's final at Century High School in Santa Ana after defeating the Saints, 25-12, 27-25, to open pool play.

"Santa Ana at the end of the day blocked better than they had earlier in the day and they simply dug us better than we dug them," Norman coach Marla Weiss said. "They served better than we served."

Beverly Hills defeated Anaheim Western, ranked seventh in the Division III-A preseason poll released Monday, 25-21, in a championship semifinal.

The Normans also defeated Anaheim Magnolia, 25-10, 25-11, Anaheim, 25-10, 15-10, and Anaheim Katella, 25-11, 25-8, in pool play.

Senior outside hitter Deborah Frantz and senior setter Bettina Shore were both named to the all-tournament team, while junior middle blocker Netta Rotstein "played quite well," for Beverly Hills, Weiss said.

### What's Next?

The Normans are scheduled to face Barnstable, Mass at 9 a.m. and Marshfield, Mass at 11 a.m. (Pacific Daylight Time) Saturday at Marshfield High School.





## FROM BEVERLY HIGH TO 'JERICHO'

Local graduate and acclaimed movie director to produce new CBS series.

Jon Turteltaub has gone from being an actor in student productions at Beverly Hills High School in the early 1980s to the director of such hit films as "National Treasure," "While You Were Sleeping" and "Phenomenon."

Fans of the 1981 Beverly High graduate included CBS Entertainment President Nina Tassler.

"He's a brilliant filmmaker, a great storyteller," Tassler said in an interview this summer at the CBS portion of the Television Critics Association summer press tour. "I've been after him for years to do a pilot."

CBS and Turteltaub made a deal last year, leading to Turteltaub directing the pilot of "Jericho," a drama about the effects of a nuclear explosion on the residents of a Western Kansas town, which CBS put on its fall schedule and is set to premiere Wednesday at 8 p.m. on KCBS-TV Channel 2.

"This is a fresh concept," Tassler said. "I loved the universe, I loved the mythology. I loved his characters. The show was full of event and drama and suspense. There was humor and irony. What you respond to is the quality of writing and it was an incredibly well-written script, very compelling story telling."

Turteltaub said the idea for "Jericho" "started with friends of friends saying, 'Wouldn't it be a cool idea for a show if...?' and then developing the idea."

Turteltaub hired Stephen Chbosky, and the writing team of Jonathan A. Stenberg and Josh Schaer, to write "Jericho's" pilot. Chbosky wrote the screenplay for the film adaptation of the musical "Rent," and was called by Turteltaub "a terrific character writer, because characters are what matter."

"A show will last forever if you care about the people," said Turteltaub, who played George Gibbs in a 1980 Beverly Hills High School production of "Our Town" and Will Parker in a 1981 BHHS production of "Oklahoma," whose cast also included his future "National Treasure" star Nicolas Cage.

"If you have actors who are compelling and charismatic and characters who are those things, you can keep going."

Although nearly all Turteltaub's career before "Jericho" was in movies, he does have television experience. His only previous television endeavor — directing an episode of the 1998 HBO miniseries, "From the Earth to the Moon," about the Apollo

project, brought him a Directors Guild of America nomination.

"There's still something to the movies — right or wrong — that holds a more glamorous position in American culture," said Turteltaub, who has a bachelor's degree from Wesleyan University and a master's

degree from the University of Southern California's Film School. "There aren't a lot of movie stars who say, 'If only I could get into television.' That may not be the same of writers, producers and directors."

else, arguing over the best line of dialogue and the best editing," Turteltaub said.

Turteltaub has quickly won over cast member Pamela Reed and the series' showrunner.

"Jon has become my favorite person in the universe after my family," said Reed, who portrays the strong and savvy wife of the town's mayor (Gerald McRaney). "He is so funny. He is so supportive. There's nothing like feeling the love of somebody across a set." Reed also called Turteltaub, "the silliest person I know."

"He absolutely renders us to guffaws and stitches," Reed said.

Turteltaub brings "incredible knowledge" to "Jericho," Reed said.

"He's done incredible research," Reed said. "Most importantly, he believes in the people that he's has hired and you feel that on his set. There's no guessing, there's no


temper tantrums. He knows who he is and therefore the rest of us feel pretty good."

Carol Barbee, the "Jericho" executive producer who runs the series on a day-to-day basis, hence the title "showrunner," called Turteltaub, "the greatest guy ever."

"He's got the big name, he's got the resume to prove he and he's got it because he's a great storyteller," Barbee said. "He's also just a great guy to hang out with and that doesn't always go hand in hand."

"One of the things I always say to people is, 'He's really good at his job' because writers get scared [and wonder] 'Who am I working for? Is he a nightmare?' He's a great guy and really a great storyteller. The crew loves him. That's how you tell."

Turteltaub will be heading back to movies in January when shooting begins on "National Treasure 2," which like the original, stars Cage. The film is due out Christmas Day, 2007, with Turteltaub describing it as "completely" being "in the same flavor as the first movie, but [taking] us to other places and other pieces of history with other puzzles to solve."

"That said, it is very easy for a movie to suck and you have to approach every movie as if you make a single mistake, the whole thing will suck."

## TAKING THE HELM

The Weekly's exclusive interview with New Beverly Hills Unified School District Superintendent Kari McVeigh

Kari McVeigh's belief in working in a school district that's goals and values speak to her has taken her from San Francisco to Boston and all the way back to California to become the new superintendent for the Beverly Hills Unified School District.

In her inaugural speech to the community on Tuesday night, McVeigh compared what she described as her call to teaching to the same overwhelming desire actors, artists and musicians often express.

"Teachers really don't have a choice," McVeigh said. "We are compelled to be educators."

It was the district's goals and values that attracted McVeigh and convinced her to apply after spending five years in the San Diego Unified School District.

"The belief statement on the web page spoke to me personally," McVeigh said. "Beverly Hills Unified School District truly believes in establishing a professional learning community based on collaboration and accountability to improving student performance."

McVeigh said she was drawn to the district because of the hands on approach they strive for and the relationship they have with the community.

"The district believes that staff working together and with the community can create a culture and practice of continuous improvement resulting in improved student performance and improved conditions for teaching and learning," McVeigh said. "All of these beliefs were stated in the districts mission and belief statements and echoed by the Board, and these beliefs mirror my own. What a perfect match."

Although she knew she wanted to work for Beverly Hills, getting the job was not a quick and easy process. From the time she applied, to when she was hired, McVeigh estimated that it was about three months full of paperwork and interviews.

"It's a very humbling process," McVeigh said.

McVeigh started her career when she graduated from San Francisco State University in 1976 and took a teaching job in the then booming Clark County School District in Nevada. McVeigh said that at first, she was unhappy in Las Vegas and missed California, but the quickly growing district needed someone with experience to help open new schools and they chose her.

"It's a great honor where you're the one

approached to open a new school," McVeigh said.

At that time, Clark County was and still is today, the fastest growing school district in the country. From the mid-1980's to 2000, McVeigh was in charge of opening 18 new schools in Las Vegas.

In 2000, after spending the first 23 years in the same school district, McVeigh said new administration was bringing about changes in the school system that she did not fully

McVeigh was in charge of coaching elementary and middle school principals to create an in-school accountability plan. The plan was to educate the school leaders so that they would be better able to educate their staff and in turn their students.

"You're leading people where you want to see them go and also where they want to go," McVeigh said.

Although many teachers in the area and the teacher's union initially opposed the

support, so she looked for a school with values that interested her. She then took a position with the project for Whole School change in Boston.

"What attracted me to it was what they were doing over there and the reform," McVeigh said.

After spending nearly two years there, the curriculum again began to change and McVeigh was once again drawn to a reforming district. She moved back to the West Coast to take a job in the newly reforming San Diego Unified School District.

The five years McVeigh spent there were in the midst of District Superintendent Alan Bersin's controversial school reform. While working there as Assistant Superintendent,

changes, once they were in place, McVeigh said things calmed down, but she learned the stigmatism of the word.

"Reform has a connotation that something is broken," she said.

McVeigh said that around the time the new Superintendent Carl Cohn replaced Bersin, she felt drawn to Beverly Hills which has the size to make some educational plans more workable than San Diego.

"Carl took time learning about the district," McVeigh said of the changes Cohn brought about. "He wanted to remove the vestige of the stigma (from the reform)."

In response to the District's concerns that superintendents don't stay longer than a few years, McVeigh referred to her long tenure in

Las Vegas and her five years in San Diego and assured that she is committed to staying.

"You can't build community unless you're involved in it," McVeigh said.

She is already working to make Beverly Hills her new home and become a part of the community. Her current concerns include moving into the area and finding temporary housing while she shops for a home.

Instead of going into the job with any set changes she would like to make, McVeigh said she hopes to commit her first three months to learning the area and the schools strengths as well as the concerns of teachers, parents and students.

"The biggest thing I'm going to be stressing is listening and learning," McVeigh said.

McVeigh expressed that she does not want to focus on how working in Beverly Hills will be different than

San Diego. She said that coming into the area with too many expectations or preconceptions could possibly inhibit her from fully taking in what challenges she may face and what benefits there will be.

"I try not to have preconceptions of what will be or not be, but to be open to meeting and learning about the district from the people within and the people who support the district from the outside," she said. "I plan to spend considerable time learning from all stakeholder groups about the district, their wants and needs and what their hopes and aspirations are for the district."

For all of its differences in size and resources compared to other Southern California school districts, McVeigh pointed out that Beverly Hills does have one great common denominator with them.

"What I do know is that all parents want the best for their children from the schooling experience," McVeigh said. "That is true wherever one goes and is a charge I take seriously and with great humility."

When addressing the community, McVeigh once again stated her desire to work with everyone involved in the Beverly Hills School District to learn about the area's needs.

"I need you compelled," McVeigh told the crowd. "We need each other to answer the call."
