



## Hilton Referendum Will Be on November Ballot

Council unanimously decides to put referendum to vote

The Beverly Hills City Council unanimously decided that Beverly Hills voters should decide the fate of the anti-Hilton referendum on November 4, when the referendum will be added to the presidential election ballot, at Tuesday night's meeting.

In contrast to the 3 to 2 vote that approved the project, the City Council unanimously agreed on the future of referendum aimed at halting the current Hilton expansion project, which includes the development of a 12-story Waldorf=Astoria hotel, a six- to eight-story condominium building, 16- to 18-story condominium building and green gardens on the Hilton's nine-acre lot on Wilshire and Santa Monica Boulevard.

"This referendum is not about the Hilton, though the Hilton is subject matter. It's a wake up call to the entire council and community regarding the upcoming general plan. The community wants a say in the future without manipulation and spot zoning, not about no growth, it's about responsible growth in an orderly manner," said Councilmember Nancy Krasne, who voted against the project the last time it was before the council.

The Citizens Right to Decide Committee submitted 3,092 signatures in favor of the Referendum petition on May 29. The Los

Angeles County Registrar-Recorder's Office verified that 2,574 of those signatures were valid on June 25. The petition needed at least 10 percent or 2,075 signatures of the 20,747 registered voters in Beverly Hills to be viable for a public vote.

"It is the citizens right to decide," said Councilmember Linda Briskman at the meeting in support of putting the referendum to a vote. "It took a huge effort to collect those signatures."

The council favored Nov. 4 for the vote because the voter turnout will be substantial, it will be economical and it will be quickest, as Briskman noted in the meeting.

"[I] see there is support for the November 4 ballot, which I have no problem with at all so I will go along with it," said Mayor Barry Brucker, who voted against the project the last time it came before the council.

Should the referendum be approved by voters in November, Hilton's developer Oasis West Realty LLC would either have to develop a new plan for the project or wait a full year before coming to the City Council with the same plan again.

"We look forward to the vote in November and are confident that the residents of Beverly Hills will confirm the

## Another 3-2 Board Vote Over New Asst. Principal

Fenton, Goldberg believe hiring process was biased

A divided BHUSD Board of Education approved Santa Monica High School special-education teacher Kelly Tabis as the new assistant principal for Beverly High in a vote of 3 to 2 at a meeting on Tuesday evening.

Dissenting votes came from Board members Brian Goldberg and Steven Fenton, who raised concerns about BHUSD's hiring process at the open meeting in the Salter Family Theatre.

"I'm not taking issue with the candidate's qualifications but rather the process and the fact that three internal [BHUSD] candidates didn't get face-to-face interviews," Goldberg said in a phone interview.

There were 89 applicants for the assistant principal position. Fourteen candidates were offered interviews, with seven candidates

actually going through the interview process. Of the three internal candidates from the BHUSD, none were offered interviews.

According to Fenton, an additional 14 applicants had principal or assistant principal experience. Only one of those candidates received an interview.

In the 1980s and 1990s, almost every BHUSD principal or assistant principal was hired from within the BHUSD. Of the 12 current principals or assistant principals, only four taught in the BHSUD prior to becoming administrators.

One source of concern was that BHUSD assistant superintendent Ilene Straus, who was the principal of Santa Monica High School when Kelly Tabis was hired as a teacher in September 2005, was a panel member in the interview process to hire the new assistant principal. Tabis, who graduated from Loyola University Chicago, worked as the special education department chair, school site council chairperson and special education intensive studies teacher at Santa Monica High School.

Only one week ago, the Board of Education discussed the importance of bringing BHUSD staff and teachers "up through the ranks" to administrative positions when they become open, which is rare in a small district like BHUSD, Fenton noted.

"So why didn't [internal candidates] get the

## Dead Man in Vacant House at Alta Drive Still a Mystery

The dead body found in a vacant house on North Alta Drive on June 26 confirmed fears of some neighbors who have had safety and aesthetic concerns about the dilapidated property for years.


"We've been talking to the city [about the house] for years. It's a firetrap and they haven't done anything about it," said neighbor who wished to remain anonymous. "And now this."

The vacant house at 720 N. Alta Drive, where the corpse was found, is owned by two brothers, according to the Los Angeles County Assessor's Office. The brothers acquired the property on July 3, 2007, after it had been foreclosed, according to county records. No sale price was listed at the Assessor's Office, but county officials valued the land alone at \$3.3 million in 2003.

The homeowners could not be reached for comment.

The body of the presumably homeless man found at the house still has not been identified nor has the cause of death been determined, according to a spokesperson for the Los Angeles County Coroner's Office. The Coroner's Office is waiting for the results of a toxicology report, which could take six to eight weeks, before they can establish a the cause of death.

A spokesperson for the BHPD said the investigation is on-going.

## BHPD Officer Gets Award for Finding 12 Stolen Cars

Beverly Hills Police Officer Jesse Perez was recognized for recovering 12 stolen vehicles during the last year and half by the California Highway Patrol, who presented him with a '10851 Award' at the BHPD headquarters on June 27.

"This is the first time a Beverly Hills officer received the 10851 Award," said Lt. Tony Lee, spokesman for BHPD. "It's truly an honor

for not only Jesse but for the men and women of the BHPD. He certainly has a knack for finding stolen vehicles and I'm sure he's going to find more."

The 10851 award stands for number of the California Vehicle Code that defines Vehicle Theft, a felony crime. The 10851 award is given to officers who find a high number of stolen cars.

A CHP lieutenant and officer presented the award to Perez in front of a group of his peers at roll-call, Lee said.

Perez found six cars by observation arrests and found the other six either parked or abandoned between January 2007 and June 2008. He found one stolen car while it was being driven by a wanted suspect that was "considered armed and dangerous."

Part of Officer Perez' success can be credited to the

Automated License Plate Recognition (ALPR), a technology in police vehicles that reads license plates at speeds over 100 miles per hour through databases in a fraction of a second. Perez is one of several officers that utilize the device.

- Ensure the economic health of the community.


- 2001 The General Plan Update began with Plan Day, an all day event focused on developing community enthusiasm and participation.

### Alan Kaye Joins S.L.E. Lupus Foundation Board of Directors



### El Rodeo Graduate Earns Spot On U.S. Olympic Team



Dara Torres, who began swimming at the Beverly Hills YMCA about 30 years ago, is scheduled to compete in the 50-meter freestyle and on the U.S. 400 freestyle and 400 medley relay teams in next month's Olympic Games.

The 1981 El Rodeo School graduate earned a spot on her fifth U.S. Olympic swim team by winning the 100 freestyle Friday at the Olympic Trials in Omaha, Neb.

"That really, really hurt," Torres told reporters after the race. "All I could think was, 'Where is that wall?' It was more about guts today, because my body's really beat up right now."

Torres, 41, won the 50 freestyle in 24.25 seconds Sunday, breaking her own American record of 24.38 that she had set in Saturday's semifinals.

"I was hoping to go somewhat fast," said Torres, who graduated from the Westlake School for Girls in 1985. "They have girls in the world who are going 24.1 and 23.9. I have five more weeks to try to drop a couple of tenths to hope to be in competition with those girls. So I'm very happy with my time and I know I have more work to do."

On Monday, Torres announced that she would not compete in the 100 freestyle at the Olympics in an attempt to reduce the strain on her body.

Torres has won nine Olympic medals, including four gold medals.

Beverly High football team opened its summer season by winning three of four games in its Best of the West Tournament June 21 at Nickoll Field.

### MWD Approves Pipe Relocation at 9900 Wilshire

The Metropolitan Water District's Board of Directors unanimously approved the relocation of a water pipe that runs under the Robinson-May on the 9900 Wilshire property at a meeting on Tuesday.

The Board authorized General Manger Jeffrey Kightlinger to sign an agreement with Project Lotus LLC, the developer for the project at 9900 Wilshire.

The 28-inch pipe, the Santa Monica Feeder pipeline, will be moved from under the 9900 Wilshire property and be relocated to public domain under Wilshire, Santa Monica Boulevard and Merv Griffin Way.

### Senior Citizens Telephonically Targeted By Man Claiming To Be Grandson

Within two days, three Beverly Hills senior citizens were conned on the telephone by a man claiming to their "grand-

son" who asked them to wire thousands of dollars to him via Western Union, the BHPD recently announced.

The male suspect called the senior citizens on the telephone and greeted the victims by saying, "Hi Grandma."

In the first two separate incidents, which occurred on June 18, the man claimed to have been arrested for Driving Under the Influence in Canada and requested thousands of dollars for assistance and additional funds to pay off the vehicle he claimed to have stuck. The man pleaded with the victims, ages 85 and 95, not to tell his parents about the accident.

Two victims complied and wired several thousand dollars to Western Union.

The other incident, which occurred on June 19, happened similarly to the first incident, except that the 76 year old victim in this case was quickly skeptical of the caller because her only grandson did not consume alcohol. When the victim stated she didn't have the money, the suspect hung up immediately.

"These are despicable crimes preying on our senior citizens, to gain their trust and then taking advantage of them," said Lt. Tony Lee, spokesperson for the BHPD. "Our detectives are conducting follow-up investigations and would advise senior citizens to obtain as much information as possible about the suspects and don't give any personal information. Then call the police immediately."

council's approval of the project," said Corrine Verdery, senior vice president in charge of The Beverly Hilton Revitalization Project, in a prepared statement.

Larry Larson, treasurer for the Citizens Right to Decide Committee and the spearhead behind the referendum petition and signature-gathering campaign, is not worried about the November election.

"We could have received another 600 to 1,000 signatures [on the referendum petition] but many people were afraid that Hilton and city would somehow find out who signed and were fearful of retaliation. When these voters get into the secret voting booth, there's no way anyone can know how they voted so I'm confident that in November we have enough signatures already to defeat the Hilton," said Larson in a phone interview prior to Tuesday's meeting.

opportunity to compete for this job?" said Fenton. "It sends the wrong message."

According to Goldberg, this is not an isolated incident. BHUSD's most recent hires have come from Hamilton High, where Beverly High principal J. Guidetti used to be principal, Santa Monica-Malibu Unified School District, where Straus was principal of Santa Monica High, and San Diego Unified School District, where superintendent Kari McVeigh worked as an assistant superintendent previously.

"That troubles me greatly," said Goldberg, who believes that the process may look "rigged" given this history of external hires coupled with an administrator on the hiring panel who knows the candidate from a previous district.

One issue that arises with external candidates joining BHUSD is that "so few employees here have risen through the ranks that it's

difficult for non-administrators to have that common history here," said Beverly Hills Education Association president Chris Bushee.

Another problem is policy decisions being made on the administrator's experience in other districts.

"Those solutions are not tailored to the unique circumstances of Beverly Hills," said Bushee, who believes that those problems could be overcome with better communication, among other things.

However, the other three Board members argued that recruiting from other districts helps bring the best and brightest to the school district.

"You look to people you have experience with," said Board member Myra Lurie about recent hires from outside districts where administrators have previously worked.

"We want to encourage our own but at the same time we are obligated to pick the best in the process," said Board member Nooshin

Meshkaty. "We all want the best people to work in our district" and for that reason, there is no problem with recruiting from other districts, she added.

As an example, Meshkaty pointed to outgoing assistant principal Amy Golden, who was hired from outside BHUSD and became a "great leader" in the district. Golden has since accepted a principal position in Northern California.

Board president Myra Demeter and member Myra Lurie echoed these sentiments, each adding that they had faith in the hiring panel and the hiring process, which had been through revisions a few years ago.

But both Goldberg and Fenton attributed their concern about an unfair and possibly biased process to the reason they voted against the incoming assistant principal.

"Our role is to provide oversight; it is not our role to dictate the candidates or the criteria, but we have a duty to ensure the process is fair," said Goldberg.

## Places To Avoid, Some To Enjoy And People Making News

Time to revisit some stores and shops that still allow me to get past security.

What? You expected me to do a consumer report on Rodeo Drive?

As frequent readers know, my favorite shopping time is at Rite Aid on Canon. You need not waste time asking where a product can be found or even if it is in stock. No one knows, but you will be directed to whatever aisle number first comes to mind. This saves you money, avoiding purchases you probably don't need. Much more time is conserved at the checkout stations where the ancient custom of actually thanking you for your patronage is totally avoided.

Sometime, through some management miscalculation, new checkers appear who are customer sensitive and even knowledgeable. However, for a real drug store experience, stick with the veterans. They have a tradition to maintain.

As for the pharmacy, it must be operated by lovers of group meetings. The dispensers of drugs simply can't accept the idea that you might want to leave anytime soon. If only Schwab's on Bedford, yes the one with family ties to the famous Sunset Blvd. store, opened for evenings. These guys actually are patron friendly as is the Robert's Optical Shop next door.

One of our most successful retailers: Whole Foods, on Crescent, is now celebrating its tenth year in our village. There was one very small problem last month. The milk on the shelves was almost as old as the store, almost.

The carton I wanted to buy had an expiration date for the day before. Fortunately, I found a "team" member, you know that the word "employee" is totally passé, and he did remove about six of the offending containers and even thanked me for my vigilance.

As for the checkers, they are courteous and attentive. But during one visit, not one staff person seemed to have any idea where I could find "Reddi Whip," maybe because before this was a "Whole Foods" the original Mrs. Gooch would never have permitted that product in her store. Not quite up to Nate 'n Al's offerings, but Whole Foods does have a fine beef sandwich: you have to ask for the "Signature" type.

Just down the street is the role model for all checkers, **Elaine Webster**. Easier in a smaller store, Beverly Hills Market, but this sometime singer, knows her patrons and can actually explain where to find obscure items.

Of course, as a warbler she knows you have to please the customers. No, I'm not suggesting Rite Aid's folks take singing lessons.

Ralph's always is interesting. Clearly, the most completely stocked food store in our region, they too have workers with no idea where to find even easy items. A request to locate Slim Fast turned me, by two different workers, to two different aisles, neither right.

However, the most puzzling lack of knowledge has to do with their malfunctioning down escalator. This contraption has been "out of order" for nearly six months, which means you have to use the elevator. On two separate visits, I asked if it had been repaired and each time I was told it was working. The second time, I was skeptical and wanted more assurance before pushing my cart to the other end of the store. Wrong again. No signs of life. Last week, it was barely functioning, too slow to be useful, but at last the "team" members gave me a timely warning.

For the best, most friendly service in the village, go no further than Pavilion's. I am always pleasantly surprised by their willingness to assist customers, even one as cranky as me. Too bad the store is not larger, the selections not as complete as Ralph's, but they work hard at being patron friendly and that includes checkers, floor people and management.

Making it better are the people at Time Warner. They do answer the phones, something Adelphia found offensive and an intrusion. The repair staff appointments are kept and the response time is usually one or two days.

You know there has to be a however. Not just Time Warner, but the cable industry, has found a way to add to their revenues with "On Demand." Most days the programming on HBO and the other premium channels are two-star movies, titles that mostly went directly to cable, bypassing even videos.

There are some fine exceptions, but for better quality films, you are permitted to pay extra.

I am an admirer of Los Angeles Times

food critic **S. Irene Virbila's** work, although I know her reviews can be devastating to new restaurants, and she is often acerbic when a more tolerant view might have been in order.

So, I finally managed to test Paper Fish, the eatery that replaced Maple Drive and that drew such harsh words from Virbila. Either they have made vast changes in the kitchen or Virbila was having a bad night out. The food was incredibly good and I hope the Times gives the restaurant a second look.

Perfect, it wasn't. Our server was very knowledgeable about the menu and described the offerings with care and controlled enthusiasm – just the right touch. But after that, he vanished. The bread came late, the water after the main course and the cocktails with the meal. In fact, we had to ask for servers twice in the course of a 45 minute meal. Strange, because the restaurant was not busy and our server seemed highly professional. Maybe this was their idea of not wanting to be overly visible or interrupting. Interrupt.

The Beverly Wilshire used to redecorate every time owner **Hernando Courtright** changed wives. If you saw new awnings on Wilshire, a divorce lawyer was earning new fees.

Now changes at the hotel have more to do with changing "flags" than domestic turmoil. The flags of a hotel tell you who operates or, sometimes, owns it. In an incredible twist of historic fates, the venerable BW is now operated by The Four Seasons.

What makes this so fascinating is how much effort former owner Courtright expended to keep the Four Seasons out of Beverly Hills. His backing of the successful campaign against the Four Seasons led the Canadian group to make a deal that found them operating a Four Seasons on Doheny, fifty feet from Beverly Hills. The Four Seasons says it is "at" Beverly Hills.

Although the name Beverly Wilshire has historical meaning and was retained when Courtright sold the hotel and it was renamed the Regent Beverly Wilshire, for a time it had an even longer name: The Regent Beverly Wilshire, a Four Seasons Hotel. "Regent" has been dropped from the name.

The last stages of a renovation that also included major improvements in the "BLVD" restaurant will come soon with redesign of the lobby areas.

The hotel actually boasts two highly rated dining rooms – Wolfgang Puck's "Cut" Steak House now occupying space that once housed the world famous "El Padrino" off the center entrance and the Wilshire Boulevard "BLVD."

All in time as the hotel industry awaits the opening of the Montage Beverly Hills this fall. New chef at the Peninsula, a new lounge/bar at the Beverly Hills, plans for a Waldorf Astoria at the Hilton – our hotel industry seems to be thriving with high optimism for future occupancy rates.

Only your doctor can determine if TRI-LUMA® Cream is right for you.

**What is the most important information I should know about TRI-LUMA® Cream? Use of TRI-LUMA® Cream in pregnant women may carry the chance of having birth defects in the baby.** Tell your doctor if you are pregnant, may be pregnant, or plan to become pregnant. Your doctor will talk with you about the benefits and risks of using TRI-LUMA® Cream during pregnancy to help decide if the benefits for you are greater than the risks. You may decide to delay treatment until after your baby is born.

**If you become pregnant while taking TRI-LUMA® Cream, tell your doctor right away.** You should discuss the chances that your baby may be harmed. Using TRI-LUMA® Cream early in pregnancy may be more likely to produce birth defects than using it later in pregnancy.

**What is TRI-LUMA® Cream?** TRI-LUMA® Cream is a medicine with three active components. You put TRI-LUMA® Cream on your face to treat a skin condition called melasma. Melasma consists of dark (hyperpigmented) spots on facial skin, especially on the cheeks and forehead. This condition usually happens with hormone changes.

TRI-LUMA® Cream is for short-term and intermittent long-term treatment of moderate to severe melasma of the face, in

the presence of measures for sun avoidance, including the use of sunscreens.

TRI-LUMA® Cream showed a significantly favorable safety profile for the long-term treatment of melasma, up to 6 months. Milder forms of melasma may not need treatment with medicine. Melasma can also be managed by staying out of the sun or by stopping the use of birth control methods that involve hormones.

In clinical studies, after 8 weeks of treatment with TRI-LUMA® Cream, most patients had improvements, with 42 (26%) out of 161 patients experiencing complete clearing of their melasma. In most patients treated with TRI-LUMA® Cream, melasma came back after treatment was stopped. If the underlying causes of melasma, such as the use of certain birth control pills or too much exposure to sunlight, are not removed, melasma will come back when you stop treatment. In the long-term studies, patients were treated with TRI-LUMA® Cream on and off, whenever their melasma came back until it cleared. About 300 patients used TRI-LUMA® Cream intermittently (not continuously) for 180 days, and the majority of the side effects were mild in severity. **TRI-LUMA® Cream may improve your melasma, but it is NOT a cure.**

**Who should not use TRI-LUMA® Cream?** Do not use TRI-LUMA® Cream if you are allergic to the medicine or any of its ingredients. See the end of this leaflet for a list of ingredients.

**What should I tell my doctor before using TRI-LUMA® Cream?** If you are pregnant, think you are pregnant, plan to be pregnant or are nursing an infant, tell your doctor. Your doctor will decide with you whether the benefits in using TRI-LUMA® Cream will be greater than the risks. If possible, delay treatment with TRI-LUMA® Cream until after the baby is born. Tell your doctor about all the other medicines and skin care products you use, including prescription and non-prescription medicines, cosmet-

ics, and supplements. They may make your skin more sensitive to sunlight.

### How should I use TRI-LUMA® Cream?

TRI-LUMA® Cream should be used as instructed by your doctor.

To help you use the medicine correctly, follow these steps:

- Gently wash your face with a mild cleanser. Don't use a washcloth to apply the cleanser, just your fingers. Rinse and pat your skin dry.
- Apply TRI-LUMA® Cream at night, at least 30 minutes before bedtime.
- Put a small amount (pea sized or 1/2 inch or less) of TRI-LUMA® Cream on your fingertip. Apply a thin coat onto the discolored spot(s). Include about 1/2 inch of normal skin surrounding the affected area. After you have used the medicine for a while, you may find that you need slightly less to do the job.
- Rub the medicine lightly and uniformly into your skin. The medicine should become invisible almost at once. If you can still see it, you are using too much.
- Keep the medicine away from the corners of your nose, your mouth, eyes and open wounds. Spread it away from those areas when applying it.
- Do not use more TRI-LUMA® Cream or apply it more often than recommended by your doctor. Too much TRI-LUMA® Cream may irritate your skin, waste medicine, and won't give you faster or better results.
- Do not cover the treated area with anything after applying TRI-LUMA® Cream.
- If your skin gets too irritated, stop using TRI-LUMA® Cream, and let your doctor know.
- To help avoid skin dryness, you may use a moisturizer in the morning after you wash your face.
- You may also use a moisturizer and cosmetics during the day.

Use a sunscreen of at least SPF 30 and a wide-brimmed hat over the treated areas. It requires only a small amount of sunlight to worsen melasma. Melasma can get

worse even if you don't get sunburn.

Only your doctor knows which other medicines may be helpful during treatment, and will tell you about them if needed. Do not use other medicines unless your doctor approves them.

If you get sunburned, stop using TRI-LUMA® Cream until your skin is healed. After stopping TRI-LUMA® Cream treatment, continue to protect your skin from sunlight.

### What should I avoid while using TRI-LUMA® Cream?

Sunlight or ultraviolet light. Too much natural sunlight or artificial sunlight from a sunlamp can cause sunburn. Dark skin patches may become darker when the skin is exposed to sunlight. You don't have to have a sunburn to make your melasma worse. TRI-LUMA® Cream can make your skin more likely to get sunburn or develop other unwanted effects from the sun. Protect your skin from natural sunlight as much as possible to help prevent further darkening of existing dark patches and formation of new ones. Staying out of the sun is especially important for women who take birth control pills or hormone replacement therapy, and for people who have had dark patches in the past.

Use an effective sunscreen **any time you are outside**, even on hazy days. The sunscreen should have SPF (sun protection factor) of 30 or more. Use sunscreen year-round on areas of the skin that are regularly exposed to sunlight, such as your face and hands. If possible, protect the treated area from sunlight exposure. If you spend a lot of time outside, be especially careful of sunlight. Ask your doctor what SPF level will give you the needed high level of protection. If you will be outside, wear protective clothing, including a hat.

Do not use sunlamps while you use TRI-LUMA® Cream. Heat, wind and cold. Heat and cold tend to dry or irritate normal skin. Skin treated with TRI-LUMA® Cream may be more

likely to react to heat and cold. Your doctor can recommend ways to manage your melasma under these conditions.

### Other skin care products and medicines.

Avoid products that may dry or irritate your skin. These may include soaps and cleansers that are rough or cause drying; certain astringents, such as alcohol-containing products, soaps and toiletries containing alcohol, spices, or lime; or certain medicated soaps, shampoos, and hair permanent products. Do not use any other medicines with TRI-LUMA® Cream unless you have consulted your doctor. ### What are the possible side effects of TRI-LUMA® Cream? A very few patients may get severe allergic reactions from TRI-LUMA® Cream.

This includes people allergic to sulfites. **They may have trouble breathing or severe asthma attacks, which can be life-threatening.**

While you use TRI-LUMA® Cream, your skin may develop mild-to-moderate redness, peeling, burning, dryness, or itching. TRI-LUMA® Cream contains a corticosteroid medicine as one of its active components. The following side effects have been reported with application of corticosteroid medicines to the skin: itching, irritation, dryness, infection of the hair follicles, acne, change in skin color, inflammation around the mouth, allergic skin reaction, skin infection, skin thinning, stretch marks, and sweat problems.

### Stop using TRI-LUMA® Cream and contact your doctor if you have

- severe or continued irritation, blistering, oozing, scaling, or crusting; severe burning or swelling of your skin; irritation of your eyes, nose, and mouth

This leaflet summarizes the most important information about TRI-LUMA® Cream. If you would like more information, talk with your doctor. You can ask your pharmacist or doctor for information about TRI-LUMA® Cream that is written for health professionals.

### General information about prescription medicines

Medicines are sometimes prescribed for conditions that are not mentioned in patient information leaflets. Do not use TRI-LUMA® Cream for a condition for which it was not prescribed. ## DOCTOR IN THE HOUSE

**Health and Safety Commissioner Sandra Aronberg diagnoses preparedness in Beverly Hills**



**So, how did you get to Beverly Hills?**

I'm a Florida native, from Lake Worth, which is about 50 miles north of Miami.

My husband, [former Beverly Hills mayor] Chuck Aronberg, brought me out to California. I came out here to train [to become an obstetrician/gynecologist] and settled down in Beverly Hills. I have lived here for over 30 years now and I am teaching now at the School of Public Health at UCLA.

**How'd you meet your husband?**

I was trying to decide where I wanted to practice medicine. Somebody who knew both of us suggested I talk with Chuck since he was practicing [medicine], still is practicing, and was knowledgeable about life in Southern California. He was on City Council at the time so we met in Beverly Hills City Hall. He had time for me in between other meetings that he had to go to, so I waited, caught part of one of the afternoon study sessions and had a chance to meet him then.

[After that], we dated cross country. We decided we liked each other a lot and I decided to start doing my training program at Cedars-Sinai, so I moved to California.

[Chuck] had served terms as mayor before I met him; I was present for one term. He served from 1972 to 1984. We got married in 1977.

**What was it like being married to the mayor of Beverly Hills?**

Our first date actually was a "Jerry Brown for president" dinner at the Beverly Hills Hilton and I had a glimpse

of what future life might be like when he left me in the middle of the dinner to run across the street to El Rodeo and help work with a group of people who wanted to put up a stop sign for the school.

[Being Beverly Hills' first lady] was a high-profile position and helped me get up to speed pretty quickly on Beverly Hills. I had an opportunity to learn how much the citizens care about the school district, the police and fire departments, and I found that it was a real citizens' community, unlike what some people might think about from "Beverly Hills 90210" and other things. It's a community where people care very deeply about what is going on within the community.

**Tell us about the newly formed health and safety commission.**

Well, the commission started in November 2007. The council put it together. We got a really good mix of volunteers who are involved with it. I'm quite impressed with the other commission members; they have terrific ideas and we are just in the process now of formulating where we are going to go with the commission.

There hasn't been a form available for citizens to be able to come and speak about concerns regarding health and safety, except to the council, so that's a role we are going to be able to serve. Community members are invited to come to our meetings and if they have any areas that they are concerned about regarding public health, welfare or safety, we'll be able to hear them. We're an advisory commission to the city council and we'll be able to possibly provide a sounding board for the citizens and community members.

**Specifically what issues does the commission deal with?**

We recently spent two meetings discussing our mission and vision. Our vision is that we're going to inspire greater citizen participation and awareness regarding health and safety issues that affect our community. We will most likely concentrate on issues related to preparedness for disaster, looking at neighborhood preparedness, and trying to get more people to participate in the citizen core that currently exists like the Community Emergency Response Team program. Other areas that we may look into will be related to drinking and driv-

ing, accident prevention, speeding, pedestrian safety, trying to encourage more people to learn CPR and defibrillators. We're also going to focus on sun safety and information related to pandemic flu and seasonal flu. So there are a number of upcoming activities.

I participated recently at a kick off at [California Institute of Technology] related to the November [Great] Southern California ShakeOut. They're going to have the largest drill ever in the United States and it's going to be in Southern California at 10 a.m. on Nov. 13. They're working with the cities to go all into a drop-cover-hold position at that time. We'll have a lot of information and activities about that.

**What are some of the issues you face as a new commission?**

One of the issues we face is that the services in Beverly Hills are so excellent that people tend to become complacent. I've heard people joke that the reason that they move to Beverly Hills is for the schools and the reason they stayed here as they get older is because of the paramedics. They've come to rely on how quickly all the fire and police and paramedics respond in emergencies. But in a disaster our services are going to be tied up so the more people learn to take care of themselves in a disaster, the better their chances are of coming out of it more comfortable and in better shape.

**We heard that you personally set an example on disaster-preparedness and even have a big tank of water in your house; is that true?**

After the CalTech simulation of what it would look like if we had an earthquake similar to what they just had in China, I went to a store that had some disaster preparedness supplies and bought a 55-gallon barrel that I then filled up with water when I got home and have in the corner of our condo patio. Water shortage is going to be one of the areas of most concern if we do have a disaster. The pipe and the connections that bring the water to us are in jeopardy if there's a large earthquake and that's going to be one of the biggest sources of concern, trying to make sure people have adequate water, so I immediately went out after I learned what could happen and got a lot of water.

I've gotten a list that the director of emergency management had on display at the table at the farmers market and have tried to get everything. I have food and water and flashlights and some cash and information so that my other family members know how to contact me or who to contact in case of emergency and where we might meet in an emergency. We've done some work on getting the family plan ready. I haven't quizzed my husband on whether he knows the plan, so I guess that's my next step.

**Do you ever have time for any hobbies?**

Oh boy, yes! I'm on the Fish and Game Commission in Los Angeles County. Fishing is one of my passions. I devel-

oped that growing up in Florida. It's one of the activities that our family did together so I thought that's something that I wanted to convey to other people. And I wanted to help preserve the fisheries in Southern California and to introduce fishing to children that may not have the opportunities otherwise, and to help them respect the environment a lot more.

I fish as much as I can. If I had a puddle and pole, I would probably try to fish.

I go surf fishing in the Santa Monica-Malibu area. I go out on half-day party boats in Santa Monica bay. And when I go home to Florida, I do a lot of fishing. I throw most everything [I catch] back, it allows the fish to grow and be caught again. I tend to do catch and release.

To me, it's wonderful to spend the day looking at the ocean. Here, we have dolphins. It's beautiful and peaceful; I just enjoy the experience.

Also, I love to golf. I belong to Rancho women's golf club. I've been golfing for the last 10 years. I enjoy the challenge of golf: me against the golf course.

My husband never really got into it much. I have friends I go with or I go by myself.

**Tell us about your family.**

I've got a lovely grandbaby. My stepdaughter Cindy is a Beverly High graduate ('83), went to USC law school, and for the last seven years has been a deputy controller for California. She has a 6-month-old baby named Leo.

I'm very much enjoying being a grandma. I've delivered a bunch of babies but never raised any of them, so it's been a real joy watching the little guy develop.

They live in Santa Monica. He's a real joy for me.

**Since you're on a city commission and married to a former mayor, do you consider yourself politically active?**

I follow politics a lot but I don't think I'd ever want to be in office myself. I try to stay aware of what's going on.

I participate in Emily's List [an organization for female pro-choice politicians]. The information they send out helps educate me on candidates all across the country, so it gives me a wider view than what's going on in just California.



**What's in the future for you?**

Right now I'm just working on the commission. We're trying to get our direction more determined — that's my biggest challenge. We have to figure out where we want to go with what we want to do because I know everybody on the commission has the intent of trying to do something meaningful and we have to tease out what that's going to be.




