## Council votes for \$800,000 Public Works building makeover

While older buildings in Beverly Hills, such as the City Hall, have had minimal renovations in the past 20 years, the Public Works Facility, which is less than 10-years-old, already needs renovations.

The City Council voted 4-1 Tuesday, May 26, to spend \$847,000 in renovating the first floor of the building, according to a City of Beverly Hills Staff Report.

“It’s just like any home,” Mayor Nancy Krasne said. “Once you move in and find out that there are mistakes that were made, adjustments must be made also.”

Krasne said technological changes, such as the ability to pay parking meters with credit cards, result in facility changes as well.

Councilmember John Mirisch opposed the renovations.

Mirisch said it sends the wrong message to residents.

“It says: if we don’t get it right the first time around, don’t worry because we can always fix it afterwards,” Mirisch said.

The remodel is a two-phase project, according to the report. The second phase is aimed at relocating staff from City Hall and addressing various inefficiencies within the shop area of the Public Works Facility.

Phase 1 of the renovation was approved

by the City Council in 2006. According to the report the first phase relocated all Public Works and Transportation staff into the facility, with the exception of the 30-member Parking Enforcement staff.

Krasne said some of the renovations are being made because it was cheaper than including them in the original design. The report gave an example of the expansion of the men’s locker room. It said it would originally cost \$200,000 for construction, compared to the \$50,000 it will take to renovate the existing one.

On November 18, 2008, an agreement with RTK Architects, Inc. to provide design consulting services for Phase 2 was approved by the city, the report said.

According to the report, the following renovations are included in Phase 2’s goal:

Constructing operating space for the Parking Enforcement group Expanding the men’s locker room for relocated staff Modifying parking meter repair and collection space Improving the Conservation/Exhibition space Relocating water operations staff to the second floor Modifying solid waste and environmental division shop and work area Expanding the electrical shop

Four bids were received on Feb. 4. The lowest bidder, Avi-Con, Inc. was awarded the project. It bid \$772,000, with an additional \$75,000 for unpredictable changes due to conditions, the report said.

Krasne said left over bonds from City Hall renovations will account for most of the renovation costs. She said the money

had to be spent by the end of the year, or else the city would lose it.

"If we didn't use all of this money on the city hall remodel it would have to go in a non-interest bearing account to pay off the bonds which would be absolutely ludicrous," Krasne said.

The Capital Assets Fund will provide \$672,000 of Phase 2's funding. The Water Enterprise Fund will provide the last \$175,000, which will cover upgrades to the HVAC system and relocation of the Water Division staff.

Mirisch said he'd like the Council to avoid unnecessary spending when possible. He said renovation proposals such as the Public Works Facility and Conference Visitors Bureau are taking away from programs with more pressing needs.

"One obvious example would be the CPR and CERT programs, which in certain budget proposals before the City Council, are at risk of being radically pared down or eliminated all together," Mirisch said.

Beverly Hills residents will benefit from the city avoiding frivolous spending, he said.

"Sound finances and healthy reserves allow us to weather the storms of economic downturns and gives us the freedom to make the best decisions about what is best for our community," Mirisch said.

Estimated completion of Phase 2 is December 2009, with 150 calendar days given for the work completion period.

Public Works Director David Gustavson did not return calls by press.

#### City seeks funding under American Recovery and Reinvestment Act

The City of Beverly Hills is submitting 20 projects for funding under the American Recovery and Reinvestment Act.

The \$787 Act, which was signed by President Barack Obama Feb. 17, is set to go towards upgrades in transportation, construction, safety and energy projects; state and local fiscal relief; and personal and business tax credits.

The money is divided into two types of

grants: formula and competitive. The city is applying for three formula grants totaling \$1.2 million and 17 competitive grants totaling \$30.5 million.

According to a press release, City Council authorized seven categories for funding varying from fire station renovations to library community outreach programs.

## Voter Fraud In Beverly Hills?

Press conference makes charges

It was billed as a press conference to "announce results of a voter fraud investigation" and a "demand that the Attorney General and the ( Los Angeles ) District Attorney further investigate and prosecute."

The press conference called by the Citizen's Right to Decide Committee was indeed held Tuesday, (June 1, 2009) on the steps of city hall and the allegations of mammoth illegal voting repeated by the committee's spokesperson and treasurer **Larry Larson**, but as for disclosure, it didn't quite happen.

Instead of offering proof of "voter fraud" Larson displayed a large box which he claimed contained the results of the organization's lengthy investigation that allegedly occurred during the November, 2008 election.

But the contents in the box were not revealed.

Some found a chilling similarity to the antics of the late Sen. **Joseph Mc Carthy** who claimed he had, but never disclosed,

names of "hundreds" of known Communists working in the United States State Department.

Although Larson abruptly ended the press conference before newpeople could ask questions, he did meet with reporters away from the speaker's stand.

The most important statement Larson made then was that although the investigation was made because of the referendum on the Hilton the organization had launched, "this is not about the Hilton or the referendum, its about violations of law and voter fraud."

Translated, this meant that the anti-Hilton effort was over. Larson said it was no longer relevant because "the Hilton will not be able to find financing for the project." (A Hilton source said this was nonsense and that the project would go forward.)

However, it would be hard to explain the motives for the press conference except as it related to the Hilton referendum. The speaker's podium Larson used had a cam-

paigned poster calling for a NO vote on Hilton and Larson began the press conference with a recital of the arguments against the project.

Larson defended not making public the results of the organization's investigation because "even the accused have rights of privacy." Yes, but when and if the prosecutors receive the material in the sealed box, it probably will be a mater of public record.

Without disclosing names, Larson said the investigation revealed that votes had been cast by non-residents and even people who were not citizens. Those are indeed serious charges and should be investigated. What Larson did not claim was that these improper votes were in any way the responsibility of the Hilton or that it would have impacted the results of the election. To make those charges and to ask a court to invalidate the election would have required a court test which Larson and his committee did not undertake.

Improper or even illegal voting is not a new issue in our community. But it is hard to prove or to prosecute. The range of impropriety mostly has to do with people who register to vote from a business address and who actually live outside the city. It is not illegal to use an office or post office box if you actually reside in Beverly Hills. Even more serious is the charge that people who are not United States citizens register and vote.

If the Larson investigation actually leads to either prosecution or election voting reform, it will have served a useful purpose. City elections should not be impacted by

voters who are not legally entitled to vote.

What becomes murkier is what really constitutes legal residency. Often children keep parent's homes as their voting address because that is where they have lived or still continue to consider their legal home. Some could be in college, working in other cities or simply away temporarily. That "right of choice" would almost be impossible to question.

Supposedly, the "box of proof" also may cite examples of votes being cast for the deceased. That does bring back memories of voting fraud by big city political machines.

I once asked a Democratic retainer in Chicago how he could justify having someone vote for a person who had died. "O'Reily was a loyal and life long Democrat," he replied. "We are only carrying out the recently departed's final wishes."

Making prevention of unlawful voting difficult are federal regulations against asking for identification. Although some few states have enacted laws requiring proof of citizenship and residency, federal guidelines make it very difficult. A recent case in Georgia outlawed the practice, but the reasons for the court findings were that the state was one of those covered by the Voting Rights Act.

In California the ability to ask for identification was raised in a congressional election in Orange County where it was alleged that this was being used as a means of intimidating voters.


Even if true and it probably was, it would be hard to argue that voters who were legal would be concerned about providing proof. There should be methods in place that permit election officials to see proof of residency and citizenship, but not to be used by others to scare anyone.

In fairness to Larson, he made absolutely

no claims that the Hilton had any responsibility for illegal voting and he did not charge that any city officials had any responsibility for voter fraud. But he could not resist "disclosing" that a mail box used by some voters was within walking distance of the Hilton's campaign office on South Beverly Drive!

However, his organization's press release once again attacked the Hilton project which the voters did approve. As to the size of that victory, and even though the voter turnout was far larger than most city elections, the margin of success was greater than many city or school board votes.

There was some hyperbole in their press release including this strange charge: "The three councilmembers who voted in favor of the Hilton proposal knew that the planning commission had unanimously rejected the project..." If they didn't know, they must have been voting from Iceland.

Reminds me of the candidate who defeated Florida Senator **Claude Pepper** in the 1950s who traveled the back country of the state with the shocking revelation that "your Senator is an admitted heterosexual and can not deny that charge."

Larson also reminded the press conference audience, with more anti-Hitlon activists than reporters in attendance, that two of the councilmembers who voted for the Hilton were no longer in office. He did not add that the newest member of the Planning Commission, who took office after the commission vote, came out publicly for the Hilton.

Mayor **Nancy Krasne** introduced Larson, but told us later that this was "not about the

Hilton, only voter fraud." Also in the audience, but not a speaker, was newly elected Councilmember **John Mirisch**. Councilmember **Barry Brucker** was listed as a participant, but did not attend.

Not asked was, who provided the electronic equipment used during the press conference? Strangely, it was a city owned stand, loud speakers and other electronics that the committee used. Was that proper? Doubtful.

The press conference audience was loaded with people who not only fought the Hilton, but also the Montage and almost every development project in recent memory. I admire their tenacity even when I disagree with their efforts. I couldn't resist asking some of these friends where they

were when I wrote in opposition to the William Morris, North Beverly Drive, building debacle.

\*\*\*

Speaking of debacles, what is the city able or going to do about 9900 Wilshire Boulevard? That former home to Robinsons-May and the site of an approved mammoth condominium project has fallen on very hard times, and that happened even before the downturn in the economy.

As you know, the London developers were depending on financing from a now failed Icelandic bank and the whole project was put on hold.

What troubled Councilmember **Jimmy Delshad** was the "eye sore" the property has become "at an important gateway" to the city.

City staff has supposedly made informal efforts to clean up the site, but without success. Now, this may be followed by more formal demands from code enforcement. Efforts to contact the property owners were not successful.

# CITIZEN'S GROUP SAYS NOV. ELECTION FRAUGHT WITH FRAUD

## What will DA do about the allegations?

The Citizen's Rights to Decide Committee announced the results of its five-month investigation into voter fraud Monday on the steps of Beverly Hills City Hall.

Treasurer of the committee, Larry Larson, alleged the investigation uncovered more than 500 fraudulent voters.

"Categories of voters are as follows: voters who were deceased, voters who cast multiple votes, voters who registered multiple times (and voters who did not reside in Beverly Hills," Larson said.

Larson said the last category of voters included more than 100 voters who allegedly registered to vote at a private post office business on 269 South Beverly Drive. These groups also included children of former and current public officials who supported the Hilton expansion, he said.

Despite this accusation of wrong doing, as well as requests from reporters, he left all names of those accused in the 569 page, 3-ring binder unopened and closed from viewing.

"Even fraudulent voters have a right to privacy," Larson said.

Larson said the binder contained

evidence and summaries of questioned voters.

Loyola Law School Professor Rick Hasen said proving voter fraud allegations are harder than making them.

"A lot of times when people make allegations of voter fraud it turns out to be something more like election administrative mistakes," Hasen said. "Someone signed wrong in the polling book or there are two people with similar names."

Larson said because of the large number of cases the committee found, this

"There is always a possibility there is going to be an explanation for some of the voters," Larson said. "But we have so many of them ... if a few fell through the cracks and have some reasonable explanation as to why they voted in Beverly Hills it's not going to make a difference in our accounts."

Although no appointment has been set, Larson said he plans on meeting with and distributing copies of the binder to Los Angeles

District Attorney Steve Cooley and Hilton project,

California Attorney General Jerry Brown this week or next.

At the news conference Larson passed around petitions asking Cooley and Brown to further investigate and, if accurate, prosecute those who committed voter fraud.

"If we had more money and more time we believe that we could have found more than 1,000 phony voters who voted in November on Measure H," Larson said.

In April 2008 the City Council voted 3-2 in favor of The

Beverly Hilton constructing three towers, which would almost double its square footage, according to a press release. Measure H was the committee's last attempt at stopping the proposed expansion of The Beverly Hilton. The committee petitioned and Measure H was included on the November 2008 ballot. Larson said after absentee and provisional ballots were counted, Measure H won by 129 votes, less than 1 percent.

However, Larson said the investigation was not about the

fraud.

Oasis West Realty Senior Vice President Corinne Verdery said the allegations made Monday were not connected to Measure H or The Beverly Hilton.

"The people of Beverly Hills have spoken in the last election and supported this project," Verdery said. "We stand by the results of the election."

Mayor Nancy Krasne, Councilmember John Mirisch and Board of Education member Brian Goldberg were also present for the announcement. Former Mayor Barry Brucker, who a press release said would be in attendance, was not.

Krasne said she expected Cooley and Brown's cooperation in further investigating the committee's allegations.

"Rich or poor we are entitled to equal protection under the law," Krasne said. "So as we look forward we are asking our law makers to protect us and fulfill the responsibilities they have accepted as our elected officials."

Hasen said it is common for those in authority to look into serious crime allegations; however, most allegations of voter fraud are unfounded.

"People need to take any kind of allegations of voter fraud with a grain of salt," Hasen said. "It's very tempting when your side loses an election to look at every reason other than the merits to explain the loss."

Hasen said this could merely be a local dispute taking place in a larger political context.

A six month statute of limitations for fraud made Monday the deadline to file a lawsuit, Larson said. He said because of the time and money it would take, the committee would not be filing one itself.



**ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING SECTIONS 10-3-2450, 10-3-2451, 10-3-2455, AND 10-3-3601 OF THE MUNICIPAL CODE OF THE CITY OF BEVERLY HILLS REGARDING THE TRANSFER OF DISCRETIONARY REVIEW AUTHORITY OF SPECIFIC TYPES OF APPLICATIONS AND PERMITS IN THE SINGLE-FAMILY RESIDENTIAL ZONES IN THE CENTRAL AREA OF THE CITY**

**THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:**

Section 1. Since inception of the Design Review Permit process in 2004, the concept of transferring reviewing authority of certain discretionary applications and permits from the Planning Commission to the Design Review Commission has been considered because several discretionary permits pertaining to design aspects of single-family projects are currently within the jurisdiction of the Planning Commission. Transferring the reviewing authority for certain applications will promote a more efficient review process by the City's Design Review Commission as part of its review of single-family development projects in the Central Area of the City. As proposed herein, the Design Review Commission would be the reviewing authority for those applications in the Central Area of the City specifically named and permitted through the Minor Accommodation and Central R-1 permits.

Section 2. The Planning Commission considered the zone text amendment set forth in this Ordinance at a duly-noticed public hearing on February 26, 2009. Evidence, both written and oral was presented during the hearing. After considering the evidence, discussing the ordinance, and providing direction to staff regarding revisions to same, the Planning Commission recommended that the City Council adopt an Ordinance substantially similar to this Ordinance.

Section 3. The City Council considered this Ordinance at a duly noticed public hearing on April 21, 2009. Evidence, both written and oral, was presented during the hearing.

Section 4. This Ordinance institutes a change of the reviewing authority over certain permit types which constitutes an organizational or administrative activity that will not result in direct or indirect physical changes in the environment. The review process and the discretionary nature of the permits at issue will not change, only the body responsible for considering and acting on such permit applications will change. As such, this activity is not a project for purposes of the California Environmental Quality Act ("CEQA"), pursuant to the State CEQA Guidelines Section 15378 (b)(5). Further, it can be seen with certainty that there is no possibility that amendments to the Beverly Hills Municipal Code will have a significant effect on the environment. The proposed amendments are administrative and procedural in effect, and maintain existing discretionary review processes applicable to certain developments in order to protect the public health, safety and general welfare. Therefore, as a separate and independent ground, the proposed amendments are exempt from the environmental review requirements of the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations because it can be seen with certainty that there is no possibility that this administrative change will have a significant impact on the environment.

Section 5. The City Council hereby amends Section 10-3-2450 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding the standards for which a Central R-1 permit may be granted, to read as follows:

"10-3-2450: Central R-1 Permit Authority:

Notwithstanding any other provision of this Code, upon application by a property owner, in a form satisfactory to the Director of Community Development, the reviewing authority may issue a Central R-1 permit to establish the following standards in the Central Area of the City:

A. Establish vehicular

entrance width and orientation requirements for garages in the Central Area.

B. Establish a height limit for an accessory structure located in a side, street side or rear yard north of Santa Monica Boulevard. In no event, however, shall an accessory structure exceed the height limitations permitted in the principal building area.

C. Establish a maximum floor area exceeding the limitations of Section 10-3-2402 of this Chapter for all buildings located on a site area. Nothing in this subsection, however, shall be construed to permit noncompliance with height and setback requirements set forth in Article 24 of this Chapter.

D. Establish the cumulative coverage of the maximum potential facade permitted for architectural projections which encroach into the front yard. Such architectural projections, however, may cover no more than two-thirds (2/3) of the maximum potential facade.

E. Establish standards for the placement of windows which are above a second story, and face a street on property located south of Santa Monica Boulevard.

F. Establish the minimum side setback, where the existing side setback is nonconforming, for additions with a height in excess of fourteen feet (14') at a width no less than the existing side setback, provided that in no event shall the side setback for the addition be less than three feet (3').

G. Establish the maximum encroachment into a front yard for eaves and plant-on accents provided by subsections 10-3-2408C and E of this Chapter when the primary dwelling encroaches into the front yard by the maximum amount permitted by subsection 10-3-2418C of this Chapter.

H. Establish a height limit for game court fences located within five feet (5') of a property line. In no event, however, shall a game court fence or lighting standard be permitted to exceed the height allowed for such structure located more than five feet (5') from a lot line.

Additionally, the reviewing authority shall not act under any subsection of this Section unless a property owner specifically applies for review under that subsection. This constraint shall not limit the reviewing authority's power to condition its action pursuant to Section 10-3-2454 of this Article."

Section 6. The City Council hereby amends Section 10-3-2451 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding the reviewing authority for Central R-1 permits that may be granted, to read as follows:

"10-3-2451: Reviewing Authority:

The reviewing authority for a Central R-1 permit application shall be the Planning Commission unless the application requested is for one or more of the following:

A.10-3-2450(A), regarding vehicular entrances  
B.10-3-2450(D), regarding maximum potential façade  
C.10-3-2450(E), regarding placement of second story windows  
D.10-3-2450(G), regarding maximum encroachment into front yard

The Design Review Commission shall be the reviewing authority for the aforementioned Central R-1 permit applications unless the application accompanies a separate application for discretionary approval from the Planning Commission with regard to the same project site. In that case, the Planning Commission shall be the reviewing authority for the Central R-1 permit application.

In the event that a Central R-1 permit application accompanies a separate application for a discretionary approval from the City Council with regard to the same project site, the City Council shall be the reviewing authority for the Central R-1 permit."

Section 7. The City Council hereby amends Section 10-3-2455 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding appeals from decisions for Central R-1 permits, to read as follows:

"10-3-2455: Appeals from Decisions:

The applicant or any person aggrieved by any decision of the Planning Commission regarding a Central R-1 permit, may appeal that decision to the City Council. Such decision may be appealed in the manner as provided in Title 1, Chapter 4, Article 1 of this Code.

The applicant or any person aggrieved by any decision of the Design Review Commission regarding a Central R-1 permit, may appeal that decision to the Planning Commission. Such decision may be appealed in the manner provided in Title 10, Chapter 3, Article 44, Section 10-3-4417 of this Code."

Section 8. The City Council hereby amends Section 10-3-3601 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code regarding Minor Accommodation permits that may be granted, to read as follows:

"10-3-3601: Reviewing Authority

A. Unless specified, the reviewing authority for a minor accommodation shall be the Director of Community Development. If, in the opinion of the Director, an application merits review by the Planning Commission, the Director may refer such application to the Planning Commission and the Planning Commission shall serve as the reviewing authority for such minor accommodation application and shall conduct a noticed public hearing regarding the requested minor accommodation.

B. Notwithstanding Section 10-3-3601(A), the minor accommodation speci-

filed by Section 10-3-3600(C), regarding front yard paving as specified in Section 10-3-2422(I) for the Central Area of the City, the reviewing authority shall be the Director of Community Development. If in the opinion of the Director an application merits review by the Design Review Commission, the Director may refer such application to the Design Review Commission. If the application for a minor accommodation pursuant to Section 10-3-3600 (C) accompanies an application for any other type of discretionary approval from the Planning Commission for the same project site, the Planning Commission shall be the reviewing authority for the application for the minor accommodation and shall conduct a noticed public hearing regarding the requested minor accommodation.

If the application for a minor accommodation pursuant to Section 10-3-3600 (C) accompanies an application for any other type of discretionary approval from the City Council for the same project site, the City Council shall be the reviewing authority for the application for the minor accommodation and shall conduct a noticed public hearing regarding the requested minor accommodation."

**Section 9.** If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

**Section 10.** The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

**Section 11.** This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31<sup>st</sup>) day after its passage.

**ORDINANCE NO. 09-O-2567  
AN ORDINANCE OF THE CITY OF BEVERLY HILLS RELATING TO EMERGENCY WATER CONSERVATION PROCEDURES AND AMENDING THE BEVERLY HILLS MUNICIPAL CODE**

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. Section 9-4-306 of Article 3 of Chapter 4 of Title 9 is hereby amended to read as follows:

"9-4-306. Hearings. Any person receiving notice of a violation of any water usage percentage reduction provision set forth in Section 9-4-304 shall have the right to request a hearing to appeal the imposition of the water penalty surcharge. The City Council shall establish the appeal procedures by resolution."

Section 2. Section 9-4-308 of Article 3 of Chapter 4 of Title 9 is hereby amended to read as follows:

"9-4-308. Exceptions. Nothing in this article shall be construed to require the city to curtail the supply of water to any customer when such water is required by that customer to maintain an adequate level of public health and safety."

Section 3. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31<sup>st</sup>) day after its passage.
