“Santa Monica Boulevard Reconstruction Costs Jumps from \$17 Million up to \$35 million” [Issue #754]

On April 1, our City Council will likely decide a future direction for Santa Monica Boulevard. Will they suggest that this key regional corridor continue to serve only motorists? Or should tomorrow’s corridor ensure safe passage for everyone, regardless of whether they walk, ride or drive? While the discussion has largely

turned on bicycle lanes to date, the truth is that we all have a stake in making this corridor safer.

Federal and state policies call a street ‘complete’ when it is designed for safety above all. For example, the ‘complete street’ would include well-marked crosswalks, striped bicycle lanes and pedestrian ‘refuges’ on the median for slow walkers. But safety as a priority often goes missing in our talk about transportation. Earlier this month, our councilmembers had many questions about the project but not one asked of our consultants: How can we make this street safest for all users?

It shouldn’t fall to bicycle riders to call out unsafe streets. But it’s time somebody did. According to state figures, Beverly Hills is among the most dangerous small cities in California for collision injuries.

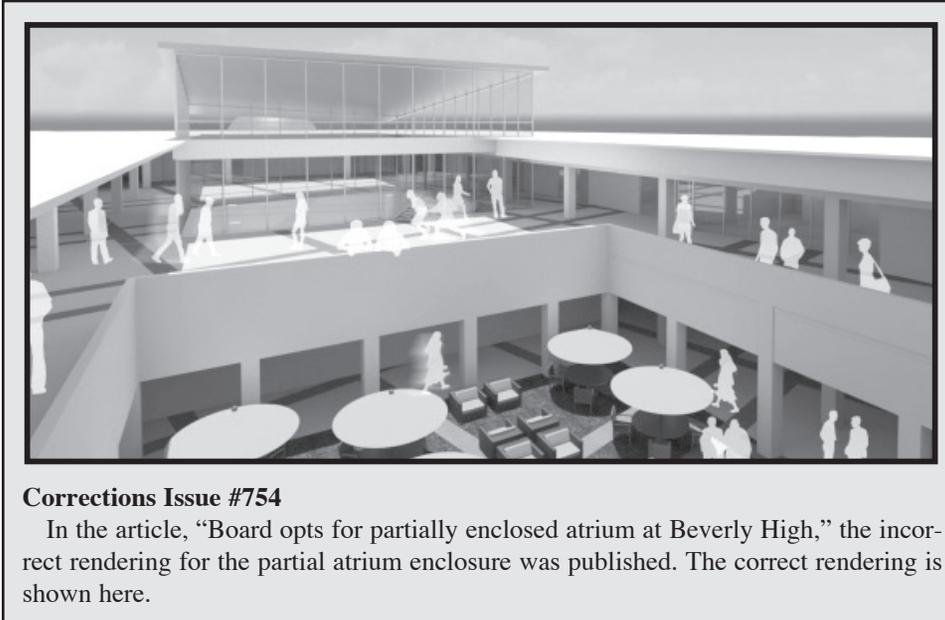

Overflow crowd at board meeting, but why isn't it televised?

A study session meeting was held on Tuesday concerning Beverly High's bell schedule and the athletic department. The Board of Education members were shown an athletic department presentation and were able to hear various stakeholders' perspectives.

But due to an unexpected amount of attendees to the study session, some stakeholders were unable to partake in and listen to the discussion that was taking place inside the relatively small Board meeting

room on Lasky Drive.

"I understand this will be the second study session where the meeting was held in a facility that was not large enough to accommodate members of the public to come and actually be a witness to the meeting," former Board of Education member Jake Manaster said.

A previous study session meeting on March 4 regarding Principal Carter Paysinger also had a standing room only audience inside the room.

But Board of Education President Noah Margo defended the meeting.

"I'm sorry that there were people who felt that they were not included or were forced to not be included, that is never the intention of the study session," Margo said. "At 5:00 p.m. we had empty chairs and the study session began. [During the meeting]

A resolution of the Planning Commission of the City of Beverly Hills recommending that the City Council adopt an ordinance to prohibit hydrolic fracturing, acidizing or any other well stimulation treatment in conjunction with the production or extraction of oil, gas or other hydrocarbon substances from any surface location in the City or any subsurface bottom hole in the City.

The proposed Ordinance would amend Section 10-5-318 of Article 3 of Chapter 5 of Title 10 to prohibit hydraulic fracturing, acidizing or any other well stimulation treatment in conjunction with the production or extraction of oil, gas or other hydrocarbon substances from any location within the City or any location outside the City limits where the subsurface bottom hole is located in the City.

Interested persons are invited to attend and speak on this matter. The final decision on this matter will be made by the City Council during a noticed public hearing. Written comments may also be submitted, and should be addressed to the Planning Division, 455 N. Rexford Drive, Beverly Hills, CA 90210.

Please note that if you challenge the Commission's action in regards to this matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

This Ordinance has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City has determined that the adoption and implementation of the Ordinance will not have a significant environmental impact. The Planning Commission will consider the recommendation to find the Ordinance exempt from the environmental review requirements of CEQA pursuant to Section 15308 of Title 14 of the California Code of Regulations.

The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, March 27, 2014, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider a request to construct a 2,276 square foot, two-story accessory structure on the property located at **1801 Angelo Drive**. The project requires the following entitlements:

Hillside R-1 Permit to allow the cumulative floor area on the site to exceed 15,000 square feet. In the Hillside Area, the cumulative floor area for all structures on a site, including the area of all basements on that site, may not exceed 15,000 square feet without the approval of a Hillside R-1 Permit. The existing structures on the site contain a total cumulative floor area of 32,632 square feet. The proposed accessory structure would contain a total of 2,276 square feet. If approved, the total cumulative floor area on the site would be approximately 34,908 square feet, exceeding the 15,000 square foot threshold triggering review by the Planning Commission, but less than the otherwise allowable maximum floor area permitted for the project site, which is 67,849 square feet.

Variance to allow more than one accessory structure that exceeds 14' in height to be constructed within a required side or rear setback. The project site currently contains an existing two-story accessory structure (21' in height) that is located with the required rear setback. In the Hillside Area, only one accessory that exceeds 14' in height may be permitted in a required side or rear setback. Since there is an existing two-story accessory structure located within the required rear setback, a Variance has been requested to allow a second two-story accessory structure within the required side setback. The proposed two-story structure would be located in the northwestern portion of the project site along the western property line. The required west side setback for the project site is 70'-5". The proposed structure would be located entirely within the required side setback and would be set back approximately 15' from the west side property line. The structure is proposed to have a maximum height of 30'.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for a Class 3 Categorical Exemption for the construction of a new accessory (appurtenant) structure within a residential zone. Therefore the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

there was room toward the front [and] we did keep inviting people to come in.”

Unlike the Board formal meetings, study session meetings are not televised live to the community, nor are they recorded.

“I realize the difficulty of predicting the size of the room needed to hold a productive meeting but recording the meeting can help that,” Manaster said. “The District did not record the meeting and you [couldn’t] get into the meeting. I came in support of BHAAA and along with several student-athletes who wanted to take part, we could not get inside. I have since been informed there were a small number of seats open up front but that was not visible or apparent to a large group waiting outside. At the very least I would have hoped the students would be allowed in as they are the people most impacted by these discussions.”

For months, there has been a backlog in posting meetings to the district’s website. Previous formal board meetings are archived at www.bhusd.org/apps/video/list.jsp. The most recent board meetings posted are from March 11 and February 25, but prior to that, the next most recent meeting was from October 8, 2013.

Though there are no agenda items that are voted on in study session meetings, and the recording of study session meetings are not required by law, individuals who are left outside the study session meetings or who can’t attend daytime meetings are at a disadvantage.

“Although they’re not making any deci-

sions, some of us don’t know whether we should come back for another meeting because we don’t know what was said and what the position of the board members were in this meeting even though we tried to attend in the spirit of a study session,” Manaster said. “My hope in the future would be that an audio recording was taken when capacity is exceeded for the meeting place.”

Margo said that there are many opportunities for the public to offer their perspectives on issues if they were for any reason, unable to attend or participate in any of the meetings. There were a few letters and e-mails that were sent to the Board and given to the superintendent from stakeholders who were not able to attend the meeting.

“If I had known [there] was going to be [more] people, I absolutely would have moved the study session, even if we had moved it out into the patio with everybody outside,” Margo said. “I sure hope that there would be that kind of fervor for any topic that affects our students because I believe it’s all important, it’s all inclusive, [and] it’s all about the students.”

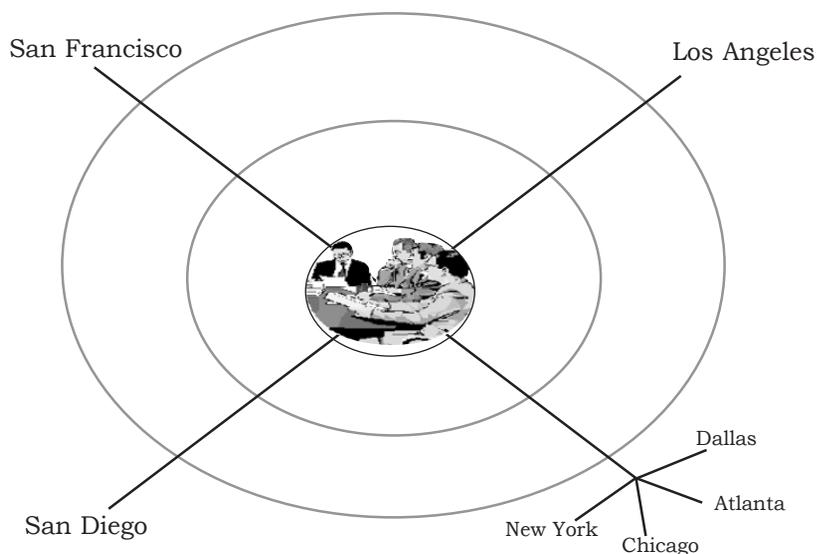

Jeff Fisher's lawsuit against the BHUSD.

Fisher filed a lawsuit against the BHUSD, Beverly High Principal Carter Paysinger and 25 fictitious does on Jan. 24 on five counts, including retaliation and breach of oral and implied contract.

"He was an at-will employee so they don't really need a reason to fire him and the facts are poorly alleged in the complaint," Attorney Ron Richards from the Law Offices of Ronald Richards and Associates, A.P.C., who is not affiliated with the case, said.

According to the demurrer, "the complaint, and each of its five causes of action, fail to state facts sufficient to constitute a cause of action" against BHUSD.

Fisher "was retaliated against and wrongfully terminated because he made inquiries as to unlawful behavior that [Principal Carter Paysinger] was involved in and orchestrating," according to the complaint.

The Weekly had previously reported that Fisher's contract was not renewed due to a failed attempt to correct performance deficiencies, according to BHUSD attorney Gary Gibbeau.

Andrew Tregar, Fisher's attorney, declined comment to the Weekly prior to press time.

"[The complaint seems to be intentionally vague] and there's a good chance the court is going to dismiss it or make them allege better facts," Richards said.

An investigation on Beverly High's Sports Academy was conducted last August in effect of Fisher's contract non-renewal in June 2013. The investigation targeted conflict of interest claims against Paysinger. Last week, Paysinger was cleared of any charges concerning the Sports Academy controversy and the case was closed. A classified draft report leak to the Los Angeles Times is still being under investigation by the BHUSD.

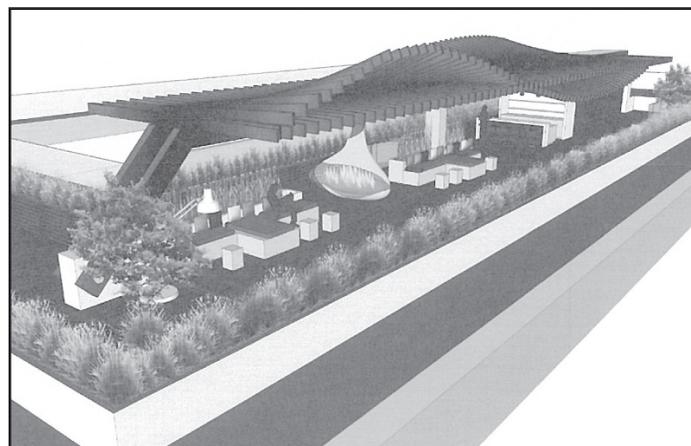

Tina Wiener was previously an elementary school teacher and has taught in both the Glendale Unified School District and the BHUSD.

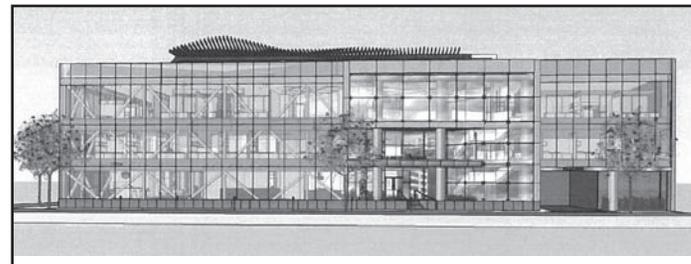
She hopes to continue teacher when her daughter, Kaela is a little older. She has been involved with the PTA for eight years when her son entered Horace Mann.

The Planning Commission approved a rooftop lunch area with a 4 -1 vote on the new headquarters for Kennedy Wilson at 151 South El Camino Drive with conditions.

Planning Commission Chair Brian Rosenstein, Vice Chair Howard Fisher, and Commissioners Howard Fisher and Joe Shooshani approved the rooftop lunch area with conditions and Commissioner Craig Corman voted against.

The lunch site construction will be in conjunction with a façade remodel of the three-story building. It will be located on the southeast portion of the rooftop and will be 3,960 square feet with a kitchenette and a 15-foot tall trellis structure.

The City's municipal code for lunchrooms and gymnasiums allows rooftop lunchrooms, but does not define what a lunchroom is which allows for various designs and layouts.

"The notion of a lunchroom and a gymnasium have changed and expanded," Fisher said.

The proposed Kennedy Wilson rooftop lunch area has a lounge-style atmosphere. Originally, the applicant asked for 12 special events a year on the rooftop lunchroom lasting as late as 10:00 p.m., while on a normal week the opening hours would be between 7:00 a.m. to 7:00 p.m. from Sunday to Thursday and 9:00 a.m. and 10:00 p.m. on Fridays and Saturdays.

The City approved a similar rooftop lunchroom at 9800

Wilshire Boulevard where the rooftop lunch area is not restricted to employees and allows guests and clients to use the space, according to Senior City Planner Ryan Gohlich. The difference between the two projects is that the Kennedy Wilson project is approximately 60 feet from residential properties, whereas 9800 Wilshire Boulevard is 225 feet away from residential properties.

"I could approve the proposed structure, but I would not be willing to allow non-employees up there and I would not be willing to allow evening events at all," Corman said. "I think that's inappropriate for this area of the city and I don't think it adequately protects the residents of that area."

Noise amplification was a concern for the commission due to the close proximity to residential areas. Rosenstein also said that free parking should be available for guests and clients to prevent cars from parking in the residential streets.

Kennedy Wilson's Senior Advisor Barry Schlesinger said that they did an outreach program to the neighbors to discuss the rooftop lunchroom project.

"[We] told them not only do we want this to be an add to the neighborhood, but we wanted to be good citizens and [be] respectful of their privacy, not only from a noise level but as far as visually, and [we] had a good response," Schlesinger said.

Schlesinger also said that allowing clients in the rooftop lunchroom would give Kennedy Wilson a chance to "show off Beverly Hills and [the] environment."

"It shows what we could do worldwide and we'd like the opportunity to show at our headquarters what we do," Schlesinger said. "It's a nice added feature and it also shows the sophistication of the firm whose business is real estate."

According to the representative, the rooftop lunch area would be more for the employees than for any of the additional beneficial use for the company.

"Our employees are our most valuable asset, they spend more time at work than they do with their families," Schlesinger said. "We have no problem to address any noise issues, we have no problem with limiting hours, [and] we have no problem with limiting events. We want to be good neighbors [and] we don't have a problem if you limit our use of that as long as we try and take care of the employees, that is our main goal."

The conditions placed on the approval was limiting the rooftop lunchroom hours from 8:00 a.m. to 7:00 p.m. from Monday to Friday, 9:00 a.m. to 7:00 p.m. on Saturdays and Sundays, with exceptions to the five special events held per year that could last until 10:00 p.m. Maximum occupancy is limited to 100 on normal lunchroom hours, and non-employees would be able to have access. The commission also included no amplified sounds as a precaution to not disturb the neighboring residences, and if needed a glass wall will be constructed to further minimize noise.

The proposed rooftop lunchroom will require an Architectural Commission review.

Tedford and Goler go to Teachers for Global Classrooms Symposium

Sophomore Beverly High Honors English teacher Julie Goler and BHUSD Chief Academic Officer Jennifer Tedford attended The Teachers for Global Classrooms Symposium in Washington, DC in late Feb.

Goler was selected for Teachers for Global Classrooms, a yearlong program through the U.S. State Department that teaches teachers to prepare students for a global economy and global competencies.

“When I was in college, it was about diversity, and training kids to deal with an ethnically diverse population and that’s not what it’s about anymore,” Goler said. “We recognize that our students could end up with jobs anywhere around the world and it’s preparing them to enter that world.”

MIRISCH SUES SECRETARY OF STATE AND LA COUNTY REGISTRAR

But will he be reinstated as a candidate?

Mayor John Mirisch has sued California Secretary of State Debra Bowen and Los Angeles County Registrar Recorder Dean Logan for blocking his candidacy for the 26th State Senate District.

Mirisch said he was asked by state GOP leaders to run for the 26th State Senate District late Tuesday. He faxed in his paperwork from Washington, D.C. and had hardcopies sent overnight

to arrive on Wednesday. He filed as a Republican using the Beverly Hills Courier's address.

"We notified his official agent on March 13 that [Mirisch's] paperwork is not accepted because the candidate did not submit an original Declaration of Candidacy or ballot designation worksheet by the deadline," LA County Registrar Public Information Officer

Elizabeth Knox said.

The Los Angeles County Registrar rejected Mirisch's paperwork due to a faxed signature, according to Knox. Candidates would not be considered if their signature was faxed in on the day of

the deadline, even if hard copies arrived the next day.

According to the lawsuit filed in Sacramento, Bowen contacted Los Angeles County Registrar-Recorder/County Clerk Dean Logan to not accept Mirisch's faxed candidacy papers. Bowen, Logan and 100 unnamed individuals are listed as defendants.

"We're just exploring what the options [are]," Mirisch told the Weekly on Tuesday, prior to the lawsuit being filed. "No final decisions on that yet."

The hearing date is set on March 21 at 10:30 a.m. at the Sacramento Superior Court for the Mirisch v. Bowen case. The lawsuit was filed by the law firm Bell, McAndrews and Hiltachk, LLP. in Sacramento.

High profile candidates already in the 26th State Senate District race include former Assemblymember Betsy Butler (D-Torrance), Santa Monica - Malibu Board of Education Member Ben Allen, and others. The district is overwhelmingly Democratic in voter registration. The primary election is June 3.

4.4 EARTHQUAKE RATTLES NERVES MONDAY

Residents are reminded to be prepared

By Nancy Yeang

A 4.4 magnitude earthquake occurred near Encino at approximately 6:25 a.m. on Monday, rattling nerves and reminding residents the need to be prepared.

Beverly Hills Fire Department Fire Chief Ralph Mundell said that the fire department had not received any distress calls regarding the earthquake Monday morning.

Though no phone calls were made, fire department apparatus were immediately moved out at the time the earthquake occurred to conduct a "Windshield Survey."

"We send our resources out throughout the City to check on critical infrastructure and certain high rise buildings that generally have a large occupant load," Mundell said. "Simultaneously, we sent the on-duty battalion chief over to dispatch in the event that it is something significant to prioritize calls."

There are three fire districts in the City,

and the fire departments conduct the survey within their districts to check the extent of damage, and also the potential for damage. The BHPD also conducts a "Windshield Survey" so that they are "double checking to make sure that [they're] looking at similar things but different things at the same time."

"[We check] if there are people out in their yards [and if] they [are] waving us down," Mundell said. "As funny as it might sound, we look for flower pots that

might have been on a ledge or something outside of someone's home. That gives us a real quick idea about whether those were displaced or not, how great the magnitude

significant damage or injuries to anyone that might be there."

If the earthquake is a significant magnitude, Mundell said that the on-duty battalion chief, who is sent to the dispatch center, will prioritize calls and the emergency operation center would be opened and staffed. The fire department would continue to respond to types of incidents they encounter, and if the fire department is not able to handle the responses and incidents, they will ask for mutual aid.

"This is a great opportunity for everyone to be reminded that we are an earthquake country, and now is a real good time to reevaluate their earthquake kit, make sure that it's up to date and within the expiration date," Mundell said. "If you don't have a kit, [you can] at least put one together. It could be bought commercially or you can put some things together. The City has resources that they can provide in terms of what a good kit would look like."

We would expect our Traffic and Parking Commission to address that problem. Indeed, commissioners receive a collision injury report from BHPD every month, but they don't ask why we see so many injuries, or why the rate hasn't declined over time. Moreover, two of those commissioners sat on our boulevard Blue-Ribbon Committee and neither talked about safety.

Of course we know not to expect our city officials to raise the issue either. Were our transportation planners to speak

up, say, they would remind us that our bike plan envisions a citywide network of streets that would be safe for everyone to walk, ride and drive. In fact, that plan, drafted thirty-five years ago, anticipated our support for multimodal mobility. Yet when adopted (in 1977) it was more ambitious than anything put on the table since, including the Santa Monica Boulevard Blue-Ribbon Committee-recommended bicycle lanes.
