



The Planning Commission of the City of Beverly Hills, at its REGULAR meeting on Thursday, July 24, 2014, will hold a public hearing beginning at **1:30 PM**, or as soon thereafter as the matter may be heard to consider:

A request to renew a previously approved Conditional use Permit and Extended Hours Permit for the Sixty Beverly Hills Hotel (formerly the Thompson Hotel) located at **9360 Wilshire Boulevard**. Renewal of the subject entitlements would continue to allow the following rooftop operations at the hotel:

- Use of the rooftop area until 1:00 AM Sunday through Thursday
- Use of the rooftop area until 2:00 AM Friday and Saturday
- Allowance for up to 12 rooftop events per year in which the rooftop can
- be occupied until 2:00 AM on a day other than a Friday or Saturday
- Maximum rooftop occupancy of 165 persons (excluding hotel staff)

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project qualifies for a Class 1 Categorical Exemption for continuation of operations within a commercial building, and the project has been determined not to have a significant environmental impact and is exempt from the provisions of CEQA.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

According to Government Code Section 65009, if you challenge the Commission's action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

## **Neff designed property nominated for historic landmark distinction despite owners’ opposition**

The Cultural Heritage Commission unanimously nominated on July 9 a single-family residence property to be included on the Local Register of Historic Properties, though the owners were opposed to the decision.

The property located at 805 North Linden Drive was designed by Master Archi-

tect Wallace Neff. The Spanish colonial revival features are defining characteristics of Neff’s architectural portfolio.

“He helped us set the standard for this architecture and a lot of people copied what he did,” Historical Resources Group principal Christine Lazzaretto said. “The features became common and vernacular [and] it was in large measure due to a lot of the great work he was doing.”

HRG conducted a peer review of two reports conducted by city consultant Jan

Ostashay and another report requested by the owners from PCR Services Corporation consultant Margarita Wuellener.

“His other projects that I’ve seen respond very specifically to the site and are more creative, more unique, [and] more distinctive to that particular site and how those features relate to that site,” Wuellener said. “This example is more formulaic and does not reflect his creative genius, and is designed for a speculative example.”


# 45 years later

## Where were you during the Apollo 11 moon landing?



### JULY 20, 1969

#### JOE TILEM FORMER MAYOR



I was in Sarasota, Florida at a reunion of my Maritime Academy graduating class. I graduated in 1947 with 125 merchant marine officers. That was at the tail end of the war.

The first few moments of [the landing] didn't seem real. We were shocked, just standing watching it, this couldn't have happened. It was one of total disbelief with everybody. Even when we were watching it we couldn't believe it was real. It was so impossible and so unlikely to have really happened that the first thought was that it was a movie or a fantasy film that somebody had developed.

Then as it unfolded further it looked like it was a very real event. This was actually an American person putting his foot on the moon. [When Neil Armstrong said], "That's one small step for man, one giant leap for mankind," it was just an amazing thing to hear those words. To think about the technology that went into making that happen, it certainly spurred us on to do some bigger and better things.

[It was] just one of those signal events, a place marker in your life.

#### DONNA ELLMAN GARBER FORMER MAYOR



I was at home [in Beverly Hills] watching television. I was with my husband and my younger daughter [Debi, who was 15 at the time]. My older daughter [Linda, who was 16 at the time] was there with a whole

bunch of kids and they wanted to go out. I said, "You can't. You have to stay here and watch man's first landing on the moon."

They left. They were young [and] they just weren't interested, but Linda later became a news producer.

Debi stayed and watched. She didn't have the crowd of kids with her.


[Linda and Debi] were interested, but it didn't seem to be a bigger deal to them as I knew it would be.

I think we watched the entire video feed. It was mesmerizing. It was watching the world change before our eyes.

I felt like the world was expanding. That one day we will have not next door neighbors but next world neighbors. How I felt at the time? It just felt that we were expanding. How I feel now? Maybe we'll need this expanded world because we're working very hard to destroy the one we're living in.

Soon [after the moon landing], for a while [there were people] selling tickets to go to the moon and I was all set to buy one. I figured they would expire before I would get there. I think I may have the ticket I bought. I have no idea where it is, but I thought it would be worth saving. It probably cost a dollar or something.

#### DICK DOUGLAS FORMER BHUSD SUPERINTENDENT



I was living in Manhattan Beach with [my kids Craig and Danny and my wife Sheila]. We planned our evening and what we were going to do, and sat in front of an old, old television at home and watched this

historical event take place. We just stayed up and watched all the proceedings and then watched [Neil Armstrong] step on and off the moon. It was at an ungodly hour, but it was one of those things where it was so historical that you just had to stay awake and see it. [My boys who were both babies] didn't much care that we didn't have much sleep.

It seemed to me so amazing all of the things that were necessary in order to escape the earth's atmosphere [and] to get into orbit around the moon, in order to just

watch this lander come down, and the thing looked like a washing machine.

I just marveled at the fact that we had accomplished this incredible feat and a guy could actually come down and put his feet on the surface of the moon. I still think it's amazing and the fact is that it's a very small fraternity of people that have done it.

It [was] a fabulous exploration. I was thankful I was able to see it and I still marvel at it.

#### GLORIA SEIFF FORMER PUBLIC WORKS COMMISSIONER



I was visiting my aunt in the [San Fernando] Valley with my three young children [Stuart, Sherri, and Karen]. We were having a Sunday evening dinner, and saw that our man was walking

on the moon. I think maybe there was some look of disbelief. It was really a family event and a family dinner and we all probably reacted in saying, "Oh my gosh, have we really done this?"

[My children] were lucky enough to be around for the space age. It's just something that we really take for granted, what we've really done in space, and it's kind of sad that we're not still number one or whatever it is, but certainly for my generation, it was a very, very awesome happening.

I think we all were just sort of awestruck and it's really something where you pinch[ed] yourself and think, "Is this really for real?" Growing up [I thought] the moon was made of cheese and it really wasn't something that we ever aspired to walk on. Even today when I look at the full moon or even a half of a moon, I think to myself, "Oh my goodness, we've been up there." Not [that it's] something that I would aspire to do, but to me it's still just very awesome to think about it.

It was just something that happened in outer space. I grew up in the years [where] Pearl Harbor was one of the things [that] you usually remember where you were, and we all unfortunately went through 9/11 here. It was just something that is indelibly imprinted in your mind.

We were lucky to be around and alive at the time when this happened. It was a truly spectacular kind of thing to remember happening in your lifetime. Every time you look up at the moon it sort of has a different feeling and meaning than when you looked up before there was a man on the moon. I, as an American citizen, get chills knowing that [the American flag] was planted up there.

#### ROBERT K. TANENBAUM FORMER MAYOR

I went out to play on a basketball scholarship at Cal [Berkeley] and I was there from 1961 to 1968 [for] college and law school. I married [Patti] in 1967. We went back to New York in 1968 to work in the



[District Attorney's] office in Manhattan and I had an injury. One of the injuries I had [was] a spinal fusion. My fourth and fifth lumbar vertebrae were fused from a bone from my hip.

I was not crazy about the doctor at Columbia Presbyterian Hospital on 168 Street on Broadway. He said to me, "You should be in body cast for three months," and I said, "Wait, so you cut holes in the thing?" It was ridiculous.

I didn't want Patti to take the subway. A major crime [occurred] when I took the subway to see [the doctor]. A guy pulled out a blade and he was threatening a woman and her two children on the subway, and it was an express stop from 59th to 125th. I had to grab this guy and throw him out of the train. [The] last thing I wanted was to be [in the hospital] for that length of time incapacitated and have my family come up and visit.

We came out [to Beverly Hills] on a vacation to visit Patti's family, who was friendly with [longtime Board of Education member] Bernice Hutter. My in-laws recommended for me to speak with [Bernice's husband] Dr. Charles Hutter about the spinal fusion surgery. Dr. Hutter was a brilliant orthopaedic surgeon, he just put me back together again. I went to see [him] on a Friday and he told me that he was roofing and he had an accident and he fell. His team performed this [surgery] on him. He told me exactly what was going to happen. He had the strength, character and expertise that [made me say], "Okay do it." I was very nervous obviously to have my back spliced open.



I said, "When can I have it done?" and he said, "Well, when do you want to do it?" I said, "Right away." He sent me to the [Hollywood Presbyterian Hospital] on Sunday, performed some tests, and then he performed the surgery on Monday. I was in the hospital for ten days, [and] when I was being operated on and recover[ing] in the hospital in that ten-day period, that's when the moon [landing] occurred.

I was watching it with my wife Patti and family members [at the hospital].

I [thought] there [were] rooms somewhere in Washington where this whole thing was a Hollywood [film]. It was too fantastic to actually register, when you think about the fact that we sent somebody to the moon, which is what John F. Kennedy said we were going to do in 1961, and we did it. It's not something that's an everyday occurrence. It was an awe-inspiring vision, what more can you say? The courage of the people that did it is beyond description. The sense of duty, training, honor, and moral code just shows you know that there's no fear. We're on a mission. That's what I call American exceptionalism.

I walked out [of the hospital] ten days later without a bandage on me, like I was walking on the moon.

According to Wuellener, when compared to other properties Neff designed, the 805 North Linden Drive property is not considered one of his most notable works. Speculative homes are built for resale, and are “similar or even copies of the same design.”

“There’s not the level of architectural attention or quality of material put into speculative houses as there is to custom houses,” Wuellener said. “One needs to look at the body of speculative houses and decide, is this an influential speculative house or not?”

HRG founding principal Christy McAvoy said that they have found 16 examples of Neff’s work in the Los Angeles area, in which eight “no longer retain their integrity.”

“I cannot say that preserving eight buildings, which have integrity, which tell the story of Wallace Neff’s work in Beverly Hills, is too many,” McAvoy said. “I think we have moved away from, in standard preservation practice, ‘the best of.’ It is no longer considered good preservation practice to save only one example or two

examples of a master architect’s work.”

The property owners’ attorney Steve Webb said that if by approving the nomination, the commission would be forcing landmark distinction on the property owner against the property owner’s will.

“You need to be extra careful in the decision you make,” Webb said. “It’s an honor to have your house landmarked.’ You’ll find out [that] there are a lot of people that respectfully disagree with that. There will be unintended consequences with this going forward.”

Though the commission found points through the ordinance that qualifies the property to be included on the Local Registrar of Historic Properties, the City Council will have the final vote for the distinction.

“We have time and time and time again, let properties go to demolition,” outgoing Chair Richard Waldow said. “I think we’re working very hard to being sensitive to the wishes of owners and property owners’ rights. When it comes to whether or not a property should or should not be landmarked, we have been given a very clear set of standards and criteria and procedures from the City Council. Our job is to look

at the ordinance, look at the evidence, see if we can make the findings, and I believe we’ve been very careful to do that.”

Former mayor Richard A. Stone owned the house over for 40 years and recently sold it.

## Courier v. Weekly lawsuit dismissed

The *Beverly Hills Courier* dismissed the appeal on their last remaining count yesterday in a lawsuit against *Beverly Hills Weekly* that was brought last year.

“Out of all the cases I’ve handled being a lifelong resident of Beverly Hills this one provided me with a great amount of civic pride and responsibility,” the *Weekly*’s attorney Ronald Richards said. “This is because at the onset of the case it was obvious a local business was the target of an attempt to wipe them out.”

The *Courier* sought thousands of dollars in compensatory damages that they claimed were lost as a result of the *Weekly*’s business practices.

“I am grateful that upon changing ownership the new *Courier*’s owners saw the wisdom in having Beverly Hills served by

two newspapers instead of one,” Richards said.

Former *Courier* publisher Clif Smith recently sold the *Courier* to the late Paula Kent Meehan, who passed away in late June. The current trustees of the *Courier* were not involved in the original lawsuit.

“By heading them off at the pass by filing a successful anti SLAPP motion, *Beverly Hills Weekly* was able to show the court the real purpose of the *Courier*’s complaint, which was to drive the *Weekly* out of business so the *Courier* could enjoy a monopoly,” Richards said.

The Los Angeles Superior Court ruled in favor of the *Weekly* in a SLAPP motion (Strategic Lawsuit Against Public Participation) last December on two of the three causes of action.

The *Courier* paid an attorneys fee motion of \$40,000 that was awarded to the *Weekly* on Feb. 21. The dismissal does not seek for any other fees and costs in addition to the attorney’s fees that were already paid, according to Richards.

“I don’t expect our firm’s representation to be needed in the future on this matter,” Richards said. “However we will always

## What's wrong with our schools - and how to fix it

The mission of the BHUSD, adopted by the Board of Education in 2010 is, "To inspire and empower each student to achieve academic excellence." The District objectives state further, "Every person deserves the opportunity to achieve his or her potential; 100 percent of our graduates will feel satisfied with their preparation for post-graduate pursuit; nothing will take precedence over the elementary through secondary instructional program." I have no doubt that those objectives reflect the expectations of a majority of Beverly Hills residents.

How faithfully is the District's mission being met? The record is dismal. Over the past two decades through 2013 more than 40 percent of Beverly High graduates each year have enrolled in community colleges. Last month the school board was informed that an all-time record of 50 percent of this year's graduating seniors who were polled will attend community colleges and another 15 percent have no post-graduate plans.

All the essential resources have been available to fulfill the District's mission. It is heartbreaking, therefore, that our students, whose parents either cannot afford to enroll them in private schools or have chosen not to, are deprived of a superior primary and secondary education, and corresponding post-graduate pursuits and career opportunities.

### Background

The academic program of the BHUSD plummeted from national preeminence to mediocrity in the mid-1980s, to the extent that all references to "academic achievement" were eliminated from the District's mission statement in the mid-1990s. The immediate cause of the downfall was the failure by school boards and administrators to maintain academic standards during a sudden and massive influx of ESL students. A more systemic cause is that most of the individuals elected to the school board since the early

1980s have lacked business training and experience essential for problem-solving such as overcoming challenges to the mission of an organization that has grown to annual budgets exceeding 50 million dollars and overseeing capital projects involving hundreds of millions.

### Evaluating the current school board

Last December a school board member who has been on the board over six years wrote, "Some of our graduates are not able to pass an English writing placement exam or a math placement exam...are forced to take non-college credit courses before they can be placed in a college writing or math course...high school teachers have shared with me their frustration that many of the students coming from middle school...lack the fundamentals required to succeed in courses designed to prepare graduates for...admission to either CSU or UC, or 80 percent of all four-year colleges and universities in the U.S...a process is needed to turn Beverly High into a college preparatory high school." His evaluation of the BHUSD academic program was accurate. It jibes with the dismal record of post-graduate pursuits, and it verifies that this school board has failed to improve the academic program and achieve the objectives of the District.

### How business executives would resolve the shortcomings in our academic program

Business executives would create an "action plan" by convening a planning group consisting of school board members, superintendent, chief academic officer, teachers and consultants. Led by a facilitator the group would identify every "task" that must be accomplished, such as identifying the deficiencies in the curricula and potential solutions. They would name an individual to oversee each task, set a completion date for each task,

and appoint a plan coordinator to monitor progress. A successful result would be virtually assured.

### Making matters worse: "Common Core"

To make matters worse, two years ago the school board voted unanimously to adopt and implement a new federal standard for teaching and testing K-12 students called Common Core. It is an unprecedented attempt to achieve national uniformity, replacing local control with centralized federal control. The U.S. government provided \$200 per student as an incentive to adopt it, and to cover teacher re-training, new textbooks and other costs. The system is new and untried, and has not yet been developed for all subjects and grade levels.

The portion that has been developed establishes such rigid standardization and impractical teaching methods that the elimination of honors and AP programs is likely. That process is already underway with the school board's action to eliminate sixth grade math honors classes. Chief Academic Officer Jennifer Tedford has repeatedly misinformed the Board of Education that they had no choice but to adopt Common Core. The truth is that although students will be required to take Common Core state tests, school districts in California are not required to adopt the Common Core curricula, textbooks and teaching methods.

Last month the superintendent of one of the top-performing districts in Southern California told me that he expects that Common Core will diminish the quality of education in his district. Implementing Common Core, evaluating it, eventually scrapping it and re-

building the educational program will take years. Meanwhile thousands of our students' educations, post-graduate pursuits and career opportunities will be severely impaired.

### How to fix what's wrong

The terms of three school board members, Brian Goldberg, Lewis Hall and Noah Margo, will expire in 2015. It is imperative that we elect individuals who are qualified to fulfill the District's mission and render independent judgment and oversight in key functions such as financial planning and budgeting, organizational structure, initiating and controlling capital projects, business and contractual relationships, employee relations and collective bargaining, compliance with governmental regulations, hiring the Chief Executive Officer (Superintendent) and working collaboratively with him/her, and responding effectively to external challenges.

The ideal background is that of business executives, preferably those who have served on one or more corporate boards, and who endorse the District's mission and are dedicated to fulfilling it. Undoubtedly there are residents in Beverly Hills who have those qualifications, and would commit a portion of their time and energy for the betterment of our schools. be standing guard to protect the *Weekly's* first amendment rights as well as any other Beverly Hills business that is ever subjected to the same attack in the future."

### Traffic and parking commission denies parking restrictions on Almont

The traffic and parking commission unanimously denied parking restrictions at their July 3 meeting on the 300 block of

North Almont Drive that would decrease public parking to one hour.

The 300 block of North Almont Drive currently has a parking regulation of allowing two hours for public parking between 8:00 a.m. to 6:00 p.m. from Monday through Saturday, and AK permits are exempt. There are 70 multi family units on the block with 29 on street parking spaces.

According to transportation planner Martha Eros, the city conducted a parking study on a Thursday that showed a 67 percent average parking occupancy rate with

20 cars parked, and at 8:00 p.m. parking occupancy would be at 86 percent with 25 cars parked.

"Sometimes vehicles don't park in the appropriate spacing," Eros said. "They'll be in the middle of the [space] and that would limit the parking on the street."

The proposed change would be reducing public parking to one hour between 8:00 a.m. to 8:00 p.m. from Monday to Saturday, and AK permits will still be exempt.

The time extension took into consideration people who would come home late

from work, and reducing the parking time was due to parking occupancy, city staff's observations of the site, and the 71 percent signatures, which is 50 out of the 70 multi-family units, that approved the petition for the change.

Four residents living on the 300 North Almont Drive block spoke to the commission that the residents who signed the petition were being misled by the lead petitioner who "verbally misrepresented her efforts for parking change" and "harassed" those who wouldn't sign the petition.

## PAYSINGER SUES BHUSD, LEWIS HALL

### Beverly High principal alleges discrimination and retaliation

Beverly High Principal Carter Paysinger filed a lawsuit yesterday against the BHUSD and Board of Education member Lewis Hall on eight causes of actions including retaliation and discrimination.

“As stated in the complaint, members of the Beverly Hills Board of Education have used knowingly false statements, meritless investigations, illegal leaks, racist rhetoric, and other abusive and illegal behavior as part of a coordinated effort to destroy Paysinger’s career and reputation,” Paysinger’s attorney Reed Aljian wrote in an e-mail to the Weekly.

The complaint alleges that Paysinger “has been the victim of a malicious campaign of discrimination and retaliation” from Board of Education members Lisa Korbatov and Lewis Hall.

According to the complaint, Korbatov said to Paysinger, “One of the problems that you

will have is that you do not look like what a principal of Beverly High should look like.”

When Korbatov was asked about her statement she said, “Yeah, I said it. That’s how I am.”

The complaint further states that Hall said he did not trust Paysinger because of “where he is from.”

Board member Brian Goldberg allegedly said, “It would be easier [for Paysinger] if he had lighter skin,” and that “[Paysinger] looks more intelligent when he wears glasses.”

Paysinger submitted three previous complaints regarding “unlawful conduct” of the Board members’ behavior, but the District did not respond to any of the complaints.

“Paysinger has made every effort to resolve these employment issues with the District privately,” Aljian said. “His efforts have only been met by repeated and continued re-

taliation by the very Board sworn to protect him and the other employees. He was left no other choice but to bring this lawsuit now to protect his rights.”

The first complaint was filed on July 12, 2013 regarding Hall’s threats to Paysinger and his family, saying that they would “suffer professional harm and unjustified attacks and investigations if he refused to follow Hall’s orders.” Though the complaint was confidential, a copy of the complaint was given to Hall. Hall then requested his colleagues on the Board of Education that Paysinger be fired, and he requested from Superintendent Gary Woods that Paysinger should be reprimanded for making the complaint.

Though the district admitted that Hall violated several district policies, the district did not discipline Hall “nor took any other remedial or disciplinary action,” according to the complaint.

Paysinger’s second complaint on January 30 alleged that the District ignored his first complaint and that the District and Hall “had engaged in a continued and pervasive pattern of retaliation and racial discrimination.” Though the District was required to perform an investigation on the matter and to prepare a written report on the findings and any decisions the District may have made, the District did not do any of this, according to the complaint.

The same complaint was illegally distributed to “various members of the District” in-

cluding Hall and Korbatov.

A third complaint was filed on February 12, alleging that the District had “intentionally and maliciously disclosed to the Los Angeles Times [a] draft report in retaliation for Paysinger’s” second complaint. The draft

report regarded an investigation brought on by Hall and regarding a summer sports program called Beverly Hills Sports Academy. The District Attorney’s office cleared Paysinger on all charges relating to the Sports Academy controversy in March.

Paysinger had requested explanations from the District on all three complaints, but the district “never responded” to any of his requests.

The Board of Education is scheduled to meet Tuesday to determine their next course of action in

closed session. Superintendent Gary Woods declined to comment.

“We intend to prove that members of the Board of Education have engaged in a campaign of abuse, harassment and discrimination against Paysinger because of racial intolerance and because Paysinger chose to stand up to Board members and report their illegal activities,” Aljian said. “Paysinger maintains the deepest respect, loyalty and commitment to the Beverly Hills community, which has supported him for his entire career. This lawsuit addresses the Board and its conduct, not the community it claims to represent.”

The lead petitioner was not present at the meeting, and the residents mentioned that she was moving away from Beverly Hills.

Eros said that the week prior to the meeting, city staff received 24 correspondence, with 23 opposed to the parking change and one in support. From the 23 signatures, 16 were from residents, and nine of those residents requested to withdraw their support of the petition. City staff received four additional opposition letters the morning of the meeting.

“I am wondering why our lead petitioner is not here,” Commissioner Julie Steinberg said. “This doesn’t happen very often where we have so many people back out at the last minute.”

To modify an existing parking restriction, a petition would need 60 percent of occupants living in the area to sign the petition.

“I’m happy to vote to deny [the change], my concern relates to the sanctity of the process,” Commissioner Jake Manaster said. “There are several zones that have relied on the process over time. Something

moved forward because of the process and something might not have gone forward because of the process. It’s important to keep it consistent.”

The City Council will have the final vote on the parking changes.

Commissioner Lester Friedman requested staff to ask the city attorney on the significance of the petition and the signatures on it. Manaster said that signing a petition would mean the resident shows support for the petition.

“I think all you’ve done when you’ve signed the petition is saying that you want this issue to move forward,” Friedman said. “What does the signature actually mean?”

### Obama nominates Sherwood-Randall as Department of Energy deputy secretary

President Barack Obama nominated eight individuals for key administrative positions July 8, including 1977 Beverly High graduate Elizabeth Sherwood-Randall as Deputy Secretary of Energy.

“These dedicated individuals bring a

wealth of experience and talent to their new roles and I am proud to have them serve in this administration,” Obama said in a press release. “I look forward to working with them in the months and years to come.”

Since March 2013, Sherwood-Randall has served as the White House coordinator for defense policy where she focused on nuclear weapons and arms control. From 2009 to 2013, she served as senior director for European affairs at the National Security Council.

Prior to joining the White House, she was a Stanford University senior research scholar from 2000 to 2008 and from 1997 to 2008 she was the founding principal in the Harvard-Stanford Preventive Defense Project.

Sherwood-Randall served in the Penta-

gon as deputy assistant secretary of defense for Russia, Ukraine, and Eurasia from 1994 to 1996, and received the Defense Medal for Distinguished Public Service.

From 1986 to 1987, she worked as a foreign affairs and defense policy advisor to then Senator Joe Biden (D-Delaware). Sherwood-Randall received her Bachelor’s degree from Harvard University and her doctorate as a Rhodes Scholar at Oxford University.

## METRO RECOMMENDS A \$1.636 BILLION CONTRACT FOR PURPLE LINE EXTENSION

But the lowest bidder isn't selected

Metro staff has recommended contractors Skanska, Traylor Bros. and J.F. Shea on July 7 with a \$1.636 billion contract to build the first phase of the Westside subway extension to Beverly Hills, according to [thesource.metro.net](http://thesource.metro.net).

Westside Transit Partners and Dragados, Astaldi, and Southland were two other bidders for the project. Dragados, Astaldi, and Southland was the lowest bidder at approximately \$200 million less than Skanska, Traylor Bros. and J.F. Shea's contract, but was not selected.

Dragados alleged Metro was biased in the contracting process.

"We will evaluate the complain," Metro communications manager Dave Sotero said. "We stand by our recommendation to the

board."

Dragodos Costa Mesa Vice President Eric Taylor did not return phone calls from the *Weekly*.

The contractors would work on the 3.92-mile subway extension route for the Purple Line with three underground stations along Wilshire Boulevard at La Brea, Fairfax, and La Cienega.

Excavation for the Fairfax station was complete in March, and fiber-optic cable relocation began in the same month. The utility relocation is projected to be complete in the second calendar quarter of 2016, according to the website.

The Beverly Hills City Council approved utility relocation permits in April for the La

Cienega station. Fiber work began in May, and currently Metro and the City of Beverly Hills are discussing a memorandum of Agreement for utility relocation work. Utility relocations are projected to be completed by the third quarter of 2016, according to the website.

Utility relocation work commenced Monday on Wilshire and La Brea and will last until Saturday, according to the website.

The three contractors, Traylor Bros., Skanska, and Shea, have all worked either independently or jointly on several Metro projects, including the Metro Gold Line Eastside project connecting downtown Los Angeles

with Boyle Heights and East Los Angeles and the Expo light rail project from Culver City and Santa Monica set to open in early 2016.

Shea, along with Kiewit and Kenny, also worked on the Red Line subway extension in the 1990s. During the subway construction, in 1995, a sinkhole appeared and collapsed Hollywood Boulevard. Shea was subsequently fired by Metro after the incident.

"There's bound to be issues with contractors [and] you have to really look at all the contractors and evaluate their past performance," Sotero said."

Sotero mentioned that Shea built the underground stations for the Gold Line east side extension in 2009 and complete 4.5 million work hours without any accidents and had no surface subsidence.

Metro's Construction Committee will review the recommendation at their meeting today at 10:15 a.m. at One Gateway Plaza, Los Angeles in the third floor board room. If the contract is ap-

proved by the Construction Committee, it will go before Metro's Board of Directors for final approval.

Once a final contract is ready, construction would begin later this year with required completion in October 2024, according to [thesource.metro.net](http://thesource.metro.net). The suggested contractors proposed completing the project early by 300 calendar days.

### Design Review commission rejects re-design of Spanish revival house

The Design Review Commission rejected new designs for a single-family residence construction project on South Almont Drive, which was taken over by new owners, with a 3 - 0 vote.

Chair John Wyka and Commissioner Arline Pepp were absent from the meeting.

The two story single-family residence was originally approved with a Spanish mission revival style. The new owners, Jon and Sepi Zarrabi, bought the house while construction was underway with the previously approved design. According to the project architect Ben Borukhim, only the first floor has been framed.

"We did minimum change on the inside, but the outside [design] is the one we're not happy with," Jon Zarrabi said. "We want something more modern, more contemporary."

According to the owners, in order to move to construction process forward quickly and to lessen cost, they attempted to maintain the main look of what was already approved while incorporating what they wanted.

"We're open to suggestions, anything to take it toward the contemporary look," Sepi Zarrabi said. "We're willing to change it so long as we can still continue moving forward because it's just a lot of stress, pain, mortgage and putting it on hold."

Commissioner Ilene Nathan said that the previous design had more charm and detail, while the new design was more bulky and massive, and did not reflect a true contemporary house. Nathan advised the Zarrabis and Borukhim to discard the Spanish revival mission style design and come up with a completely new contemporary house.

"If that's what [the owners] don't like, then there's no reason to keep any part of that," Nathan said. "Don't try to use the previous design as a way to come up with something new that you think might be approved quicker because your utilizing parts of the old design."

City staff and a sub-committee consisting of commissioners Susan Strauss and Efi Hubchman will work with Borukhim and the Zarrabis in the design process to move the project forward. The new designs will be presented to the commission at a future date.

"If you were very far in the building process, I [would understand] that you [wouldn't] want to touch the frame of the structure," Hubchman said. "But here you have the opportunity to really do contemporary if this is what you like."

### Water restrictions to begin August 1

The State Water Resources Control Board approved an emergency water regulation on July 15 that would require cities, including Beverly Hills, to prohibit wasteful watering practices.

Regulations will include prohibiting washing down driveways and sidewalks, over-watering outdoor landscapes to cause excess runoff, and using a hose to wash a vehicle.

Fines of up to \$500 per day could be imposed on customers who waste water. Water regulations will begin on August 1 and last into 2015.

Sixty to seventy percent of annual water usage in the city is due to residential landscaping irrigation, according to a press release.

The City is recommending residents to

limit landscape watering to three days a week. Residents living north of Santa Monica Boulevard should water their gardens on Monday, Wednesday and Friday. Residents south of Santa Monica should water on Tuesday, Thursday and Saturday.

Watering should be done between 5:00 p.m. and 9:00 a.m. every day to minimize evaporation, according to the press release. The City encourages water customers to avoid watering between 11:00 p.m. and 6:00 a.m. to respect their neighbors. If conservation goals are not met, mandatory watering days could be implemented.


