



the city. Serra’s Twins to be relocated to City Hall lawn



The Fine Art Commission considered a proposal by the Gagosian Gallery on North Camden Drive to loan the Richard Serra sculpture Twins to the City during a meeting on December 18. The sculpture features a pair of wedge-shaped Corten steel plates totaling 18,000 pounds.

“I think it would look great and break up the space really nicely,” said Jeremy Shockley, who oversees special projects and exhibitions at Gagosian Gallery. “[The sculpture] complements the building and the architecture.”

When Serra produced Twins for the Ace Gallery he also conceived an outdoor version that was sold as a certificate to the



Beverly High evacuated following telephonic bomb threat

Updated from Monday’s e-blast.

According to Beverly Hills Police Department Lieutenant Lincoln Hoshino, Beverly Hills High School received a telephonic bomb threat at 11 a.m. on January 5.

“Our primary responsibility is the safety of our students and staff,” said BHUSD Superintendent Dr. Gary Woods in response to a faculty member’s complaint that parents were notified of the phone-in threat before teachers.

Students, including Beverly High senior Karen Shilyan, were evacuated to Roxbury Park.

“While the students evacuated the school and made their way to the park, three helicopters were seen circling above,” Shilyan said.

As of press time, no bomb device or suspicious package had been located.

“Under difficult circumstances, the team was awesome,” Woods said. “We successfully moved approximately 1,700 students and 200 adults within minutes to a safe location.”

Community Development Department requests \$378,700 for new employees

Director of Community Development Susan Healy Keene and Assistant Director of Community Development/Building Official Raj Patel requested \$378,700 from the General Fund Revenue for the formation of three new Community Development Department positions at the City Council meeting on January 6. The new positions include one Senior Plan Review Engineer, one Building Inspector and one Customer Service Representative. Staff is also requesting modification of the existing limited-term Code Enforcement Officer position to a permanent-term position.


“There’s an industry standard about the appropriate amount of inspections for an inspector to do each day and that’s 12 inspections each day,” Keene said. “We already have inspectors doing some additional inspections as needed but there’s just a limit to how many an inspector can do each day and do completely and comprehensively. Their primary role is to ensure that buildings are safe and we would never want to shortcut whatever time they need to ensure safety.”

Since Fiscal Year 2009-2010, when the City experienced the lowest number of total building permits issued, the number of permits issued has tripled and construction valuation has quadrupled. The average number of permits issued over the past three years represents a 43% increase over the average number of permits from Fiscal Year 2000-2001 through Fiscal Year 2010-2011.

In Fiscal Year 2012-2013, the Mayor’s Task Force on Government Efficiency combined building, zoning, public works and fire reviews and inspections in Development Services. During the past three years, Development Services has not been adequately staffed to meet the increased workload.

The Department currently has four budgeted full-time employees, which is a 20% reduction in staff since 2008. Before the recent slump in the construction economy, the Department sustained at least five full-time employees to perform plan review. Matrix Consulting Group evaluated this staffing level in 2008 and determined it suitable for the workload. Since 2008, however, the yearly workload has increased by nearly 35%, bringing the number of employees required to meet the average workload demand up to 6-7.

The \$378,700 would be allocated as follows, and includes total compensation (salary and benefits): \$154,030 annually for the Senior Plan Review Engineer position; \$132,350 annually for the Senior Building Inspector position; \$92,320 annually for the Customer Service Representative position.



The fiscal impact for the conversion from limited-term to permanent for the Code Enforcement Officer would carry over to Fiscal Year 2015-2016. There would be the additional cost of \$38,700 for the four-month remainder of the fiscal year. The \$116,020 annual salary and benefits cost of the position will become ongoing, beginning in Fiscal Year 2016-2017.

The Community Development Department offers development-related services, which include plan review, permit issuance, building inspection, community preservation and record request processing.

On December 18, staff met with City Council Process Efficiency Ad Hoc Committee members Mayor Lili Bosse and Councilmember Willie Brien, who expressed their support for the proposed allocation.

Following the Council’s approval of the agenda item at the January 6 meeting, the next step is to transfer the funds into the budget and begin the recruitment process.



HOW TO SPEND THE SURPLUS?

City Council to consider uses for General Fund surplus

Possible uses for the Fiscal Year 2013-2014 year-end General Fund surplus of about \$12 million was slated for discussion at the City Council study session meeting on January 6. Due to a shortage of time, the Council will discuss the matter at their next study session.

"[The year-end surplus] is a combination of the excess revenue and the reduced expenditures beyond what was approved in the budget," said Assistant City Manager Mahdi Aluzri. "The reductions in the expenditures are largely due to ongoing position vacancies that we have."

At the end of Fiscal Year 2013-2014, the unaudited General Fund surplus totaled \$13.8 million. However, because City Council financial policies require that a General Fund reserve equal to 40% of the fund's operating revenues is maintained, \$1.8 million was set aside for the reserve.

Don Rhoads, Administrative Services Director and Chief Financial Officer, and Don Harrison, Budget and Revenue Officer, identified several potential uses for the year-end surplus. They advised that \$525,000 of the surplus be allocated to subway litigation, \$750,000 of the surplus be set aside to fund Santa Monica Boulevard reconstruction West of Wilshire and \$1.5 million go towards financing a new community center at La Cienega Park.

The largest portion of the surplus, \$2.75 million, will be allocated for property acquisition. In the past, Council has reserved \$5.75 million for property acquisition. These funds are most likely spent on purchasing property that will be used as parking facilities in the Southeast section of the City. In recent years, \$2.15 million has also been set aside for Southeast enhancements. Due to the high cost of property in Beverly Hills

and the need for more parking and additional improvements in the Southeast portion of the City, it is recommended that the Council set aside an extra \$2.75 million of the surplus for Property Acquisition.

After adopting the Fiscal Year 2014-2015 budget, the Council approved \$500,000 through the CIP as seed money for restoration of the Greystone Mansion Theatre. \$250,000 of the surplus will be set aside to match private contributions made for the

restoration of the theatre.

In recent years, the Council has assigned \$2 million to a Budget Stabilization Reserve for future unforeseen revenue shortfalls. It is recommended that the Council set aside another \$1 million of the surplus for this reserve.

The year-end surplus for Fiscal Year 2012-2013 totaled \$15.3 million.



LIFE IN THE BIKE LANE

Santa Monica Blvd. bike lanes remain on the table following study session meeting

The City Council continued its discussion of the North Santa Monica Boulevard Reconstruction Project at a study session meeting on January 6. The County Bicycle Coalition and several local advocates presented a “Beverly Hills Greenway” proposal, which envisions a 62-foot wide boulevard that fits two 5 foot-wide bike lanes and exacts no cost to the adjacent park.

Mark Elliot, who founded Better Bike in early 2010 to encourage conversation about road safety, was one of several residents who voiced support for Santa Monica Boulevard bike lanes at the meeting.

“I think what we really gained from Tuesday’s meeting was we heard a little bit more from our Council about bike

facilities and we could take their temperature about transportation alternatives in Beverly Hills,” Elliot said. “We had a discussion about how Beverly Hills should be going forward in terms of mobility. We heard from 33 advocates for bike lanes and I think we had four people speak against the lanes. I think if we had not shown up in the numbers that we did and sent the voluminous comments that we did, it would have quietly disappeared. To me, that was the big win. The second big win was just the process that City Council very patiently listened for more than two hours to us talk about what we need to feel safe on the Boulevard. Mayor Lili Bosse said, “We can get there.” When there’s a will



to find a compromise I think we will find a compromise. There’s some good will on the city side to make this happen.”

Planning and Policy Director of the Los Angeles County Biking Coalition Eric Bruins asked that the addition of bike lanes be carried into design during a study session meeting early last month. Bruins mentioned biker Paul Livingston, who suffered eight fractured vertebrae and a sheared pelvis after being struck by a car in Beverly Hills in 2011.

Mayor Lili Bosse and Councilmember Willie Brien, members of the Santa Monica Boulevard Ad-Hoc Committee, acknowledged that the bike lane issue has not been the main focus of their meetings so far.

Instead, the Council has mainly concentrated on traffic congestion issues associated with the project. Santa Monica

Boulevard’s current minimum width of 60 feet is too narrow to accommodate bike lanes.

“I won’t vote in favor of any project where we don’t have dedicated bike lanes because I think it would be a grave mistake,” said Councilmember John Mirisch. “But I do agree that we should look to get additional space from the Southside.”

Council allowed the bike lane discussion to define the January 6th study session meeting, meaning that the issue is still on the table.

The City entered into an agreement with engineering firm Psomas in June 2013 to perform design services for the Santa Monica Boulevard Reconstruction project. Construction is anticipated to begin in Spring 2016.

Design Review Commission deliberates 446 South Elm Drive project

Architect Ben Borukhim of bBA Studios, Inc. attended the December 4th Design Review Commission meeting to request the approval of a new two-story single-family residence on 446 South Elm Drive. Borukhim applied for an R-1 Design Review Permit for design approval on behalf of property owners Leonard and Lenora Horowitz.

“I think it’s a nice design,” said Vice Chair Arline Pepp. “It’s refreshing, there’s refined detail, it has charm, it makes a statement, it’s soft and it’s well done.”

Commissioner Ilene Nathan also praised the design, but recommended that the roof be extended across the right-side element and the porte-cochere be pushed back.

“I think this is a really nice design,” said Chair John Wyka of the proposed Cape Cod-style. “I have only two concerns—well, two-and-a-half concerns. I think this is an example where the rendering is not doing your project justice because it emphasizes the two things that are perhaps most problematic, and that is the double height of the right element without any kind of horizontal breakthrough, and then it emphasizes the fact that your porte-cochere is basically right up to the front.”

Wyka’s recommendations included setting back the upper floor a few feet to provide a visual breakup and setting back the porte-cochere so it does not appear to be a continuation of the same roof.

The Commission unanimously approved the project on the conditions that the second-story element have the porch-roof line extended across, the porte-cochere be set back a minimum of four feet from the façade and the front-yard fence be limited to a maximum height of 36 inches and be comprised of wood.

“Thank you for a good project,” Pepp said.

Staff’s proposal.

The City occasionally employs outside consultants for management consulting and Departmental Audit services. In an effort to determine whether opportunities exist for increased efficacy and efficiency, City departments typically receive an audit to review procedures, policies and operations every four to five years.

In the past five years, audits of the Fire Department, Police Department and Community Services Department have been

conducted.

Management Partners offers a range of expertise that qualifies them to provide management consulting and departmental audit services. An agreement with Management Partners would provide the structure for authorizing individual project plans and billing for services based on a unit of service defined as \$2,500 of consulting assistance, including fees and expenses.

Funds for management audits and consulting services totaling \$75,000 are currently available in the Fiscal Year 2014-2015 budget. Additional funds will be requested as a

part of the Fiscal Year 2015-2016 proposed budget. A maximum of \$150,000 can be expended to help identify ways the City can improve its operational efficacy and efficiency.

Council approves T-Zone Parking Map amendment

Senior Planner Ryan Gohlich presented a report on behalf of applicant Oasis West Realty requesting the City amend the T-Zone Parking Map to add the property at 9900 North Santa Monica Boulevard during a City

Council meeting on January 6.

Oasis West Realty has already acquired building permits to begin work on the subterranean portions of the Waldorf Astoria Hotel, and is currently in the process of securing building permits for the above-ground portions of the hotel.

Oasis West Realty wants to use the 1.28-acre property located at 9900 North Santa Monica Boulevard for construction parking and staging throughout development of the Waldorf Astoria and the Beverly Hilton Specific Plan, anticipated to take six years.

Architectural Commission approves Bally project

Architect Joseph Dasilva of The Dennis Group requested review and approval of a façade remodel, a sign accommodation for multiple business identification signs and a construction barricade graphic for the Bally store located at 340 North Rodeo Drive during an Architectural Commission meeting on December 17. Dasilva attended the meeting on behalf of Ronan McNamee, the property owner, and Swiss luxury retail brand Bally, the tenant. He was accompanied by Cristiano Billia of David Chipperfield Architects, the designers of the building.

“We would kindly request your approval of the project as we’re presenting it,” Dasilva said.

The façade remodel includes a new red marble stone façade, a storefront system with clear glazing and natural brass framing, red fabric retractable awnings at the storefront windows, a coconut fiber doormat at the entry door, a walnut wood rooftop screen in a brushed and low-whitened finish and gray quartzite stone, gravel stone and bamboo on the roof deck.

The business identification signage involves four signs totaling 7.7 SF. One 6.8 SF, LED-illuminated sign would be mounted on the store’s façade. Two 0.3 SF non-illuminated signs would be fastened to the window and a final 0.3 SF non-illuminated sign would also be mounted on the store’s façade. The copy of all signs would read “BALLY.”

“I love it,” said Vice Chair Andrea Gardner Apatow. “It is so refreshing to have something that is elegant in its simplicity. I am so over the top with these facades that look like grandma’s jewelry.”

Apatow made a move to adopt a resolution conditionally approving an architectural review permit for the building. The Commission unanimously agreed on the design, concluding that the project features a balance of color, high quality materials and appropriate architectural design principles that bolster the City’s urban form and promote the City’s image.

“It’s is one of the best presentations that I’ve seen since I’ve been here—and I’ve been on the Commission for five years,” said Chair Barry Bernstein. “Thank you very much.”

The new store is expected to open in October 2015.

The staging area and parking lot, which would accommodate approximately 138 vehicles, would be used during normal construction hours, from 8 a.m. to 6 p.m.

“As contemplated in the municipal code, the T-zone parking map can be amended by the City Council directly, it does not require review by the Planning Commission,” Gohlich said. “However, this is a two-step process to create a parking and staging area on that property. If the City Council elects to adopt the T-Zone Parking Map tonight, that would identify the subject property, but it would not immediately grant privileges to use it as parking.”

Councilmember Nancy Krasne highlighted potential safety implications associated with the project and asked whether the lot would be lit at nights. Gohlich responded that there are minimum lighting requirements that will be satisfied. Both Mayor Lili Bosse and Councilmember John Mirisch stressed the potential issue of jaywalking.

“I’m supportive, but I would like to see that we include in the [Development Plan Review] that if there are issues—people running across the street— that we have the ability to address it, that our hands are not tied,” said Mirisch.

The Council unanimously agreed to adopt the resolution.

BHHS boys' basketball team wins tournament Team carries five-game winning streak into tonight's game.

The Beverly High boys' basketball team won the Gear To The Max Division of the MaxPreps Holiday Classic, defeating the German club team Urspring, 49-38, in the final Dec. 30 at Rancho Mirage High School.

Chance Comanche, the Normans' 6-foot-11-inch center, made each of his first five shots "and we were kind of rolling from there," Beverly Hills coach Jarvis Turner said after his team won its fifth consecutive game, improving to 8-4.

Turner credited the tournament victory to "great team play."

"It was a really good trip for us," Turner

said. "It gave us an opportunity to bond more as a team. I think that showed in our play.

"We were really moving the ball around extremely well, sharing the basketball, playing the game the right way on both ends of the floor."

Rafalian made the free throw after a time out by Dons coach Will Cunningham.
