## Hall in, Goldberg out

Up against the August 7th deadline, incumbent Board of Education member Lewis Hall filed papers for the November 3rd Board election last Thursday.

reelection.

Hall has sided with Board member Lisa Korbatov on many issues, including the \$190-million Measure E bond acceleration and the controversial auditorium closures at Beverly High, El Rodeo and Hawthorne.

In an effort to justify the BHUSD's increasingly expensive and unsuccessful lawsuit against Metro, Hall starred in "Why We Fight" late last year. Published on YouTube, the purportedly student-produced video series highlights the potential prob-

lems with Metro's plan to construct a subway underneath Beverly High.

As of press time, part one of the series had garnered 5,022 views, part two, 3,000 views and part three, 1,974 views. The district paid interim Facilities Director Tim Buresh \$7,260 for his consulting work on the videos.

Last July, Hall was named in a lawsuit filed by Board candidate and former Beverly High principal Carter Paysinger. The Board approved a settlement agreement for \$685,000 on June 18.

Hall owns Elevated Lab Press, a company that offers online middle school math lessons. In 2010, he launched Elevated Math, an iPad-only math application.

At a Board meeting in August 2013, an agenda item was presented for approving \$85,353 towards purchasing iPads and iPad-related products for Hawthorne. Hall failed to disclose his association with the company and its app.

Hall, who received his BFA from UCLA, teaches two classes in the Digital Media Department at Otis College of Art & Design. Formerly, he worked as senior art director for broadcast firm Novocom and as design director for CBS Entertainment.

He was elected to the Board as a newcomer candidate in 2011 with fewer than 1,000 votes. Over his four-year term, Hall was skipped over by his colleagues for the positions of vice president and president.

Hall responded to an email from the

Weekly saying he had no comment.

Former Beverly High athletic director Jason Newman did not file papers prior to the deadline.

## Board meeting highlights

Following a public comment period involving many students and parents that voiced their support for Beverly High track coach Dwayne Washington, the Board of Education appointed physical education teacher Howard Edelman to the position with a 5-0 vote at their meeting Tuesday night.

Edelman began the new job on Wednesday.

"I'm sorry about this, but we just had such late hires," said BHUSD Chief Human Resources Officer Yolanda Mendoza.

The Board had briefly considered reinstating controversial former track coach Jeff Fisher, who is currently suing the district.

Board member Lisa Korbato reported that the district-owned residence located at 220 North Doheny Drive, which housed former Superintendent Gary Woods and his family for three years, is currently listed for lease for "a touch under \$9,000 [per

month]."

"There have been several showings," Korbato said.

The Board later approved a slew of agenda items under "Planning and Facilities," including a contract with the Department of Toxic Substances Control (DTSC) totaling \$39,690 for the cleanup of Beverly High's lacrosse field, which contains high levels of arsenic. The project is estimated to require the removal of 20 tons of soil.

All seven agenda items under "Planning and Facilities" were approved unanimously, except for the agreement with Blackman & Holberton to coordinate the interim housing move at Beverly High; Board member Noah Margo dissented.

Margo has previously voiced his opposition to ordering portables before final plans at the high school are in place.

## Traffic & Parking OKs preferential parking zone for North Oakhurst

As Traffic & Parking Commission Vice Chair Jake Manaster pointed out at the committee's August 6th meeting, preferential parking permit zones have been a recurring

topic of discussion at recent hearings.

"It's really unnerving to have these keep coming up over and over again," Manaster said.

In May 2015, a qualifying petition signed by 12 of the 20 households on the 200 block of North Oakhurst Drive was submitted requesting a permit parking regulation to allow resident parking beyond the posted two-hour limit with a permit hangtag.

Staff conducted a spot-count parking occupancy survey on July 23 which revealed that on average, 60 percent of the on-street parking spaces were occupied.

"I went out to visit the site and I counted less than the designated amount of cars at the same time that was shown in the report," said Commissioner Jeff Levine. "I didn't

see it as an overwhelming, compelling issue, personally, from my own experience visiting it."

Levine, who later voted against the amendment, pointed out that lead petitioner David Kohanbash was absent from the meeting.

The current non-permit regulation allows two hours of parking from 8 a.m. to 6 p.m., except Sundays.

According to the staff report, the 200 and 300 blocks of North Maple, Palm, Oakhurst and Doheny Drives and the adjacent sections of Clifton and Dayton Ways are among the few blocks remaining with a non-permit "2-hour, 8 a.m. to 6 p.m., Except Sunday" regulation south of Burton Way.

The motion passed with a 4-1 vote, with

The Council conducted a first reading and introduced the ordinance on July 21, 2015 and set the public hearing for August 18, 2015.

## Arsenic discovery leads to Beverly High lacrosse field closure

Beverly High's lacrosse field was shut down last week after the Department of Toxic Substances Control (DTSC) discovered levels of arsenic in the soil that exceeded the DTSC-established limit of 12 mg/kg.

Two elevated samples of 41.6 mg/kg and 79 mg/kg were found in surface soil in the southwestern part of the field; three slightly elevated levels were discovered in the same area at a depth of five feet, and slightly elevated levels were found in surface soils at the northern end of the field.

According to DTSC Public Information Officer Sandy Nax, the BHUSD learned of the problem following an environmental assessment of the property, which was being considered as a potential site for portable classrooms.

As defined by the Center for Disease Control and Prevention, arsenic is a naturally occurring element that is found in combination with either inorganic or organic substances to form many different compounds.

"My own children are here on the sites as well, and I wouldn't put my own children or anyone else's children or the staff in any danger whatsoever," Board of Education President Brian Goldberg told CBS2 Los Angeles last Friday.

Goldberg told the Beverly Hills Courier that "the same consultants, lawyers and state agencies that told us our auditoriums are not safe are now telling us we need to shut down our lacrosse fields."

In point of fact, BHUSD interim Facilities Director Tim Buresh, along with district-contracted structural engineers, had advised the Board to shut down the auditoriums at Beverly High, El Rodeo and Hawthorne, citing alleged seismic issues. At no time did any state agencies declare the auditoriums to be unsafe.

The Board only closed the auditoriums after a 3-2 vote.

"We are required to go through a DTSC-mandated, public outreach and comment protocol, which is estimated will take between now and November to complete," Buresh said. "At the completion of that process, we can then go and clean up the materials, which will probably take a couple days."

The most feasible remedy, Nax said, is to remove the contaminated soil and dispose of it at a landfill licensed to handle toxic material.

In the meantime, the field will be fenced off and access is prohibited.

### It's a girl!



Reviewed by the Commission last December, the two-story, single-family home's prospective owner is Francesco Aquilini, owner of the Vancouver Canucks hockey team. Aquilini attended the Commission hearing with his attorney, former Beverly Hills Mayor Tom Levyn.

Chair Alan Robert Block mentioned that the project is "three times as large" as

## SUNUNU ON THE RECORD

**Former Bush White House Chief of Staff John Sununu on his new book**

**Why did you feel the need to write *The Quiet Man*?**

I had originally never really wanted to write a book about the White House years and I thought the president had the same feeling—that he didn't like kiss-and-tell books. But I went up to visit him about a year and a half ago and told him I really thought I should break my promise, that it was important for the public to know and historians to know—perhaps gathered all together between the two covers of a book—all of his great accomplishments not only on foreign policy, such as nurturing the collapse of the Soviet Union and kicking Saddam Hussein out of Kuwait, but also what is less well known: his tremendous domestic policy accomplishments and the very prolific record he had in passing good domestic legislation. I felt it was an appropriate thing to do at this time and when I mentioned it to the president and Mrs. Bush they were both enthusiastic about it so I felt good about going ahead and doing it.

**In what ways do you feel the Bush 41 presidency is misunderstood?**

I think his foreign policy accomplishments were so significant that they sometimes dwarf what he did domestically, but George Bush passed more domestic legislation than any president except Lyndon Johnson or Franklin Roosevelt, and it was good, free enterprise, conser-

vative legislation that had long-lasting impacts. It included the budget agreement, which may not have been popular when it happened, but it produced the surpluses and the growth of the 90s; it included the Clean Air Act, which was an amazingly effective piece of environmental legislation; it included the legislation which deregulated energy and we are now benefiting from all that deregulation; it included a civil rights bill, the Americans with Disabilities Act, an improved immigration piece of legislation, a

crime bill; it included agriculture reform, which had incentives for exports that really built up the export market for American agriculture, and it included a huge education summit with the 50 governors of the country—only the third time in history that a president has actually held a summit with the 50 governors—that focused on improved K-12 education.

**Beverly Hills resident Eli Blumenfeld is throwing you a book party tomorrow night. How do you know Eli?**

Eli and Nancy are good friends. I've worked with Eli on a couple of projects and we've gotten to know each other over the last half-dozen years and I'm really looking forward to the event at his home on the 11th and really appreciate them taking the time to let me come talk a little bit about the book *The Quiet Man* and about George Herbert Walker Bush.

**Tell us about your dealings with Beverly Hills over your years in Republican politics.**

I don't know whether I've been in Beverly Hills more than once or twice in my life, to be honest with you, and so I'm looking forward to [the Blumenfeld party]. I hope Eli gets all the strong Republicans from the community there and I'm looking forward to meeting them.

**You're appearing on *Conan* later this week. Tell us about that.**

I'm looking forward to it. I've met and chatted with Conan a couple of times and he was very interested in the book and invited me to come on and, I don't know if people realize this, but Conan is quite a student of history, in particular a student of the American presidency, and I'm looking forward to talking about the man that I think is one of the finest American presidents and most successful American presidents we've had.

**How did being Governor of New Hampshire prepare you to be Chief of Staff?**

Governors are really the ones, I believe, in the political process in this country, that get to understand policy the best. They have the specific responsibility of managing their state; they have to deal with every issue within their state, which except for national defense, is the same as every issue that has to be dealt with at the federal level. Being governor allowed me to come into the office of Chief of Staff prepared to help President Bush put together his domestic agenda and, having served as a Chief Executive myself, as governor, allowed me to get a good feeling as to how best to serve the man who would then be the Chief Executive of the United States, the President of the United States.

**What are you doing nowadays?**

I'm trying to do as little as possible. I turned 76 a few weeks ago. This book was sort of what I hope is my last big project, but I'm going to spend a little more time making sure that people know the book is out there, but once I finish that cycle, I probably will go back to being an old and cranky former politician and former engineer.

**How do you want to be remembered in the context of the Bush 41 presidency?**

I just hope people take a look at all the things that George Herbert Walker Bush accomplished and perhaps might understand that [one], I was privileged to have been there—it was an honor and a privilege to serve that president—and two, I hope they might feel that in my small way I was able to at least contribute to his success.

## HISTORICAL CHARM



### Cultural Heritage Commission Chair Lisa Greer on the challenges of historic preservation

**You've held a wide range of roles throughout your professional career, from working as vice president of Universal's consumer products group to being the HR Director of Voce. Tell us about that.**

I'm what some people call a serial entrepreneur: I started businesses since I was in high school and tried to find ways to solve problems. Even though at Universal and NBC I was in a corporate structure, we were still trying to do something new in both cases. Most of my other work, if not all, regardless of what sector it was in, has usually been about creating something that wasn't there before or taking something that is not flourishing and turning it into something successful.

**How did you become interested in historical preservation?**

I'm a history major and I knew they were looking for somebody who had that kind of background. Also, when I was at Universal, I started a business of protecting and preserving and presenting to the public things that were historic. At Universal, I created a collectibles business; we were taking, for example, the 25th anniversary of the Battlestar [Galactica] and we licensed that and brought it back. We also created a series of products related to the Alfred Hitchcock legacy and materials that the studio owned. So a lot of that [involved] taking historical items and not creating a contemporary version of them, but working to produce things and make things available to the public that in the past had been largely forgotten and going back and finding the originals of them. So when the opportunity came up to do the same thing with properties in my own city, it seemed to really fit with what I do.

**In the Weekly's cover story with former Commission Chair Maralee Beck in issue #773, she said, "The whole point of preservation is not to keep things in mothballs. It's to conserve what you can of the past to inform the future." Do you agree?**

I now have a real estate portfolio where we invest in historic buildings all over California, so I actually am a property owner of buildings—mostly residential buildings—that fit in this category, and I also live in a home that is historic. I am president of Temple Emanuel of Beverly Hills which is a restored historic building. The typical concern about preservation of

properties is that people feel that it interferes with property rights and that's the argument against historic preservation—people [believe that they] have their own right to do whatever they want with their property. At the same time, we have had many, many people come to us who say, "I don't like what's happening with my street, it doesn't look like it used to, it doesn't have the culture and the qualities and the feeling of Beverly Hills anymore." People think that by saying we want to preserve something, it means that it cannot be updated. And that's just not true. You don't go to Washington D.C. and have doors falling off because no one is allowed to update it—it just doesn't happen. You can make something look authentic without having it be broken. One of the things that our Commission does and our staff does is work very closely with homeowners to make sure that they can find a functionally modern way of preserving the look and feel of their property.

**You founded Beverly Hills Egg Donation in 2006. Tell us about that.**

It was another business where, because my husband and I were both involved in the early days of the internet, one of the things we do is we look for businesses that are arcane in the way that they do things and that could benefit by adding technology, i.e. the internet, to what they do. So the egg donor business was in that situation and had been done very much like a mom-and-pop [business] and we saw great opportunity to bring the benefits of egg donation to a large audience by putting that online. We weren't the first ones to put it online, but I think we were the first people to put it online in an extremely professional and almost corporate way. We sold the business about five years after I started it to one of the doctors that we had worked with.

**Did you use an egg donor yourself?**

No. I had five children so I was like, "Gee, I feel really badly for people who can't have a child."

**The City Council adopted the amended Historic Preservation Ordinance at their meeting last month. What is your response to people who oppose the new ordinance?**

There are two different camps of people who oppose it, and that's where this gets confusing. Some people opposed it

because they felt it was too restrictive, such as two of my fellow commission members [Rich Waldow and Rebecca Pynoos], and it would mean a lot of properties could be lost. That's their big issue. There's another group of people that believe that anything that looks like it's taking away your right for you to do anything you want with your property is inherently bad. We have talked to people who believe—I've actually had people tell me this—that anything that is old is inherently bad. Frankly, I think that's a really sad way of thinking. I think that we all have ancestry and history in our fami-

lies and history in our city and history in our country and to just throw it all out the window for the sake of modernity—I don't buy it. And I don't think that's something that Beverly Hills wants to be.

**The Cultural Heritage Commission is currently split 3-2 over the amended Historic Preservation Ordinance. Explain the split in philosophy.**

We had many properties that we couldn't move forward with over the past eight months because homeowners were saying, "We want to wait to determine if our residence is going to be protected or not because we want to see if the ordinance changes and if the ordinance changes and it's less restrictive, perhaps we can tear down that house that we can't tear down today." So for the last eight months, there were a lot of properties that were sort of frozen. For me, I think that it was extremely important to get the very best consensus that we could get with the Planning Commission and with the City Council so that we could be back in business, for lack of a better term. I think that we were just sort of stuck, and that's not good for anybody. I think that everyone on the Commission agrees—Commissioner [Rich] Waldow and [Vice Chair Rebecca] Pynoos both said this as well—I think everybody agrees that the time frame, the lack of certainty, some of the contradictions that were in the original ordinance, those needed to be fixed. The issue of should there be historic districts, I think that it is an issue, but nobody came to us wanting to do a historic district in all that time, we didn't have anything pending that's a historic district, and it was made very clear at the City Council meeting that this ordinance could be revised again, and there would be some way to alter pieces of it. I don't want to not be able to preserve properties, not be able to continue our work because we're stuck in an administrative, bureaucratic, no-man's land. I'd rather get the very best deal that we could

at the time, move forward with the idea that as we move forward we will ask for additional changes as necessary in the future. But we had to at least accept something to get it going, otherwise it was just frozen.

**Tell us about your family.**

I have nine-year old twins, Jack and Emily Greer, who go to El Rodeo. We also have three older children. My daughter Sasha Feldstein is 29 and finishing up her master's [degree] at [University of California] Berkeley in public policy. My son, Darrow Feldstein, is almost 25 and he is a Beverly High graduate and a wilderness education expert and an expert birder who has

also brought his birding classes to El Rodeo. My next daughter, Halley Crane, is 21 and she is a food writer and has a very popular blog about food and she's a senior at Occidental. She went to Horace Mann and Beverly High for two years and graduated from Wildwood. My husband is Josh and he is a serial entrepreneur as well. We met at Universal Studios in the early 90s. I grew up in the Valley, my mother went to Fairfax [High School], but both my grandmothers lived in Beverly Hills. I always thought that Beverly Hills was a place grandparents lived.

**What is your favorite landmarked building in the City?**

It's hard to choose, I don't think I can choose one. I like a lot of buildings for different reasons, but the Beverly Wilshire I think is fantastic because it's its own kind of iconic, both from films and from when I was a teenager—it was a fun place we would go and feel important. I was actually married once at the Beverly Hills Hotel, so that's very important to me and watching that place evolve from a place that used to have a room called the Persian Room. It has so much incredible history, it's fabulous. I think City Hall is incredible and my kids go to El Rodeo, which sort of has a miniature version of the tower and I look at that all the time and think that it's just fantastic. And I love the post office. On a residential side, I love the Fay's house because they lovingly took a historic house and really spent a lot of time making sure that every single piece of it inside and out was authentic and appropriate.

**What one thing would you like to accomplish as Chair?**

[I would like to] change the attitude towards historic preservation in Beverly Hills for the positive.

**ORDINANCE NO. 15-O-2684**

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING MOBILE BILLBOARD ADVERTISING DISPLAYS AND ADVERTISING ON VEHICLES

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

Section 1. The City Council hereby adds Article 5 ("Mobile Billboard Advertising Displays and Advertising on Vehicles") to Chapter 2 ("TRAFFIC REGULATIONS") of Title 7 ("TRAFFIC, PARKING, AND PUBLIC TRANSPORTATION") of the Beverly Hills Municipal Code to read as follows:

"Article 5. Mobile Billboard Advertising Displays and Advertising on Vehicles.

**7-2-501: PURPOSE**

The purpose of this Article is to eliminate Mobile Billboard Advertising Displays and advertising on vehicles within the city to promote the safe movement of vehicular traffic, to reduce air pollution, and to improve the aesthetic appearance of the city. This ordinance is adopted pursuant to California Vehicle Code Sections 21100(m) and (p).

**7-2-502: DEFINITION**

"Mobile Billboard Advertising Display" means an advertising display that is attached to a mobile, nonmotorized vehicle, device, or bicycle, that carries, pulls, or transports a sign or billboard, and is for the primary purpose of advertising.

**7-2-503: PROHIBITION**

A. It shall be unlawful for any person to transport, cause to be transported, park or leave standing any Mobile Billboard Advertising Display upon any public street, or other public place within the city in which the public has the right of travel.

B. It shall be unlawful for any person to park or leave standing upon a public street any motor vehicle with an advertising sign on the motor vehicle, except for: (1) advertising signs that are permanently affixed to the body of, an integral part of, or a mixture of the motor vehicle for permanent decoration, identification, or display and that do not extend beyond the overall length, width, or height of the vehicle; or (2) paper advertisements issued by a dealer contained within a license plate frame or any advertisements on a license plate frame, if the license plate frame is properly installed in compliance with Section 5201 of the Vehicle Code,

(i) As used in paragraph (B), "permanently affixed" means any of the following:

- (a) Painted directly on the body of a motor vehicle;
- (b) Applied as a decal on the body of a motor vehicle; or

(c) Placed in a location on the body of a motor vehicle that was specifically designed by a licensed vehicle manufacturer, in compliance with both state and federal law or guidelines, for the express purpose of containing an advertising sign.

**7-2-504: PENALTIES**

A. Any peace officer, or any regularly employed and salaried city employee who is engaged in directing traffic or enforcing parking laws and regulations, may remove a Mobile Billboard Advertising Display or a vehicle with an advertising sign on it if:

(1) The Mobile Billboard Advertising Display or vehicle is parked or left standing upon any public street or public property within the City in violation of this article; and

(2) The registered owner of the Mobile Billboard Advertising Display or vehicle was previously issued a warning citation for a previous violation of this article that notified such registered owner that he or she may be subject to penalties that may include removal of the Mobile Billboard Advertising Display or vehicle upon a subsequent violation of this article.

B. A violation of this article is a misdemeanor, punishable pursuant to Article 1 of Chapter 3 of Title 1 of this Code.

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the city within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the city Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this city.

Section 4. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage. Adopted: August 4, 2015 Effective: September 4, 2015
