## Eleven portables arrive at El Rodeo

Eleven portables arrived at El Rodeo Sunday, preceding an additional 23 slated for delivery later this month.

Superintendent Steve Kessler said the portables must be dropped off with a permit through the City of Beverly Hills, making Sundays the only permitted delivery day.

“The remainder of the middle school portables will be delivered this coming Sunday, followed by the [next] Sunday,” Kessler said.

Portable prep, which kicked off earlier this week and includes plumbing and electrical work, will roll into the winter break.

Students are scheduled to move into the new buildings after the first of the year.

The El Rodeo field will house the portables. According to a City Council presentation last month, construction activities at the school are estimated to end April 2019.

## 3,465 ballots cast as of Tuesday afternoon; updated ballot count released

As of Tuesday afternoon, 3,465 ballots had been counted for the November 3rd Board of Education election, in which challengers Isabel Hacker and Mel Spitz and incumbent Noah Margo won.

session, it is unclear whether the Board unanimously voted to retain Smith.

The California Supreme Court takes very few cases, meaning the district has a low chance of prevailing on appeal.

### Council wants more business community input on minimum wage increase

California has the highest poverty rate in the country, according to recent US Census Bureau estimations.

In 2013, Governor Jerry Brown signed AB 10, which will bring the California minimum wage to \$10 per hour starting January 1, 2016.

The cities of Los Angeles, Seattle, San Francisco, Oakland and Berkeley have recently authorized phased-in increases to eventually take their minimum wage to \$15 per hour.

At their September 1st study session, the Beverly Hills City Council expressed general support for a minimum wage hike, and directed staff to continue their outreach to local businesses and neighboring municipalities.

“We need to have a complete picture of what the impacts are going to be,” Mayor

Julian Gold said.

A chart prepared by the City’s Finance Department shows an increase to \$15/hour would add \$114,445 to the City budget over a five-year period.

But surveys conducted by the Chamber of Commerce paint a business community that needs convincing.

“Many restaurants have expressed skepticism,” said Chamber of Commerce Economic Development and Government Affairs Director Andy Sywak.

Sent out to the Chamber’s entire membership, the eight-question survey was completed by 70 businesses, which Councilmember Lili Bosse said is not “a large enough universe to make an educated decision.”

At the Council meeting November 3, Deputy City Manager for Public Affairs Cheryl Friedling pointed out that neighboring cities Santa Monica and West Hollywood have been moving “fairly quickly on these topics.”

Under the Los Angeles ordinance signed into law by Mayor Eric Garcetti in June, the minimum wage will climb from \$9 per hour to \$10.50 per hour beginning in 2016.

The rate will then rise to \$12 in 2017; \$13.25 in 2018; and \$14.25 in 2019, before increasing to \$15 in 2020.

Friedling underlined the Council’s cur-

rent options: wait until West Hollywood and Santa Monica have an ordinance in place; proceed with developing an ordinance based on Los Angeles’ law; or develop an ordinance for Beverly Hills with different parameters or rates.

Councilmember Nancy Krasne said she is “all for moving forward,” but would like to know how the raise would be enacted.

Aside from Councilmember Willie Brien, the Council seemed lackadaisical about the raise, and requested the Chamber expand its outreach efforts so that a larger slice of the

City’s business community can be heard.

“I don’t need to get outreach from the other businesses for us to do what’s right for our employees,” Brien said.

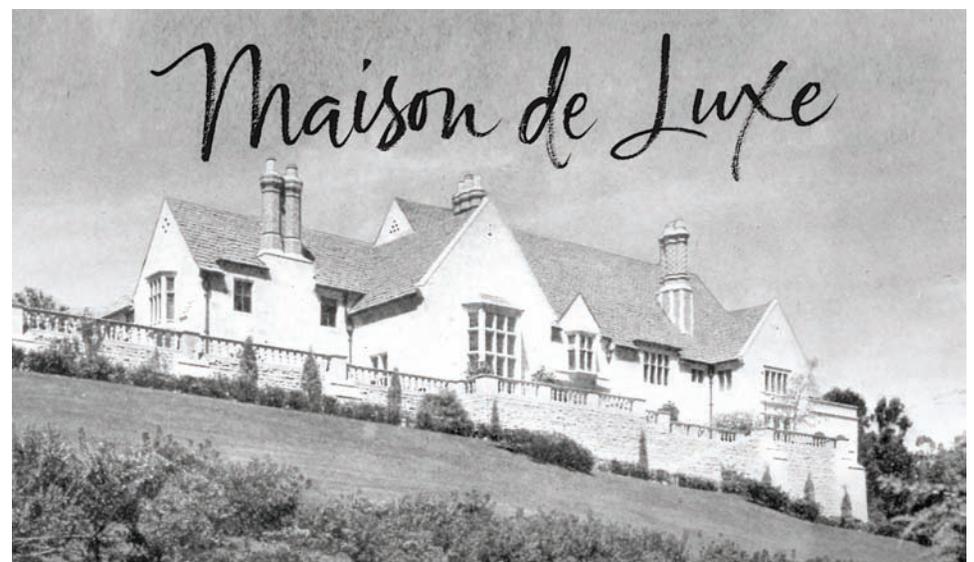


### Congregation Or Shalom celebrates Carl Laemmle

### “Willie Brien accepts job at Houston medical center, but how will his vacancy be filled?” [Issue 840]

Thank you for reporting on Council’s discussion about how best to seat a fifth member once member Willie Brien departs. Somehow only the *Weekly* thought the policy discussion worthy of recapping.

The question facing our elected representatives: do we hold an election for his seat, or else allow four councilmembers to make an appointment? It’s not an academic question; indeed it speaks to the very essence of representative democracy. Our policy mandates an election.

After a brief discussion, though, Council recommended that the current policy align with state law, which does allow a general law city like ours to appoint to fill that vacancy. Those in support of the change - Mayor Gold, Vice-Mayor Mirisch and

Councilmember Krasne - opted for ‘flexibility.’

The Mayor seemed to suggest he favors an appointment. “Would we need to actually ask for applications or could the council just have its own conversation about potential appointees?” the Mayor asked. “Would we need to identify the criteria by which we’re making this decision, or could it just be, ‘I recommend so-and-so’...?” His inquiry suggested flexibility without transparency; that would be representative democracy, perhaps, but it’s not particularly democratic.

Thankfully Councilmember Lili Bosse weighted in on behalf of democracy. “The person who sits up here should be the will of the people,” she said. “Under no condition do I think we should appoint anybody.” She opposed changing the policy.

Once councilmember Brien departs, two of our four sitting councilmembers will be continuing their second term without having been re-elected. (No challenger filed in the 2015 contest.) Do we really need three of our five councilmembers seated without an election? I don’t think so; too much rides on the judgment of \*elected\* leaders to leave it to appointments.

### Design Review Commission "not comfortable" with South Oakhurst Drive project

A project rejected by the Design Review Commission in September was once more sent back for restudy at the Commission's November 5th meeting.

Slated for 220 South Oakhurst Drive, the original design was deemed too bulky and boxy, but the second version was not determined a vast improvement.

"This is not a complete redesign," said Commission Vice Chair Ilene Nathan. "This is basically the same design with the windows changed and the balconies slightly

changed. It's the same."

Commissioner John Wyka, who recommended that the balconies be scrapped, said "[this] is not the result we intended"

The City's Urban Design Team believes the proposed entry design is "too heavy" and overwhelms the structure. The building could benefit from a precast base to anchor the ground floor, according to the staff report.

"I'm not sure what we're trying to say here," Commission Chair Arline Pepp said. "I'm looking at the house, and it appears large and bulky, but it doesn't tell me anything, it doesn't have the

flavor of a particular design."

Perhaps in an effort to lift property owner Shahram Khazan's spirits, Commissioner Mahnaz Sharifi Ardani offered words of encouragement.

"It needs to tell a better story, [but] we are getting there, I think," she said.

### Beverly High assembly sheds light on suicide prevention

The Beverly High lawn was strewn with 1,100 backpacks Friday morning to represent the number of college students that die by suicide each year.

Fronted by non-profit organization Active Minds, the "Send Silence Packing" program raises awareness about the impact of suicide and connects students to needed mental health resources.

## BHHS football season ends with loss to Culver City

Beverly High allowed 34 points in a 15-minute, 34-second span over three quarters as Culver City turned a one-point lead into a 41-6 victory in an Ocean League football game Friday night at Culver City.

The Normans trailed 7-6 late in the second quarter in their final game of the 2015 season when they drove to Culver City's 3-yard. Quarterback Jake Wolken was sacked for an 8-yard loss on third down and his

fourth-down pass was intercepted by Mekhi Ware at the 2-yard line.

The Centaurs then drove 98 yards on 10 plays in one minute, 50 seconds, with Bryce Lewis-Wolfe throwing a 2-yard pass to Deven Osborne for the touchdown 20 seconds before halftime.

Beverly Hills coach Charlie Stansbury called an onside kickoff to start the second half that Enzo Fantau-Barker recovered for the Normans, but they turned the ball over on downs.

Following an exchange of possessions, Lewis-Wolfe threw his third touchdown pass

of the game.

Rashad Ysaguirre lost a fumble on a long pass play on Beverly Hills' first play of the ensuing possession. Culver City then drove 89 yards for a touchdown, with

Frederick Poindexter running the final 27 yards for the score.

Justin Cox ran 71 yards and Cahllil Hooper ran 3 yards for fourth-quarter touchdowns as the Centaurs (7-3, 4-1 in league play, including a forfeit victory over Lawndale in a game Culver City lost on the field 48-41) assured themselves of the league championship.

ADOPTION OF THE FINAL MITIGATED NEGATIVE DECLARATION FOR THE BEVERLY HILLS DOG PARK PROJECT

The City of Beverly Hills has prepared a Mitigated Negative Declaration (MND) for a proposed dog park located at the southeast corner of the intersection of Foothill Road and Alden Drive in Beverly Hills. Mitigation measures have been identified to reduce potential impacts associated with Air Quality, Cultural Resources, Hazards and Hazardous Materials, and Noise to a less than significant level.

The proposed project would involve demolition of an existing asphalt-capped surface parking lot and construction of a new off-leash dog park on the site, with possible internal separation by chain-link fence to differentiate areas of use for large and small animals. The project would involve improvements including new surface materials; benches; shade canopies; trash receptacles; water fountains; and related basic support needs.

This project is being assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City prepared an Initial Study to determine the proposed project's potential impact on the environment. After reviewing the Initial Study, the City determined that this project may have a significant effect on the environment, but by implementing certain mitigation measures, the project's potentially significant effects could be reduced to less than significant levels. Accordingly, a Mitigated Negative Declaration has been prepared.

The MND was previously circulated for a 20-day public review period, from July 31, 2015 to August 20, 2015. Responses to the comments received during this time will be provided in the Final Mitigated Negative Declaration Document.

Any interested person may attend the meeting and be heard or present written comments to the Commission.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak on this matter. Written comments may also be submitted and should be addressed to the City Council, c/o City Clerk, 455 N. Rexford Drive, Beverly Hills, CA 90210. ## Lisa Schwartz Incoming Health & Safety Commission Chair

### What drew you to the Health & Safety Commission?

I had graduated Team Beverly Hills and it came to my attention that two seats were becoming available on the Health & Safety Commission, so I applied. Ironically enough, all of the volunteering and philanthropy I do falls into either the health or safety category, so it was a natural fit for me.

### Explain what your Commission looks for when considering someone for a Health & Safety recognition award.

Each month a commissioner—as part of the Health & Safety recognition program—will honor an individual, business or group who has demonstrated leadership in the field of health and safety issues or made a contribution to the mission of the Health & Safety Commission. We have so many residents and citizens within our city that do so many great things that it should be recognized, even if it's in a small way. Often someone hears or reads that a person or group is getting recognized for doing a great deed or helping within the community that's related to health and safety that merits an award. It makes people happy to see others being honored. Hopefully this can be good motivation to do something for the first time or can motivate people to continue doing good things.

### In a March 2014 interview with the Weekly, you said, "The big thing that [the Health & Safety Commission] has been working on right now is the e-cigarettes, the vaping in the City." What do you find most concerning about e-cigarettes?

Our Commission was asked by, I believe at the time, Mayor [Lili] Bosse, to research and give a recommendation to our City Council to find out what the recommendations of our Commission would be regarding e-cigarettes and vaping. We spent a long time researching, and we were one of the first cities to come out with the recommendation to couple e-cigarettes and vaping with the tobacco laws. I think it sets such a dangerous precedence that a lot of kids and students don't feel that it's harmful. They've added flavoring, for example bubble gum, to lure the kids into thinking it's less harmless.

### What do you think is the greatest challenge to the City's health and safety goals?

To educate our residents and people who work within our city to become aware, because obviously knowledge is power. Whether it's about vaccines, distracted driving and distracted walking or living a healthy life.

### Tell us about your involvement with veterans.

I've been volunteering at a program called New Directions for the last nine years. New Directions is a rehabilitative residential program for veterans who have become addicted to drugs, alcohol or who have become homeless. The New Directions mission is to empower men and women who have served in the military and their families to lead productive and fulfilled lives. We are committed to building a national community in which all at-risk veterans and their families lead lives of honor, dignity, well-being and respect. I became affiliated with it because my aunt was one of the founders of New Directions. She passed away nine years ago and at her funeral I decided that I wanted to carry on her legacy.



a two-day program that our juniors and seniors see. It's our goal for the students of Beverly Hills High School to understand that one wrong choice could be life-changing. So, don't drink and drive; don't use drugs and drive; don't text and drive; don't get in a car with someone who's doing any one of those things, either.

The best part of that program is running into students who tell me that they went off to college the following year and the program changed their mind and they didn't get into the car when someone was drunk or they decided to Uber home instead of get in someone's car—they made the right decisions rather than the wrong decisions.

### Tell us about your family.

My husband Mark [Schwartz] and I love philanthropy and do a lot of charity work. One of the other things I'm very proud of is I've been a volunteer counselor at Camp Dream Street, which is a camp [in Ojai, California] for kids who are terminally and chronically ill. My [daughter] Kirsten has come up and helped me up there and [my son] Kyle has come up and taught baseball to our campers. Both [Kirsten and Kyle] went to Hawthorne and Beverly High.

### How do you define a healthy city?

I define a healthy city by communicating healthy choices for a lifestyle. Another big thing is not being distracted as you're walking, as a pedestrian, [which] is also becoming an issue. Those are two examples that I feel very strongly about.

"The game encapsulates at times what we've experienced this year," Stansbury said after the 28th loss in his 30 games in three seasons as the Normans' coach.

"These kids have played their hearts out. At times we get a bad break here, we get a bad break there.

"In the first half, we had an ability to rally and stay with it. In the second half, we get to a point we feel we're almost in a sand trap. We're doing everything we can to get

out, but a penalty goes against us, a deep ball hits us. Now it's tough to get your head back and keep coming back when you've been through what we've been through."

Said Wolken: "When we get down, we're not a very good team at staying mentally tough. When we were up, it was great. We had the momentum, then we lost it pretty quickly."

Stansbury said Beverly Hills allowed 27 points in the second half partially because "we weren't able to sustain drives on offense. That puts us on defense for a long period."

The Normans opened the scoring on Joe Kolko's 3-yard run with 4:18 left in the first quarter, three plays after Ysaguirre's 32-yard run gave it a first down on the Centaurs' 7-yard line.

## CAN TOUR BUSES BE REGULATED?

**Council to move forward with 10K-pound vehicle weight limit for several city streets**

By Mina Riazi

The City's attempts to alleviate the negative impact of tour bus activity reached new heights November 3, when the Council approved the first reading of an ordinance that establishes a 10,000-pound weight limit for vehicles on several streets within the business triangle.

"Safety is paramount, that was one of the concerns with the buses," Councilmember

Willie Brien said.

Over the past two-and-a-half years, tour bus ad-hoc committee members Brien and Councilmember Nancy Krasne have met several times with tour bus operators and business community members to vet options for managing tour bus activity in the business triangle.

Oversized vehicles impede traffic on

local streets by occupying more than one travel lane, block intersections with left-turn movements and slow or stop vehicles midblock for sightseeing purposes, the staff report reads.

But attorney Jason Lieber, who represents Starline Tours, called the statements "factually incorrect," and asserted the Court will invalidate the statute.

"I'm not aware of any reports, surveys or studies showing a preponderance or an increase in accidents," Lieber said.

Krasne interjected, and stated she has photographic evidence, to which Lieber responded "one incident doesn't make a trend."

"We cannot simply issue a regulation prohibiting one type of conduct, when the true motivation is to prevent a different type of conduct," Lieber said.

The 10,000-pound limit includes the weight of the vehicle and its passenger load, which Mayor Julian Gold said does

not leave much "weight for the passengers."

"Essentially what you're effectively doing is pretty much limiting it to the van and the sprinter," said City Manager Mahdi Aluzri.

The regulation will be established on Rodeo Drive and Canon Drive, between Wilshire and Santa Monica Boulevards; Brighton and Dayton Ways, due to their narrow roadways; Bedford Drive between Wilshire and Santa Monica Boulevards; and South Santa Monica Boulevard, between Wilshire Boulevard and Beverly Drive.

"We've selected the streets that would best allow them to be able to stay in a lane, because some of the lanes are wider," Brien said.

Vehicles delivering goods or people to a specific destination are exempt from the regulation.

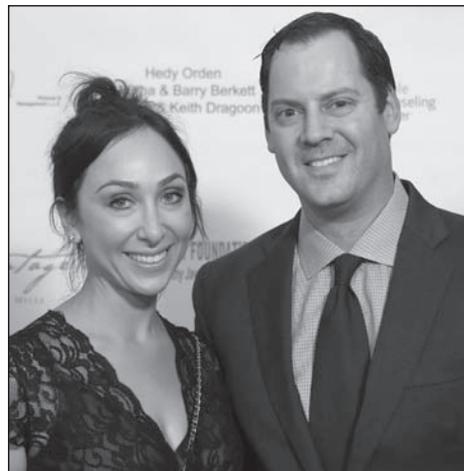

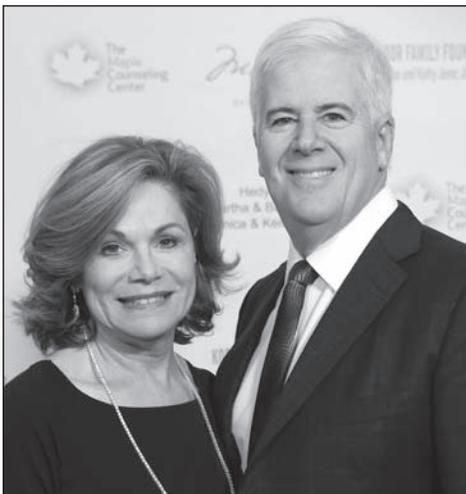

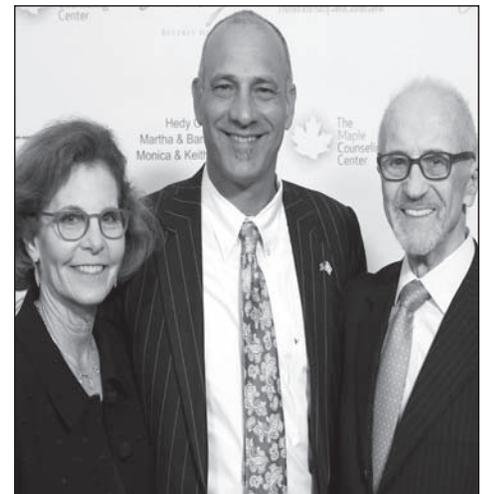

#### ORDINANCE NO. 15-O-2693

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING OUTSIDE EMPLOYMENT

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The City Council hereby amends Section 2-5-212 ("OUTSIDE EMPLOYMENT") of Article 2 ("Personnel Procedures") to Chapter 5 ("CIVIL SERVICE, PERSONNEL PROCEDURES, AND EMPLOYEE REGULATIONS") of Title 2 ("ADMINISTRATION, PERSONNEL, AND PROCEDURES") of the Beverly Hills Municipal Code to read as follows:

#### "2-5-212: OUTSIDE EMPLOYMENT:

A. Prohibition. A City employee shall not accept, participate, or engage in any outside employment or business, whether or not compensated, which is inconsistent, incompatible, or conflicts with the employee's duties, functions, or responsibilities as a City employee. Inconsistent or incompatible employment or business includes, but is not limited to, the following situations:

1. Employment or business which involves hours of work or physical effort which could be reasonably expected to reduce the quality or quantity of the employee's services to the City;

2. Employment or business which involves hours or locations of work which could be reasonably expected to interfere with the employee's availability for overtime emergency services to the City, particularly when the employee is on call for emergency services;

3. Employment or business which is directly or indirectly connected with the employee's duties in the City, such as dealing in merchandise or services with persons contacted in the course of City employment;

4. Employment or business which involves services of the employee in a capacity of advisor, consultant, or witness which could reasonably be expected to conflict with the interests of the City; or

5. Employment or business which causes the employee to become financially interested in any contract, sale, or transaction to which the City is a party.

#### B. Authorization.

1. Full-time employees who desire to (a) engage in outside employment for compensation or operate a business for compensation; or (b) invest or participate in any business venture conducting business in the City of Beverly Hills (except for stock ownership in any company whose capital stock is publicly held and regularly traded), shall first obtain the written approval of the applicable Department Head and the Assistant Administrative Services Director/Human Resources, except that the City Manager, Assistant and Deputy City Managers, and all Department Heads (including the Chief of Police and Fire Chief), shall first obtain the approval of the City Council.

The Assistant Administrative Services Director/Human Resources shall send written notice to the City Council and City Manager within two business days from the date on which any approval is granted relating to a member of the Executive Management Group, other than a Department Head. Any such approval relating to any member of the Executive Management Group shall not become effective until the expiration of 10 business days after dispatch of notice to the City Council and City Manager. The Council may order a review of any approval relating to a member of the Executive Management Group. Such review may be ordered by motion of the Council duly adopted within 10 business days after dispatch of notice to the City Council. If the Council orders a review of a decision approving outside employment or engagement or investment in a business venture, the effectiveness of such decision shall be stayed until Council review is final.

Approval shall not be granted if the employment or business or investment would violate the prohibition set forth in subsection A.

2. Employees who seek approval for compensated outside

employment or to engage or invest in a business must describe the outside employment or business, including the employer, the types of duties or activities involved, the location, hours and duration of employment.

3. The Human Resources Division shall maintain a copy of all written approvals for outside employment, business or investment. Approvals shall not exceed a period of one year; provided, however, further extensions of one year each may be granted if such extension request is filed not later than two months prior to the expiration of the one year term. The employee shall immediately notify the City of any change in the extent or character of the outside employment.

C. For the purposes of this Section, compensation shall not include any cash payment or exchange of non-cash goods or services of less than fifty dollars (\$50) in any one year. Additionally, free admission and refreshments and similar non-cash nominal benefits provided to an employee during an event at which an employee gives a speech, participates in a panel or seminar, or provides a service, and actual transportation and any necessary lodging and subsistence provided directly in connection with the speech, panel, seminar, or service, including but not limited to meals and beverages on the day of the activity, shall not be considered compensation for the purposes of this Section.

D. Employees shall also report to their Department Head the purchase or investment in any real estate or real property improvements in the City of Beverly Hills, except that the City Manager, Assistant and Deputy City Managers, and Department Heads shall make such report to the City Council.

Section 2. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

Section 3. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 4. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
