## Traffic & Parking Continues Preferential Parking Permit Discussion

Continued discussion of the Preferential Parking Permits (PPP) districting process shaped a portion of last Thursday's Traffic and Parking meeting.

Implementation would mean consolidating the multi-family zones on the 100 blocks south of Wilshire Boulevard between Spalding and South Rodeo Drives (District 10) to increase efficiency. The first step to creating districts entails sending a notice and survey card to each dwelling unit in the proposed district area.

The City Council/TPC Liaison Committee recommended moving forward with the first step of the PPP districting strategy on May 4, but Chair David Seidel expressed an interest in further reviewing the proposal, stating that several different zones would be helpful in terms of receiving feedback from the community.

If more than 40 percent of the households in a proposed district return a survey form objecting to the creation of the district, staff cannot proceed with conducting parking occupancy studies.

"We could get into the type of situation where a certain type of zone loves the idea and another type of zone hates the idea, and

then [we] end up with a city where some fraction is in districts and then some fraction is still block by block," said Seidel. "So looking for a variety of types of zones to implement initially would give us better data about what this is going to look like down the road."

The Commissioners explored six other options for multiple-family corridors that could be simultaneously surveyed for districting, proposed by the Liaison Committee.

Citing reasons like simplicity, girth, and opportunity, the Commission expressed support for multi-family zones bordered by Civic Center Drive, Doheny Drive, Burton Way, and Maple Drive—adjacent to the Public Works neighborhood (District 5); and multi-family zones bordered by North Almont Drive, Burton Way, North Clark Drive, and Wilshire Boulevard—adjacent to Robertson and Wilshire business areas (District 7).

If approved, the Commission plans to write a master document of Frequently Asked Questions for affected residents in order to avoid an over-40-percent-objection. They will also post online the facts, reasoning behind the project, and cities that have implemented similar plans in the past, so that people aren't surprised by the changes.

"Residents don't always understand all the ramifications," said Commissioner Jake Manaster. "My hope was that if we got to be efficient enough and there wasn't as much staff time being spent and we had prescribed avenues for people to take, it is a possibility

that the price of this goes down.”

He noted that three permits per year could potentially decrease to \$25 instead of the current price of over \$100.

Staff will now present the pilot program recommendation to City Council, and—barring concerns—proceed with occupancy studies for District 10, and likely Districts 5 and 7.



nation by his classmate, former Beverly High Principal Carter Paysinger '74.


Katleman is a longtime film executive, having served from 1980-1992



The 24-year-old received a misdemeanor citation for Beverly Hills Municipal Code Violation 5-1-104—Excessive Noise, and was issued after officers responded to five other noise complaints from the same location which resulted in verbal warnings.

In a statement, the BHPD said, "These noise violations occurred at a residence in Beverly Hills where Bolingoli was temporarily residing. Bolingoli was released at the scene with the citation and was not physically arrested."

### Hot 8 Yoga to Install Signs During Metro Construction

Hot 8 Yoga, located on 8383 Wilshire Boulevard, will implement three temporary business identification signs during the Purple Line Extension construction following the Architectural Commission's unanimous approval.

The Commission reviewed applicant and Hot 8 Yoga owner Vincent Nicoletta's proposal on June 21, who argued that the Los Angeles County Metropolitan Transportation Authority (LACMTA)'s construction of the

Purple Line has impeded patron's view of his retail locations.

Currently, two eight-square-foot illuminated signs account for the total signage of Hot 8 Yoga, but Nicoletta said at the meeting that despite his signage, his business is down almost 20 percent. Many people, he states, avoid Wilshire Boulevard. Certain parts of the street are also closed entirely on weekends, which accounts for almost one fourth of his business.

Nicoletta's proposal for three signs follows an ordinance adopted on April 20 that allows certain businesses along Wilshire Boulevard impacted by the Metro construction to request additional temporary signage.

"I would respectfully like to remind the Commission that one of the purposes of the code is to keep me in business. I shouldn't be disproportionately paying for the subway," said Nicoletta at the meeting. "I'm a subway proponent; I'm from Manhattan; I love the fact that there's subways coming in, but I feel like I'm paying a little bit more than the rest of the citizens and to ask for a few signs that are lit I don't think is that unreasonable."

Commissioner Michelle Kaye acknowledged the negative impacts on his business, but questioned the necessity of the third sign, contending that the allowance of this sign might encourage "every other business [to] start asking for more and more signage."

But Nicoletta said that the "slippery slope" argument can be alleviated by understanding that his business is located on a corner that will be obstructed on several sides.

## Design Review Denies North Beverly Permit Request

The Design Review Commission unanimously denied a proposal for an R-1 Design Review Permit that would have allowed an addition and remodel of 708 North Beverly Drive.

Architect Carla Vaga of William Hefner Architects submitted the proposal for the two-story single-family residence, located in the City’s Central Area, north of Santa Monica Boulevard.

The remodel would have included a mix of more traditional and contemporary architectural styles in addition to a rich landscape palette and a reduction of stone veneer cladding. The front façade would also have created shadow lines to lend the appearance of greater depth. According to the staff report, the design would “allow for a more cohesive architectural expression and serve as an enhancement to the streetscape.”

Vaga has described the proposed style as “French Revival,” but because it doesn’t adhere to a pure architectural style, the Commission needed to review the request.

Commissioner Barry Bernstein questioned the applicant’s reasoning behind and elevation of the proposed remodel, contending that the existing house is already “charming.”

“[The current house has] got color, [it’s] got shade, shadow—it’s really very dynamic,” said Bernstein.

But Vaga responded by saying that the current house is actually not true to its Mediterranean style, whereas the remodel encompasses a more “pure” design.

Even with a more “pure” design, though, the Commissioners noted that the proposed plan still doesn’t fit the “French Revival” description. The roofline, for instance, should be much steeper if it were to be considered French.

Additionally, all the Commissioners agreed that the proposed design is much too “stern” and would like to see a new iteration before approving the project.

“This design looks like a very serious face,” said Commission Chair Mahnaz Sharifi Ardani. “You need some smile; you need some jewelry; you need some flavor to this design. It needs some more detailing.”

A complete redesign of the project will appear before the Commission on August 3.



# NOTICE OF PUBLIC HEARING

The Beverly Hills City Council, at its regular meeting to be held on **Tuesday, July 18, 2017, at 7:00 p.m.**, in the City Hall Council Chamber, 455 N. Rexford Drive, Beverly Hills, CA, will hold a public hearing to consider adoption of:

**AN ORDINANCE OF THE CITY OF BEVERLY HILLS PROHIBITING ALL COMMERCIAL CANNABIS ACTIVITY (BOTH MEDICAL AND NON-MEDICAL) EXCEPT FOR DELIVERIES OF MEDICAL CANNABIS, AND FINDING THE ORDINANCE EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT**

The proposed Ordinance would amend the definition of “person” contained in Section 1-2-1 of Chapter 2 of Title 1 of the Beverly Hills Municipal Code to include the words cooperative and collective as part of the definition.

The proposed Ordinance would add Article 47 to Chapter 3 of Title 10 of the Beverly Hills Municipal Code to prohibit all commercial cannabis activity in the City. “Commercial cannabis activity” is defined to include the cultivation, possession, manufacture, distribution, processing, storing, laboratory testing, labeling, transportation, delivery or sale of cannabis and cannabis products. The term “commercial cannabis activity” also means and includes the activities of any business licensed by the State or other government entity under Division 10 of the Business and Professions Code, as it may be amended from time to time. The prohibition on commercial cannabis activity would apply to cannabis used for medical, non-medical, or any other purpose.

The proposed Ordinance contains an exception that allows for the delivery of medical cannabis into the city. Additionally, consistent with State law, the prohibitions adopted under the proposed Ordinance will not prohibit a person twenty-one (21) years of age or older from: (1) possessing, processing, purchasing, transporting, obtaining or giving away to persons twenty-one (21) years of age or older, without compensation whatsoever, not more than 28.5 grams of marijuana not in the form of concentrated cannabis or up to eight (8) grams in the form of concentrated cannabis; (2) smoking or ingesting marijuana or marijuana products; or (3) possessing, transporting, purchasing, obtaining, using, manufacturing or giving away marijuana accessories to persons twenty-one (21) years of age or older without compensation whatsoever, to the extent that such activities are authorized by Health and Safety Code Sections 11362.1 and 11362.2, as the same may be amended from time to time.

The Planning Commission, at a duly noted public hearing conducted on June 22, 2017, approved a resolution recommending that the City Council adopt an Ordinance which will add Article 47, Cannabis Prohibitions and Regulations, to Chapter 3 of Title 10 of the City’s zoning code, and recommending that the City Council find that the Ordinance is exempt from the requirements of the California Environmental Quality Act (“CEQA”) and the City’s CEQA Guidelines pursuant to CEQA Guidelines Section 15061(b)(3) because it can be seen with certainty that there is no possibility that the Ordinance will have a significant effect on the environment. The proposed Ordinance will not result in a permanent alteration of property nor the construction of any new or expanded structures.

After the Planning Commission considered and made a recommendation on the proposed Ordinance, the Governor signed SB 94 into law, the Medicinal and Adult-Use Cannabis Regulation and Safety Act. The ordinance presented to the City Council will take into account revisions prompted by SB 94.

Any interested person may attend the meeting and be heard or present written comments to the City Council.

According to Government Code Section 65009, if you challenge the City Council’s action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

ticularly during events.

The project zone is located at 360 North Rode Drive, and has received verbal support from local businesses such as Valentino, Salvatore Ferragamo, Geary's, Tom Ford and the Rodeo Drive Committee.

The City Council discussed the proposal at their June 29 meeting, where several comments cropped up such as that the proposal should have gone to Traffic and Parking Commission first, and that the valet operators must address the Uber and Lyft "situation" by creating a designated drop-off spot to mitigate the increasingly prevalent issue of drivers stopping in the middle of traffic for passengers.

Another question that arose is how the service would ensure public access. The proposed signage originally had the word "Luxe" written on it, which Councilmember Lester Friedman noted could confuse people into assuming the service only pertains to hotel-goers.

"I just want to make sure [the valet service is] successful in that people know they're

going to be able to use it," said Friedman.

Assistant Director of Public Works Chad Lynn said the hotel has since changed the signage to clearly state that the service is open to the public.

Thanks to the Council's unanimous approval, the \$9,284 proposal will begin in mid-July and run through August, with the hope of continuing on into the future pending a data report.

"The Drive as a whole has been crying out for this service. It's not just about the hotel visitors; we service anyone who would like to park a car with us," said Adam Sydenham, the Regional General Manager of Luxe Hotels. "Phase one is to show you what value we can bring to the B.O.L.D initiative, and then we'd love to come back and discuss a more long-term partnership."

### Fine Arts Commission to Handle Cultural and Art Activities

At the request of Councilmember John Mirisch, the City Council discussed and subsequently supported a proposal to expand

the Fine Arts Commission to handle cultural and art activities.

The item, discussed at the June 20 study session, was originally proposed as creating an entirely new commission. Mirisch

Manhattan Beach, and Malibu.

Their duties include, but are not limited to, encouraging cultural education programs in the community and schools, and advising the City Council on policies affecting the arts and cultural life of the city.

Mirisch stated that because the endow-

ments of the arts in this year's budget have been threatened, the City should work to show local support in whatever ways it can. The Wallis and Theater 40 have expressed their support for the proposal.

He also noted that while Beverly Hills charges an effective Fine Arts Commission, it serves as more of an "art acquisition committee."

"The arts and culture in general are so much more than just the acquisition of fine arts," said Mirisch. "It's theater, it's dance, it's music, it's photography—it's so much more and we really have no Commission to promote any of these kinds of activities."

But Mayor Lili Bosse said that while she agrees with the proposal, she does not think an entirely new Commission is necessary, contending that the Fine Arts Commission would be best suited to expand and handle the activities in question.

"This would be another way to promote the culture of our city," said Bosse. "[The Fine Arts Commission could] reach out to the Wallis and reach out to our other cultural institutions and see how this could be synergistic."

Fine Arts Commission Chair Alan Kaye, however, expressed concern regarding the issue of staffing. He stated that the Commission is already responsible for a

## Mahnaz Sharifi Design Review Commission Chair

### What inspired you to apply for the Design Review Commission?

I have an architectural background. I was always interested in architecture and commenting on architecture and critiquing architecture. I just happened to pass by one of the Design Review Commission meetings when I was in the library getting some books, and saw a [sign] which invited people to come to the Design Review Commission. I thought, "Oh, what a cool thing to do! You get to not only criticize but also look at other peoples' work, comment on it and enhance the neighborhood." So I really liked the idea, [and applied when] I saw there was an opening. I think that because of my architecture background and because I already had some idea about design, it was enough to get the position.

### How does the Design Review Commission differ from the Architectural Commission?

I haven't [been on] the Architectural Commission so I'm not sure exactly what [it] is all about. I'm assuming that in the Architectural Commission, there is more of a familiarity with code and also that the projects are on a bigger scale, but I'm not really familiar with the Architectural Commission. The Design Review Commission goes hand in hand with Architecture; they're very much related. You need to be able to read the plans, the elevation—even if you are not an architect, you need to have a good knowledge of architecture to be able to comment on the design.

### What are the top priorities of your Commission?

It's to create a city that is in harmony. As a whole, it's to bring a garden-like quality;

[we have] five criteria we always judge the projects on. That's the main mission statement of the Design Review Commission: to make sure that each project is enhancing the neighborhood and the city as a whole.

**When the *Weekly* interviewed former Design Review Commission Chair Arline Pepp in issue #832, she said, "To me, [if] you have an existing streetscape— and let's say the houses are all of a certain type of design or mixed design—the new house can be different, but it has to be of the same scale, the same proportion, and the same quality of design." Do you agree?**

Yes, I agree. I don't feel that all the projects need to be the same; I don't feel the city has to remain in the same shape that it was several years ago. Every era has its own mission. For me, I feel that this is our era—we are in 2017—and we need put our own pace for the future. [Just because] architecture style after 2000 is [considered] contemporary style, doesn't mean that every contemporary style is a good style. I think it's nice to have different styles and to have buildings all over from different eras. But at the same time they need to be in harmony; it shouldn't be that when a new build-



ing comes, suddenly all the neighbors feel that project is the only one getting noticed and [that people] are disregarding the rest of the neighborhood. I think the perfect neighborhood would be [where] all the projects in the neighborhood feel as one—that they're not exactly the same but that they fit together well.

At the same time, they all have their own flavor. Like every other creature in this world, trees [for example] are all different but at the same time trees are trees. They all have specific characteristics. Or like people—we're all different, but at the same time we're all people.

**The Design Review Commission was created to "control mansionization of the City's residential neighborhoods." Do you feel the Commission has accomplished this goal?**

I think it definitely has. When I pass by or drive by the neighborhoods, there are some projects where I think "Oh, this project is very different from other projects that we've [seen before]" and with a little research I figure out that, yes, this project was before the Design Review Commission existed. There is much more consistency and much better designs, I would say, after the Design Review Commission was put in place.

Tell us about your career as a realtor.

I have a Master's Degree in architecture. Most of my architecture experience has been overseas. I have some experience here in the U.S. I

was a senior architect at an international firm in the Middle east. Then I moved to the U.S, did architecture for some time, and then I felt I wanted to break free from a nine to five job, and I wanted to have my own business. So I started my real estate business. I'm very happy. It's very different from architecture,

which is a very introverted profession, [whereas] real estate is very extroverted. But the product is the same, so I'm happy. My architecture background helped my real estate knowledge. I'm looking into combining both in the future.

### Tell us about your family.

I live here by myself. I'm single. I don't really have a family here; [some of] my family lives in San Jose, [like] my parents and my uncle. And the rest of my family is in Iran.

### What's in store for the next year of the Design Review Commission?

The Design Review Commission has gone through changes this year. Three of our more senior Commissioners, whom I've learned from a lot, have left the Commission or retired. We have three newer Commissioners. I've been in the Commission for two and a half years. My Vice Chair [Ilona Sherman] has been in the Commission maybe a year. So we have a very new Commission, and my goal is to basically make sure I support all the other Commissioners and make sure that everybody is on the same page. Everybody has a different communication style and different backgrounds in what they're most experienced in—some people are more comfortable in landscape and some people are all about architecture, so I want to make sure that we complement each other.

myriad of topics, many of which are delayed for extended periods of time. "Adding new responsibilities to our commission would not be reasonable based on our current staffing and organization," wrote Kaye in a letter.

The Council discussed the possibility of adding an extra charge to accommodate the expansion of the Commission, but the fiscal impact is currently unknown.


"With the caveat that resources are going to have to be reallocated so that it can be handled efficiently and properly, I would be supportive," said Councilmember Lester Friedman.

The Council will now send a notice to the Fine Arts Commission that they are looking into implementing these changes and determine next steps.

## PLANNING THE FUTURE

### Planning Commission Chair Lori Greene Gordon on “smart development”

**You’ve just been appointed Planning Commission Chair. What drew you to the commission in the first place?**

I’ve lived here most of my life. When I was 19 years old [in the early 70’s], I ran for a seat on the Board of Education. At that point in time, they had just allowed 18-year-olds to vote so I thought this was the perfect opportunity to get involved at a real grassroots level. Ironically I ran a campaign where there were 13 candidates. I came in sixth. Three were elected—one of whom is the cur-

rent Board president, Mel Spitz. But I established myself, as a very young person, as someone who was interested in the community, active in the community.

I’ve been active ever since—many years of raising my kids and being active in PTA and all of that. And I reached a certain stage in my life where I was available and interested in being involved on a deeper level in the community. My experience and my background, in many respects, has to do with building, construction, real estate. So I have a good handle of that, [of] being able to

take a look at a set of plans and be able to read them. I’ve always been able to really understand the complex concepts even though I’m not an attorney. And I thought it was a perfect fit for me so I applied and happily was chosen to be on the Planning Commission.

**In issue #875 of the Weekly, outgoing Planning Commission Chair Farshid “Joe” Shooshani said, “Everybody on the commission wants to do the best for the city, but the question is we have different approaches to it.” What’s your approach?**

My approach is to look at all the issues, and really try to separate them out. We’re in a community that has many divergent interests. We have residents who obviously have an interest because of their home, and everyone feels very strongly about the place they live. We have business interests who certainly are, in many respects, the life blood of our community in terms of financing our lifestyle, so we have to be cognizant of that. I think what my approach would be is to try and look at it from a holistic perspective, to try and understand all the sides that are coming to us, try to really come to a meeting with an open mind. Really one of the most important things I think any commissioner should do is do your research, do your homework, understand what the project is, visit the site—I feel very strongly about always visiting the site, walk the area, know what the area is like, and then come to the meeting with an open

mind. You’ll hear things at a hearing that you [didn’t] even expect were coming at you. People will

come up and make statements—sometimes it’d developers; sometimes it’s people in the community—and when you hear these things, it doesn’t help make the decision for you but it helps guide your decision. I think that’s my approach.

**What have you learned from Joe?**

Joe and I have worked together for the past year, and I’ve learned that he and I have different approaches. We focus on different aspects of what makes a project important. I’m extraordinarily detail-oriented. In fact I’m the person [who] asked that we see all the entitlements when we look at a project, because sometimes we get projects that have been entitled over a number of years in different ways. I’m very research-oriented and I think it’s really important. We get all the entitlements

now, in our packets. So I focus on detail. And Joe is a lovely man; I like him very much. We just have different approaches.

**Would it be accurate to say that you’re the most slow-growth of the five commissioners?**

I don’t know if I’d take a label like that, but I believe very strongly in adhering to the General Plan. I believe strongly that we have a 45-foot, three story limit for a reason. And every time somebody would like to exceed that limit, I’d like to know why. I want to know how this is good for the community. I understand that it’s good for the developer, [but] I also want to understand how it’s good for the community. So I guess from that perspective, I want to make sure that we try and preserve as much of our community as we can. If we didn’t have that regulation, then whatever. But we do. And if we have it, people put it in place for a reason.

**Do you think there’s too much development in Beverly Hills?**

I don’t think there’s too much development in Beverly Hills. I think in order for a community to be vital, it has to continually reinvent itself because if you’re only sticking with what was there in the 1960’s, clearly it’s not the same community. Clearly we don’t have the same needs. We don’t have the same retail environment. We don’t have the same demographics in our community. I want to see development, but I want to see development that’s

smart, I want to see development that is not just good for the developer but good for the community, and I want to see something that always keeps us on the cutting edge of being

vital. Beverly Hills is vital; it has to maintain its vitality because we’re a world-renowned city. People know of Beverly Hills in probably every corner of the earth. We can’t just be what we were, but we have to be smart about it and we have to be considerate about it.

**How can the City best be smart and considerate about development?**

We have to be aware of the impact on the residents, and I’m not talking about the short-term impacts because the short-term impacts can be mitigated. Something being constructed—it’s always a mess, but that’s short-term and you have to be able to live with that in any community. I’m talking about the long-term impacts: the traffic, the parking. And I think we’re changing. I think society as a whole is changing. I think the subway is going to make a big difference to the city. I think

that if the automated cars ever become a reality—which I certainly hope they do—that’s going to make a difference in terms of the amount of parking that’s required. I think that if we can make any kinds of changes at all to reduce the amount of cars on the road...anything that we can do. We have to be aware of how our community can continue to grow, continue to be vital, and continue to mitigate the impact on the residents. It’s a

approaches. You have to be mindful of all of those things. It’s a tough balancing act and I really think that every time I make a decision, I try and focus on the larger issue.

**You’re an accomplished harpist. Tell us about that.**

I’ve been playing the harp since I was a ten-year-old. My uncle [Ernest Katz] was a symphony conductor and he had the oldest symphony orchestra in the western United States. It

was called the “Junior Philharmonic.” So my brothers and I became musicians. My oldest brother Gary [Greene] is a violinist and has his own orchestra called the “LA Lawyers.” My other brother Terry [Greene] is a cellist. When it came to be selecting an

instrument I chose the viola and my mother said, “No, no, no, that’s not the right instrument for you.” So I came home one day and there was a harp in the living room. I started playing with my uncle’s orchestra and then I played at UCLA when I was a student there. I still play—occasionally you’ll see me at the Peninsula Hotel. I love to play; I have many harps and I play them when I can.

**Tell us about your family.**

I have my husband Neil Gordon who is a television director and producer. And my daughters—my eldest is Victoria [Gordon] who is an alum of Beverly. She graduated two years ago from USC and she is a writer, actress, producer. She does short films. And my younger daughter Natalie [Gordon] just graduated from USC School of Cinematic Arts in May, and she is now going to embark on her career in the film business.

**What is your top priority as Chair?**

In addition to a lot of significant projects coming down the pipe, I would like to see the community have some more under-

standing back and forth about what goes on. Things become escalated very fast—if a group of people don’t like a particular project, it has to be a fight. And I don’t want to see fights in the community; I want to see a little more harmony in our community. I think it’s important to bring up issues when they are significant but I think we can do it in a way that doesn’t become developers against residents. I’d also like to work with the City Council when we can so that decisions made by the Planning Commission are not called up as frequently as they have been in the past. I think that will be important. [We should] have respect and understanding in the community from all sides, and if we have that kind of environment we’re going to have better projects, better community relations, and I’m very much in favor of seeing that. Not everyone’s going to be happy all the time, but I want everyone to feel like they’re being heard, that their opinion is respected, and that the decision made is what we deem [will be] best for the community.

## **Beverly High Cafeteria Food Quality Back on the Menu**

Although it wasn’t on the agenda, discussion about the quality of cafeteria food at Beverly High shaped a portion of July 11’s Board of Education meeting.

What originally started as an approval of a new point of sale system for food services, turned into something much bigger when Board member Isabel Hacker asked when the Board could continue an ongoing conversation about the “horrible” cafeteria food currently served at Beverly High.

“I’m glad we’re doing some improvement to our systems, but I’d like to really get to the core of the actual meal,” said Hacker. “I wouldn’t buy [cafeteria food] for my kids. I wouldn’t even punish them by having them eat it. That’s how terrible it is.”

Chief Administrative Officer La Tanya Kirk-Carter said that because the District has such a low free and reduced count, it can only rely on the money coming in from the students.

In order to achieve the coveted balance of staying in the black and serving healthy foods, Food Services Director Heather Oyamo visited the San Dieguito School District, which has a very similar population to the BHUSD in terms of being basic aid and having a low free and reduced count.

It also, however, manages to offer a wide selection of menu items, from sushi to an entire “farm to table” section.

“The way to figure it out is to figure out what other districts are doing, and [what districts] are doing it right,” said Kirk-Carter.

Although Board member Noah Margo commented that the discussion left the scope of the agenda item, the Board did agree to bring it back at a later date. Students and parents will be invited to participate and share their own experiences with cafeteria food, an ongoing complaint Hacker says she has seen time and time again.

“Believe them, don’t believe me,” said Hacker.


