

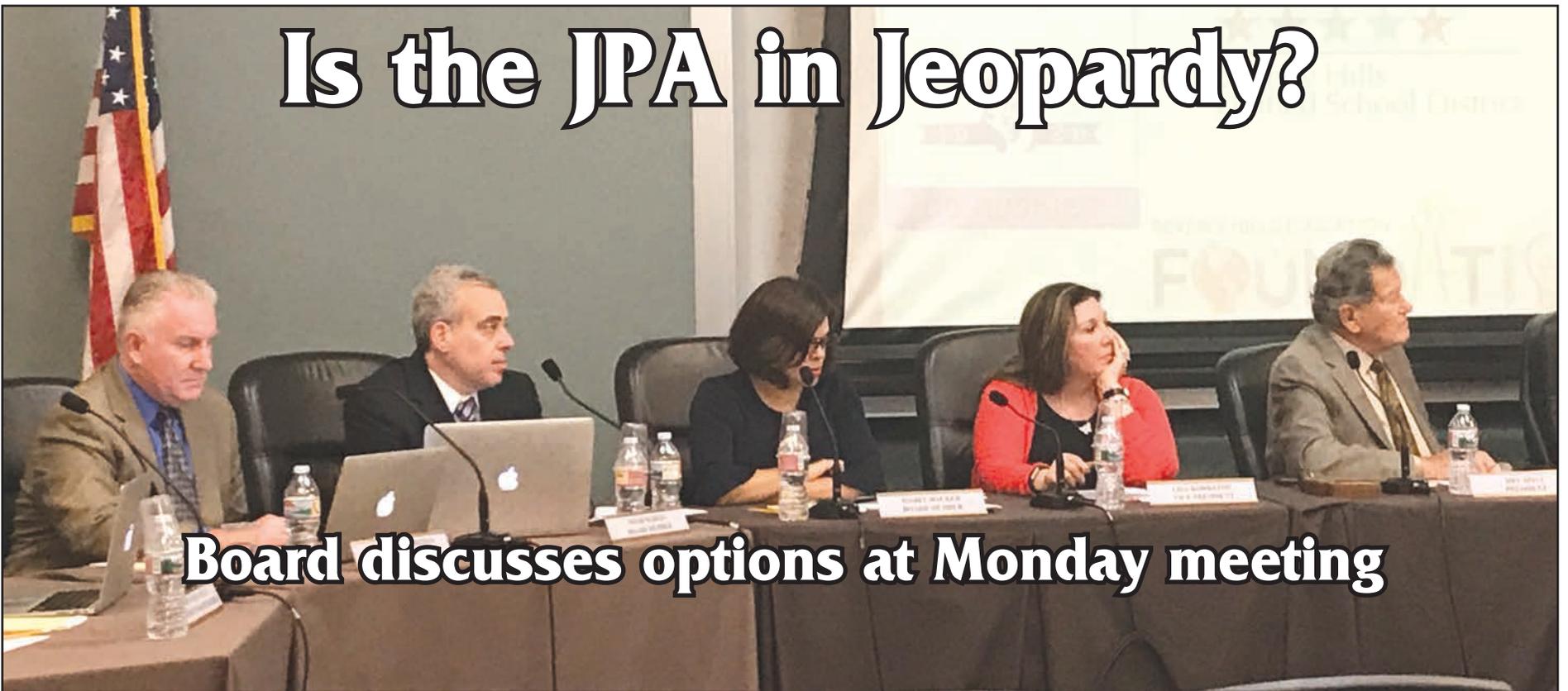

## South Clark Preferential Parking Permit Zone Discussion to Move to City Council

At their meeting on October 5, the Traffic and Parking formally voted 4-0 to recommend that City Council approve the installation of preferential parking permits on the 100 block of South Clark Drive. Commissioner Jay Solnit recused himself.

Back in September, the Traffic and Parking Commission reviewed a qualifying petition signed by 60 percent (12 out of 20) households on that block, requesting a daytime permit parking regulation of “No Parking, 8:00 a.m. to 6:00 p.m., Daily, Except by Permit.”

After the meeting on September 6, five written correspondences were received. Two residents on the block expressed support of the petition, and two individuals—that did not provide an address—expressed opposition. One business representative sent a correspondence stating that they were neutral on the topic.

At the latest meeting, resident Amir Dar called the anonymous oppositions “not very credible,” suggesting that they could potentially be the same person and urging the council to not consider them.

Staff conducted several parking occupan-

cy surveys, the most recent of which on September 17 from 12:00 p.m. to 6:00 p.m. On average, 18 percent (5 of 28 spaces) of the on-street parking spaces between the alley south of Wilshire and Charleville were occupied during the 6-hour survey period, with an average of 11 percent of the spaces occupied by commuter vehicles.

At last Thursday’s public comment, Hawthorne Principal Michelle Halimi Dar called the entire process “democracy at its best,” thanking the commission for recognizing community concern and hearing out the residents.

“When people don’t want their names to be on paper, it says a lot,” said Dar. “So when 13 out of 20 residents are putting their name on a piece of paper, they’re obviously very concerned about something.”

Dar also requested that Sundays receive a regulation, as originally requested, citing ongoing parking issues that have resulted in multiple tickets and even a car that was impounded.

At deliberation, Commissioner Pamela Hendry said that it is necessary to find a balance, expressing her support for a Monday through Saturday regulation from 8:00 a.m. to 6:00 p.m. This, she said, would maintain consistency with the blocks around it.

“I have to think about the community and balance—both the needs of the individuals on the street versus what we’re trying to accomplish city-wide,” said Hendry.

But, ultimately, Hendry said she can think

## NEXT STOP: BEVERLY HILLS

Through Fall 2017, Metro contractors will be relocating utilities on Wilshire Bl from Beverly Dr to Crescent Dr, the future home of the Purple Line Extension’s Wilshire/Rodeo Station. The first step in building the station is coordinating with privately owned utility companies such as Southern California Edison to relocate utility lines. Typically, relocation consists of excavating a trench, covering it with metal plates when not working on it, installing new service vaults or manholes to protect underground utilities, placing new pipe or conduit, and restoring the street.

about the issue “from both sides.” Along with the rest of the commission, she voted in favor of a Permit “CC” exemption for the 100 block of South Clark Drive, “No Parking 8:00

a.m. to 6:00 p.m. Daily, except with permits. The item will appear before the City Council most likely on November 7.

**Board Approves Beverly High Temporary Security Fence**

After debate about the necessity of a temporary security fence along Moreno Drive in front of Beverly High, the Board approved the agreement at their meeting on Tuesday.

The decision follows the Board’s approval in May 2016 of a resolution authorizing the Superintendent to approve and execute agreements under \$45,000. The resolution requires these agreements to be ratified by the Board of Education.

The fence will sit on the remaining part of the front lawn that runs from the current construction fence along the sidewalk to the corner of the tennis courts. It contains two gates—one on the north end and one on the south end—which allows workers to lock the site and keep the public away during off

hours.

The temporary fence was authorized by the Board on August 8. With Southern California Industries, the total cost of the fence is \$16,749.

Board member Noah Margo acknowledged that although it’s not a large sum of money, he is opposed to the fence. Margo said that perhaps as B1 and B2 begin construction, the contractors may potentially need to utilize the front lawn. He also cited several other potential factors like the future of the field and the oil well.

“There are so many unknowns floating up in the air right now that it’s hard-pressed for me to support this,” said Margo.

On the other hand, though, Board President Mel Spitz stated that security is a top priority and a primary reason as to why the fence should be approved.

Board member Howard Goldstein also

noted that as someone who lives in the area, he has witnessed balls flying into the street and kids running after them without looking.

“It’s an incredibly dangerous situation,” said Goldstein. “If we can increase the security of our students, I’m all for it.”

The item was ultimately approved 4-1, with Margo dissenting.

### BHPOA Honors Recipients at Black and White Ball

The BHPOA held its annual Black and White Ball on Tuesday, honoring several recipients.

Explorer Lucas Ellin received the Explorer of The Year Award; Disaster Communication System (DCS) members Norman Riker and Marty Geimer received the Lawrence I. Shapiro Award; BHPD Officer Michael Corren received the Albert H. Lightfoot Award; BHPD Forensic Specialist Segalit Oz received the Distinguished Service Award; BHPD Officer Rodney Solorzano received the Officer of the Year Award; and BHPD Officers Alexander Rhee and Erik Pena received the Life Saving Award.

### Board Approves Williams Uniform Complaint Summary

At their meeting on October 9, the Board of Education approved the quarterly Williams Uniform Complaint Summary.

It must be presented to the Board for approval every quarter (October 20; January 19, 2018; April 20, 2018; and July 20, 2018).

The most recent report summary is for July 1 through September 30. All schools in California are affected by new laws that are the result of the Williams lawsuit settlement.

Known as the “Williams legislation,” the

laws seek to ensure that all students have equal access to the basics of a quality education: textbooks, safe and decent school facilities and qualified teachers.

The laws focus on the state’s lowest-performing schools. Williams creates an expanded role for the county superintendent of schools to monitor and report on low-performing schools.

In LA County, LACOE is responsible for conducting annual visits of the county’s 600 low-performing schools and determining whether students have access to sufficient instructional materials and clean buildings.

In the BHUSD summary, Superintendent Michael Bregy indicated that no complaints were filed with any school in the district during the quarter.

With the Board’s approval, the report will now be forwarded to the Los Angeles County Superintendent for approval.

### Harlem Quartet Returns to The Wallis

The Harlem Quartet will return to the Wallis on October 15 at 7:30 p.m.

Praised for its “panache” by The New York Times, the acclaimed quartet is “bringing a new attitude to classical music, one that is fresh, bracing and intelligent,” says the Cincinnati Enquirer. That new attitude will be on full display at The Wallis when they return with Harlem Quartet: Game-Changers.

### City to Hold Annual artSHOW

The 44th annual Beverly Hills artSHOW will take place on October 21 and 22. Held in Beverly Gardens Park, the event will feature master sculptor Gedion Nyanhongo.

Many artists create by building – Gedion Nyanhongo creates by subtracting. “The natural configuration of a stone calls to me and I remove what doesn’t belong,” said Nyanhongo.

“All the while, it’s as if the stone is guiding my hand to release the spirit inside.”

Using the basic hammer and chisel to carve, Nyanhongo also scrapes, drills, files and sands by hand. Sculptures range in size and weight from five pounds to over 155 pounds.

At a very young age, Gedion Nyanhongo learned the techniques of the Shona Sculpture Movement that began in his homeland of Zimbabwe, Africa and skillfully continues to adhere to this traditional style. He imports

### Maple Counseling Center Offers Free Mental Health Services Following Vegas Shooting

On October 7, the Maple Counseling Center offered free mental health services to those impacted by the Las Vegas shootings.

In addition to offering its team of counselors for over two hours, the non-profit mental health center also provided information about the topic of grief counseling and how tragic events like Las Vegas are increasing the rise of stress among Americans.

The purpose of the event aimed to alleviate as much anxiety as possible. According to a press release, 42 percent of adults who need counseling do not receive help in Los Angeles County. This is mostly because they do not have access or the financial means to services.

The recent tragedy as well as the disasters in Texas and Puerto Rico, coupled with higher levels of economic uncertainty, family distress and the current political climate, has caused a spike in stress levels, said the press release. If left untreated, anxiety can lead to deteriorating mental health problems, chronic physical health problems, homelessness and job stability issues, and in certain occasions, incarceration.

Open six days a week, the Maple Counseling Center counselors treat a range of issues, including anxiety, depression, family and relationship conflicts, and grief.

stone from Zimbabwe mines such as serpentine, springstone, opal, lepidolite, and verdite.

### Traffic and Parking Commission Discusses Luxe Rodeo Drive Hotel Parking Extension

The Traffic and Parking Commission discussed last Thursday a request for continuation of expanded valet parking and a waiver request for the Luxe Rodeo Drive Hotel.



Luxe Rodeo Drive Hotel

Staff initially recommended authorizing a partial waiver of maximum potential lost revenue associated with removed meters for the time period September 7 to November 1.

Staff also initially recommended authorizing the extension of the expanded valet service through the holiday season (November 2 to January 2, 2018) and partial waiver of maximum potential lost revenue associated with removed meters.

The partial waiver would leave a cost to the valet operator for the lost revenue associated with the removed meters of \$3,427 for September 7 to November 1 and \$3,526 for November 2 to January 2, 2018.

The potential revenue waived would be \$3,743 for the time period September 7 to January 2, 2018.

The commission discussed the potential downsides and benefits to the Luxe Hotel and other tenants along Rodeo Drive, which, according to the staff report, will "invite the public to the valet/concierge operation and showcases that the service is open to the public."

The valet operator stated that the daily activity for non-hotel visitor cars more than doubled during Mayor Lili Bosse's BOLD initiative.

The daily average of Rodeo Drive shops cars before BOLD, was 22. After BOLD it was 57. Before BOLD, the daily average of Ubers, Lyfts and Taxis was 49. After BOLD it was 90.

At deliberation, the commission

debated whether or not the request would serve a benefit from a revenue standpoint. Ultimately, they wrote a letter that will go to City Council expressing their thoughts and opinions.

"This particular request could be made by an extremely large number of commercial blocks and individual businesses throughout the city," read Chair David Seidel. "Extraordinary care should be made to identify explicitly why this special request is being made to the point of qualifying it in the Municipal Code."

The request will now be presented to City Council at a future date.

### Planning Commission Prepares for Upcoming Projects

Coming before the Planning Commission

this quarter are several large-scale projects.

Among others, a proposal has been requested to rezone two parcels of 128 and 130 South Carson Road from single-family residential zones to multiple residential zones.

The project would include a General Plan amendment in order to reflect the changed zone and designate the parcels as Multi-family residential low density.

"They're big projects," Planning Commission Chair Lori Greene Gordon told

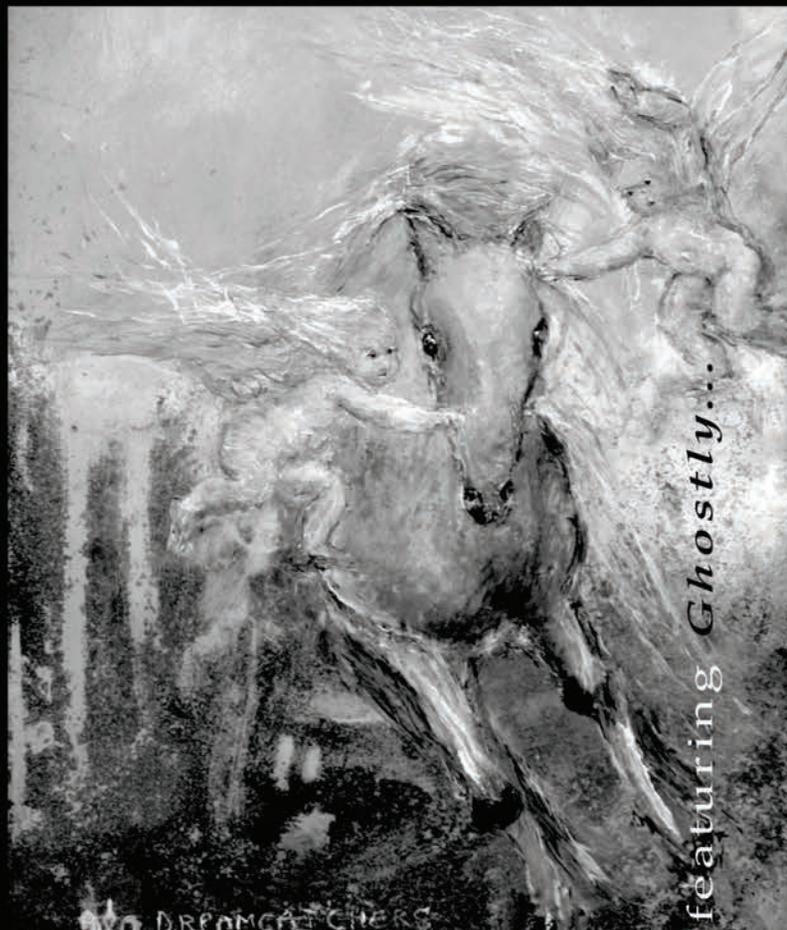

## IS THE JPA IN JEOPARDY?

### Board discusses options at Monday meeting

By Olivia Anderson

At their meeting on October 9, the Board of Education carved out time for a discussion regarding the future of the Joint Powers Agreement (JPA).

Board President Mel Spitz called for this item to appear on the agenda in order for the Board to discuss the consequences of terminating the agreement.

The JPA agreement between the BHUSD and the City, which expired on June 30, is now currently in a second 60-day extension to reach consensus on a renewal negotiation.

Previously, the City requested that the district provide a cost analysis of the JPA to the school district. This would

justify their request to increase the JPA from \$9.7 million to \$13.5 million.

The BHUSD then commissioned a \$50,000 contract with firm Moss Adams to provide a financial assessment of the JPA. The report found that the costs to operate and administer the JPA increased from \$7.5 million in the 2008-2009 school year to \$9.3 million in the 2015-2016 school year.

The Board maintains that the increase would allow the district to rent out and maintain facilities, but three of the five auditoriums remain closed.

In his statement on Tuesday, Spitz pointed out that the JPA revenue of \$9.7

million amounts to 1/6 of the district's total revenue, noting that the JPA expenditures incurred are mostly for utilities, repairs and janitorial personnel.

Estimating that those expenditures result in a net cash flow inflow of \$7 to \$8 million, Spitz said that losing that revenue stream would "throw the district into insolvency."

Spitz criticized the suggestion that the district replace the JPA by renting district facilities to outside users. "Every problem and risk we encounter in administering the

During the discussion, Board member Noah Margo kept his comments concise

and to the point: "I am happy to have the JPA as long as we don't need the JPA."

But an ending to the JPA could be imminent should both sides fail to reach a negotiation, noted Councilmember John Mirisch. "It's not an amendment of the constitution or set in stone," said Mirisch. "If both

sides don't [come to] an agreement, then generally it will come to an end."

## HOLIDAY LIGHTING BUDGET TO EXCEED \$2 MILLION

### The Business District will receive enhanced holiday décor

The cost of Beverly Hills' new BOLD Holidays lighting budget will cost a total of \$2,495,581, according to the Public Information Manager.

On August 8 staff provided an overview of enhanced holiday décor for

the Business District, including Bacarat lighting on Rodeo Drive and enhanced holiday lighting elements for streets like North and South Beverly Drive.

Staff consulted with the City holiday program contractor Utopia Worldwide Inc. to look at various options for enhancing the lighting on La Cienega and

Robertson Boulevards. The proposed holiday lighting consists of off the shelf designs this year, as it is too late for any custom designs to be built for the area.

The Council went with the last of four proposed options; it will consist of white LED tree lights on La Cienega, but will add various colored spheres in different sizes to the 41 trees on La Cienega in lieu of snowfall LED lights. Robertson will be decorated with multi-colored LED tree and snowfall lights as the vendor for the spheres does not have enough LED spheres in stock to decorate the trees on both La Cienega and Robertson. It will require \$241,465 in additional funding, which is included in the total costs.

Mayor Lili Bosse said that this enhancement will encourage people to open businesses and walk on Robertson



more, saying the street "will come to life."

"I think this is an investment in our future," said Bosse. "It will bring forward a more vibrant business community."

The CVB received

\$1,150,000 for the holiday lighting with \$150,000 for marketing. They have \$1,000,000 for North Beverly Drive (\$350,000), South Beverly Drive (\$200,000), North Canon Drive (\$300,000), and Beverly Canon Gardens (\$150,000).

The Rodeo Drive Committee received \$540,000 on August 8 for Bacarat and enhancing their median décor lighting to correspond to the light switch. This was in addition to the \$200,000 for median décor. Their total is \$640,000.

These costs exclude all of the year round lighting that will stay up during the holiday.

ORDINANCE NO. 17-O-2737

AN ORDINANCE OF THE CITY  
OF BEVERLY HILLS AMENDING  
CHAPTER 4 OF TITLE 5 OF THE  
BEVERLY HILLS MUNICIPAL  
CODE TO REGULATE SMOKING  
IN MULTI-UNIT RESIDENCES  
AND COMMON INTEREST  
DEVELOPMENTS

WHEREAS, tobacco use causes death and disease and continues to be an urgent public health threat, as evidenced by the fact that 480,000 people die prematurely in the United States from smoking-related diseases every year, making tobacco use the leading cause of preventable death.<sup>1</sup> Tobacco use can cause disease in nearly all organ systems and is responsible for 87 percent of lung cancer deaths, 79 percent of all chronic obstructive pulmonary disease deaths, and 32 percent of coronary heart disease deaths.<sup>2</sup> The World Health Organization estimates that tobacco accounts for the greatest cause of death worldwide accounting for nearly 6 million deaths per year.<sup>3</sup>

WHEREAS, secondhand smoke has repeatedly been identified as a health hazard as evidenced by the U.S. Surgeon General concluding that there is no risk-free level of exposure to secondhand smoke;<sup>4</sup> the California Air Resources Board placing secondhand smoke in the same category as the most toxic automotive and industrial air pollutants by categorizing it as a toxic air contaminant for which there is no safe level of exposure;<sup>5,6</sup> and the California Environmental Protection Agency including secondhand smoke on the Proposition 65 list of chemicals known to the State of California to cause cancer, birth defects, and other reproductive harm.<sup>7</sup>

WHEREAS, since 1964, approximately 2.5 million nonsmokers have died from health problems caused by exposure to secondhand smoke. Secondhand smoke is responsible for an estimated 41,300 heart disease-related and lung cancer-related deaths among adult nonsmokers each year in the United States.<sup>8</sup> Secondhand smoke kills more than 400 infants every year.<sup>9</sup> Secondhand smoke exposure adversely affects fetal growth with an increased risk of low birth weight and of Sudden Infant Death Syndrome in infants of mothers who smoke.<sup>10</sup> Just 30 minutes of exposure to secondhand smoke is sufficient to damage blood vessels in a healthy nonsmoker.<sup>11</sup>

WHEREAS, secondhand aerosol emitted from electronic smoking devices has been identified as a health hazard<sup>12 13 14</sup> as evidenced by research finding at least ten chemicals known to the State of California to cause

cancer, birth defects, or other reproductive harm, such as formaldehyde, acetaldehyde, lead, nickel, and toluene to be present in electronic smoking devices.<sup>16 17 18</sup>

WHEREAS, it is the intent of the City Council of the City of Beverly Hills to provide for the public's health, safety, and welfare by discouraging the inherently dangerous activity of smoking around non-consenting individuals, protecting children from exposure to smoking where they live and play, and protecting the public from nonconsensual exposure to secondhand smoke in and around their homes.

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Code Amendment. Section 5-4-1 (DEFINITIONS) of Chapter 4 (SMOKING REGULATIONS) of Title 5 (PUBLIC HEALTH, WELFARE, AND SANITATION) of the Beverly Hills Municipal Code is hereby amended to add the following definitions, in alphabetical order, with all other provisions of Section 5-4-1 remaining in effect without amendment:

**"COMMON AREA:** Every interior or exterior area of a multi-unit residence or common interest development that residents of more than one unit of the multi-unit residence or owners of more than one unit of the common interest development are entitled to enter or use, including, for example, halls, paths, lobbies, courtyards, elevators, stairs, community rooms, recreation areas or rooms, playgrounds, gym facilities, swimming pools, jacuzzis, parking garages, parking lots, restrooms, laundry rooms, cooking areas, and eating areas. Common area shall also mean "common area" as defined in California Civil Code section 4095, or any successor legislation."

**"COMMON INTEREST DEVELOPMENT:** Shall mean (1) a community apartment project as defined in California Civil Code section 4105, or any successor legislation, (2) a condominium project as defined in California Civil Code section 4125, or any successor legislation, (3) a planned development as defined in California Civil Code section 4175, or any successor legislation, and (4) a stock cooperative as defined in California Civil Code section 4190, or any successor legislation."

**"EXISTING LEASE:** Any lease or rental agreement that allows a person to occupy a unit that was entered into before January 1, 2018."

**"HOME OWNERS ASSOCIATION or HOA:** An organization or entity established for the purpose of managing and/or maintaining a common interest development. A homeowners association shall also mean "association" as defined in California Civil Code section 4080, or any successor legislation."

**"LANDLORD:** Any person who owns property let for residential use."

**"MIXED HOTEL/COMMON INTEREST DEVELOPMENT PROJECT:** A project that is comprised of both a hotel and a common interest development. The project can be in any configuration such as, but not limited to, the hotel and common interest development being located in separate buildings, or the hotel and common interest development being located on separate floors of the same building."

**"MULTI-UNIT RESIDENCE:** A residential property containing two or more units on the same lot, where one or more of the units is offered for rent. The following types of housing are specifically excluded from this definition:

1. A single-family home;
2. A detached or attached accessory dwelling unit on a single-family zoned property;
3. A hotel;

4. A common interest development; and
5. A mixed hotel/common interest development project.

**"NEW LEASE:** Any lease or rental agreement that allows a person to occupy a unit that was entered into, amended, or renewed on or after January 1, 2018. This includes any month-to-month lease that is renewed after January 1, 2018.

**"OWNER:** The owner of a "separate interest" as that term is defined in California Civil Code section 4185, or any successor legislation."

**"UNIT:** Any personal dwelling space in a multi-unit residence or common interest development. A unit shall include any associated exclusive-use area, such as, for example, a private balcony, porch, deck, or patio. A unit shall also have the same meaning as "separate interest" as that term is defined in California Civil Code section 4185, or any successor legislation."

Section 2. Code Amendment. Section 5-4-18 (PENALTIES AND ENFORCEMENT) is hereby renumbered as Section 5-4-20 (PENALTIES AND ENFORCEMENT) and a new Section 5-4-18 (SMOKING REGULATIONS FOR MULTI-UNIT RESIDENCES) is added to Chapter 4 (SMOKING REGULATIONS) of Title 5 (PUBLIC HEALTH, WELFARE, AND SANITATION) of the Beverly Hills Municipal Code to read as follows:

**"5-4-18: SMOKING REGULATIONS FOR MULTI-UNIT RESIDENCES:**

Smoking in multi-unit residences shall be governed by the following rules:

A. Beginning January 1, 2018, the following regulations apply:

1. Smoking is prohibited in all common areas.
2. Smoking is prohibited in all units governed by a new lease.
3. A landlord shall not permit the presence of ash trays, ash cans, or other receptacles designed for, or primarily used for, the disposal of smoking waste within any common area.
4. Every new lease shall include a provision substantially consistent with the following: "Beverly Hills Municipal Code section 5-4-18 prohibits smoking in all common areas in a multi-unit residence, and in all units governed by a lease that was entered into, renewed, or amended after January 1, 2018. It is a material breach of this lease for the tenant, or any other person subject to the control of the tenant or present by invitation or permission of the tenant, to engage in smoking on the property, including in the unit and common areas (as those terms are defined in Beverly Hills Municipal Code section 5-4-1), or to violate any law regulating smoking while anywhere on the property."

B. On or before January 1, 2018, the following regulations apply:

1. The landlord shall post, or shall cause to be posted, clear and unambiguous "No Smoking" signs in sufficient numbers and locations in the multi-unit residence to make it obvious to a reasonable person that smoking is prohibited in all common areas. The signs shall have letters of no less than one inch in height or contain the international "No Smoking" symbol (consisting of a pictorial representation of a burning cigarette enclosed in a red circle crossed by a red bar). Such signs shall be maintained by the

landlord. The absence of signs shall not be a defense to a violation of any provision of this chapter.

2. The landlord shall provide written notice to all tenants whose units are governed by existing leases stating that (1) smoking is prohibited in all common areas of the multi-unit residence beginning January 1, 2018, (2) any unit that is governed by a lease that was entered into on or after January 1, 2018 is designated as a non-smoking unit, and (3) any unit that is governed by a lease that was entered into before January 1, 2018 will be designated as a non-smoking unit when the lease is renewed or extended, or January 1, 2019, whichever is earlier, unless an earlier date is chosen by the landlord. The landlord does not need to comply with this provision if smoking is already prohibited in all common areas and units in the multi-unit residence.

C. In addition to the above, beginning January 1, 2019, smoking is prohibited in all units.

D. If the landlord has fully complied with Sections 5-4-18(A)(4) and B(1) and (2), the landlord shall not be criminally or civilly liable to any person for a person's breach of any smoking provision while on the multi-unit residence."

Section 3. Code Amendment. Section 5-4-19 (SMOKING REGULATIONS FOR COMMON INTEREST DEVELOPMENTS) is hereby added to Chapter 4 (SMOKING REGULATIONS) of Title 5 (PUBLIC HEALTH, WELFARE, AND SANITATION) of the Beverly Hills Municipal Code to read as follows:

**"5-4-19: SMOKING REGULATIONS FOR COMMON INTEREST DEVELOPMENTS:**

Smoking in common interest developments shall be governed by the following rules:

A. Beginning January 1, 2018, the following regulations apply:

1. Smoking is prohibited in all common areas.
2. The HOA, or any person having legal ownership over the common areas of a common interest development, shall not permit the presence of ash trays, ash cans, or other receptacles designed for, or primarily used for, the disposal of smoking waste within any common area.

3. If an owner enters into a new lease to lease a unit to a tenant, that unit shall be designated as a non-smoking unit until such time as the owner resumes the occupancy of the unit. Any new lease for the occupancy of a unit in a common interest development entered into, renewed, or amended on or after January 1, 2018, shall include a provision notifying the tenant that it is a material breach of the lease or other rental agreement to allow or engage in smoking in the common interest development. Such clause shall be substantially consistent with the following: "It is a material breach of this agreement for the tenant, or any other person subject to the control of the tenant or present by invitation or permission of the tenant, to engage in smoking on the property, including in the unit and common areas (as those terms are defined in Beverly Hills Municipal Code section 5-4-1), or to violate any law regulating smoking while anywhere on the property."

B. On or before January 1, 2018, the following regulations apply:

1. The HOA, or any person having legal ownership over the common areas of the common interest, shall post clear and unambiguous "No Smoking" signs in sufficient numbers and locations in the common interest development to make it obvious to a reasonable person that smoking is prohibited throughout the common interest development. The signs shall have letters of no less than one inch in height or contain the international "No Smoking" symbol (consisting of a pictorial representation of a burning cigarette enclosed in a red circle crossed by a red bar). Such signs shall be maintained by the HOA or any person with legal control over the common areas of the common interest development. The absence of signs shall not be a defense to a violation of any provision of this chapter.

2. The HOA shall provide written notice to all owners of units clearly stating that (1) smoking will be prohibited in all common areas of the common interest development beginning January 1, 2018, and (2) that all units will become non-smoking beginning January 1, 2019. The HOA does not need to comply with this provision if smoking is already prohibited in all common areas and units in the common interest development.

C. In addition to the above, beginning January 1, 2019, smoking is prohibited in all units.

D. If the HOA Board has fully complied with Sections 5-4-19 (A)(2), and (B) (1) and (2), the HOA shall not be criminally or civilly liable to any person as a result of a owner or any other person violating the smoking regulations while on the common interest development's property. If an owner has fully complied with Section 5-4-19(A)(3), then the owner shall not be criminally or civilly liable to any person for a tenant or a tenant's guest violating the smoking regulations while on the common interest development's property.

E. The above-referenced regulations will apply to a mixed hotel/common interest development project except as follows:

1. The regulations will not apply to the buildings, portions of the buildings, or any other areas that are designated as part of the hotel including, but not limited to, hotel rooms, and common areas that are used by hotel patrons and guests.
2. The regulations will not prohibit the designation of a smoking area in the hotel portion of the project regardless of whether the designated smoking area can be used by both hotel patrons and owners.
3. The regulations will not prohibit smoking at hotel swimming pools consistent with Section 5-4-2."

Section 4. Code Amendment. Section 5-4-20 (PENALTIES AND ENFORCEMENT) of Chapter 4 (SMOKING REGULATIONS) of Title 5 (PUBLIC HEALTH, WELFARE, AND SANITATION) of the Beverly Hills Municipal Code is hereby amended to add a new subsection E to read as follows:

"E. No provision of this Chapter shall authorize a criminal prosecution prohibited by Health and Safety Code sections 11362.71, et seq. or 11362.1, et seq. In the event of any conflict between the penalties enumerated under Title 1 of the Beverly Hills Municipal Code and any penalties set forth in State law, the maximum penalties allowable under State law shall govern."

**Section 5. CEQA.** The City Council hereby finds that it can be seen with certainty that there is no possibility the adoption of this Ordinance will have a significant adverse effect on the environment because the Ordinance only expands upon existing smoking use restrictions. It is therefore exempt from California Environmental Quality Act review pursuant to Title 14, Section 15061(b)(3) of the California Code of Regulations.

**Section 6. Severability.** If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance for any reason is held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

**Section 7. Publication.** The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation, published and circulated in the city within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this city.

**Section 8. Effective Date.** This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.

ORDINANCE NO. 17-O-2738

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE REGARDING CHARITABLE

## SOLICITATIONS

WHEREAS, the City Council, upon recommendation by the Charitable Solicitations Commission, desires to amend the charitable solicitations provisions in the Beverly Hills Municipal Code regarding solicitation for charitable events occurring within the City of Beverly Hills.

NOW, THEREFORE, the City Council of the City of Beverly Hills does hereby resolve as follows:

**Section 1.** The City Council hereby amends and restates Article 8 ("CHARITABLE SOLICITATIONS") to Chapter 3 ("OTHER ACTIVITIES REQUIRING REGULATORY PERMITS") of Title 4 ("REGULATION OF CERTAIN TYPES OF BUSINESSES AND ACTIVITIES") to read as follows:

### "Article 8. Charitable Solicitations

#### 4-3-801: PERMIT REQUIRED:

No person shall engage in or carry on any solicitation or event for contributions for any charitable purpose without a permit issued under the provisions of chapter 1, article 1 of this title.

#### 4-3-802: EXEMPTIONS:

A. Except as provided in subsection B of this section, the provisions of this article shall not apply to an organization which solicits contributions from among the members of such organization, to solicitations or collections made upon premises which are owned or occupied by such organization, or to organizations that are formed by the City and whose accounts are managed and maintained by the City.

B. The provisions of this article shall not apply to a retail business that represents that any portion of the proceeds from the sale of merchandise will be used for a charitable purpose.

#### 4-3-803: DEFINITIONS:

The following definitions shall apply to this article:

**CHARITABLE:** Means and includes the words patriotic, philanthropic, social services, welfare, benevolent, educational, civic or fraternal, either actual or purported.

**CHARITABLE ORGANIZATION:** An organization recognized as a 501(c)(3) organization by the Internal Revenue Service, i.e. eligible to receive tax-deductible contributions.

**CONTRIBUTIONS:** Means and includes food, clothing, money, subscriptions, property or donations given or solicited either directly or under the guise of a loan.

**EVENT:** A single solicitation activity.

**EVENT PLANNER:** A person who is hired by a charitable organization to coordinate the planning or execution of a charitable event or solicitation.

**HOTEL:** As defined in section 10-3-100 of this code.

**HOTEL EVENT COORDINATOR:** A person who is hired by a hotel to accommodate the planning and execution of charitable events and solicitations held at that hotel and executes the contract for this purpose.

**MONETARY DRIVE:** Multiple solicitation activities by a single organization for a single purpose in a twelve (12) month period, including membership drives or solicitations by mail or telephone, but not including events such as dinners, carnivals, fairs or dances.

**SOLICIT AND SOLICITATION:** The direct or indirect request for money, pledges, credit,

property, financial assistance or other thing of value either by way of donation or as consideration for services, or the sale of merchandise when representation is made that any portion thereof will be used for a charitable purpose. A solicitation shall be deemed completed when such a request has been made.

#### 4-3-804: APPLICATIONS:

A. Applications for a charitable solicitation permit shall be filed with the city a minimum of fifteen (15) days prior to the date the proposed solicitation is to commence. Each application shall indicate whether the proposed solicitation is an event or a monetary drive.

B. The application shall be accompanied by a financial statement of the applicant for the previous such solicitation, if conducted within Beverly Hills by the applicant, setting forth the funds collected for charitable purposes by the applicant, and stating the amount raised through solicitations, together with the cost of raising such amount and the final distribution thereof; and an authorization for city inspection of the applicant's financial records and files.

C. Renewal applications shall be filed ten (10) days prior to expiration of the existing permit.

D. No fee shall be charged for a solicitation permit required by the provisions of this article.

#### 4-3-805: REVIEW OF APPLICATIONS BY CHARITABLE SOLICITATIONS COMMISSION:

After filing of the application, the application shall be submitted to the charitable solicitations commission for review and recommendation. The commission shall review the application, and shall also review any information furnished by the police department, based on their investigation of the applicant; and the commission shall then make a recommendation to the official empowered by the city to grant or deny the permit.

#### 4-3-806: COMMISSION RECOMMENDATION:

The city official empowered to grant or deny the application may consider the recommendation of the commission prior to acting on the permit request, provided further, the official is not bound by the recommendation, and shall grant or deny the permit based solely on the criteria set forth in section 4-3-807 of this article. If the commission fails to make a recommendation within ten (10) days after filing of the application, the city official empowered to act on the application may grant or deny the permit without a recommendation from the commission. The city official empowered to act on the application shall grant or deny the permit within fourteen (14) days after filing of the application, and shall grant or deny the renewal of an existing permit prior to the expiration of such permit.

#### 4-3-807: GENERAL CRITERIA FOR ISSUANCE OR DENIAL:

A. In lieu of the criteria for issuance or denial of a permit under provisions of section 4-1-103 of this title the following criteria shall apply to issuance or denial of a solicitation permit under this article. The permit will be issued by the official designated by the city to act on the application unless there is a finding that:

1. The information contained in the application is incomplete, false, or intentionally misleading.

2. The kind, character, and method of the solicitation, the time when it will take place or its duration are such that the solicitation will be inimical to the safety, convenience, or welfare of the inhabitants of the city.

3. If the application is for a renewal or subsequent permit, that the applicant has violated provisions of the previous permit, or the ordinances or regulations of the city in the conduct of previous solicitations.

B. Notwithstanding the presence of one or more grounds for denial listed above, the city official empowered to act on the application may approve the permit if the applicant agrees to abide by such conditions as imposed by the official to negate any circumstances that would otherwise justify denial.

**4-3-808: TERM OF PERMIT:**

A solicitation permit issued for an event pursuant to this article shall be valid until one hundred eighty (180) days from the date of issue, or until the completion of the event, whichever comes first. A solicitation permit issued for a monetary drive pursuant to this article shall be valid until twelve (12) months from the date of issue, or the completion of the monetary drive, whichever comes first.

**4-3-809: PERMITS NONTRANSFERABLE:**

Any permit issued for solicitation under provisions of this article is non-transferable notwithstanding section 4-1-112 of this title.

**4-3-810: NONDISCRIMINATION:**

The official designated by the city to act on permit applications shall uniformly consider each application upon its merits and shall not discriminate in granting or denying permits and shall not deny any permit based upon political or religious grounds or reasons.

**4-3-811: RESTRICTIONS AND PROHIBITIONS:**

Any solicitation regulated by this article shall comply with the following provisions:

A. Solicitation upon private residential premises is prohibited at premises that contain a conspicuously posted sign stating "no solicitation" or "do not disturb", unless the solicitor has been invited to the premises by the owner or occupant thereof.

B. Solicitation by means of a box or other receptacle shall be prohibited in, upon or adjacent to any street, alley, sidewalk, park, or other public place; or in or upon any place of business or other place open and accessible to the public; unless the permit specifically authorizes this type of solicitation.

C. Solicitation of funds for a purpose other than designated in the permit shall be prohibited.

D. Solicitors shall not misrepresent their physical or mental health, or make other false or misleading representations.

E. Solicitors shall not touch, come into physical contact with, or affix any object to the person of any member of the public, without first receiving express permission therefor from such member of the public.

F. Solicitors shall not persistently and importunately solicit any member of the public after such member of the public expresses a desire not to be solicited.

G. Solicitors shall not solicit from persons who are standing in lines, seated in public areas, waiting at bus stops or similarly stationary for a specific purpose that would not allow evasion of the solicitation.

H. Solicitors shall not intentionally or deliberately obstruct the free movement of any member of the public on any street, sidewalk, or other place, or in any place open to the public generally.

I. All solicitations made by mail shall include a copy of the solicitation permit.

J. Charitable events involving solicitations of funds shall have a copy of the permit prominently displayed on the premises.

K. Solicitors shall have in their possession at all times, when engaged in the activity regulated by this article, a copy of the solicitation permit, and shall display said copy upon request of any person being solicited.

**4-3-812: WRITTEN RECEIPTS REQUIRED FOR DONATIONS:**

Any solicitation regulated by the provisions of this article which results in a contribution of one dollar (\$1.00) or more in value shall require the solicitor to furnish a written receipt to the person making the contribution upon request of such person.

**4-3-813: RECORDS AND REPORTS:**

A. The permittee shall compile and retain for a period of not less than three (3) years detailed records and a financial statement showing the amount of funds raised by the solicitation, the amount expended in collecting such funds, including a detailed report of the wages, fees, commissions, and expenses paid to any person in connection with such solicitation, and the disposition of the balance of the funds collected by the solicitation.

B. Within sixty (60) days of the expiration of the permit, the permittee shall file a complete and detailed report of the information required by subsection A of this section with the city. Such report shall be a public record and be available for public inspection. Failure to provide the report to the City in accordance with the provisions of this paragraph is a violation of this Code and shall subject the violator to the penalties set forth in Article 3 of Chapter 3 of Title 1 of the Code, including, without limitation, the payment of administrative fines imposed pursuant to Article 3 of Chapter 3 of Title 1.

**4-3-814: HOTEL REGULATIONS:**

Prior to executing the lease or rental agreement, any hotel that leases or rents facilities to a charitable organization for a charitable event or solicitation shall provide the prospective lessee or renter with a city issued charitable solicitations packet or website address that describes the requirements of this article.

**4-3-815: CHARITABLE SOLICITATION REPORTING:**

Any event planner or hotel event coordinator that executes a contract to assist a charitable organization with a charitable event or solicitation shall notify the Commission of the charitable event or solicitation. The notification shall be contained in a report submitted to the Commission twice a month that includes the following information:

A. Name of the organization.

B. Date of the event.

C. Location of the event.

D. Solicitor/Organization contact information."

**Section 2. Severability.** If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

**Section 3. Publication.** The City Clerk shall cause this Ordinance to be published at least

once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and his certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

**Section 4. Effective Date.** This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.

**ORDINANCE NO. 17-O-2739**

**AN ORDINANCE OF THE CITY OF BEVERLY HILLS ESTABLISHING AN EXPEDITED PERMITTING PROCESS FOR ELECTRIC VEHICLE CHARGING STATIONS, AND AMENDING TITLE 9 OF THE BEVERLY HILLS MUNICIPAL CODE**

WHEREAS, the State of California and the City of Beverly Hills have consistently promoted and encouraged the use of electric vehicles; and

WHEREAS, in 2015 the State of California adopted Assembly Bill 1236, which requires local agencies to adopt an ordinance that creates an expedited, streamlined permitting process for electric vehicle charging stations; and

WHEREAS, creation of an expedited, streamlined permitting process for electric vehicle charging stations will facilitate timely and cost-effective installation of such charging stations, and encourage the use of electric vehicles to help reduce the City's reliance on environmentally damaging fossil fuels.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

**Section 1.** Article 1 of Chapter 1 of Title 9 of the Beverly Hills Municipal Code is hereby amended by adding a new Section 9-1-120 to read as follows:

**"9-1-120: EXPEDITED PERMITTING PROCESS FOR ELECTRIC VEHICLE CHARGING STATIONS:**

A. Applicability. This section applies to applications for expedited building permits for electric vehicle charging stations consistent with California Government Code Section 65850.7.

B. Definitions. The following definitions shall apply for purposes of this section:

1. "Electric vehicle charging station" or "charging station" means any level of electric vehicle supply equipment station that is designed and built in compliance with Article 625 of the California Electric Code, as it read on January 1, 2016, and delivers electricity from a source outside of an electric vehicle into a plug-in electric vehicle.

2. "Electronic submission" means a submission of an application utilizing email, the internet, and/or facsimile transmission.

3. "Specific, adverse impact" means a significant, quantifiable, direct, and unavoidable impact, based on objective, identified, and written public health or safety standards, policies, or conditions as they existed on the date an application was deemed complete.

**C. Process.**

1. The building official shall adopt a checklist of all application requirements for expedited building permits for electric vehicle charging stations. The checklist shall substantially conform to the most current version of the "Plug-In Electric Vehicle Infrastructure Permitting Checklist" found in the "Zero-Emission Vehicles in California: Community Readiness Guidebook" published by the Governor's Office of Planning and Research. The checklist, application form, and any other documents required by the building official shall be published on the City's website.

2. Anyone seeking to install an electric vehicle charging station at any site within the City may apply to the building official for an expedited nondiscretionary building permit.

3. An application for an expedited building permit for an electric vehicle charging station, and all associated documentation, may be submitted to the building official in person, by mail, or by electronic submission. Electronic signatures may be used in lieu of wet signatures.

4. An application that, in the opinion of the building official, satisfies the information requirements of the checklist adopted by the City shall be deemed complete.

5. If an application for an expedited building permit is deemed incomplete, the building official shall provide a written correction notice of the deficiencies and the additional information required to complete the application.

6. If the building official determines that an application for an expedited building permit is complete, the building official shall process the application. If the building official determines that the proposed charging station meets all health and safety requirements of state and federal law, and would not have a specific, adverse impact upon the public health or safety, the application shall be approved and a building permit shall be issued.

7. If the building official finds, based on substantial evidence, that a proposed charging station could have a specific, adverse impact upon the public health or safety, the City may require the applicant to apply for an electric vehicle charging station use permit in order to install the proposed charging station.

8. An application for an electric vehicle charging station use permit shall be reviewed by the building official. The building official shall not deny such an application without making written findings, based upon substantial evidence in the record, that the proposed charging station would have a specific, adverse impact upon the public health or safety which could not feasibly be satisfactorily mitigated or avoided. The written findings required for rejection of an electric vehicle charging station use permit application shall include the building official's basis for rejecting any potentially feasible alternatives that could mitigate or prevent the alleged adverse impact. Pursuant to Government Code Section 65850.7, the building official's review shall be

limited to health and safety issues. Aesthetic concerns, or other items not related to public health or safety shall not be considered.

9. A decision of the building official made pursuant to paragraphs 6-8 of this subsection may be appealed to the Planning Commission. The Planning Commission's review shall be subject to the same limitations as that of the building official, and only health and safety issues may be considered.

10. Any condition imposed on an application for an expedited building permit or electric vehicle charging station use permit shall be designed to mitigate the specific, adverse impact upon health and safety at the lowest possible cost.

D. Fees. The City Council may establish by resolution fees that shall be charged for permits issued under this section."

**Section 2.** Any provisions of the Beverly Hills Municipal Code or appendices thereto

that are inconsistent with the provisions of this Ordinance are hereby repealed or modified to give effect to the provisions of this Ordinance, to the extent of such inconsistencies and no further.

**Section 3.** Exemption from the California Environmental Quality Act. The City Council finds that the adoption of this Ordinance is exempt from the California Environmental Quality Act (CEQA) pursuant to the General Rule (14 C.C.R. Section 15061(b)(3)) because the project involves updates and revisions to existing administrative building permit regulations consistent with California law, specifically Government Code section 65850.7. It can be seen with certainty that the Municipal Code text amendments adopted herein will have no significant negative effect on the environment. Additionally, the adoption of this Ordinance is categorically exempt from further environmental review as a regulatory action taken to protect natural resources and the environment in support of state and local climate action goals pursuant to CEQA Guidelines, 14

C.C.R., Sections 15307 and 15308.

**Section 4.** Severability. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of any competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have passed this Ordinance, and each and every section, subsection, sentence, clause, or phrase not declared invalid or unconstitutional without regard to whether any portion of the Ordinance would be subsequently declared invalid or unconstitutional.

**Section 5.** The City Clerk shall certify to the adoption of this Ordinance.

Section 6. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
