

Planning Commission to Discuss 9900 North Santa Monica Project

At their Thursday meeting the Planning Commission is expected to discuss a City-initiated Zone Text Amendment to add surface parking lots, film production staging, construction staging, partial assembly of temporary model building components, and temporary construction offices within the T-1 and T-2 Transporta-

Additionally, the project includes a request by the owner Roxbury Managers for a conditional use permit to allow for construction-related parking and staging associated with an offsite project on a vacant lot located at 9900 North Santa Monica Boulevard. This request would allow for the project site to be used for construction parking and the staging of materials and temporary offices for One Beverly Hills located to the north of the site.

It is also proposed that the site be used as a privately-operated surface parking lot after the construction of One Beverly Hills has concluded.

The site is currently a vacant lot. It has recently been used for construction and parking for the Waldorf Astoria project. The project site is located within the T-1, Transportation Zone, which is part of a strip of properties that run along the south side of North Santa Monica Boulevard.

The T-Zone Parking Map was established for the allowable uses in the T-1 and T-2 zones. Properties located in the zone were able to establish surface parking lot uses if the property was identified on the map. Originally the map included three city-owned properties. These properties were removed from the map when the properties were rezoned in 1998.

From 1998 until 2015, no eligible properties were included on the T-Zone Parking Map. In 2015, the City Council adopted a resolution to temporarily add 9900 North Santa Monica Boulevard to the map. This amendment allowed 9900 North Santa Monica Boulevard to be used during the construction of the Waldorf Astoria.

Part of the resolution made it so that the map will automatically cease to be in effect at the conclusion of the sixth year, unless the City Council approves an extension.

Since this approval was not renewed prior to its expiration, 9900 North Santa Monica was removed from the map. Subsequently, the map does not identify any eligible properties at the moment.

It is proposed that instead of using a process where properties are temporarily added to allow for parking and construction-related uses, that the municipal code be amended to instead allow these uses be approved through a conditional use permit. This is intended for a more regular process through which the Planning Commission may review each request.

Arts and Culture Commission Discusses Judy Chicago Proposed Acquisition

At last Tuesday's meeting the Arts and Culture Commission discussed updated information for the installation of the sculpture titled Trinity by artist Judy Chicago.

This sculpture was recommended for acquisition at the 2022 Fine Art Priority Exercise by the Commission, and it will be presented to the City Council/Arts and Culture Liaison for consideration at their March 23 meeting.

The Arts and Culture Council Liaisons had previously reviewed this proposed acquisition at their Aug. meeting, and had recommended at that time the southwest corner in front of the Crescent Drive garage elevator structure in City Hall as the preferred location for installation of this sculpture

On Nov. 18 Chicago joined City staff for a site visit and agreed to install the sculpture at the selected site. The artist also identified an alternative location for installation at Beverly Gardens Park at the Canon Block. During this visit the artist placed the mock-up of the sculpture on both sites with her desired orientation.

Two significant changes were identified at the time of the artist's visit:

Requirement to install the artwork on a concrete base to ensure longevity and protection of the artwork, instead of installing the artwork flushed to the grass. The artist

has selected Musky Mulberry as the color to be used for the concrete base which is intended to complement the artwork. She also preferred the alternative location at Beverly Gardens Park to be the Canon Block, instead of the Rodeo Block.

Since these two changes deviate from the original information that was reviewed, the updated information will need further review and approval.

City staff is also seeking approval to increase the amount that was allocated for cost from the originally approved amount of \$500,000 to \$550,000, to account for inflation and the recommended integral concrete colored base.

City Council Extends City Manager Contract

In a 4-1 vote, the City Council extended the term of Nancy Hunt-Coffey's employment agreement as City Manager until March 31, 2026, at their Tuesday meeting.

Councilemmber John Mirisch voted against the employment agreement because he believes the pay raise is too high.

According to the staff report, the employment agreement increases her annual base salary from \$366,221 to \$391,400. The modified salary is equal to former City Manager George Chavez's salary upon his retirement. To mitigate the financial impact of the salary increase, the Amendment reduces the management incentive pay from \$975 per month to \$625 per month. It also lowers the annual cost of living increase to CPI up to 3% rather than up to 4%.

The amendment changes the expiration date of the agreement from Dec. 31, 2025 to March 31, 2026 so that it remains three years, and adjusts the timeline of the severance provision.

The amendment will increase beginning July of 2023.

April 24, 2023, marks the 100th anniversary of an election that was held to keep Beverly Hills an independent City from Los Angeles.

The Beverly Hills Historical Society will showcase their videos at the following

locations to celebrate this significant milestone for the City of Beverly Hills:

Farmers' Market Sunday, April 23 in partnership with Earth Day; Monday entertainment for seniors at Roxbury Park on Monday, April 24; Movie screening at Greystone Mansion on Thursday, April 27; and BHTV will include as part of their programming the Beverly Hills Historical Society produced video on Monday, April 24 on Channel 10.

The Greystone event will include two video screenings in the theater followed by a brief question and answer session with a special guest provided by the Historical Society, a reception with small bites and non-alcoholic beverages in the Courtyard and/or card room depending on weather and convenience. The Beverly Hills Historical Society will be displaying videos, posters, and banners honoring "The Stars Who Saved Our City" and "Celebrating Beverly Hills Onscreen" with unique photo opportunities.

The estimated waived fees are approximately \$10,726. A rental fee is not yet set for the theatre, so the mansion rental fee was applied to cover use of both the mansion and the theatre.

and dance to bluegrass music and the witches' sound would be rock. And the songwriters have delivered," Prince said.

The production is under the direction of Jim O'Neil, with music supervision by Brad Haak, and choreography by Tony-winner Chris Gattelli.

Brush Clearance Inspections Set to Begin April 1

"We appreciate the cooperation of our community as we work to reduce the risk that dry and hazardous vegetation presents," Fire Chief Greg Barton said. "During a fire, these dangerous conditions act as fuel for fire and by removing these hazards, we are all working together to protect life and property."

Prior to joining Trevor, Abbe served as Co-CEO of The Saban Community Clinic, in Los Angeles, a preeminent organization dedicated to providing healthcare to the underserved.

In addition, Land served as an elected Councilmember of the City of West Hollywood from 1986-1997 and from 2003-2015, serving as Mayor five times.

"No one deserves this honor more than Abbe Land," Zbur. "She is a tireless advocate for our most cherished values of fairness, decency and social justice for all human beings and a longtime friend. Over three decades, Abbe's work has improved the lives of our most vulnerable. I am proud to recognize her lifetime of contributions to West Hollywood, California and our nation."

Land currently serves on the Planned Parenthood of Los Angeles Board of Directors; Creative Acts Advisory Board; Women Against Gun Violence Advisory Board; the L.A. County Department of Public Health's Women's Health Policy Council and MAZON's Public Policy Committee. In addition, she is involved with a number of civic and political organizations including ROAR Resistance, a group she co-founded in 2016.

Senator Ben Allen (D – Santa Monica) recognized Maryam S. Zar as the 24th Senate District Woman of the Year. An attorney by trade, Zar is a strong advocate for human rights and the women's movement taking place in Iran. Currently, she is president of the Pacific Palisades Community Council, chair of the Westside Regional Alliance of Councils Land Use and Planning Committee, secretary of her local Park Advisory Board, and chair of the board of her community YMCA.

CITY COUNCIL NIXES BEVERLY/CAÑON/LOMITAS ROUNDABOUT

City to Explore Adding Pedestrian Crosswalk

By Danielle Berjikian

At their Tuesday Study Session the City Council declined to further explore the Traffic and Parking Commission's recommendation of adding a roundabout at the Beverly/Cañon/Lomitas intersection. However, the Council gave direction to explore adding a pedestrian crosswalk at the intersection.

Councilmember Sharona Nazarian recused herself from the discussion due to the proximity of her home.

At the May 5, 2022 Traffic and Parking Commission meeting, city staff provided an introduction to the issues observed at the intersection and discussed an evaluation being conducted by engineering design firm, GHD, Inc.

At the Sept. 1, 2022 meeting, the Commission was presented with the results of a safety review and revealed this interreported collisions, with a total of 23 injury collisions between 2014-2020.

Video analysis of the intersection found that there are conflicts between road users or narrowly avoided collisions occurring all day.

Six conceptual design options were considered. This included raised midblock crosswalks, raised midblock crosswalks and turn pockets, intersection crosswalks, intersection crosswalks and turn pockets, roundabout, or no change.

A traffic signal was not recommended at this intersection due to projected operational delay involved with signalizing the six approaches and multiple turning movements. Curb extensions are also not recommended because curb radii are not the same at all approaches, which results in sight distance issues.

The commission believed that the roundabout would address conflict rates/ near misses. They also believe it provided a visible and accessible cross-

section has experienced a low record of walk, with islands allowing pedestrian crossing in two stages. It would have also added bicycle crossing facilities via ramps to sidewalks, and the commission believed it would have increased operating efficiency.

One con previously discussed by the commission was that since this type of infrastructure is new to Beverly Hills, it would have required community educa-

"As it is presented to us, the design would have it narrowed down to one lane and that would potentially cause a backup. There could be the conflict that a fire apparatus would have coming up to the intersection with the cars being stacked up and the second conflict going into the roundabout," Councilmember Lester Friedman said.

Had the Council agreed with the recommendation to add a roundabout, it would have cost the City around \$2 mil-


Jack Paul 1928-2023
