

## Traffic and Parking Approves Beverly Boulevard Bike Lanes

The Traffic and Parking Commission approved a recommendation to the City Council on proposed bike lanes on Beverly Boulevard between North Santa Monica Boulevard and Doheny Drive. The proposed design would not remove any vehicle travel lanes or on-street parking.

The Commission approved the recommendation in a 4-1 vote, with Ron Shalowitz dissenting.

This bikeway would connect with existing bike lanes on North Santa Monica Boulevard, an existing bike route on North Palm Drive, and planned bike lanes on Beverly Boulevard in the City of West Hollywood, which would close a gap in the regional bicycle network, according to the staff report.

According to the report, between Jan. 1, 2016 and Dec. 31, 2022, there have been 42 collisions on this segment of Beverly Boulevard. Nearly all were injury collisions except one.

"The top three primary collision factors include drivers violating right-of-way, failing to obey traffic signs and signals, and traveling at an unsafe speed. Two of these collisions involved bicyclists and four of them involved pedestrians, although the available data does not specify the party at fault," according to the staff report.

Proposed bike lanes on Beverly Blvd are not expected to result in any reduction in the number of vehicle travel lanes, turn lanes, or on-street parking spaces, as there is currently no on-street parking along this segment.

This is also intended to address reported concerns from residents by narrowing the travel lanes to include bike lanes in hopes of addressing excessive vehicle speeds. Electronic driver speed feedback signs will also be installed in an effort to encourage drivers to travel at speeds within the limit.

Staff is also exploring the possibility of installing narrow delineators on the bike lane lines to create protected bike lanes.

"Narrow protected bike lanes can create challenges, such as moving around any obstructions or debris that have fallen into the bike lane. However, it's possible that widely spaced delineators (as opposed to a continuous barrier) could alleviate these issues," according to the staff report.

If approved by the City Council, the bike lanes will be installed in late 2023.

## **City to Restrict Certain Products on Halloween**

The City Council approved a recommendation from the Beverly Hills Police Department (BHPD) on implementing restrictions of aerosol string, hair removal products and shaving cream on Halloween

In 2020, the city adopted an urgency ordinance outlining regulations for Halloween. While the purpose of the ordinance

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING ARTICLE 47 OF CHAPTER 3 OF TITLE 10 OF THE BEVERLY HILLS MUNICIPAL CODE ESTABLISHING NON-STOREFRONT, DELIVERY-ONLY MEDICAL CANNABIS RETAIL AS A CONDITIONALLY PERMITTED USE FOR PROPERTIES LOCATED IN PORTIONS OF THE C-3 ZONE AND ADDING ARTICLE 23 TO CHAPTER 2 OF TITLE 4 OF THE BEVERLY HILLS MUNICIPAL CODE ESTABLISHING REGULATORY AND OPERATIONAL RESTRICTIONS FOR SUCH RETAILERS AND MAKING A DETERMINATION OF EXEMPTION FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT

Article 47 of Chapter 3 of Title 10 of the Beverly Hills Municipal Code (BHMC) generally prohibits the establishment of commercial cannabis uses and activity in the City with certain exceptions as required by state law. In 2022, Senate Bill 1186 ("SB 1186"), referred to as the Medicinal Cannabis Patients' Right of Access Act (hereinafter referred to as "the Act"), added Chapter 26 (commencing with Section 26320) to Division 10 of the Business and Professions Code. The Act prohibits local governments, beginning January 1, 2024, from adopting or enforcing any regulations which prohibits or effectively prohibits, the delivery of medicinal cannabis to patients or primary caregivers within their jurisdictions.

The proposed ordinance incorporates code changes to the BHMC for SB 1186 compliance and will be presented to the City Council for a public hearing and first reading. The proposed ordinance makes code changes in the BHMC that include, but are not limited to, the following:

- $\cdot$  Adds Article 23 to Chapter 2 of Title 4 to establish regulatory and operational requirements for non-storefront, delivery-only medical cannabis retail businesses.
- · Amends Section 10-3-1604 of Article 16 of Chapter 3 of Title 10 to add "Non-storefront, delivery-only medical cannabis retail" as a conditionally permitted use, with the remainder of Section 10-3-1604 to remain unchanged.
- $\cdot$  Adds paragraph "E" to Section 10-3-1654 of Article 16.5 of Chapter 3 of Title 10 to prohibit non-storefront, delivery-only medical cannabis retail uses in a pedestrian oriented area with the remainder of Section 10-3-1654 to remain unchanged.
- · Amends paragraph "B" of Section 10-3-3800 of Article 38 of Chapter 3 of Title 10 to add non-storefront, delivery-only medical cannabis retail as a conditionally permitted use with required findings with the remainder of Section 10-3-3800 to remain otherwise unchanged.
- $\cdot$  Amends Section 10-3-4701 of Article 47 of Chapter 3 of Title 10 to add definitions of certain terms.
- $\cdot$  Amends Section 10-3-4703 of Article 47 of Chapter 3 of Title 10 to add paragraph "D" providing an exemption from the general prohibition on cannabis activity for certain non-storefront, delivery-only medical cannabis retail, with the remainder of Section 10-3-4703 to remain unchanged.
- $\cdot$  Adds Section 10-3-4705 to Article 47 of Chapter 3 of Title 10 to specify the standards and requirements for non-storefront, delivery-only medical cannabis retail use.

On August 24, 2023, the Planning Commission held a duly noticed public hearing on the proposed ordinance and adopted Resolution No. 2036, recommending the City Council amend portions of the BMHC to establish "non-storefront, delivery-only medical cannabis retail" as a conditionally permitted use for properties in portions of the C-3 zone and to establish regulatory and operational restrictions for such retailers (collectively, the "Amendments").

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The project will not result in a direct or reasonably foreseeable indirect physical change in the environment; and the activity is covered by

the general rule that CEQA applies only to projects, which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity may have a significant effect on the environment, the activity is not subject to CEQA. The businesses authorized under this zone text amendment are similar to already existing permitted general uses such as retail, with the only difference being the product sold (i.e., medical cannabis and medical cannabis products). The proposed ordinance does not change the zoning for any properties, meaning that they do not create negative environmental impacts or result in physical changes to the environment. Accordingly, the City Council will consider a recommendation to find the project categorically exempt from CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations.

ation as a local landmark. The commission directed staff to provide a recommendation to the City Council for designation of the property as a local landmark.

Representatives from The Peninsula expressed a number of concerns at the Planning Commission meeting, including one with the requested times to receive deliv-

eries. The Planning Commission adjusted the allowable delivery times to align with The Peninsula, which prohibits deliveries from 10pm to 7am.

The Mixed Use Overlay Zone (MU Overlay Zone) was adopted in November 2020, via Ordinance No. 20-O-2825, and established development standards to guide future commercial/residential mixed use developments on certain C-3 Commercial Zone properties in the City. The MU Overlay Zone allows for properties to be redeveloped with mixed use projects, or to convert existing commercial buildings to mixed use projects. At their July 18, 2023 formal meeting, the City Council reviewed the progress of the implementation of the MU Overlay Zone thus far, and discussed whether the MU Overlay Zone regulations should be modified in the future. As part of this discussion, staff identified an existing issue in the conversion section (BHMC §10-3-1888) of the MU Overlay Zone regulations, as it does not allow existing commercial buildings to calculate density based on the existing building envelope, rather than the size of the property. The City Council provided direction to staff to develop a draft amendment of the MU Overlay Zone regulations for the City Council's consideration to allow the use of the minimum unit size of 500 square feet to calculate the maximum density allowed for conversion projects. This will also necessitate a change to the General Plan Land Use map to identify the density calculation that is applicable for conversion projects, and therefore, requires a General Plan Amendment. Once staff presents the draft ordinance and General Plan Amendment to the Planning Commission for review, the draft zoning ordinance and General Plan Amendment resolution will be presented to the City Council for consideration.

#### **ENVIRONMENTAL REVIEW**

The City of Beverly Hills has previously adopted a Mitigated Negative Declaration (MND) for the adoption of the Mixed Use Overlay Zone regulations (Project). The City of Beverly Hills was the lead agency, pursuant to the California Environmental Quality Act (CEQA), and was responsible for the preparation of the MND and related initial study. The previously adopted MND document is available at www.beverlyhills.org/ environmental. If a digital copy cannot be obtained by an interested party, please contact the staff listed in this notice and alternate arrangements will be made. The previously adopted MND indicated that the Project would not result in significant impacts to Agricultural and Forestry Resources, Biological Resources, Mineral Resources, and Transportation/Traffic. The MND also indicated that the Project would result in less than significant impacts related to Air Quality, Cultural Resources, Energy, Greenhouse Gas Emissions, Public Services, Recreation, Tribal Cultural Resources, Utilities and

Service Systems, and Wildfire, and either no impact or less than significant impacts on certain environmental issues related to Aesthetics, Geology and Soils, Hazards and Hazardous Materials, Hydrology and Water Quality, Land Use and Planning, Noise, and Population and Housing.

An addendum to the previously adopted MND for a proposed change to the Mixed Use Overlay Zone has been prepared, pursuant to California Code of Regulations, Title 14, §15164. A copy of the addendum will be available as part of the agenda materials for this meeting date, on www.beverlyhills.org/citycouncilmeetings, at least 72 hours before the meeting. The Project description and location are described above, and the adoption of amendments includes changes that are limited to revisions that will result in greater clarity regarding the application of regulations. The proposed general plan amendment and code changes will include a clarification regarding the calculation of maximum density allowed for conversion projects under the MU Overlay Zone, and a change to the General Plan Land Use map noting this clarification. Since these changes consist of clarifications of existing regulations, the Project will not result in significant impacts to the areas of study in the adopted MND, and none of the conditions in California Code of Regulations, Title 14, §15162 have occurred, the City Council will consider the adoption of the addendum to the previously adopted MND.

The rooftop uses at the Sixty Hotel consist of a rooftop bar, lounge areas with unenclosed architectural features, food preparation room, and a rooftop gymnasium.



Conditional Use Permit. Pursuant to BHMC §10-3-2862, a Conditional

Use Permit is required to allow outdoor recreation and dining facilities for a hotel, as well as to allow an increase in the overall capacity of hotel areas. The Sixty Hotel currently operates a dining facility on the ground floor and offers dining services on its rooftop. The Sixty Hotel provides outdoor recreational options with a rooftop pool and poolside lounge areas.

**Extended Hours Permit.** Pursuant to BHMC §10-3-1958, an Extended Hours Permit is required to allow rooftop operations during extended hours (defined as those hours between 10:00 PM – 7:00 AM on weekdays and 10:00 PM – 9:00 AM on weekends). The Sixty Hotel is located within a commercial-residential transition area and is requesting rooftop operations as follows:

- · Rooftop operations until 2:00 AM on Friday night and Saturday night;
- · Rooftop operations until 1:00 AM from Sunday night Thursday night;
- · Up to 12 rooftop events per year that could operate until 2:00 AM on a night other than a Friday or Saturday;

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, the project appears to qualify for a Class 1 Categorical Exemption (Existing Facilities) in accordance with the requirements of Section 15301 of the state CEQA Guidelines. # HEART OF LA DEMOCRATIC CLUB CRITICIZES CITY COUNCIL OVER ABORTION CONTROVERSY

## **Activists Demand Local Legislation**

Activists from the Heart of LA Democratic Club criticized the City Council at Tuesday's meeting regarding DuPont Clinic, an all trimester abortion provider that planned to open a clinic in Beverly Hills

The mission statement of the Heart of

L.A. Democratic Club is to "help make the Democratic Party and its elected officials responsive to, and responsible for, the needs of all people, particularly, though not exclusively, women in our community," according to its website.

The Democratic Club is claiming that

Beverly Hills Mayor Julian Gold, Police Chief Mark Stainbrook, and other city officials conspired with pro-life activists and the landlord Douglas Emmett to block the clinic from opening in the City

DuPont Clinic offers elective abortions during the third trimester through 31 weeks and six days gestation. Pro-life activists previously petitioned the City Council in an effort to prevent DuPont from opening up this fall.

DuPont Clinic filed a suit against the landlord Douglas Emmett, Inc., alleging Douglas Emmett colluded with the City to delay DuPont's opening and then attempted to "baselessly" rescind DuPont's lease.

The clinic is also alleging that the City interfered with its permits in an effort to run them out of town, and has said they will also file a suit against the City as well

The Clinic claims that City officials met with pro life activists, shared Du-Pont's private information, and "directly and intentionally" interfered with its permits. City Officials named in the letter include Mayor Julian Gold, City Man-

ager Nancy Hunt-Coffey, Deputy City Manager Keith Sterling, and City Attorney Larry Wiener.

"Douglas Emmett's shameful cowardice in the face of protestors and politics has given DuPont no choice but to resort to legal action," the complaint states.

Pro-life activists from the group 'Survivors' petitioned the City Council in July in an effort to prevent DuPont Clinic from opening up its doors in the City. Survivors is a "youth based pro-life activism and apologetics ministry that exists to empower and equip the rising generation to end the abortion genocide in America," according to its website.

The clinic would have opened up at 8920 Wilshire Blvd.

Organizers from the Democratic club are claiming they want a full investigation and disclosure of contact between city officials, BHPD, Douglas Emmett and pro-life groups; and legislation prohibiting city agencies from using resources when it comes to working against out-of-state entities related to abortions performed in California.

## BHHS Football Team Set To Play Host to Whittier Christian Tonight


