#### "Heart of LA Democratic Club Criticizes City Council Over Abortion Controversy" [Issues #1250 and 1251]

My letter is long. As I researched information on the phrase 'late term abortion' and the effects on reproductive care in a post-Roe world, I learned a lot. I hope that readers will read through this letter and perhaps do their own research to understand the complexities and challenges that this decision has thrust on women, medical professionals, and others.

Addressing the first point, the original article from issue #1250 inaccurately stated "that activists from Heart of LA Democratic Club criticized the City Council at Tuesday's meeting regarding DuPont Clinic, an all-trimester abortion clinic in Beverly Hills."

To clarify, I was one of the residents that made a statement that evening regarding the rescinding of the DuPont Clinic lease. I am not a member of Heart of LA Democratic Club nor were the other speakers. It is my understanding that the Heart of LA Democrats had highlighted the opportunity to speak at the City Council Meeting regarding DuPont Clinic and Reproductive Rights in a newsletter to members. They were not involved in any formal organizing. To be clear, the statements and sentiments made by me and the other residents that evening were strictly our own.

The statements that the author of the 'letter to the editor', issue #1251 made

about 'late term procedures' are misleading and inaccurate.

According to the California Health and Safety Code:

'California only limits abortions after the point of viability, which is when a physician determines based on a goodfaith medical judgment that there is a reasonable likelihood the fetus can survive outside the uterus without extraordinary medical measures. Abortions can only be performed after the point of viability if a physician determines based on a goodfaith medical judgment that continuing the pregnancy would pose a risk to the life or health of the pregnant person. These determinations are individual to the person and their situation.'

To correct another misleading comment; it is the position of many major and respected organizations such as the ACOG (American College of Obstetrics and Gynecologists) that the fetus can't feel pain until at least 24-25 weeks.

Further clarification regarding 'late term abortion': The phrase 'late term abortion' is misleading. The procedure is generally performed during the latter part of the second trimester approximately during the 21st to 24th week of gestation. Anti-abortionists purposely use the term to confuse and alarm the public.

The latest findings from CDC (Centers for Disease Control and Prevention) and the Guttmacher Institute, a leading research organization suggests that approximately 1.1% to 1.3% of abortions were performed at or greater than 21 weeks of

gestation in 2015. In contrast, 91.1% were performed at or before 13 weeks and 7.6% at 14 to 20 weeks of gestation.

• Research has long indicated that abortion bans have the greatest impact on people in marginalized groups <https://www. guttmacher.org/2023/01/inequity-us-abortion-rights-and-access-end-roe-deepening-existing-divides> who already struggle to access health care, including abortion.

• Fetal health issues that are often serious or fatal cannot be medically determined until the third trimester leading to catastrophic situations and challenges facing the mother.

• Significant health issues develop later in the pregnancy that risk the life of the mother and/or the fetus.

• Obstacles for women seeking abortion procedures earlier in their pregnancy lead women seeking these services to be forced to terminate later than desired.

The reasons are the following: Abortion procedures are greatly restricted or banned in the states that they live; Unable to receive the necessary approvals from doctors in time to meet the policy cut off restrictions; Have families and jobs that limit their availability to travel to a state where the procedure is legal; And do not have the financial resources to travel out of state to receive the safe medical treatment needed.

Fourth- [The letter's] statement referring to 'deference given to any political party of affiliated clubs to be avoided' has already been proven inaccurate since the Heart Of LA Democrats neither influenced any of the statements that evening and certainly did nothing to change the outcome for the DuPont Clinic. In addition, it appears that the City of Beverly Hills did give deference to a political party and club. An anti-abortion group called "The Survivors of the Abortion Holocaust" petitioned and met with one or more of our city officials with demands to close DuPont Clinic before it opened leading to the rescinding of DuPont's lease. It is a fair guess that the anti-abortion extremist group aligns with our current Republican Party's platform and not with The Democratic Party.

In conclusion, it is the author's first amendment right to refer to a 'late term abortion' procedure as "murder". #### Judge Rules in Favor of Nonprofit Over Housing Plan

Beverly Hills has submitted an updated plan, but Calfiornians for Homeownership, a nonprofit housing group, brought a suit against the city as a way to force the issue into the courts.

Following a September 12 hearing, a judge granted the organization's petition for writ of mandate, finding that Beverly Hills had not complied with its legal duty to plan for housing under the regional housing needs allocation (RHNA) and housing element system.

The organization first sued the city over its housing element in January. The city amended its housing element in February, and the lawsuit was amended to challenge the new version.

State law requires housing elements to identify sites that are likely to be developed into housing over an eight-year period. For sites with existing uses, such as office buildings, cities must provide evidence that the existing uses will be discontinued during that time, according to the nonprofit. It is alleged that Beverly Hills has not complied with these obligations.

"This is a milestone decision in state housing law," President Jennifer Branchini said. "For far too long, cities and counties have used unrealistic and underdeveloped housing plans to skirt around state planning rules. This case proves that the Legislature's recent improvements to housing element law go a long way toward solving this problem, so long as these new laws are vigorously enforced." The nonprofit claimed that the City's 2013-2021 allocation was just three units. And that recent changes have made the RHNA allocation process more robust, and the City was assigned a 2021-2029 RHNA of 3,104 units, including 1,688 units of housing for low and very low-income households.

It was further alleged that the city shifted its approach and chose to identify "broad swaths" of the commercial corridors as potential sites for housing, even though most of these sites contain established office and cultural uses that have "little potential: for residential development by 2029, according to the nonprofit.

The nonprofit also claimed that the city "drastically" overcounted the development potential on these sites, using a calculation method that assumed that the existing buildings on all of the sites will be replaced with ground-up residential developments, at the maximum density allowed by law.

In opposing the lawsuit, the city argued that it was entitled to "broad discretion" in crafting its housing element, despite "recent changes to state law designed to limit that discretion," according to the nonprofit.

"Approximately 60% of the residential units in the City of Beverly Hills are rental units and in excess of 40% of those rental units are occupied by lower income individuals. Thus, Beverly Hills was one of the State's earlier adopters of rent stabilization. As a consequence, the City's Housing Element directs new residential development to commercial areas," Beverly Hills City Attorney Larry Wiener said.

The City has appealed the decision.

"The City has established a mixed-use zone in order to direct new development away from multi-family areas to preserve rent stabilized units and avoid displacing tenants. Additionally, the City is working with the State Department of Housing and Community Development to further revise its housing element," Wiener said.

The nonprofit has filed lawsuits against a total of 10 Southern California cities claiming they violated state laws that require cities to plan for the development of housing.

#### Planning Commission to Discuss Mixed Use Overlay Zone

At their Thursday meeting the Planning Commission is expected to discuss a draft ordinance to amend the municipal code to change the maximum density calculation applicable to residential conversion projects in the Mixed Use Overlay Zone.

The proposed amendment to the Mixed Use Overlay Zone regulations would allow a residential conversion project to utilize the minimum unit size of 500 square feet to determine the maximum number of units allowed to be created within a conversion project, in which an existing commercial building located within the zone may be converted to a mixed use project.

The proposed density calculation would be applied to a residential conversion project by taking the existing building floor area, minus the ground floor footprint and dividing this by the minimum unit size, 500 square feet. The existing floor area would be determined after non-residential floor area is defined and the ground floor footprint would not be included, as the regulations generally require that this area is used for commercial uses only.

This differs from the existing maximum density calculation, which allows one dwelling unit per 550 square feet of lot area, according to the staff report. However, the proposed change would allow a conversion project to maximize the number of units that are able to be created within an existing commercial building.

On Nov. 17, 2020, the City Council adopted an ordinance to establish standards to guide future mixed use development proposals along specific commercial corridors within the C-3 Commercial Zone.

At their July 18 meeting, the City Council reviewed the progress of the implementation thus far, and discussed whether the regulations should be modified in the future. As part of this discussion, city staff identified an existing issue in the conversion section, as it does not allow existing buildings to calculate density based on the existing building envelope, rather than the size of the property.

The Council provided direction to develop a draft amendment of the regulations in order to allow the use of the minimum unit size of 500 square feet to calculate the maximum density allowed for conversion projects.

The Planning Commission is expected to discuss the draft ordinance and possibly recommend approval to the City Council.

#### **Board Approves New JPA** Agreement

The Board of Education approved the Joint Powers Agreement (JPA), with the City, at Tuesday's meeting.

The Joint Powers Agreement specifies mutual responsibilities, uses, and compensation, which has typically been termed for up to four years.

The City will make annual payments to the BHUSD in the following amounts:

• FY 23/24: \$13,700,000

• FY 24/25: \$14,100,000

• FY 25/26: \$14,500,000

Each year also includes \$300,000 for Crossing Guard reimbursement.

The City Council also previously approved an amendment to the JPA with the BHUSD for the first quarter of fiscal year 2023-24 and approved the purchase order for just under \$3 million. The purpose of the amendment was to extend the current agreement for one quarter while negotiations for a three-year agreement take place.

BHUSD Board members and Council Liaisons have been meeting to discuss the terms of the agreement as well as the funding request brought forward by the District. The former JPA expired on June 30 but the amendment extended the current JPA until Sept. 30.

The City Council is expected to approve the agreement at its meeting next

tion criteria matrix ranking. After that meeting each Committee member completed the matrix indicating Committee priorities.

Electricity resilience and reliability are expected to be the highest priorities to the Committee, with renewable energy and reduction of carbon footprint also being high priorities. Bill savings and various types of power sales to the broader grid are ranked lower, according to the staff report.

Results indicate that alternative energy development is a priority for the City, but not at the 'expense of resilience and reliability.' Which indicates other energy sources, such as diesel backup generation, could be an option, possible in an emergency situation or for sites where businesses and residences are more vulnerable in an outage situation and where 'installation of solar is not feasible,' according to the staff report.

The Committee was also expected to provide input on moving forward with incorporating a Resiliency Audit Program into the Committee's final plan., which is expected to reveal risks in the event of electricity loss, as well as identify opportunities to mitigate the worst impacts of an electricity outage through critical loads, threats to service loss, and potential for installation.

#### **Item Pulled That Would Have** Hired Samadi as Bullying **Parent Liaison**

The Board of Education pulled a professional services agreement with Elham Samadi to work as a Parent Liaison to address bullying Districtwide, at Tuesday's meeting.

The item was pulled from the agenda and not approved. Board President Noah Margo, Board Vice President Mandy Stern, and Board member Rachelle Marcus voted to pull the item.

> Board members Mary Wells and Judy Manouchehri voted against pulling the item.

During Board Comment, Marcus, who attended the meeting virtually, said she was not ready to vote

on the item because the full description was not read out loud when the item was pulled. Marcus said that although she voted yes to pull the item, she actually meant to vote no, and just wanted to clear the record.

"It was pulled before I could even realize what I was voting for," Marcus said.

Manouchehri requested to amend the agenda during the public comment period so that the board could subsequently "vote the other way now" because "it would be a good idea to do so that [the board] can move on with [other] business," Manouchehri said.

Since the item was removed from the agenda, Margo said that item cannot be brought back. But the item would be on the agenda at the next meeting.

"Anything can be undone through an amendment. It is not like it disappeared into thin air," Manouchehri said.

Wells then questioned that since Marcus was unaware what the Board was voting on, what other options they could do before adjourning the meeting.

Margo clarified that there is room for comments and questions during the time the motion is made to approve the agenda.

"Like any other motion, I gave it its fair due. Since the agenda is approved already, you cannot add things," Margo said.

Mary then questioned again on what the protocol is as Marcus was attending the meeting via Zoom.

"You cannot bring the vote back to the table. You can bring it back to another agenda, but not this one." Margo said.

The contract would have had Samadi work as a parent liaison to address bullying districtwide. It would have establish a referral system for therapy for families that need support; establish community support groups among parents; provide parent education seminars on bullying; facilitate community centered outreach by "empowering parent groups to address community members; form a task force to assist parents and known families with issues related to bullying; and provide emergency MFT services."

Superintendent Michael Bregy revealed the idea for a Parent Liaison came from the Behavior and Accountability Advisory Panel. Samadi is a member of that committee.

Earlier in the meeting, Margo expressed

### LACO's 2023-24 Season to Open At the Wallis Sept. 30

Los Angeles Chamber Orchestra opens its Chamber Series with a program curated by Concertmaster and Director of Chamber Music Margaret Batjer.

#### You are involved in three separate LACO concerts at The Wallis in conjunction with LACO's 2023-24 season opening concert on Sept. 30. Tell us about that.

We're so happy to be in this collaboration with The Wallis, because it's such a great hall and such a needed hall across the city. It's so wonderful to be able to play three concerts this year. I basically curate this series - meaning that I design the programs. I cast the programs and try to come up with concepts both in our chamber music programs and our Baroque series that have some commonality between the different programs and the chamber music program. The Baroque programs this year were especially fun for me because I decided to focus on two really great pianists living today,

Anne-Marie McDermott and Marc-André Hamelin, who are just fantastic chamber musicians and collaborators.

The first program that we are doing is an interesting mixture of composers. Samuel Coleridge-Taylor was the first of his kind. He was a British born, mixed race composer. born in 1875, and he died very early, which his output of scores and music. But he was a violinist and composer. When he came to America, they called him the 'African Mahler.' So his music is very rich in texture. Edward Elgar helped his career be-

cause at the time it was very difficult for Black skinned, mixed race composers to get onto the main concert stages. It was unusual for a composer to not be a white

Lineage is so interesting to me in terms of composers who have children or relatives who take on their role of being a composer. Coleridge-Taylor's daughter, Avril Coleridge-Taylor, became a composer and unfortunately for her, she suffered some of the same injustices as her

> father and even wrote under a male synonym for some of her works because it was hard to get her works played. But her children have been great champions of her, composed of her works. They found boxes of music from her works that were actually never performed. So there's kind of a renaissance for her. And in some ways a basis based on father's works being played much more cert stages. So those two together make a wonderful combination, a deal for flute and piano and then the clarinet quintet.

always had a great opportunity for his music. I find it so fascinating. His life was interesting and he didn't become a composer until very late in life. His fa-

It's the solo parts, the violin and the piano part sort of sit together. And then the String Quartet is more like the concerto grosso part. So it is one of the most difficult pieces in all of the piano literature. And we are just so excited to welcome back Anne-Marie McDermott to LACO. She hasn't been here for many years and she is one of the most wonderful and prolific performers of solo and chamber music concerts. She's the artistic director of the Bravo Vail Valley Music Festival. She's a very powerful performer and musician. So that is our program for September [and] October

#### You are Los Angeles Chamber Orchestra's Concertmaster and Director of Chamber Music. Tell us about that.

I've been at LACO for 24 years. I can't keep count anymore. And when I came, I had never been in an orchestra. I joined the orchestra very late. I think I was probably close to 40 years old and I had been mainly playing chamber music and solo works and teaching a little bit. When I had children, I decided I needed to find something locally, something in Los Angeles that would give me a nice base instead of traveling nine or ten months out of the year. When the opening for concertmaster of the Chamber Orchestra came open, I decided to take it. And it's been a really amazing ride for me. I have loved every minute. I love my colleagues. I was hired by our former music director Jeffrey Kahane who is a wonderful friend, colleague and pianist and music director. Now I am working with Jaime Martín, who is our new music director. I can't say enough great things about him. He's just so much fun to play for and such a great music director. Many years ago, they decided to start a chamber music series and they asked me to be the director of that. Chamber music being part of my main background [made it] a very nice fit for me. I have enjoyed it so much over the 15 years.

## coverstory **FBI SUED AFTER ALLEGEDLY LOSING** HUNDREDS OF **THOUSANDS IN RARE COINS DURING RAID IN BEVERLY HILLS**

### Security Deposit Box Renters Demand FBI **Return Missing Property**

The Institute for Justice filed two lawsuits Friday on behalf of clients who had property seized from their safety deposit boxes in a March 2021, FBI raid on U.S. Private Vaults, a Beverly Hills-based company that was located at 9182 West Olympic Blvd.

According to the Institute for Justice, Don Mellein was never accused of a crime, but his security deposit box was seized in the FBI raid. They allege that after the government gave up on trying to take his savings, it failed to return 63 precious metal coins worth more than \$100,000.

It is further alleged that the same thing happened to Jeni Pearsons and her husband Michael Storc. The FBI returned some of their property, but not the \$2,000 cash they stored below a liner in their box, according to the suit.

In each instance, the FBI claimed there was no property to return and said it had done nothing wrong by failing to return it, the institute alleges.

The plaintiffs are filing separate lawsuits demanding that their coins and cash be returned.

"If normal people are held accountable for stealing or losing your property, then the government should be, too," IJ attorney Joe Gay said. "Don, Jeni, and Michael did nothing wrong. The government never should have broken into their safe-deposit boxes, but once it did, it became responsible for keeping their property safe. If it doesn't give it back, there must be a legal remedy.'

The three plaintiffs rented security deposit boxes from US Private Vaults. They claim that they were unaware that the business was being investigated by the FBI. After the raid, they received notices stating that the government was seeking to keep their property through civil forfeiture, according to the Institute.

"After effectively proving his own innocence, the ment gave up on forfeiting Don's savings. But the FBI did not return 110 gold coins

stored in the Plaintiff Jeni Pearsons box. In fact, the FBI's in-

ventory receipt for his box did not list any coins. But after Don sued, agents conveniently "discovered" 47 of the coins that had gone missing and returned them," according to a statement from Institute for Justice.

The class action lawsuit further alleges that the agent in charge of forfeitures testified that months before seeking a warrant for the raid, the FBI had already planned to try to take any box with property worth more than \$5,000 using civil forfeiture. And that the FBI sought forfeiture of more than \$85 million in cash and tens of millions of dollars' worth of precious metals, jewelry, and poker chips.

"Unfortunately, civil forfeiture creates a powerful incentive for law enforcement to seize money since the proceeds flow into accounts that are controlled by the agencies, not Congress," IJ Senior attorney Rob Frommer said. "Law enforcement does not have to convict or even charge someone with a crime to take property. It's a flawed system that turns citizens into ATMs."

A federal judge ruled two years ago that the search and seizure was constitutional. The now-defunct company was fined over \$1 million last year for money laundering after admitting it sought drug traffickers and other criminals as customers who would keep cash that was obtained illegally in their deposit boxes.

According to the criminal indictment, U.S. Private Vaults was raided by the FBI who broke open boxes, seizing drugs, firearms and large amounts of gold bullion and cash, as well as other valuables, from about 396 of the rented boxes.

Many box holders have denied criminal culpability and were able to successfully petition to have their property returned

FBI spokesperson Laura Eimiller declined to comment due to a policy regarding not speaking on pending litigation. However, they provided the following statement issued by the Los Angeles office previously in response to reporting on court rulings in this case:

"Today's District Court ruling makes it clear that agents investigating criminal activity at U.S. Private Vaults did not mislead the court and affirms the FBI's position that the investigation was conducted without malice and in a manner consistent with the law, FBI policies and the U.S. Constitution. As a result of the investigation, U.S. Private Vaults, Inc. pleaded guilty to conspiring with its customers to launder money. From the outset, FBI Agents outlined evidence of widespread criminal wrongdoing in court filings while establishing a simple procedure to return safeguarded contents to box holders who were not otherwise subject to asset forfeiture. The FBI stands by its ongoing investigation of U.S. Private Vaults, a business that criminally facilitated drug trafficking and money laundering, and which allowed customers to store their criminal proceeds anonymously in safe deposit boxes. As the court's comprehensive ruling today makes clear, claims made by the plaintiffs' attorneys and amplified in news reports are not supported by the facts."

#### Sixty Hotel Requesting **Rooftop Permit**
